

NEW TRAFFIC ORDINANCE TAKES EFFECT IN 30 DAYS

The new traffic ordinance as passed by the city council Wednesday, and which takes effect in 30 days, follows: Section 1. The term "street" shall mean any highway or bridge, whether or not a public street, and shall include any alley, driveway, or other way, whether or not a public street, and shall include any alley, driveway, or other way, whether or not a public street...

Section 2. The term "vehicle" shall apply to any conveyance used for travel on a street, whether or not it is a motor vehicle, and shall include any conveyance used for travel on a street, whether or not it is a motor vehicle...

Section 3. The term "driver" shall apply to any person who is in the driver's seat of a vehicle, whether or not he is the owner of the vehicle, and shall include any person who is in the driver's seat of a vehicle...

Section 4. The term "passenger" shall apply to any person who is seated in a vehicle, whether or not he is the owner of the vehicle, and shall include any person who is seated in a vehicle...

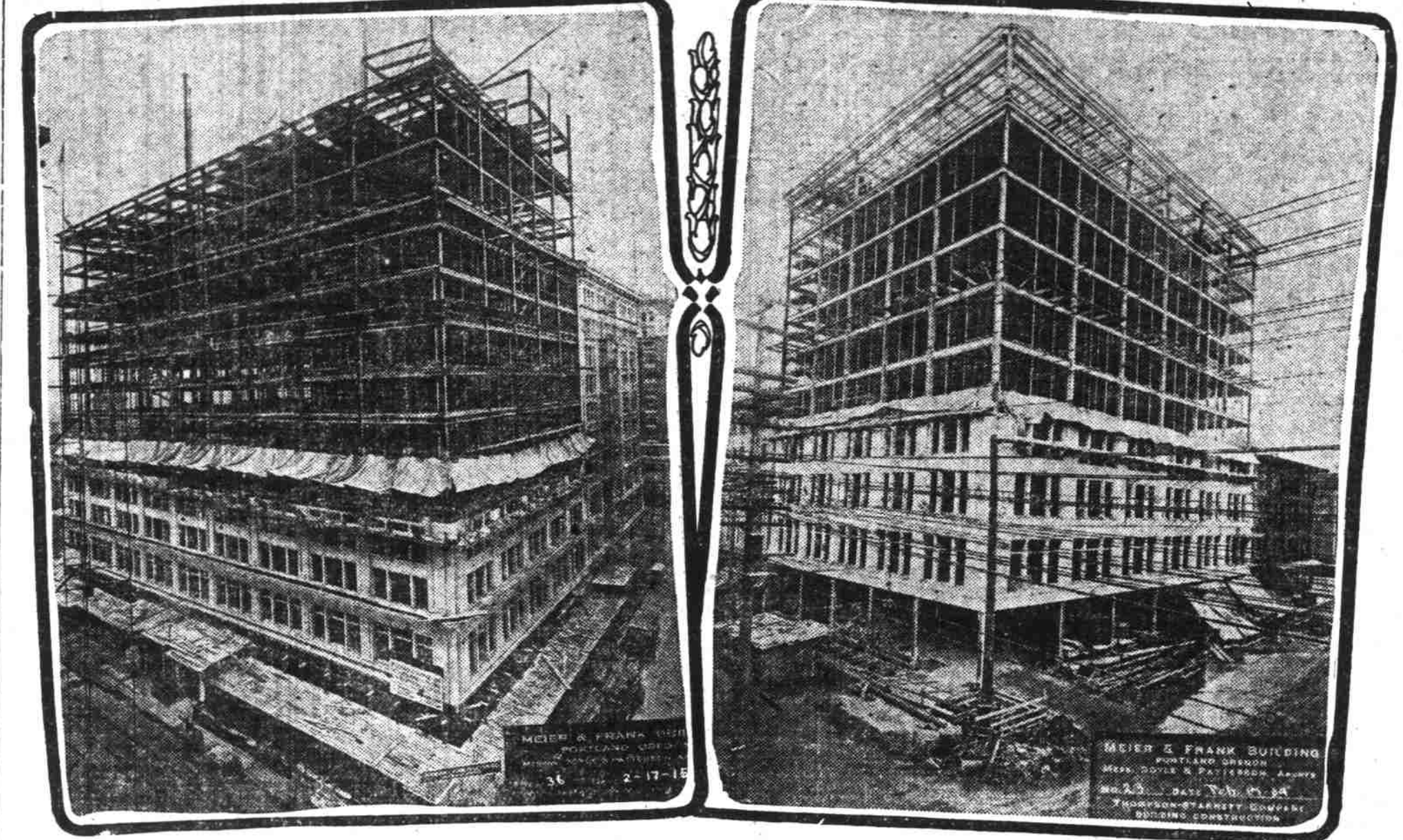
Section 5. The term "pedestrian" shall apply to any person who is walking on a sidewalk, whether or not he is a citizen of the city, and shall include any person who is walking on a sidewalk...

Section 6. The term "sidewalk" shall apply to any way, whether or not it is a public street, and shall include any way, whether or not it is a public street...

Section 7. The term "crosswalk" shall apply to any way, whether or not it is a public street, and shall include any way, whether or not it is a public street...

Section 8. The term "intersection" shall apply to any place where two streets meet, whether or not they are public streets, and shall include any place where two streets meet...
