

REPUBLICAN NATIONAL COMMITTEEMAN WILL GO EAST TOMORROW

R. E. Williams to Attend the Meeting Which Will Arrange Preliminaries.

GATHERING NEXT MONDAY

Oregon Man Favors Borah for Temporary Chairman and Hughes as Presidential Nominee.

Ralph E. Williams, Republican national committeeman from Oregon, will leave tomorrow night for Chicago to attend the meeting of the sub-committee having charge of the preliminary organization of the national convention. He will be accompanied by Mrs. Williams and will not return to Portland for two weeks or so.

The meeting of the committee on arrangements will be held on Monday and Tuesday next. One of its principal duties will be to determine upon the temporary chairman of the national convention. It will also provide for the various committees on credentials, on permanent organization, and do all of those many other things usually done preparatory to the assembling of a well ordered national convention.

Mr. Williams is starting to Chicago with a Borah vote for temporary chairman in his pocket. He believes that Senator Borah is the man who should rule the convention in its preliminary stages. If Borah be elected temporary chairman he will, in all probability, be selected as the permanent chairman as well.

Associate Justice Hughes is the man who should be selected as the presidential nominee, according to the belief of the Oregon committeeman. He believes that Justice Hughes is the man who should be nominated if the Republican party expects to elect a president this fall, and he also is of the opinion that should such a nomination be made it would be accepted by Justice Hughes.

REORGANIZATION PLAN OF CHAMBER WILL BE SUBMITTED TONIGHT

Executive Secretary Hardy to Present Outline for Economy in Service.

Before the entire board of directors of the Chamber of Commerce tonight, Executive Secretary George E. GRAND JURY HANDS UP 19 INDICTMENTS; 6 ARE MADE PUBLIC

Geo. Whitfield, Oxford Man, Charged With Forgery; Dr. Childs Is Another Accused.

SOME ARE NON-SUPPORT

One Man Accused of Burglary, Another of Stealing Cow; No Report on Liquor Theft.

Nineteen indictments and three not true bills were returned by the Multnomah county grand jury today. Only six of the indictments were made public, the persons accused in the remaining 13 indictments not being in custody.

Among the indictments not made public are four or five against the men alleged to be involved in the vice investigation.

Two indictments were returned against George Whitfield, the Oxford graduate and college professor, who is charged with passing a fraudulent check for \$25 at the Imperial hotel. In one indictment he is charged with forging an endorsement and in the other with obtaining money under false pretenses.

Dr. C. Howard Childs was indicted on the charge of obtaining money under false pretenses in connection with the sale to J. G. Garman of a catarrh remedy.

Larceny of silverware and jewelry is the charge on which Lester Butler has been indicted. An indictment was returned against Gordon L. Brown and Jennie Shanley. Amos Jones was indicted for larceny. He is charged with stealing a Jersey cow belonging to Harry French on February 18.

No indictments were returned against the persons who entered the basement storeroom at the court house and stole a quantity of liquor that had been confiscated in various raids.

Some of the indictments not made public, it is understood, are non-support cases.

DAMAGE SUIT BEING TRIED

\$10,000 Asked for Alleged Malicious Prosecution.

Suit for \$10,000 damages for alleged malicious prosecution is being tried today before a jury in Judge Kavanaugh's court. The action was brought by R. W. Booth against A. F. Smith and the Smith Hotel company.

The Smith Hotel company is the owner of property near Sixth and Main streets on which is a rooming house. Booth was a renter. Last December he undertook to move the house from the premises. On the complaint of Smith he was arrested on a charge of trespassing. Two days later he was tried in the municipal court and acquitted.

Booth alleges that the lessee was the owner of the building and he had a right to remove it, and that his arrest was malicious.

Smith says he was advised by Deputy City Attorney Stadler to have Booth arrested for trespassing.

O. & C. GRANT NOT TO BE TIED UP AS FOREST LAND

CONGRESSIONAL ALBERT JOHNSON OF WASHINGTON, EXPLAINING HIS PART IN INTRODUCING AN "APPLICANT'S" BILL AT THE LAST SESSION, SAID IT WAS PREPARED BY CROSWHITE, AS STATED BY PUTER, BUT HE HAD NO IDEA THAT CROSWHITE WAS ATTORNEY FOR PUTER. HE WAS NOT SATISFIED WITH SOME FEATURES OF IT, HE SAID, AND CHANGED IT MATERIALLY BEFORE INTRODUCING IT. HE WOULD NOT INTRODUCE THE BILL THIS SESSION, HE SAID, AS HE FEARED IT WOULD LEAD TO MORE "PEDDLING" OF PRETENDED CLAIMS TO THE LANDS.

Puter became somewhat heated at times as he testified, and at others joined in the laughs he created by picturesque expression of his sentiments.

Puter declared the "applicant's" bill is the only one that "protects" the applicants, who have paid out their money for locations and ought, in his view, to have preference rights. He added, under cross examination by Chairman Ferris, that he is acquainted with numerous locators, but denied that he is in touch with them.

Puter turned accuser to take up the question of exonerating contracts, which, under an amendment to the Chamberlain bill, prepared by Attorney General Gregory, would be carried out and ratified upon completion of the agreed price to the railroad, with a proviso that where such contracts call for more than 1000 acres the purchaser shall pay the government \$2.50 an acre, placing such purchasers on the same plane as those whose titles were confirmed by the innocent purchaser act of 1912.

After this, said Puter, the attorney general came along with a recommendation for "another steal" of \$80,000 acres. He said the land is no doubt the cream of the timber land, worth perhaps \$10,000,000.

Representative Lenroot pointed out that the \$8,000 acres embraced in the exonerating contracts as given at the time the figures were first presented have been reduced to 18,000 acres at the present time through the completion of payments or the writing off of accounts where the purchasers have dropped from sight.

"They are crying 'stop thief' at me," said Puter, "and here they are trying to make away with \$8,000 acres. That is the motive behind the
