

CAMPBELL'S AMERICAN BAND WILL FURNISH MUSIC IN CITY PARKS

Percy A. Campbell Is Engaged to Conduct for the Season.

By unanimous vote the city council today selected Percy A. Campbell as director of the municipal band for the summer season to be given in the parks. The director will select the band members.

Owing to a reduction in appropriation present plans call for only 20 concerts. Last year the fund provided for 60. No date has yet been set for the opening concert, nor has the schedule been arranged. The band will consist of 35 pieces.

Director Campbell was recommended by Commissioner Baker in charge of the parks, and then selected by the council. He is well known in Portland, having had the official band in the Rose Festivals for the last three years. For seven years he had the official band at the Astoria Regattas. He now has charge of Campbell's American band. Prior to coming to Portland he was associated with Liberator's, Zimmerman's and other famous bands.

REQUEST DENIED BY COUNCIL

Portland in Palmy Days Not to Be Represented.

Portland in her "palmy days" will not be reproduced here with the permission of the city commissioners. Charles Olmsted, 1095 Concord street, today attempted to get the council to

sanction a reproduction of the city as it appeared prior to 1877 and permit the operation of old time roulette wheel, farbank and other games, but the council filed his petition.

HEATING PLAN DROPPED

Extension of Auditorium System Not Feasible at Present.

Plans for heating the city hall with the heating plant in the proposed auditorium are to be dropped, at least temporarily, according to a decision reached by the council. The council was originally proposed to discontinue the heating system in the city hall and run pipes from the auditorium to heat the building. The cost was estimated at approximately \$19,000. City Attorney La Roche has ruled that no money of the auditorium fund can be used for any other purposes than for the auditorium.

Arrangements are to be made, however, that additions can be made to the auditorium heating plant in the future.

Printing Contract Awarded.

The Daily Bulletin, a local publication, was today awarded the contract for printing the city's official advertising for the ensuing year. Its bid was the lowest submitted. The Oregon Building Record, which had submitted the next lowest bid, protested against the award being made to the Bulletin, but the objections were overruled. Under the new contract price the city will pay about 80 per cent less than it is now paying for advertising.

Higher Salary Suggested.

City Health Officer Marcellus is urging that the salary of Dr. D. W. Mack, head of the city's milk division, be increased from \$1560 to \$1800 a year. Dr. Marcellus says that unless Dr. Mack's salary is increased the city may lose him, as he has been offered the position of deputy inspector for the western dairy division of the United States bureau of animal industry. Since 1909 Dr. Mack has had charge of the campaign for improving Portland's milk supply.

A. T. Hahn Scores Highest.

A. T. Hahn passed highest in the recent civil-service examination for topographical draftsmen, according to announcement made by Secretary McLean of the civil service board. His rating was 81.2 per cent. Others who passed were E. L. Vinton, 79.17 per cent; D. Beckwith, 76.4 per cent, and Ben Werthing, 75 per cent.

Bond Ordered Forfeited.

Mrs. S. W. Burnett, who submitted the lowest bid for concessions in Washington Park the ensuing summer, does not want to go through with her contract and as a result the city is to collect on the \$75 bond given by her. The bond was ordered forfeited by the council.

\$45,490 Contract Given.

The Oregon Independent Paving company was today awarded the contract for improving and hard surfacing Broadway from Union avenue to Larabee street, and intersecting streets affected by the change on Broadway. The contract price is \$45,490.

Sum of \$25,000 Is Offered for Tract

Agreement Reached in Condemnation Suit of State of Oregon Against the Salem Hospital and Aid Society.

Salem, Or., April 21.—An agreement was reached today in the condemna-

tion suit of the state against the Salem hospital and Oregon Childrens Aid society whereby a judgment awarding the defendants \$25,000 for a tract of land and hospital buildings, located just west of the receiving hospital of the state hospital for the insane here, will be entered in circuit court, and the state will get full possession of the tract soon and add it to the state hospital grounds.

The question of whether the Salem hospital or the Oregon Childrens Aid society will get the money to be paid for the tract will probably be litigated by the two. The aid society originally owned the land and hospital building and deeded it to the Salem hospital. There were several provisions in the deed, one being that the Salem hospital should not be permitted to transfer the property to anyone else, and that it should provide for the care of indigent orphans under the age of 15 years.

As a small fraction of the state hospital's receiving hospital is located on the tract, the transfer is important from that standpoint alone. The Salem hospital plans the erection of a new hospital building on a tract near by.

32 COUNTIES WILL BE REPRESENTED IN BIG TAX CONFERENCE

Formation of State Taxpayers' League Will Be Considered at Meeting.

Representatives from 32 counties will be in Portland tomorrow for the Oregon State Tax conference which opens at 10 o'clock in the Imperial hotel. More than 200 persons interested in taxation are expected and it is probable that the two counties of

the state which have not as yet been heard from will be represented.

The conference will consider the consolidation of all the county taxpayers' leagues in the state into one state taxpayers' league; the submission of a constitutional amendment limiting increase in state taxation, similar to the Bingham bill limiting increase in county taxation; a recommendation of the Benton County Taxpayers' league for the abolition of local commissions; the question of devising a workable plan of lateral and state highways and the proper distribution of expenses; and the O. & C. land grant as it pertains to taxation.

Among the speakers will be former Governor Oswald West, "Waste in State Expenditures," Henry Reed, assessor of Multnomah county, "The Scope of Activities of a State Taxpayers' League," C. C. Chapman, editor of the Oregon Voter, "What a State Taxpayers' League Can Accomplish," Rufus C. Holman, commissioner of Multnomah county, "The System Which Makes County Government Extravagant," George W. Joseph, state senator, "Why Logrolling Makes Taxes

High," John B. Yeon, Multnomah county roadmaster, "The Necessity for the Improvement of State Highways," Charles E. Spence, master of the State Grange, "Why Lateral Roads Should Be Improved Before State Highways," Representative J. L. Kelley of The Dalles, "Suggestions for a Comprehensive Plan for State Aid in Road Building," O. W. Taylor, chairman of the roads committee of the Oregon State Hotel association, "Getting Together on a Workable Road Plan," and C. P. Strain, assessor of Umatilla county, "Extravagance in Administration of County Government."

Robert E. Smith will open the conference.

Salem Behind Fight For Big Naval Base

Four Hundred Dollars Collected for Campaign Purposes by Wallace Struble of Astoria.

Salem has entered enthusiastically and wholeheartedly into the campaign to procure the establishment of a naval base at the mouth of the Columbia river.

Wallace Struble returned to Portland this morning from the capital. Wednesday evening he was the principal speaker at the annual meeting of the Salem Commercial club.

"I was scheduled to speak at 9 o'clock," said Mr. Struble, "and as I rose Company M. Oregon National Guard, marched into the room in full uniform and bearing arms. The entrance was magnetic and seemed to emphasize more than ever before the

need of a naval base at the mouth of the Columbia."

Mr. Struble collected \$400 for campaign purposes.

A committee has been appointed to assist in the campaign as follows: George F. Rodgers, ex-mayor, chairman; Hal D. Fulton, D. F. Deckebach and Benjamin Brick.

Company Revenues Shown.

Operating revenues of the Portland Gas & Coke Co. during the quarter ending March 31 were \$352,168.26, and operating expenses during the same period were \$163,884.41, according to the quarterly financial statement of the company filed with City Auditor Barbur. The value of the properties is given at \$3,614,650.44, including the generating plant at Linton valued at \$1,433,820.57, the plant at St. Johns valued at \$122,705.08, and its distributing mains valued at \$4,390,062.45.
