

EXPOSITION EXHIBIT IS NOW MERGED WITH COMMERCE CHAMBER'S

Rooms Will Be Kept Open on Wednesday Night as Well as Daytime.

EVERYTHING IS DISPLAYED

All of Oregon's Products Are Shown in Rooms of Oregon Building—Exhibit Is Interesting.

Oregon in all its variety may be seen in the exhibit brought up from the San Francisco exposition and merged with the old Chamber of Commerce exhibit now installed on the ground floor of the Oregon building.

Because of the popularity of this exhibit room and the number of inquiries received there daily, State Exhibit Agent Ed T. Judd has arranged to keep it open each Wednesday night as well as all day during the days of the week. This will give opportunity for people who work during the day to see the exhibit anyway.

Mr. Judd and his assistants take delight in showing off these multifarious exhibits. They are especially eager to show the educational display, the most important of all, but which they consider in many respects the least important because when families move in from outside, their first inquiry is: "Can I educate my children?"

Some of the important exhibits show the new flax industry, samples of flax raised in Oregon being placed side by side with the standard qualities raised in other states, which is not very flattering to the outside flax, to say the least. On a row of shelves is seen the new sugar beet industry, with the whole process of making sugar by graduated processes from the raw beet to the snowy granules.

The new evaporated fruit industry is also shown, with specimen boxes of every sort of Oregon fruit that is adapted to this form of preservation—apples, peaches, pears, prunes, loganberries and plums.

Ranged about the big room are paintings of Oregon scenery, the Columbia river highway coming in for the most gorgeous display.

Oregon walnuts are likewise shown, to the wonder of hundreds of visitors, especially native Oregonians, who did not even know nuts could be grown in the state.

Wood Exhibit Wonderful.

One of the most wonderful exhibits is that of the native woods, a section of the room being done up in Coos bay laurel, which is not very flattering to the outside flax, to say the least. On a row of shelves is seen the new sugar beet industry, with the whole process of making sugar by graduated processes from the raw beet to the snowy granules.

Among the most interesting exhibits is the mineral display. Specimens of rich ores from eastern, southern and western Oregon are ranged in glass cases, each labeled to show its origin.

Belief Map Is Indexed. In the center of the space devoted to minerals is a great relief map, indexed in such a way that the visitor, by comparing numerals and letters on identification cards, may find at a glance the part of the state where the ores originated.

The Mazamas have an attractive mountain climbing exhibit and everywhere about the big room are preserved fresh fruits, grains, grasses and vegetables from every portion of the state. The information booth is equipped to give the visitor supplementary data on whatever may have interested him.

If the Wednesday evening opening proves popular, it may be arranged to set aside other evenings also for the display.

Floater Is Found in River at Stevenson

Stevenson, Wash., April 22.—A floater was found this afternoon three miles above Stevenson with one side of the head smashed in, indicating that the man either had been thrown from his body thrown into the river or that he had floated over the rapids and the body struck on the rocks.

The clothing bore no marks of identification and there was neither money nor a watch in the pockets. At first it was thought that the body was that of John McClelland, a brakeman of the Oregon Trunk railroad, but M. A. Burgeon, an S. P. & S. brakeman, and C. W. Maden, a brakeman of the Brotherhood of Railroad Trainmen, both said the body was not that of McClelland.

The dead man was unusually well dressed in blue serge with two suits of underclothing, a light suit next to the body and a heavier suit on the outside. He was about 35 years old, and 5 feet, 9 inches tall, with dark hair, and weighed about 180 pounds. He had no beard. The body was decomposed, showing it had been in the river about a month.

COST OF IMPROVING BROADWAY WILL BE \$45,000 NOT MORE

Circular Sent to the Property Owners Is Declared Erroneous by City Engineer.

The cost of improving Broadway from Union avenue to Larabee street will be \$65,000 and not \$140,000 as represented in a circular which is being sent people living in the proposed assessment district by those who are actively opposing the improvement, according to City Engineer Dater today.

The contract for improving the street and intersections was let by the city council yesterday to the Oregon Independent Paving company for \$45,490 but the actual cost will be less owing to a slight change in bid. Despite this, circulars have made their appearance calling attention to the fact that the work is to cost \$140,000. The circular announces a meeting of the property owners to be held in the Albina Branch library next Wednesday evening at 8 o'clock. It says: "To protest against the unjust district assessment of \$140,000 for the improving and grading of Broadway and intersecting streets."

TRIP THROUGH SEWER TAKEN

Engineers Examine Interior of the Big Montavilla Conduit.

Engineers, advised by the city as to the condition of the Montavilla sewer made a trip through a mile of the foot pipe yesterday, it taking them from 9 in the morning to the afternoon to make the inspection trip. It is expected that they will make a report of their findings to the city council early next week. The members of the council expect to make an inspection trip of their own. The trip has not been set yet. Those who made the trip yesterday were J. L. Stannard, George C. Mason and J. P. Newell, representing the local chapter of the American Society of Engineers, and G. C. Kyle, representing the people of Montavilla.

City Receives Taxes.

Since February 1, the city has received approximately \$675,000 of its share of the first installment of taxes received, according to City Treasurer Adams today. The city's entire share of the first installment was \$1,248,000. City Treasurer Adams expects to receive the remainder from the county early next week.

Rome, April 22.—(U. P.)—The classes of 1888 to 1894, inclusive, under the first, second and third categories, and the class of 1879 for the third category, were called to the colors today, effective May 15. There will be no exemption from duty no matter what plea may be offered.

The call brings men of 57 years to the colors in the class of 1879, but as they serve only in the third category, it is assumed they will be used in the clerical and not the active service.

STORY OF RISKING HIS LIFE TO SAVE FRIEND IS TOLD BY WITNESS

Suit Is to Recover Damages From Towing Company for Death of Boy.

JUMPED INTO ICY RIVER

Companion Carried Into Water by Wheel of Boat and Failed to Come to the Surface.

How he risked his life for his friend was told in Federal court yesterday before Judge Wolvortzen by C. W. King, 21, of Seattle.

King is a witness in the suit of Ella A. Hutchison against the Willamette & Columbia River Towing company for \$25,000 for the death of R. Verne Hutchison, who was drowned at Lewiston, Idaho, May 3, 1915.

King and Hutchison were both members of the Washington State Boat Band, which was assisting in the celebration of the opening of the Cello canal.

Hutchison fell through the broken covering of the wheel of the steamer J. N. Neal. His body was found two weeks later 30 miles down the Snake river.

"There were six or seven of us standing on the flooring above the wheel when the boards began to break," said King. "We all made a scramble for the rail. Verne fell through onto the wheel, which was slowly revolving backward. I thought the wheel would carry him under and he would come up alongside the steamer. He came up once. I jumped in and dived twice, looking up through the water to see if I couldn't see him coming up above me, but he didn't come up again."

King wore his tight fitting band under and heavy shoes when he leaped in the river, which was only three degrees above freezing and very swift.

Wilson League Is Formed at Medford

Organization Starts Off With Membership of 150—Ashland Too, to Have Club.

Medford, Or., April 22.—A Woodrow Wilson league was organized in this city last night with a membership of 150. Many names are being added to the roster today. G. Y. Harry, organizer for the Woodrow Wilson league of the state, assisted in the organization of the local body. Judge W. E. Crews was elected president; Newton W. Borden was chosen secretary, and Joseph Parker, treasurer. A meeting will be held on Monday evening at 8 o'clock at the home of Judge W. E. Crews to discuss the management of the Woodrow Wilson women of the city, and a woman vice president will be chosen.

Organizer Harry will form a club at Ashland tonight, another at Grants Pass Saturday night, and one at Roseburg Monday evening. Harry in the near future at a point in southern Oregon to be agreed on at a conference of the league in some of the district. Grants Pass has already suggested that the big grove on the river bank near that place be utilized for a big basket dinner, addresses and music.

Mr. Harry is most agreeably surprised at the Wilson enthusiasm he finds in all cities in southern Oregon. Inasmuch as the organizations he is effecting are nonpartisan, many Republicans attended the meeting last night at the Hotel Medford and signed the roll of membership. He said today that within a week in southern Oregon he will have at least five strong minor leagues formed and fighting. "I know of no more fertile soil in which to plant the germ of Woodrow Wilson enthusiasm than in the city council," said Mr. Harry.

Many Republicans in the Medford district openly avow their purpose to vote for Wilson.

Republicans Have Row at Medford

Medford, Or., April 22.—A ruction of more than usual import has occurred in the ranks of the Republican forces of Jackson county, after having brewed ominously for a month. The question of leadership is somewhat picturesquely involved, but since the storm broke no one is anxious to claim it. Each of those who would like to enjoy the honor of being chosen times is now strenuously busy escaping it. The county central committee is the storm-center of the fray. Two full committees are in the field for election next month. The fight over this minor honor appears locally to be more acute than that over the county offices. Two factions have suddenly appeared in the Republican party and their scrap with each other leaves the Democratic candidates for the real plums almost without open opposition.

The discord began when the organization prevented the appointment of a Medford man, R. L. Ewing, the choice of the local sportsmen, as state game warden and threw its strength to a Roseburg man. The appointment of O. Boggs, a member of the organization, as attorney for the state land board over Gus Newbury, popularly known as "the land shark," added fuel to the flames and almost provoked a riot among aspirants for local office helped the revolt.

McCue, candidate for the nomination for district attorney, began his speaking campaign today with an address before the Sellwood branch of the Oregon Republican club in Sellwood this afternoon. At 7 o'clock tonight he will speak before the Tillamook club at the Portland Labor Temple.

WAR RELIEF IS GREAT WORK FOR WOMEN IN FOREIGN HOSPITALS

Mrs. Julia Henshaw of Vancouver, B. C., arrived in Portland yesterday from a tour of the hospitals of France and Great Britain, to see how the war relief work of the women of America and Canada can do to assist in the hospital work.

"The Anglo-American hospitals and those in the larger cities of France are modern, spacious and perfectly fitted, but the outlying hospitals of France need all the help that can be given them."

"The French women are wonderful. When one sees the work these women are doing, he is obliged to reconstruct his entire ideal of that nation and its people. The optimism in the French hospitals is one of the features that strikes a visitor. The patients and nurses all have a welcoming smile even amidst hard labor and suffering. I cannot say too much in praise of the excellent work done by the women of Canada and America in sending supplies and of the Canadian army medical corps."

"I made it my business to find out just what was most needed and, remembering the great need for hot water bottles in some of the French hospitals, I spent the money from my first lecture in California in a supply of these bottles, which I forwarded at once. Other things most needed are clean bandages and dressings of all kinds, pajamas, hospital shirts, socks, and a host of other necessities. I will be back in the city in a few days."

Mrs. Henshaw will lecture on her hospital tour Tuesday evening at the Art museum under the auspices of the Portland War Relief society.

Roosevelt May Yet Stump Middle West

Hint Given Plans May Be Reconsidered; Friends Say, He May Challenge Ford's Showing Against Preparedness.

Oyster Bay, L. I., April 22.—(U. P.)—President Roosevelt's reconsideration of his plans not to stump the middle west before the national convention, it was hinted today. He has not yet accepted the invitation to deliver the May 12 address at Kansas City, but it is likely he will do so.

Should a whirlwind tour of Iowa, Nebraska and other states revive the old Roosevelt demonstrations, the colonel might enter Chicago at a dramatic moment when the stage is set for the choice of a Republican-Progressive leader, his friends said.

They would then expect a stampede of delegates from former Roosevelt strongholds. Roosevelt would not comment on Henry Ford's showing in Nebraska, which some interpret as proof that the middle west is against preparedness. Some friends said that Roosevelt might accept the challenge and carry on a preparedness campaign in a whirlwind tour.

'INNER CIRCLE' IS OUT TO CONTROL G. O. P. CENTRAL COMMITTEE

Each Faction Has Filled Full Ticket Composed of Precinct Prospectives.

LOCKWOOD MAKES COUP

Timid Head of Republican Club of Oregon Puts One Over on the Republican Club.

Charlie Lockwood, the Oregon Republican club and Jay Bowerman and the other members of the inner circle of the Bolo club are out after the control of the Republican county central committee. Each faction, or wing or sector, or whatever it may be called, believes in preparedness, in fact that is the slogan of the Bolo club candidates, and each has filled a full ticket composed of a prospective member from every precinct in the county.

Lockwood Turns Trick. Charlie Lockwood, favorite son and titular forefront of the Republican club of Oregon, is known as the "timid" head of the club, but he has put one over on the Oregon Republican club. The Oregon Republican club prepared a nice little ticket for its candidates in filling for precinct committeemen, each bearing the slogan, "For representative, Republican government."

One of those time honored and age tried batteries to which campaign orators have intermittently pointed with pride during years that are forgotten. It was expected that this would be the mystic symbol by which the voter would know the chosen of the Oregon Republican club when he came to make his mark on the primary ballot.

Charlie Lockwood spoiled the game, however, by also preparing neatly printed forms, bearing the same slogan, which have been used by candidates of his club in filling their notices of candidacy.

Things Mixed Up.

"This action has mixed things all up to that unless a campaign of education is carried on the voter cannot tell a Lockwood candidate from a McCourt candidate."

The Bolo club has also filed a full ticket, and each candidate on the ticket will wear after his name on the ballot the potent word "preparedness."

This means presumably that the club believes in getting ready to control the official political machinery of Multnomah county insofar as the county central committee with its waning power may be able to do so. Theoretically the county central committee is supposed to have active charge of the party campaign, to arrange for the campaign meetings, to furnish speakers, to back up the candidates, handle the cash, get out the votes, and, as a post script, to make a record of the day's political appointments and the distribution of political patronage, both county and state. This theory has not worked out in the hands of the club in the recent past, but the hope still lingers and the strife still continues for the committee's control.

Robber Suspect Is Taken at Seattle

Arthur Schmidling Believed to Have Aided in Local Robberies, Will Be Brought Back to Portland.

Arthur Schmidling, suspected as the confederate of "Kid Irish" Donlin and "Burrhead" Wachtel in the robbery of two east side homes about two weeks ago, is under arrest in Seattle and will be brought to Portland tonight.

City Detective C. R. Hellyer went to Seattle yesterday to arrest A. J. Burns, alleged principal in the gold "burrhead" game uncovered by the police Wednesday. He found Schmidling in the city jail there, awaiting trial on another charge, and the Seattle police agreed to turn Schmidling over to the local police.

The house robberies in which Schmidling is involved by the confessions of the other two were at the homes of Mrs. M. E. McCormick, 337 East Knott street, and of John B. Greenway, 380 Schumacher street, and were committed by Schmidling and Donlin.

When Schmidling and Donlin were arrested by Detectives Gledhill and Hamersley, Donlin broke away from the officers and escaped, only to be recaptured in South Portland the following day.

CRUCIFIXION SUBJECT OF REV. FATHER LEWIS' GOOD FRIDAY SERMON

Great Moral Force Endures Although City Where He Was Slain Is Buried.

"Sad and sorrowful, the church tonight commemorates the crucifixion and death of Jesus," said Rev. Father Lewis, O. P., in his Good Friday sermon at Holy Rosary church, East Third and Clackamas streets, last night. "Who isn't moved by the thought of this day's bloody drama?"

"Over 1900 years ago the city of Jerusalem was a bedlam. A man was to be crucified. It was the day that the world was to be changed, but Jesus Christ lives on as the greatest moral force the world ever knew. The people who crucified him three long years ago have his blood upon them, as they cried to Pilate they would."

"Christ died for the sins of men. In the Garden of Gethsemane he suffered for all the sins since Adam, and to him came the vision of the sins that man, despite the great sacrifice made about to make, would still commit."

"He heard the cry of the little children who were denied the right to live, yes, sometimes by Catholic parents."

"And yet people, for slight social or political preferment, for money, for the sin of a moment, deny him and cast back his gifts into his face. 'Why, it isn't a gambler's chance these people take in bartering eternal ages of happiness for this short satisfaction?'"
