Inspiring Spectacle of Thousands of Marching Human Rosebuds Tomorrow.

PARADE STARTS AT 10

Krohn's Famous Rose Girls and Flag and Drill Sections to Be in Line; Parade Formation.

Over on Grand avenue, on the east side, tomorrow morning, will take place the first big event of the 1916 Rose Festival proper—the children's parade.

Called also the Human Rosebud parade, this procession of youngsters from the schools of the city is to many the finest and most inspiring feature of the entire fiesta.

This percent of childhood will move southward from Holladay street toward Madison, as in past years, under the direction of O. M. Plummer, member of the school board, grand marshal and Robert Krohn as director.

Parade Starts at 10. NEWLY REORGANIZED WESTERN PACIFIC IS TO ENLARGE SYSTEM

Incorporation of Company to Take Over Property of System Completed.

CAPITAL IS \$75,000,000

Fifteen Branch Lines to Add 334 Miles of Track Provided and Total Mileage Will Be 1300.

San Francisco, June 6.—(U. P. S.)—The new reorganized Western Pacific railroad company, with a capital of \$75,000,000, was incorporated today.

Articles of incorporation, signed on June 1 by 13 incorporators, were filed today with the superior court here, and lay down the future plans of the great company.

The move follows the fixing of the upset price for the sale of the old Western Pacific's property to the bondholders by Federal Judge M. T. Dooling several days ago at \$18,000,000.

The Western Pacific Railroad company, the official title of the new company, takes over all the properties, rights, franchises and business of the Western Pacific Railway company both of them California corporations.

Branch Lines Provided. In addition to this the articles of incorporation provide for the building of the following branch lines by the new company:

Carbons, San Joaquin county, to Tesla, Alameda county, 20 miles. Hawley, Plumas county, to Boca, Nevada county, 40 miles. Lathrop, San Joaquin county, to Porterville, Tulare county, 180 miles, being the longest branch line provided for.

Niles, Alameda county, to Los Gatos by way of San Jose, 23 miles. Stockton to Byron, Contra Costa county, 18 miles. Los San Joaquin county, to Isleton, Sacramento county, 20 miles. Sacramento to New Castle, via Fairlocks and Orangedale, 28 miles.

Other lines, not specified, which the new company will build will bring up the total mileage of the present main line, 925, to 1200 miles.

Great Russian Drive Believed Under Way

Plan Supposed to Be to Strike Austrian Forces Along Entire 200 Mile Front With Equal Vigor.

London, June 6.—(U. P.)—The great drive of the czar against the Austrian lines along the 200 mile front from Pruth to Kolki is believed under way. The czar's plan is designed, it is believed, to hit the Austrian forces with equal vigor all along the line.

The attack has been in preliminary preparation since the beginning of winter months, in the gathering of great quantities of munitions and in actual preparation in the last several days by general military offensive. These are announced by the Russians and admitted by the Austrians.

In the several heavy infantry rushes already made in the Tarnopol region the Russians have taken many prisoners and some Austrian supplies.

Shanghai, June 6.—(I. N. S.)—Count Okuma, Japan's premier, has been assassinated, according to advices received here today.

Count Okuma had been prime minister of Japan since 1914. He was born at Saga, Hizen, in 1838. Count Okuma was one of the founders of the new Japanese government. He was finance minister from 1899 to 1900, minister of agriculture and commerce, 1897-1898; prime minister and foreign minister, 1898; prime minister, 1914-15-16.

EFFORT BEING MADE TO SHAKE OFF GRIP OF M. BLOCH, SHAVER

Judge Dayton Considering Case Against Court Bailiff in Garnishment Suit.

FUND SALARY ASSIGNED

County Commissioners' Order Forfeiting Assignment of Pay Warrants Being Ignored Under Technicality.

An effort to break the grip of Mose Bloch, county warrant shaver, on the salary warrant of a bailiff of the circuit court is being made in District Judge Dayton's court.

The woman obtained the judgment in 1913. Several times attempts were made to garnish the bailiff's salary, and the present action is another attempt. The garnishment was served on Multnomah county April 1, but it developed that on March 6, before the salary was earned, it was assigned to Mose Bloch.

Case Under Adversement. The matter was argued before Judge Dayton, who took it under advisement, and asked that briefs be submitted by the attorneys. Attorney W. E. Heckett, representing the plaintiff, declared that the case on record where the courts hold that a public employe can legally assign his salary in advance.

Deputy District Attorney Pierce, representing the county, argued that the position taken in the past in common law that it was against public policy to allow a public official or employe to assign his salary has been broken down by the court's decision that the assignment is legal.

On April 14 the board of county commissioners passed the following order: "Be it resolved, That from and after the first day of May, 1916, the presentation to the county auditor or clerk of any assignment for salary of an employe of the county will be considered by the board of county commissioners as a resignation from the service of the county on the part of the person making such assignment."

Board's Order Ignored. At the same time the commissioners passed an order requesting the county clerk to advise any assignment for salary of the employe who shall make assignments of their salary after May 1. Inquiry at the office of the commissioners reveals that this request has been ignored.

The warrant receipt books at the clerk's office shows that this month Bloch has drawn warrants of deputies in the offices of the clerk, the sheriff, the juvenile court, circuit court bailiffs, clerks at the courthouse, employes on the ferries and bridges and others.

Order Used as Club. He is also using the order of the commission as a club to hold over the heads of other county employes who are afraid openly to assign their wages to him. He advances money on their salary, they sign the receipt, but he does not record the assignment. He permits them to draw their own warrants with the threat that if they do not immediately sign the assignment he will record the assignment and thus expose them to the county commissioners.

Seeks Writ to Free Man Held for Debt

James M. Level Wants Release From Jail From Judgment Held by Life Convict at San Quentin.

A petition for a writ of habeas corpus for James M. Level, was presented to Judge Bean in federal court; this morning by William P. Lord, attorney for Level. Mr. Lord was authorized to draft an order for Sheriff Hurlburt to show cause why the man should not be released from the county jail. The hearing on the order will be Monday.

James M. Level lives near Yaocott, Wash. There is a judgment against him in circuit court for \$1034 in favor of John M. Level, who is now serving a life term for murder at San Quentin penitentiary, California. In the judgment the court held that James M. Level was fraudulently withholding the amount of judgment from John M. Level. The two men are said to be cousins, although it is said also that they are no kin, but that the latter assumed the name of Level.

Level turned certain property over to James Level, and later sued him for its return, securing judgment. That was two years ago.

James M. Level was arrested two weeks ago because he was held under the clause of the judgment which says that he is fraudulently withholding the money.

His attorney is asking for his release on the grounds that the judgment is void. An effort was made in circuit court to have the judgment nullified, but it was overruled. It is in favor of a man, who, as a life term in a penitentiary, has no legal standing.

COUNCILMEN TAKE UP NEW ORDINANCES, BUT ACTION IS DELAYED

Ordinances regulating taxicabs, sightseeing cars and for hire machines and prohibiting automobiles from remaining standing on Washington and Morrison streets during the day, were considered by the council this morning but no action was taken.

Action on the ordinance regulating taxicabs, sightseeing and other machines was deferred until June 15, and the other measure was referred to City Attorney La Rorie for minor amendments and revisions.

WATER LITIGATION ENDED

City and Bridal Veil Lumbering Company Reach Agreement. The Bridal Veil Lumbering company will be allowed to use nine cubic feet per second of the water of Young's creek for 15 years, under an agreement to be made by the city and the company. The agreement was outlined to the council by City Attorney La Rorie and accepted.

The agreement will end litigation between the company, the city and George Shepherd concerning the use of the water from the stream crossing the Columbia river highway near Bridal Veil.

On holidays and Sundays the company is not to use the water and at all times, according to the agreement, city and county engineers are to use the water they need for domestic purposes.

Two of the successful applicants were veterans of the Civil war. TRAFFIC PLANS FOR HIGHWAY EXERCISES ARE NOW COMPLETED

Convenience and Safety of Guests Are Assured During Dedication Program.

GUARDSMEN ON DUTY

Speeding or Reckless Driving Will Not Be Allowed; Parking Arrangements Are Made.

Traffic arrangements for convenience and safety have been made in connection with the world dedication of the Columbia river highway tomorrow afternoon. H. P. Coffin, chairman of the public safety commission, announced this morning.

"Arrangements have been made for handling the automobile traffic Wednesday in such a way that the most time need not have fear of using the highway that day. For the safety of the public all automobiles proceeding east will not park between Crown Point and Multnomah falls, but shall turn around and may park, if desired, along the highway, headed west. At 2 o'clock no autos or other vehicles will be allowed to pass the figure 8 (west of Latourelle falls) until after the ceremonies, in order to keep the way clear for the parade.

Guardsmen to Act. "There will be a company of Oregon National Guard on duty to assist in patrolling the highway, and they will have authority to regulate the traffic; there will be no speeding or reckless driving during the exercises. After the exercises have been held at Multnomah falls the official party will proceed to Crown Point followed by the interested spectators in automobiles, where two lines of automobiles will be allowed to park around the base of Crown Point and will be held at that point until after the official party has proceeded toward Portland, when parked machines may follow and the highway will be opened to regular traffic."
