

COOKS AND STEWARDS THREATEN TO LEAVE CENTRAL LABOR BODY

Split Reported at Seattle Because of Boycott Waged Against Certain Lines.

SAILORS SUPPORT MOVE

Contention Is That Firms Placed on "Unfair List" Are Not Antagonistic to Organized Labor.

Seattle, Wash., July 12.—(P. N. S.)—The Marine Cooks and Stewards' union is preparing today to withdraw from the Central Labor council of Seattle for putting a number of steamship companies on the "unfair" list. The Sailors' union also voiced its objection.

The cooks and stewards, through their business agent, Leonard Norkgauer, declared the council had acted hastily when they put the Admiral Line, the Alaska Steamship company, the Pacific Coast Steamship company, the Border Line and the Matson Navigation company on the unfair list. Peta Gill, business agent of the Sailors' union, supported the contentions of the stewards. It was shown where the companies' ships were manned by union men, they employing their labor from three unions and two bodies far from labor.

At first the "insurrectionists" threatened to withdraw the council and not reconsider their action. The council voted to stand by its decision. Norkgauer called attention to his written threat to withdraw his union.

When suggestions were made that the Cooks and Stewards, the Sailors and the Masters, Matees and Pilot associations walk out in sympathy with the striking Longshoremen, Peta Gill answered that the longshoremen had refused to join the sailors in their industrial fight and the sailors would not now join the longshoremen. Martin Meyer, delegate to the council from the Longshoremen's union, led the fight against reconsideration of action. He said a reopening of the case would put organized labor in the light that it failed to support its craft.

Broker Stabbed in Back

Seattle, Wash., July 12.—(P. N. S.)—J. F. Willett, a broker of Santa Barbara, Cal., who came to Seattle recently, nurses two stab wounds in the back, following the murder of a union longshoreman. Willett is a powerful man and fought off his assailants, but not until they had stabbed him. Frank O'Connor, 39 years old, non-union worker, was beaten into unconsciousness last night with brass knuckles in the hands of a striker. Numerous fights occurred yesterday along the waterfront.

Police Accused of Inactivity

Seattle, July 12.—(P. N. S.)—The charge that Mayor Gill and Chief Beckinghams had "laid down" and that no protection to non-union men from murderous assault at the hands of striking longshoremen could be expected from, or had at any time been wholeheartedly extended by the Seattle police department, was made by Robert W. Baxter, executive head of the Alaska Steamship company, operating 16 ocean going vessels, in a letter to the port commission this afternoon. He indicted the letter as an answer to the commission's second invitation, which was also declined, for the reasons stated, and as in the first instance, to have his vessels load and discharge freight at the public terminals.

Eugene Florist Is Dead

Eugene, Or., July 12.—Robert Rae, a pioneer florist of this city, died at his home at 1927 Eighth avenue west yesterday, aged 67 years. He had been unconscious for many days before the end came. Mr. Rae leaves a wife and three sons, Leonard Rae, a local florist, and Warren Rae, both of Eugene; and Arthur W. Rae of Chicago. He was a member of the local Masonic lodge and the local camp of the Modern Woodmen of America.

Tied Robin to a Tree

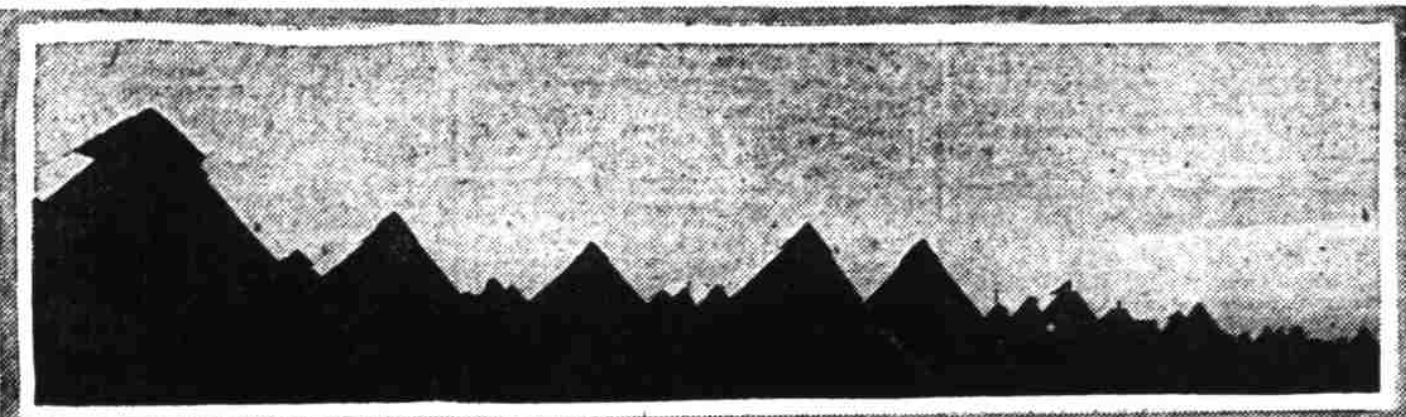

Hood line to announce a round-trip passenger rate from Parkdale to Portland of \$4.50, and from Dea to Portland for \$5 on 30-day limit tickets. This is almost the same rate as from Hood River to Portland and return.

Druggists Will Sell Only on Prescription

Pendleton City Council Passes Ordinance Prohibiting Sale of Alcohol Unless Upon Physician's Prescription.

Pendleton, Or., July 12.—Acting upon petition of the druggists of the city, the council last evening passed an ordinance prohibiting the sale of alcohol in the city by drug stores except upon written prescription of a physician.

Traffic in alcohol has become large under provision of the state law permitting anyone to secure alcohol upon making an affidavit that it is for external use and the city authorities have been trying to devise some means of checking the sale.

County Refunds Tax Money

Baker, Or., July 12.—The county court has settled with Mrs. E. F. Keller claims against the county on sheriff deeds to certain property, purchased by her, title to which was invalidated by the 1907 tax law. She has been a resident of California and had not been advised that her property was in jeopardy when the 1907 redemption law was passed. The court paid her \$100 for taxes, gave her credit for \$50 on other taxes and a deed for property in the Bellevue addition to Baker, the only piece purchased at the tax sale that was not later redeemed by the original owners.

Hood River, Or., July 12.—Harley Glass, residing near this city, claims the record for growing the largest number of strawberries on a single plant. He states that one of his plants carried 482 berries after two hallocks containing 50 berries had been picked. The plant is of unusual size and only two years old.

Casement's Reprieve Is Asked in Petitions

Many Britons Express Sympathy for Agitator; Others Think Execution Would Provoke Further Disorders.

London, July 12.—(I. N. S.)—Petitions for the reprieve of Sir Roger Casement, the Irish agitator found guilty of treason and sentenced to death, were being generally signed. Many of the signers expressed personal sympathy for Casement and many others added their names to the plea for mercy in the belief that his execution would provoke further disorders in Ireland.

Lemaster stated to the court that the officers shot him on the night of his arrest when he had his hands up and had surrendered.

PENDELTON PLEASD WITH BILL PROVIDING FOR NORMAL SCHOOL

Action Upon Proposed Measure Taken to Indicate Realization of Need.

MASS MEETING IS HELD

Citizens Place Themselves Behind Bill and Pledge All Support They Can Possibly Give.

Pendleton, Or., July 12.—There is considerable elation in Pendleton over the indorsement of the initiative bill providing for a normal school in this city by the county superintendents of the state who are now in session in Salem.

The fact that the resolution was presented by the superintendent of Polk county, where the present normal school is located, that it was indorsed by a special committee appointed to investigate the merits of the bill and then adopted by the convention with only a single negative vote, indicates to local people that the school men of the state recognize the need for better normal training and the advantages of this city as a location.

A mass meeting was held here on Tuesday evening at which the citizens were made acquainted with the situation and the need of a campaign of education over the state. The citizens placed themselves behind the bill and pledged themselves to contribute time and money toward making the voters acquainted with the true conditions.
