DEUTSCHLAND READY TO TAKE ON PILOT FOR RUN DOWN THE RIVER

Indications Are That Vessel May Remain in the Bay for a Time.

Boston, Mass., July 28.—(I. N. S.)—Captain Frank B. Howarth, commanding the Celtic, which arrived here today, stated that he had information from an authoritative source that a merchant submarine, leaving Germany before the Deutschland had been captured and taken to England and that the Bremen had also been captured and taken to the same place.

Baltimore, Md., July 28.—(U. P.)—The Deutschland prepared today to take on a pilot from the Maryland Pilots' association, but that organization said Owen Coleman, who brought her up the river, was out of town and was not immediately available for service. While Captain Zack Guillion of the tug Timmins wants Coleman, the rules of the association require that vessel take the "first man out"—the first man on the pilot list.

A 24 hour crew is aboard the Timmins, giving the impression that the stay of the Deutschland is not long and that when she does head out she may plan a lay-over in the lower bay before trying to run the allied patrol.

PORTLAND BUSINESS MEN ENLIST FOR THE TRAINING CAMP WORK

Seventeen Had Enrolled Their Names for American Lake Outing Up to Noon.

HEADQUARTERS THRONGED

Camp Work Intensive and Physical Training Occupies First Week; Target Practice Is Included.

Seventeen Portland business men up to noon today had formally enlisted for a month's military training at the camp to be held at American lake.

The headquarters of the enlistment at 347 Washington street, just west of Broadway, were thronged this morning with inquirers, most of whom took the question of enlistment under serious consideration.

Captain J. B. Murphy, aide of Major General J. Franklin Bell, arrived today to give his personal attention to the enlistment and to help the publically campaign. The captain is in direct charge of the training camps, the one at Monterey, Cal., now drawing to a close.

Work Is Intensive

Captain Murphy explained that the work at the camp is intensive, with physical training drills occupying the first week. These drills are in setting up exercises, manual of arms and the ordinary maneuvers of close formation. That is regarded as the important, if routine, feature of the whole training camp idea—building up the physical body.

The second week will see a change in tactics, with much instruction along the broader lines of maneuver. The third week will see target practice, outpost duty, principles of attack and defense, reconnaissance work and road sketching, advance guard and rear guard, fire direction and control, fire discipline, map reading, making camp outposts, battle line, infantry trenches, obstacles and demolitions.

Larger Operations Incited

The fourth week will be devoted to even larger operations—attack by platoon and company, attack by battalion and by regiment. A practice march, with instructions in individual cooking and practical camp sanitation will feature one day's operations.

If the army bill, now in conference, finally passes with the appropriation intact for maintenance of these military camps, Portland's business men will be able to engage in it without cost save for a trifling deposit to cover possible damage to government property.

Mrs. M. E. Deaton Dies at Age of 81

Aged Woman Passes Away as Result of Attack of Grip; Funeral Held Thursday Afternoon.

Mrs. Mary Elizabeth Deaton died July 25 at the home of her daughter, 1027 East Seventh street, north of this city, at the age of 81 years. Her husband died nine years ago. She came to the Pacific coast from St. Louis, Mo., to join her son. For the last three years she has resided in Portland.

She is survived by two children, a son, William T. Deaton; a daughter, Mayme A. Deaton, and one grandchild, William L. Deaton, all of Portland. In her childhood she developed a desire to live on the Pacific coast, and after waiting more than half a century, her wishes were fulfilled, and she never regretted coming.

FOOTPRINT LEADS TO ARREST OF JUVENILE BURGLAR SUSPECTS

With Sherlock Holmes Instinct Portland Sleuths Make a Capture.

A grimy footprint on the paved sidewalk of a narrow candy cart that had been left lying on the back porch, led to the arrest this morning by Detectives Coleman and Snow and Patrolman L. Stone of two juvenile burglars with instructions in close formation.

Last night, the two lads confessed, they broke into a cigar and candy store owned by L. A. Jones, 294 East 12th street, north, and pilfered his apartments, which are in the rear of the store, for a short time after 9 o'clock last night. He left between \$40 and \$50 in a small box under the pillow of his bed.

The boys sought entrance through a trap door under the back part of the store, reached the inside, and took \$23.85. They said they went in after an older boy, whom they did not know, came out. He had taken the balance of the money, they said.

The lads then took their loot and buried it in the most approved pirate fashion near a pier at the east end of the Morrison bridge.

When Mr. Jones returned some time later he found the room disarranged and the money missing. He found the footprint on the paper carton on the back porch and knew at once that the intruders had been boys. He thought at once of two lads, who hung around the store and whom he had treated kindly for some minutes before closing time last night.

Early this morning he notified the police, and the detectives, visiting the boys' home, found the lads sleeping soundly. They readily admitted their theft when confronted, and they were taken to the juvenile court.

APPEAL TO BE TAKEN TO SUPREME COURT IN PROHIBITION CASE

Circuit Judge Morrow's Decision Will Come Before the Highest State Court.

NOTICE OF APPEAL FILED

San Francisco & Portland Steamship Company, Defendant, Makes Move to Have Law Interpreted.

An appeal from Judge Morrow's important liquor law decision made Tuesday will be taken to the supreme court. Attorneys for the San Francisco & Portland steamship company filed notice of appeal in the circuit court this morning in the suit of Wadhams & Co. against the transportation line for the recovery of two barrels of ethyl alcohol valued at \$200 which the steamship line refuses to deliver because of the prohibition law.

Judge Morrow in his decision held that inasmuch as it was lawful for manufacturers to have alcohol for manufacturing purposes in their possession it is lawful for them to bring it into the state.

According to the court the Oregon law which restricts importation of alcohol to druggists only is in violation of the interstate commerce clause of the federal constitution.

Wadhams & Co. are wholesale grocers and manufacturers of flavoring extracts and use alcohol in the manufacture of their extracts.

Notice of appeal to the supreme court was signed by W. A. Robbins, A. C. Spencer and R. B. Haillock, attorneys for the steamship company.
