

OREGON WOMEN WILL HAVE A LOBBY DURING LEGISLATIVE SESSIONS

Four State Organizations to Be Represented by Women's Legislative Council.

DECIDED AT THE DALLIES

Plan Is to Unify Efforts and Secure Concerted Action on Measures Before the Lawmakers.

The Dailies, Or., Oct. 14.—The Oregon Mothers Congress in convention today raised \$200 in a few minutes towards the erection of a new building at the University of Oregon.

The convention also endorsed the plan to erect a new normal school at Pendleton. Fred Lockley presented the plan. Mrs. J. A. Waldron of Oak Grove, was the only delegate who "spoke" against the endorsement. Her "no" was emphatic. "It's a big mistake," said Mrs. Waldron. "The state should support the normal school in the West rather than spend more money to erect a new building."

Attend Luncheon Today.

O. M. Plummer talked on the proposed eight months school law. The delegates later went to Orlin to attend luncheon. A banquet at the Hotel Dailies will be given tonight for the delegates by The Dailies teachers' association.

In the future four strong state women's organizations—Women's Christian Temperance Union, Consumers League, Oregon Congress of Mothers, Parent-Teacher association and State Federated Women's clubs—will be represented at the state legislative sessions by the Women's Legislative Council of Oregon.

The Congress of Mothers, in convention here, Friday voted to appoint a member of the council to represent the Mothers' Congress.

Mrs. C. W. Hayhurst of Portland introduced the plan to the convention. The object is to unify the legislative efforts of state organizations eligible to membership and secure concerted action on legislative measures.

Will Attempt Real Lobbying.

The first real lobbying ever attempted by the council will take place at the next meeting of the legislature. The council will be divided into four divisions—economic, hygienic, educational, civic.

Benson Would Keep Food Within Nation

Socialist Candidate Would Use Navy to Prevent Exportation Until War in U. S. Should Be Unknown.

San Francisco, Oct. 14.—(U. P.)—Alfred Benson, Socialist candidate for president, will conclude his campaign in the San Francisco Bay cities tomorrow night with an address in Oakland, where Socialist leaders expect a large attendance.

Benson, continued to dwell at length upon the draft clause of the Hay-Chamberlain army reorganization bill in his address here last night. He criticized the attitude of both President Wilson and Republican candidate Hughes in this regard, declaring they have a "gentlemen's agreement" not to mention the subject.

Discussing what he would do if elected, Benson declared: "I would use the great navy to establish a blockade that would prevent any food from going out of this country so long as there was a hungry man, woman or child in it."

He denounced Hughes' record as governor of New York and asserted that President Wilson is audacious in his attempt to pose as the friend of the laborer.

Benson will be the guest of the Newspapermen's club of this city at a reception tonight.

PROPOSED CANON TO PREVENT REMARRIAGE AFTER DIVORCE LOST

Episcopalians Bishops Favor Resolution but Laymen Vote Down New Law.

St. Louis, Oct. 14.—(U. P.)—The house of deputies and the house of bishops of the Protestant Episcopal church, in joint session this afternoon, killed a resolution that would have prohibited the marriage of all divorced persons in the church.

The laymen, by refusing to concur in the bishops' marriage of the resolution. The total vote to change the present canon was: Ayes, 38; noes, 56. It stood 40 yeas against the minority with 21 yeas. The laymen vote was 25 yeas, 31 noes. Both ministers and laymen must concur before a church law can be changed. The vote was by diocese deputations among both ministers and laymen.

The vote on the question came after an hour's debate. It had been announced earlier the question would not be debated at today's session, but an eleven o'clock move to the afternoon session brought the proposed canon before the deputies and bishops. The tabulation of the vote showed that the ministers voting for the proposed canon of the law while a majority of the laymen voted for its rejection.

Today's action will continue for at least three years, the present canon, which permits the marriage of the "innocent" party to a divorce which was granted on statutory charges.

The defeated canon would have prohibited Protestant Episcopal laymen from marrying a person divorced from any cause whatsoever during the life of the second party to a divorce decree.

Police Played Looking Part.

But the crowd was good natured, if volatile. Someone sent a riot call to police headquarters and a lot of patrolmen appeared on the scene. Fifty duty, however, appeared to end with warning a way through the dense pack and looking first at one side of the street and then at the other.

MISMANAGEMENT IN MILES ESTATE IS NOW CHARGED BY AN HEIR

Mrs. M. E. Butler Asks That Proceedings Be Reopened and Assets Cashed.

INVENTORY IS CRITICIZED

Plaintiff Charges That Executors Loaned Money to Themselves, Without Authority of Court.

Charging mismanagement of the estate of S. A. Miles, who died in Portland in 1913 possessed of real and personal property inventoried at approximately \$150,000, Mary E. Butler, one of the heirs, has filed suit in the circuit court, asking that the order of the county court issued last may, approving the final account of the executors, be rescinded, and that a new trustee be appointed who will diligently reduce the assets to cash and make equitable distribution.

S. A. Miles, at the time of his death, was 82 years of age. His estate was inventoried as follows: Personal property and cash, \$92,772.13; real property, \$58,227.87.

According to the terms of the will, the estate was to be divided between the widow, Sarah Elizabeth Miles, and each of the eight children, share and share alike.

Frank M. Miles and William A. Miles, sons, were appointed as executors. It is alleged by the plaintiff that the inventory of the estate omitted many assets.

A further allegation is that the executors managed the estate as if it was their individual property, without regard to the interests of the plaintiff. It is charged that they advanced to and loaned themselves money of the estate, without authority of law or order of the court.

TO INVESTIGATE PAVEMENT.

Capitol Highway Surface Said to Be Cracking Badly.

Responding to reports that the concrete pavement laid on the Capitol highway is cracking badly, the board of directors has formally ordered "that Roadmaster Yon be informed that it is the desire of the board that the road department will not present a final settlement until a thorough investigation has been made of the condition of the pavement."

In the meantime a balance of \$7000 in the fund for the improvement of the road will be withheld by the county.

\$2000 DAMAGES AWARDED.

W. H. Smith Given Verdict as Result of Injuries Sustained.

The suit of W. H. Smith against Xerox & Co., Inc., for damages to recover \$10,000 damages for personal injuries received in falling on a slippery sidewalk terminated in the circuit court today when a jury in Judge Denton's court rendered a verdict in favor of the plaintiff, awarding him \$2000.

The suit was brought under the city ordinance requiring property owners to clear their sidewalks. The accident occurred last January during the silver thaw at Fourteenth and Johnson streets.

Ethel R. Johnson has filed a suit in the circuit court asking for a divorce from George Johnson, a member of the Portland fire department, on the ground of cruel treatment. It is alleged that the defendant is of an unduly jealous disposition, and has on several occasions, both in private and public, caused the plaintiff humiliation.

Suits for divorce were filed in the circuit court yesterday by Cora H. Harris versus William H. Harris, Ethel R. Johnson versus George Johnson, Pearl West versus Jess West, and Richard G. Hungerford versus Nettie E. Hungerford.

Anna Smith was granted a decree of divorce yesterday from Albert E. Smith by Circuit Judge Davis.

Skeleton Is Found; Identity Is Sought

Man May Have Been a Delegate to Elks' Grand Lodge in Portland in Year 1912.

The skeleton of a man who perished three or four years ago in the woods near Olympia, Wash., and found October 3, may be that of a delegate who attended the Elks' grand lodge here in June of 1912.

Chief of Police Clark received a letter from Jesse T. Mills, acting coroner at Olympia, this morning, stating that with the bones was found a blue pencil, and a penknife, and a small piece of Portland lodge to delegates during the 1912 convention.

The man is described as having been 5 feet 10 inches tall, weighing 160 lbs. in a blue serge suit, a black soft hat and black shoes. With the clothing was found an open-faced Elgin watch and a penknife.

Coroner Mills said the man had been dead from three to four years. Nothing but the skeleton remained. Chief Clark was asked to look over his local records to see if anyone was reported missing from Portland at or shortly after the time of the convention.

SHIPYARD STRIKE ON SAN FRANCISCO BAY'S NEAR SETTLEMENT

Boilermakers and the Allied Workers May Go Back to Work Monday.

(San Francisco, Oct. 14.—(U. P. N. S.))—The strike of 2200 boilermakers and allied workers at the San Francisco and Alameda plants of the Union Iron Works and the Moore & Scott shipyard will probably be over by Monday, according to declarations made today by those in close touch with the situation.

Pace, it was asserted, is expected to come as a result of a meeting called by Mayor Ralph Jr., at which proposals were made to the boilermakers and the Shipfitters union, whose refusal to affiliate with the American Federation of Labor forces caused the walkout.

While Mayor Ralph refused to discuss the situation, it was reported that men influential in both the unions involved were for a settlement.

Meanwhile the Union Iron Works, according to J. J. Tynan, manager, is making no move, hoping the dispute will be settled by its principals.

George Wittman, former police chief and now attached to the Chamber of Commerce law and order committee, called on Tynan to tell him the law and order committee had authorized him to offer a supply of non-union labor. The offer was declined.

The law and order committee issued a statement comparing the strike to that of longshoremen, during which the committee was formed.

POLICE CALLED OUT IN THE UPHOLSTERERS' STRIKE CONTROVERSY

Steps Taken to Prevent Possible Violence at Mattress Factory This Morning.

Police were on hand at the King-Fisher Mattress company, Albina and Goldsmith streets, this morning for the first time since the strike of mattress makers was called last Sunday.

Officers of the company requested police protection, asserting that the strikers were massing in numbers when the strikebreakers came to and went from the plant. This was quite a disturbance for the police to quell this morning.

H. W. Wright, a striking mattress maker, was arrested by Patrolman J. H. Black at Broadway and Larabee street last night at 2:30 and charged with assault and battery. He had engaged in a fight with a strikebreaker.

Several other law and order committee men, following words, and taking part in the fracas when the patrolman arrived, Wright will be given a hearing in the municipal court Tuesday morning.

In references to the strike situation G. W. Haines, secretary Upholsterers' Union, No. 65, makes the following declaration:

"I have appeared in The Journal a statement made by Mr. King of King-Fisher Mattress company, that in the three principal mattress shops the workmen were making, previous to the strike, from \$18 to \$20 a week. The mattress makers who left their work rather than continue under the conditions for the wages they were receiving, make a public offer to accept the scale of \$18 to \$20 a week, the principal competitive point, named at San Francisco. The scale there is \$22 per week of 48 hours, time and a half for overtime work."

COUNCIL COMMITTEE IS UNABLE TO DECIDE ONE JITNEY PROBLEM

Commission Itself Must Determine if Streets Having Carlines Can Be Used.

HUGHES DEVOTES HIS ATTENTION TO TRADE AFTER WAR IS OVER

Declares American Rights in Foreign Countries Must Be Protected.

Falls City, Neb., Oct. 14.—(U. P.)—Enforcement of American rights should be coupled with opening of opportunities for extension of American trade abroad if this country is to succeed in foreign fields, Republican nominee Hughes took an early morning gathering here today. He spoke of the "temporary stimulus" given the European war to American business and warned his auditors that such a temporary prosperity was an unhealthy condition.

"We want in the United States to have a basis of prosperity that does not depend upon the European war," he declared, "but upon the basis of a permanent, but you cannot have a stimulant for any great length of time. When the war does cease, you will find a great deal of labor disappointed in this country."

WOULD PROTECT CITIZENS ABROAD.

"We must remember that it is perfectly idle to ask American merchants, American engineers, American traders to go to foreign lands and seek for new opportunities that are afforded in connection with branch houses abroad. It is perfectly idle to ask them to go abroad to do business if they are not protected by the American flag. It is not mean full protection to every American, citizen lawfully engaged, wherever he is. We cannot have an extension of our foreign trade unless we have a recognition of the dignity of our own citizenship and are prepared to maintain our own rights."

He declared that the United States is more extraordinary than the claim of this administration that it has kept us out of war. Only inexperienced politicians could have gotten us into war. We did not have peace in Mexico. We had war. It was a personal affair. It was not based on anything that is sanctioned by international law.

Declares Policy Vindictive.

"It was vindictive to destroy the only semblance of government Mexico had. We have had no proper policy for years in Mexico. We have had no peace maintained, but it will not be maintained unless we have it understood that we do not propose to meddle with things that do not concern us. In the next place, the just rights of our citizens with respect to their lives and property will be maintained."

Thirty years ago, when Hughes was president of Delta Upsilon fraternity at Amherst, he sent a telegram of congratulations and best wishes to the Republican candidate for the presidency, Garfield. Today Hughes, now a candidate, received a somewhat similar message from Chester W. Barrows, conveying best wishes from the Delta Upsilon convention at Providence, R. I.

RUB DUNN PROVES STIMULATING.

On Board Governor Hughes' Special Train, Beatrice, Neb., Oct. 14.—(U. P.)—Swinging across the Nebraska country today, Governor Hughes struck vigorously at the Democratic tariff policy and cried solemn warning against the evil days to come after the war. Berlin, Va. Wireless to Sayville, Oct. 14.—(U. P.)—The Anglo-American divisions (about 1,620,000 men) were practically annihilated in the three months and a half of the Somme offensive, the military critic of the semi-official news agency asserted today.

These divisions were withdrawn and disappeared completely from the battle front and partly were annihilated in consequence of heavy losses, could engage in the combat only twice; 15 divisions were in action three times, and only one division was left to take part in the battle four different times. Four divisions were beaten so badly that after the second engagement they had to be sent to fronts where fighting occurred, but on critical days these were recalled and sent to other fronts.

Since the beginning of the Somme offensive, 175 divisions (3,140,000 men) have been sent to the front and have been launched against the German positions, the military critic stated.

Russian losses from June 1 to October 1 are estimated at about 1,000,000 men, quoting the statement of a Kiev officer in a Swiss paper as authority. Some Siberian regiments were completely annihilated, he asserted, and the Fourth Siberian army corps alone lost between 13,000 and 14,000 men from August 31 to September 3.

German Diver Sends Cruiser to Bottom

Berlin Reports French Warship Rigel and Troopship Galia Torpedoed in Mediterranean—1000 Troops Lost.

Berlin, Oct. 14.—(U. P.)—A German submarine sunk the French cruiser Rigel in the Mediterranean October 4 and torpedoed the French cruiser Galia on October 4, 1900 French and Serbian troops perishing, it was officially announced today.

"A German submarine in the Mediterranean, October 2, sank by two torpedoes the small French cruiser Rigel, built as a destroyer, and on October 4 torpedoed the French auxiliary cruiser Galia by one torpedo," said the official statement.

About 1000 men of the Franco-Serbian troops on board the Galia perished for Saloniki, perished. The ship sank within 15 minutes.

Loss of the Galia was admitted by the French Admiralty. The crew and it was stated that more than 800 men were missing. The French steamer Rigel, of 3500 tons, registered at Bordeaux, is believed to be the "small French cruiser" mentioned in the Berlin statement.

Carl Gregg Doney Inaugurated With Due Ceremony—Leading Educators of the West Take Part in Program.

Willamette University, Salem, Or., Oct. 14.—The twenty-first day of the early thirties, no event in old Willamette's history has attracted as much attention in the collegiate world as the inauguration of Carl Gregg Doney, Ph. D., LL. D., as the seventeenth president of the university in the Salem First Methodist church.

The ceremonies of the day were formally opened with the academic procession. In the line were Blahoe Hughes, Dr. Doney, T. S. McDaniel and members of the board of trustees, former Senator R. A. Booth, the presidents and representatives of the various colleges, the faculty, the alumni and the general student body.

Inductory greetings were given by T. S. McDaniel and R. A. Booth, who presided. Bishop Hughes of the Methodist Episcopal church delivered the inaugural address on the "Mission of the American Christian College."

President Doney responded. Concluding the morning's ceremonies was the bestowal of the official baccalaureate degrees in Chinese Sidering, noted jurist of Chicago, who was a member of the class of 1873 for two years.

Addresses by visiting college presidents and Governor Witham were given during the afternoon. Among those speaking were: Edward H. Todd, College of Puget Sound; P. L.
