

DELEGATES GATHER IN PORTLAND TO DISCUSS PLANS FOR ECONOMY

Edward F. Trefz, Personal Representative of Herbert Hoover, Makes Address.

GERMAN MENACE IS TOLD

Every One Can't Fight at Front but Every One Can Help Save Food and Thus Aid Allies.

"If Germany can win Calais and train her guns on Dover with a bombardment against which no warship can live, London will be occupied by the enemy, and within a year there will be an army of 500,000 German soldiers in Canada and 250,000 in Mexico, and men will go to work as our forefathers did, not knowing when democracy will die.

"But if America is strong in the war, this will not happen. And that means strength not only in men and munitions, but in supplying food."

Delegates Here From Two States

With these words, Edward F. Trefz, one of Federal Food Administrator Herbert Hoover's personal representatives, explained to delegates from Oregon and Washington in conference at the Hotel Portland this morning, why the government has inaugurated a national food economy campaign.

Among the delegates were representatives of the food administration appointed for the several counties, county school superintendents and county officials.

They are to lead the campaign to pledge every home to food economy. Food economy, definitely, means a pound of wheat less a week for each person, two meatless days—Tuesday and Friday—each week; half as much sugar consumption as at present. A pound of wheat is about equivalent to a loaf of bread, said Mr. Trefz. The denial on the part of 100,000,000 Americans will release for export 200,000,000 bushels of wheat or the product of that quantity of wheat in flour.

Pledge Cards Are Offered
The pledge card which each home is to sign says to the food administration: "I am glad to join you in the service of food conservation for our nation and I hereby accept membership in the United States food administration, pledging myself to carry out the directions and advice of the food administration, insofar as my circumstances permit."

"It will do no good to sign this card," said Lyman L. Pierce, another of the food administrator's personal representatives, "unless it is accompanied by conviction—the conviction that it is actually an enlistment in the national service, not less important than any other enlistment by any group of people in the world today."

We Can All Economize

Food economy, explained Mr. Pierce, is pioneer work in the United States, because food liberality has been the rule. But now, he declared, a hungry

The conference this morning was called to order by W. B. Ayer, federal food administrator for Oregon, who introduced Charles Hebbard, federal food administrator for Washington, as presiding officer.

"I have a conviction," said Mr. Hebbard, "that until each man, woman and child in this country takes a conscious part in the war, the war will continue. We cannot all build ships or make munitions, but we can all economize in food."

The conference adjourned early that the delegates might listen to Ambassador Gerard at the Auditorium, but it will be continued this afternoon.

JUDGE ROBERT EAKIN, WELL KNOWN JURIST, DIES AT SALEM HOME

Was Chief Justice of Oregon State Supreme Court From January, 1911 to 1913.

Salem, Or., Oct. 1.—Judge Robert Eakin, for 10 years a member of the Oregon supreme court and one of the progressive jurists of his day, died today at his home in Salem, following an illness covering a period of several years. He leaves a widow and three children: Robert Eakin Jr., attorney at La Grande, and Harold and Gertrude Eakin, both of Salem. He also leaves two brothers, Judge J. A. Eakin of the Fifth judicial district, and H. E. Eakin, Cottage Grove.

Funeral services will be held at the Presbyterian church at 2 o'clock Tuesday afternoon. They will be conducted by Rev. Carl H. Elliott, pastor, assisted by Rev. J. Edward Blair of Redmond, Or. The body will be taken to Union for interment Wednesday.

Judge Eakin was 69 years old. He was born at Elgin, Ill., March 15, 1848. He came to Oregon in 1866, and was graduated from Willamette university in 1872. During the next two years he read law with George B. Dorris, and was admitted to the bar and began practicing law at Union. In 1895 he was appointed judge for the Eighth judicial district and continued on the circuit bench until 1906, when he was elected to the state supreme court, of which he was chief justice from January 1, 1911, to January 1, 1913, when his term expired.

Judge Eakin was reelected for a six-year term, but was forced to resign the first of this year because of continued ill health, and was succeeded by Judge Wallace McCamant of Portland.

with prolonged applause but was listened to in profound silence.

"None of you want to know what Prussian rule is," he said in solemn warning of the horror that will come to America unless America serves herself to the utmost and utilizes every resource to win the war.

Treatment of Women Unpleasant
"I have seen cities as large as this, people as prosperous and well educated, entirely under German oppression. I don't want such sights repeated in America," he declared.

His picture of women captured by Germans as slaves, made to live with brutal German soldiers in lonely farmhouses and compelled to labor in the fields like beasts of burden, was tremendously impressive yet revolting. Of the same character was his description of the insane penalties visited upon the hostages of Germany upon every pretext or because of every pretended violation of German military government of captured cities and peoples.

Ambassador Gerard was in excellent voice. His voice rang clear over the great auditorium, and the wariness that seemed to envelop him when he arrived in Portland dropped from him as he recalled the ruthless atrocity of German war methods.

Incidentally, he referred to the Swedes. "No one in the United States ever doubted their loyalty," he said amid applause.

GERMANS SPURN HUMANITY
Because some German civilians gave some prisoners cold water their names were printed and they were held up to the contempt of Germans, said Ambassador Gerard, in further description of Germany's hate in war.
