

NORTHWEST RESPONDS WITH A BANG TO THE LIBERTY BOND APPEAL

Oregon and Sister States "Come Through" to Help Uncle Sam Win War.

PERSONAL CANVASS MADE

Capitalists, Laborers, Professional Men and Women, School Children and All on Lists and Still Coming.

Baker, Or., Oct. 20.—Baker county's \$100,000 Liberty bond quota has been better than half subscribed, reports by local banks this afternoon showing over \$50,000 sold, including over \$18,000 bought by one bank, customers of three banks in Baker, and reports from banks in other towns.

Two of the local banks have not yet made their subscription, but the First National took \$50,000. The county Liberty loan committee at a meeting today planned to follow a speaking campaign of the county with personal canvass next week, committees for the purpose being named in all communities.

F. E. Rogers, laborer with \$530 savings, invested \$500, saving \$30 was all he needed for personal use. School children, depositors in the school bank, are planning to pool their deposits and invest the whole amount in bonds.

The disappointing feature in Baker county is the failure of ranchers, sheepmen and cattlemen, who have been unusually prosperous, to do their share, but it is believed that nevertheless the county's quota will be assured in the next few days.

DUFUR

Dufur, Or., Oct. 20.—At a meeting of the Farmers' union held at Dufur this afternoon, the sum of \$20,750 in Liberty bonds was subscribed by 64 persons. The first subscriber was Mrs. J. J. Klingler of Dufur, subscribing \$2000.

F. E. Ingells, president of the Wasco Farmers' union, presided at the meeting and addresses were delivered by J. W. McCullough of Ontario, and F. A. Freeman, vice president of the Lumbermen's Trust company.

Johnston Brothers, bankers of Dufur offered to lend anybody money to purchase a Liberty bond at 4 per cent interest—the same rate the banks are paying.

At the conclusion of the addresses Mr. Ingells said the meeting was then open for anyone to subscribe, and subscriptions poured in thick and fast until the above amount was subscribed.

An Dufur had previously reported \$12,250 subscribed, the total subscribed is now \$33,000. Several thousand dollars more is absolutely assured, but subscribers are not quite sure as to amounts as yet. There will easily run the subscriptions over \$35,000, and as Dufur's allotment is \$26,000, its quota is reached.

This was all subscribed by farmers.

HOOD RIVER

Hood River, Or., Oct. 20.—The special committee appointed from among the business men of the city to canvass the residents of the county in the interest of the second Liberty bond drive after their day's work yesterday returned with approximately \$8000. Among the subscribers to the bonds were a large number of apple pickers, who are temporarily in the valley and who subscribed for one or more of the \$50 bonds.

Hood River county has now subscribed for \$25,000 worth of the bonds to date.

In the special drive yesterday the committee, composed of C. D. Nickelson, native-born German, and A. C. Loftis, native-born Englishman, returned with \$2000, which was the largest amount secured by any of the committees, and approximately one-half of this amount was subscribed by German residents of the valley.

Hood River county expects to raise its full quota and wind up the campaign with a big celebration.

LEBANON

Lebanon, Or., Oct. 20.—Liberty day will be fittingly observed here on next Wednesday. ARMY OFFICER FOUND DEAD IN HIS TENT AT VANCOUVER RANGE Indications Are That Lieutenant M. C. McCoy Killed Self; Ill Health Cause. Vancouver, Wash., Oct. 20.—The body of Lieutenant M. C. McCoy, Fourth United States Infantry, was found early Saturday morning in his tent on the target range at Vancouver lake, about four miles from Vancouver barracks. Indications point to suicide. McCoy's revolver lay beside the body. A bullet from the gun had penetrated McCoy's brain. McCoy had been despondent because of illness.

McCoy was commissioned at the officers' training camp at Fort Sheridan in August and came to Vancouver August 29. He is survived by his father, Colonel Robert McCoy, Sixth Infantry, Wisconsin National Guard, now in federal service, and by an aunt, Mrs. Mary Gibson, Sparta, Wis.

Hood Apple Crop Is Being Packed Hood River, Or., Oct. 20.—Apples in the Hood River valley amounting to about 1,000,000 boxes will practically all be picked by next week and under cover. The freeze of last year that destroyed several thousand boxes of apples that were left out in the orchards piled in boxes and covered with sacks, has taught the growers a good lesson this year and this risk will not be taken.
