

AMERICANS WERE OUTNUMBERED BY NEARLY 10 TO ONE

Detachment Cut Off by German Barrage Fought Like Wildcats Until Overcome by Weight of Opponents.

Three Killed in Action to Be Buried in France—Best Traditions of American Army Upheld by Men.

With the American Army at the front, Nov. 6.—(U. P.)—They were making ready today to bury in the hallowed soil of France the first American soldiers to fight and die to make the world safe for democracy.

Three of them died, four others sustained wounds and 13 are somewhere behind the German lines in this first encounter—and today every man making ready for the battle line awarded to them the supreme commendation that in their fight they sustained the best traditions of the American army.

Detachment was outnumbered. They were outnumbered, this little detachment of Sammlers. The fact that they fought against overwhelming odds and were hopelessly cut off from reinforcements did not deter them in striking back with all their power.

In the narrow trenches where there was no room for rifle shots, the Americans fought with their clubbed guns, their bayonets, their trench knives, their entrenching spades—even their hands.

Confusion Reigned Over Battle
Flares and the sudden glare of exploding shells showed occasional rapid pictures of struggling grapples or two American soldiers surrounded by a solid mass of Germans, a whirling maelstrom of arms and hands and kicking feet, flashing bayonets, shouts, muffled yells and the sounds of pain wrung from the wounded.

This was the story as survivors tell it. The Americans did not have a chance against overwhelming superior masses of the enemy. The fact that they didn't have a chance didn't make them stop fighting, however, until they had literally been smothered under the Germans.

Barrage Surrounds Unit.
The small American detachment was in a front line trench. The usual desultory artillery fire suddenly rolled to an intense rumble. The enemy put down a heavy barrage of shells completely round the single unit. Then a big party of Germans—Americans estimated them at 210 in all—suddenly swarmed over.

The German raiding party was composed of picked and veteran "shock troops"—specialists in attack. They charged in a powerful rush. The American troops had just entered this particular bit of trench. They fought back until literally smothered in the weight of the superior attacking forces. Then the Germans scurried back to their own lines, dragging their own dead and wounded with them, together with their American prisoners.

Lieutenant Is Knocked Down
A young reserve lieutenant with the detachment attacked was puzzled immediately he brought his men into the trench, by the sudden acceleration of artillery fire. He decided to consult his superior officers and started carefully weaving his way back. He struck the German barrage. It knocked him flat, but he recovered and a second time tried to press along. Again he was flung down by exploding shells and for the third time he dauntlessly went on. Then he was completely "knocked out" by a narrow shave, from a high explosive shell. After the German raiders had returned to their lines the lieutenant was found, unconscious. He was revived later and told his story. Today he was in the base hospital recovering from shell shock.

It All Happened in a Flash
"The shelling began darn suddenly," said one of the wounded Americans today. "A few minutes later I turned around and saw a big German standing in the trench beside me. The next thing I knew he shot me—bang!"

The whole American army in France, realizing that the first American army casualties were those of an ordinary trench raid, nevertheless was boiling

with impatience today to get revenge on the Boches.

The American dead will be buried with military honors in a little American cemetery near the camp.

The official casualties list, as issued by the war department from General Pershing's reports, showed three dead, five wounded and 12 missing—20 in all.

The United Press dispatch above makes the list:
Three dead, four wounded and 13 taken prisoner—20 in all.

The discrepancy is in the wounded and missing.

WORK IN NOME AMONG MASONS RECALLED BY DEATH OF F. SWANTON

Sudden Passing of Prominent Portlander Attribute d to Cancerous Growth.

Prominent Portland Masons and other private citizens Wednesday will attend the funeral of Frank W. Swanton, grain man and one time postmaster at Nome, in the days of the Alaska gold rush.

The funeral will be held at the undertaking parlors of F. S. Dunning at 414 East Alder street at 2:30 o'clock. Interment will be at Riverview cemetery.

The death of Mr. Swanton came as a shock to his wife and immediate relatives and his wide circle of friends. Apparently in good health up until the time he was stricken, he had been actively engaged in managing the affairs of the Astoria Flouring mill. He was in Portland where Mrs. Swanton resides when taken ill. The autopsy, performed by Dr. W. H. Ewin, disclosed that death was due to acute inflammation of the large and small intestines, brought on by a malignant cancerous growth.

Work in Nome Recalled
In conducting the funeral Masons will perform one of the rites which their departed brother had performed many times during the stirring days at Nome. At that time the new gold camp had a population of about 10,000.

Mr. Swanton served two terms as postmaster under President Roosevelt. The influx of miners from all parts of the country swelled the Masonic contingent there, and one of the first activities of Mr. Swanton was to organize the Anvil Masonic club. Subsequently he helped form the Anvil Masonic lodge, and was its first master. He also helped organize the Arctic Brotherhood and served as chief of the camp.

W. H. Bard of Portland, who was assistant United States attorney and afterwards mayor of Nome, recalls many of the activities of Mr. Swanton at Nome. The Masonic lodge at one time had as high as 3500 members. Mr. Swanton and Mr. Bard served together on finance and relief committees. In that capacity Mr. Swanton personally aided hundreds of needy Masons. No Mason was ever buried in the potters' field at Nome, and when necessary dog sledges would be sent out to bring in sick and helpless members, the trips over the snow fields sometimes covering nearly 100 miles.

Smile Wins Many Friends
In civil and social affairs Mr. Swanton always took an active part, and his genial nature and happy smile, which was one of his characteristics, won him friends in every walk of life.

Mr. Swanton was one of the best known grain men in the country. He learned the business in the middle Western states. He was an able presiding officer and a good executive, according to those who personally knew him. Some years ago he was sent to Washington by Portland commercial interests in the matter of Alaskan industries.

As he was a member of Portland lodge No. 15 A. F. and A. M. One brother, Dr. James H. Swanton of London, and a sister, Mrs. Robert Day of Victoria, B. C., and his wife, survive him. The Misses Ethel and Leota Smith of this city are nieces of Mrs. Swanton. He was a native of Ireland and was born in 1857.
