

K. OF C. WAR WORK FUND DRIVE IS TO BEGIN ON MONDAY

Every Dollar Raised Will Be Used to Provide Recreation Centers for American Soldiers

PROMINENT PEOPLE HELPING Monday Night Dinner Will Be Held at Which Downtown Section of City Will Be Assigned.

To help the American soldiers and sailors at home and abroad, a campaign will be launched this week to raise \$50,000 for the Knights of Columbus war work fund.

As is generally known, the K. of C. and the Y. M. C. A. have been designated by the government to provide recreation centers for the American forces during the mobilization of the war.

Nonsectarian in character is the K. of C. work with the American soldiers and sailors. The halls are there for everyone to use and enjoy irrespective of religious or other affiliation.

It was because of the service rendered by the K. of C. halls along the Mexican border during the mobilization of the national guard, that the government invited a continuation of this labor when the United States entered the world war.

General of the K. of C. drive is J. D. Farrell, with Guy W. Tabbot and John E. Cronan as the colonels.

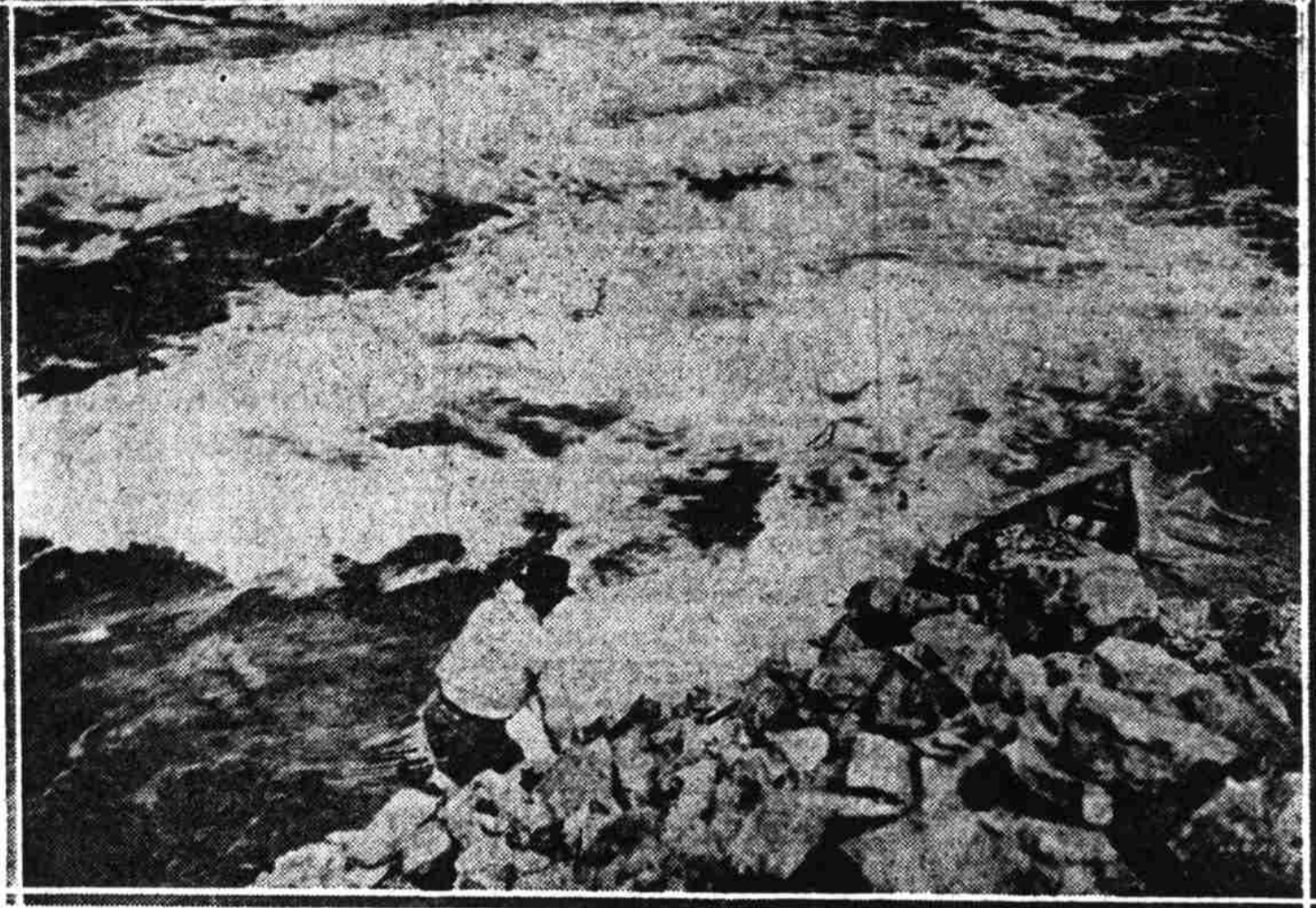

ESTERY WILLING TO PASS OFFICE ON TO WINNER IN PRIMARIES

Democratic National Committeeman Wants It Understood He Is Not Resigning.

H. M. Estery, Democratic national committeeman for Oregon, is willing to pass the robes of office along to any one who may aspire to the job and be elected at the coming primaries.

Mr. Estery has written a letter to Samuel White, state chairman, in which he explains his position. It is as follows:

I desire to notify you and all Democratic voters of the state that a Democratic national committeeman to succeed me, should be elected at the primary election to be held next May.

By a ruling of the St. Louis convention in 1916 my term will expire on May 1st, 1920, but I think I should abide by the Oregon law and the terms of my certificate.

I wish it understood that I do not hereby resign. On the contrary, I shall hold the office until my successor is elected.

PORTLAND - SEATTLE PASSENGER SERVICE CUT TO BE TAKEN UP

Northwest Traffic Men to Meet in Seattle Monday; Six Trains May Be Dropped.

Plans for again curtailing passenger service between Portland and Seattle will be discussed at a meeting of Northwest traffic men at Seattle Monday. It is proposed to reduce the service to six trains each way daily during the period of the war.

Another important change to be considered affects shipments of freight in less than carload lots. It is proposed that the three roads operating in the Portland - Seattle territory pool their shipments of merchandise and avoid hauling less than carloads.

These proposed changes came up for consideration at a meeting of Northwest traffic men held Thursday in Seattle, but no definite conclusion upon which to base a recommendation of altered service was reached at that time and the whole matter was left for Monday's meeting.
