

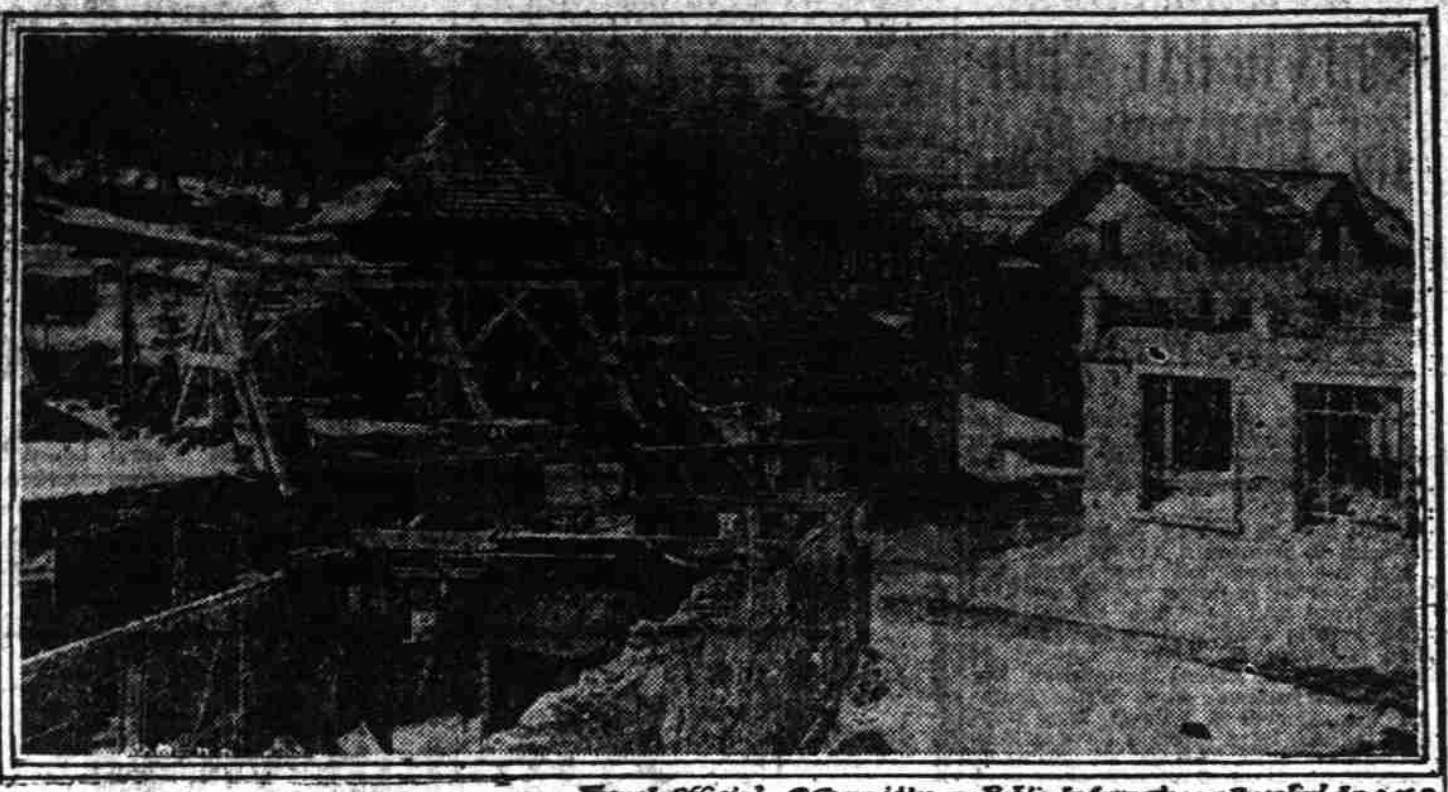
WARDEN MURPHY AT HOME WITH PAROLE VIOLATOR, C. B. SMITH

Parole Officer Joe Keller Is Left in San Francisco to Fight Kidnaping Charge.

Salem, Or., March 12.—Warden Murphy of the state penitentiary arrived here Monday night from San Francisco with C. B. Smith and Charles Emerson, parole violators, in his custody. Joseph Keller, state parole officer, is still in San Francisco, where he is charged with attempted kidnaping as the result of his attempt to whisk Smith out of California and into Oregon without being armed with extradition papers.

Warden Murphy denies published reports that Keller and Smith engaged in a fight when Keller nabbed Smith as he was being released from serving a term in San Quentin prison, and declares that Smith agreed to return voluntarily to Oregon with Keller until Smith's lawyer got into communication with him and caused Smith to change his mind.

ALSACE TOWN AGAIN COMES UNDER FRENCH RULE AFTER HUN DOMINATION



This little town, Col de la Schlucht, in the Vosges, held by the Germans since the war of 1870, is once more under the tri-color of France. In the recent French drive in Alsace the town was liberated from Teutonic bondage after more than 46 years.

Warden Murphy, who immediately caught a train for Salem, while Keller remained to fight the kidnaping charge. Warden Murphy had gone to California to bring back A. G. Graham, a parole violator, who was arrested at San Bernardino and had escaped officers once before. He had to leave Graham in jail at San Francisco and expects Keller to bring him when Keller disposes of the kidnaping charge. Keller will also bring Paul Durbey, another parole violator.

MAY ALLOW IDENTITY OF DEAD HEROES

WASHINGTON, March 12.—(U. S. S.)—The American people, very probably, will be informed of the identity of their hero dead. At the cabinet meeting Tuesday afternoon President Wilson took up with his advisers the question of supplying, when casualty lists are published, the home addresses of soldiers killed or wounded in France, and it is said the decision will be to order addresses made known when the names are given out. Officials here, both civilian and military, have not been convinced that publication of the addresses really aids the enemy, as has been claimed. While there is the strongest desire to comply with all requests of the allies, it is felt, privately, that the French government was not fully informed of circumstances when it asked that the publication of addresses with the names be discontinued. It is pointed out that there is a real reason for suppression of the addresses in other countries that does not exist in the United States, and it is further argued that the present lists containing merely names do not mean anything to the country at large.

Saloon Closing Edict Brings No Protests

Nearest Sign Is Request by Annapolis Bar Owners for Time to Close Out Business; Brewery Suspends. Washington, March 12.—(U. S. S.)—A strange phenomenon is disclosed as a result of Secretary Daniels' drastic order closing the saloons within a five-mile radius of permanent training camps which goes into effect Saturday, March 16. Not a single organized protest has been received by the department against the enactment of the law. The only movement that could be classed as a protest was the reception of a committee of Annapolis saloonmen, headed by their congressman, which asked for further time in order to close out their business. As far as is known there is but one brewery affected by this order and its owner could not protest the order but asked in a round about manner if the order affected his establishment in the manufacture of beer and its sale to private families, in the city. He was informed that the brewery would have to close.

Frank Godsol Denies Profiteering Charge

Washington, March 12.—Frank Godsol, under arrest here on charges of reaping illegal profits from French war contracts Tuesday made blanket denial of charges that he was active in German propaganda work. Answering reported statements of Deputy Assistant Attorney General Alfred L. Becker of New York, Godsol denied that he ever knew of any "Germanic War Films, Inc.," or that Benjamin Blumenthal, whom he admitted he "knew," had been associated with him.

15,000 Camp Lewis Soldiers Will Sing

Camp Lewis, Wash., March 12.—(U. S. S.)—Fifteen thousand men singing together will be heard in a few days in the Montana building now in the course of construction on the parade grounds at the camp under the direction of Robert Lloyd. The new building will be finished by the time Mr. Lloyd returns from San Francisco, where he goes Wednesday on a 10-day leave, and it is then that he plans to have the 15,000 men come into the building and sing popular marching songs which he is now teaching them.

Carl Von Fronk Is Anti-Militaristic

Los Angeles, March 12.—(U. P.)—"I hate Prussianism, militarism, more than an American is capable of hating it," declared Karl von Fronk, in jail as an alien enemy, and I want to be moved from this cell because Germans in here are continually slurring America, which is intolerable. He was removed, though he is still held by the government.

Juror Skips Trial To Enlist in Navy

Santa Rosa, Cal., March 12.—(U. P.)—Because Earl L. Hicklin is more interested in seeing that Kaiser Wilhelm gets what's coming to him than in the fate of Wong Bow, Chinese, the Sonoma superior court has a bench warrant out for him. Hicklin was serving on the jury in the case of Wong Bow accused of arson. When court convened Tuesday there were but 11 jurors in the box. Hicklin had gone to San Pedro and joined the United States naval reserve in training there. The bench warrant was immediately issued, but in the meantime the court is trying to devise a way of finishing its case with 11 jurors.

Hot Springs Court House Dispute Hot

Klamath Falls, Or., March 12.—That he differs most decidedly from the policy of the county judge and fellow commissioner, Frank McCormack, in their policy of delaying construction of the new courthouse, now uncompleted in Hot Springs addition, is indicated in an extensive statement made public Monday by Commissioner Burrell Short, a farmer near this city. Short alleges that his colleagues, in delaying the completion of the courthouse further, are breaking their election pledges and attempting to thwart the will of the people, as expressed in a recent petition signed by nearly 1500 voters.

1000 MORTGAGES HAVE BEEN FILED WITH STATE SECRETARY SINCE LAW

Multnomah County Leads, Having Nearly Half the Number; Law Covers Auto Mortgages.

Salem, Or., March 12.—Since the enactment of a law by the last legislature providing for the filing of migratory chattel mortgages with the secretary of state, 1000 such mortgages have been filed with Secretary of State Ocott. This law is intended particularly to cover mortgages on automobiles, and by requiring all of them to be filed with the secretary of state, as well as in the county where the mortgage is issued, persons interested may be informed without searching through the records of all the counties. Convalescent Home For Camp Kearny

San Diego, Cal., March 12.—(U. S. S.)—That a large convalescent home will be built near the base hospital at Camp Kearny, was the information given out by Keith Spalding of Chicago and Colonel George Filmer of San Francisco. Messrs. Spalding and Filmer are on a tour of inspection of military relief work for the Red Cross in the United States. The building, when completed, will form a huge cross as a symbol of the organization and will be a boon to the convalescent soldiers, as every convenience has been thought of, even to accommodations for visiting relatives who may wish to remain at the camp over night. Houses of similar construction will be built at Camp Fremont and Camp Douglas.
