The funeral of Fred M. Cammack will be held Tuesday at 2 p. m. from the chapel of the F. S. Dunning undertaking parlors, East Sixth and East Alder streets, Rev. W. G. Elliot of the Unitarian church officiating. Mr. Cammack died at the family home, 1034 East Thirtieth street north, Saturday, at the age of 41. He was born in Woodburn, Or., and had spent the greater part of his life in Portland. Surviving Mr. Cammack are his parents, Francis Cammack of Montana and Mrs. Clara Cammack of Portland, four brothers and four sisters. Mr. Cammack was a member of the Second Oregon in the Spanish-American war, and funeral services will be in charge of the S. A. War Veterans.

THEODORE B. WILCOX ANSWERS LAST CALL

(Continued From Page One)

Mrs. Nellie Stevens Wilcox; Raymond B. Wilcox, eldest son, who is secretary of the Portland Flouring Mills company, Mrs. Cameron Squires, a daughter, of Portland, and Theodore B. Wilcox, Jr., a son, who is a student at Yale.

Mr. Wilcox was born at Agawam, near Springfield, Mass., July 8, 1856. Review of the career of Theodore B. Wilcox reveals one of those strong characters who, starting in business life as a poor boy, rose by dint of hard work and business acumen to a position of wealth and influence in the community. His ability received national recognition, and he gave freely of time and talent to serve the country.

Mr. Wilcox, who, at his death, was owner of 11 flouring mills in Oregon and Washington, had been instrumental in the delivery of flour ground from northwest wheat into many of the foreign markets of the world. Since he became active as an exporter he had sent out millions of barrels of flour. His activities in upbuilding the transportation business of lines between Portland and the Orient are also noteworthy. Although the pioneer efforts in this direction were rewarded for a time through the operation of railroad-owned and chartered boats, the steamers were taken off after competition became keen to warrant a continuance of the business.

Came to Portland in 1877
 As head of the Portland Flouring Mills, Mr. Wilcox was best known. His entry into this phase of the business was an outgrowth of his early connections with the Ladd & Tilton bank. About a year later, in 1877, Mr. Wilcox came to Portland to seek his fortunes in the western country. He came primarily at the solicitation of Asahel Bush and the late W. S. Ladd, who were then operating a competent young man to assist him in the rapidly growing affairs of the bank. He sent east with instructions to find a man of business and Mr. Wilcox, who was at that time living in Massachusetts, was selected for the place. His first position with the bank was that of bookkeeper. He was promoted to teller, and subsequently became Mr. Ladd's private secretary.

Became Head Portland Flouring Mills
 In 1883 the Ladd & Tilton interests took over the Portland Flouring Mills company. Mr. Wilcox was selected as the executive head of the milling interest. In the following year the Portland Flouring Mills company was formed. Mr. Ladd was made president and Mr. Wilcox vice president. Mr. Wilcox continued in this capacity until the death of Mr. Ladd, when he was elected president of the company.

In the capacity of flour exporter Mr. Wilcox early showed a keen insight to the needs of the business. He developed the Oriental trade and was the first to launch the business at Hong Kong. He was also the first flour miller to open the trade in Japan. Included in his work were markets were the Philippines and South Africa during the Boer war. He also sent occasional shipments to Australia to meet the special needs of that country. His activities in building up the American trade in Great Britain are noteworthy.

Served Nation for 21 Years
 It traces of the special fitness of Mr. Wilcox that he was chosen director of the food administration milling division as representative of the government in flour purchases in the

district comprising Oregon, Washington and Southern Idaho, a position which he held at the time of his death.

Attention to private business affairs claimed all of the time of Mr. Wilcox. He never entertained an ambition to hold public office, although his friends had repeatedly urged him to get into public life.

Mr. Wilcox was extensively interested in banking enterprises in the Pacific Northwest. He was a director in the Ladd & Tilton bank and the First National bank of Astoria. He was also interested in the Dexter-Morton bank of Seattle, and the United States National bank of Portland. Among his industrial investments was that in the Hawley Pulp & Paper company.

Through judicious business methods and constant application Mr. Wilcox rose steadily in the financial world. The major part of his investments is centered in valuable downtown business property. His estate includes, among other realty holdings, the Stevens building, the new annex to the Imperial hotel, the Wilcox building and the quarter block at the southeast corner of Fourth and Commercial.

Helped Promote Work
 He was one of the group of men who exercised large influence in attracting attention of the country to the Pacific Northwest during the construction period of 15 years ago, when Portland began a period of development from conditions of an overgrown country town to the pretensions of a large city.

As a director of the Portland Commercial club he was one of those who financed the exploitation work undertaken in 1894, when the promotion department was organized with the late Tom Richardson at its head. Mr. Wilcox gave personally of his talent and helped in financing the subsequent work. We was an ardent advocate of development of Oregon as a whole as the best method for making Portland a great metropolis.

James J. Hill, speaking at a banquet in his honor, tendered by the business men of Portland when the North Bank railroad was nearing completion, paid this tribute to Theodore B. Wilcox:

"Mr. Wilcox has done more than any other man in Portland through the fame of the institution of which he is the head to develop the commerce of the Columbia river and gain recognition for the Northwest throughout the world."
 Oregon Development League
 In 1904 he was elected president of the Trans-Mississippi Commercial Congress, which met in Portland in 1905, and recognized in such organizations, representative of the larger commercial interests of the Pacific Coast and Western states, strong possibilities for securing a better understanding of the needs of this region by the people of the country east of the Rocky mountains. He was a keen student of commercial conditions in Asia and believed firmly that complete exclusion of Chinese labor from the United States was an industrial disadvantage to the Pacific coast states, in that white labor for clearing lands, building railroads and a large amount of development work is not available when needed. It Is Belief of Officials That Subscriptions Will Run to \$18,000,000.

Portland's quota for the third Liberty loan has been placed at \$10,050,000. The maximum quota for the first loan was \$15,000,000 and for the first loan the quota was \$6,000,000. It is the belief of officials of the third campaign that subscriptions will run to \$18,000,000 in the present drive.

Multnomah county's quota, including Portland, is placed at \$10,110,000. Allotments for the counties of the state are announced today by Robert E. Smith, state campaign manager of the third Liberty loan, as follows:

Two Enemy Aliens Held as Fugitives

Eugene, Or., April 1.—Max John Andreas Larsen of 268 Pacific street, San Francisco, and Edward King of the Western hotel, Sacramento, alien enemies, are in the county jail here awaiting the arrival of federal officers. The men were registered in Sacramento and secured permits on March 25 to leave there to visit neighboring California counties. They were arrested near Irving, Sunday, while traveling on a freight train north of Eugene, and told Sheriff Elkins, when taken into custody, that they were on their way to Coos Bay to work in the timber. Had they intended to go to Coos Bay they were 20 miles off their route when arrested. Assistant United States District Attorney Rankin of Portland telegraphed instructions this afternoon to hold them until a federal officer arrived here for them.

Your War Garden

Setting the clock ahead will prove a real boon to the war gardener. If the war gardener hose and rakes in the morning the alarm clock will tumble him out sooner—radically, abruptly, almost unpleasantly sooner, for there are no minutes more jealously guarded than those that put the finishing touches on a good night's sleep and you can't change a man's habit by changing the clock.
 But although there will be little gain in the morning, the evening will be found to have lengthened out wonderfully. The dinner hour can be turned back as the gardening hour is turned forward and even after the end of a day at the office or the industrial plant, there will be found sufficient time to cultivate a really ample garden. For that matter, nearly any one could cultivate a war garden by putting merely the time used in debating when to begin.
 Have you gotten your radishes, peas, beets, early cabbage and lettuce planted?
 Have you worked up the soil of your war garden so that you will be proud to have your neighbor inspect it?
 This may seem a rather premature time to talk about irrigation for war gardens, except that it's the wise gardener who takes time by the forelock. If at all possible, provision should be made to furnish the garden in city lots with water sprinkled from the hose. The city makes a generous arrangement for the use of water in Portland on city lots or hose connections should be made. When the dry days come later in the season if you are able to sprinkle the vegetables or need them in the trenches between the rows, you will keep them from assuming that dry dustiness of expression that is like worrying, wrinkled anxiety on a pallid face.
 Never sprinkle the garden in the morning unless you are sure the sky will remain cloudy all day. Sprinkle in the evening, so that the ground will have plenty of time to absorb the water before the sun rises. Ground that gets hot sunshine following a wetting will bake hard and plants will be injured more than helped. It is always a good idea after sprinkling in the evening and in the morning to go over the surface in the morning with a rake, making sure that the top half inch or so is thoroughly loose. Such a plan, so far as moisture is concerned, will promote ideal growing conditions. If you wish to attempt irrigation on a small scale open a small furrow between the rows, making sure that the channel is not blocked at any point. Let the water run a reasonable length of time, or until you are sure the ground is wet, then shut off the flow.

Robbed of Fortune, Russ Banker Flees

P.)—Madame de Roshau, wife of a Petrograd banker, was safe in San Francisco today after fleeing from Russia, where, she said, the Bolsheviks robbed her of 10,000,000 roubles in stocks, bonds and realty.
