

LUMBERMEN CLEAR OF PROFITEERING

Judge Boyle, Kansas City, Points Out Policy of Industry; Meeting and Banquet Held.

Lumbermen in Oregon and Washington are conspicuous among all the leaders of industry in the country in that they are not accused of profiteering, as are the other industries.

In fact, Judge Boyle asserted, the figures revealed by the investigations of the Federal Trade commission show that the industry in these two states actually is selling its product at a figure less than cost.

The present price of \$26 per 1000 feet recently fixed by the government price fixing committee on Douglas fir is 40 cents less than the cost to the mill of Oregon and Washington, he declared, and presented the figures, taken from government records, to prove his statement.

Judge Boyle was particularly complimentary to E. B. Hazen of Portland, who has served at recent hearings before the federal committee as chairman of the cost analysis committee of the West coast industry.

He urged all fire producers to get behind Mr. Hazen in his present efforts to gather new cost estimates so that a fair and just price may be fixed at the forthcoming hearing in September.

In addition to Judge Boyle, other speakers included John H. Kirby of Houston, Tex., president of the National Lumber Manufacturers' association; Charles S. Keith of Kansas City, president of the Southern Pine association; John Lind, secretary of the National association, and Volney Davis Johnson of Chicago, editor of the Lumber World Review. The visitors are touring the lumber districts of the Pacific coast and attended the meeting of the West Coast Lumbermen's association on Mount Rainier last week.

Cooperative Labor Temple Incorporated

Oregon Woman Gets Soldier's Insurance

Washington, July 31.—(WASHINGTON BUREAU OF THE JOURNAL.)—How the soldiers' insurance law works and takes the place of the old time pension system is illustrated in the case of Mrs. Fannie Foster O'Rourke of Mountaineer, Or., the beneficiary of a son whose life was lost in service on May 3. Representative Hawley has been informed of the allotments to be paid. The insurance policy was for \$10,000 and it will be paid in 240 monthly installments of \$7.50 each. This will be a total of \$1,800 in a period of 20 years, \$800 being gained over the face of the policy in the payment of compound interest upon the deferred payments.

Boys Charged With Killing Colt, Free

Evidence at Third Trial Brings Out Fact That Boys Were Not Present at Time Act Was Committed.

Two small boys, tried for the third time in juvenile court, were acquitted Tuesday after evidence was produced to show that they were elsewhere when a large stone was thrown which killed a colt belonging to L. G. Green of the Sellwood Gardens.

Fred Landsberry and Harry Kessler were charged with having thrown the stone. Two former trials did not progress far and a more thorough investigation was ordered by Judge Tawell.

The several trials of the case had served to create unusual interest in the case in the Sellwood neighborhood and Tuesday afternoon every seat in the county court room was taken. When the decision exonerating the boys was rendered, the crowd broke out into cheers.

On several occasions during the trial the court was also obliged to admonish the auditors to preserve order.

Foreclosure Suit Is Begun
Foreclosure proceedings on the trust deed held by the Title Insurance and Trust company of Los Angeles were begun Tuesday by filing in the circuit court of suit against the Home Telephone & Telegraph company.

The complaint alleges that bonds of the Home company unpaid and upon which interest payments have been defaulted for more than six months amount to \$14,000. The Home company, in turn, asks for the foreclosure of its mortgage and the sale of the property of the telephone company to satisfy the claims of the trustee. Ten thousand dollars is asked as a reasonable compensation to the trustee for acting in that capacity for the telephone company.

Indictments Are Returned
The grand jury still in session from June term of court, Tuesday afternoon returned indictments for a number of offenses. Lester M. Cook was indicted on theft charges. A. P. Braham, a manufacturer's agent, was indicted on four counts alleging statutory offenses.

H. W. McGhee was indicted on a larceny charge and George and Robert Cox were indicted on burglary charges. It being charged that they broke into and stole property from the Independent Cracker company and from the Independent Foundry. George Cox was also indicted on a charge of assault with a dangerous weapon.

Soldiers Are Assisted
Following the announcement that the Multnomah County Bar association had appointed a committee of five of its members to handle the question of having members of the association handle all legal matters for enlisted soldiers and relatives during the war, President Tucker of the State Bar association stated this morning that the association has had this system in vogue for some time; that in every county in the state members of the state association have been appointed to take care of legal matters for any soldiers or sailors of their counties in need of legal assistance.

Decorating Firm Incorporates
Articles of incorporation for the M. E. Orser & Co. were filed with the county clerk Tuesday afternoon. M. E. Orser, A. Orser and F. C. Howell are named as the incorporators. The firm will do painting and interior decorating business. The stock of the company is fixed at 50 shares of a par value of \$10 each.

Soldiers' Wives May Go Over; Ban Lifted
Washington, July 31.—(U. P.)—The ban on women relatives of officers and men in the American expeditionary force going to France as Red Cross, Y. M. C. A. or similar organization workers has been lifted.

Hereafter passports will be granted to a woman when it is shown she is qualified by training for the position she is to fill. General March announced today.

The organizations to which the woman belongs will be held responsible for returning her to America in case she violates any of the rules.

FOUR MORE TRY TO ESCAPE PEN

Quartet Is Caught Before It Is Able to Duplicate Trick of Thompson and Thurber.

Salem, Or., July 31.—Four more convicts attempted last night to duplicate the trick turned by Bennett Thompson and Fred A. Thurber the previous night and escape from the state penitentiary. They were discovered before they got away from sight of the prison and were immediately retaken. Their discovery revealed the manner in which Thompson and Thurber made their escape.

The fact that these four convicts were on the secret of the way in which Thompson and Thurber planned their escape leads prison officials to believe that the plan was hatched for the delivery of a bunch of prisoners of the toughest characters. Three of the four who made the attempt last night had escaped before and been recaptured.

Thompson and Thurber cut iron bars in the mill flume which runs through the prison yard. The bars were cut below the surface of the water and the convicts made their escape by diving and crawling through the hole.

Four who attempted to escape last night made their way through the hole all right and swam about 200 yards up the stream, where they crawled out into the brush. As they left the water they were seen by Guard Burgess on the prison wall. He gave the alarm and Guards E. A. Slover and Sam Worrell ran to the place. The convicts, who were exhausted from the long swim, gave up without further attempt to run or get away. The four are:

James Carroll, sent up from Linn county, one to seven years, for larceny in a store.

Herbert Merithew, alias James Curtis, serving seven years for an attempted crime against nature. He escaped last year and was captured in Sacramento.

Jack Monahan, committed from Multnomah county for 10 years for attempted robbery. He escaped two years ago while employed in the prison flax fields and was captured in San Francisco.

Frank Smith, sent up from Multnomah county for two to five years for burglary. He escaped in October, 1916, by scaling the prison wall while the guard was asleep. He was immediately while robbing a safe in Ventura, Cal., and when he returned to town for medical treatment, was captured.

M'Adoo Defendant In Rail Rate Case

Salem, Or., July 31.—William G. McAdoo, director general of railroads, is made one of the defendants in a supplemental complaint filed with the public service commission by the Portland Traffic and Transportation association and the Oregon Portland Cement company against the O. S. L., O. W. R. & N. S. P., and the S. P. & S. railroads. The plaintiffs are seeking lower freight rates on cement shipped in carload lots from Oswego to Portland over the Southern Pacific, and also joint rates between the S. P. and the other roads named as defendants.

The complaint alleges that since the order of Director General McAdoo, increasing freight rates, went into effect, the rate on cement from Oswego to Portland has been increased from 14 cents per 100 pounds to 34 cents, which the plaintiffs declare is prohibitive.

Italian Jews to Send Mission
Rome, July 31.—(U. P.)—On behalf of the Jewish residents of Italy, the government will send to Palestine a mission composed of Attorney Angelo Levi Bianchini and Dr. Giacomo Artoni, who will accompany the American Zionists' medical mission.

General Strike Threatened
Vancouver, B. C., July 31.—(I. N. S.)—Unless the Dominion government brings about a settlement of the postal strike, a walkout of all labor organizations west of Fort Williams is threatened as the result of the administration employing strikebreakers.

Excuses Offered By German Press

Defeat on Marne Called "Small Necessary Withdrawal" Which "Will Be Useful"; Allied Initiative Denied.

Amsterdam, July 31.—(U. P.)—Further excuses for the German defeat on the Marne are appearing in German newspapers reaching here. The Frankfurter Zeitung declares:

"A small withdrawal was necessary and will be useful."

The Rheinische Westfälische Zeitung denies the allegations against the initiative, pointing out that the withdrawal on the Marne was made so that a solid front might be presented.

Reichstag member Traub chides the dispirited German press, saying:

"If Frederick the Great were here today he would say: 'You are suffering from cold feet and should be ashamed.' We are losing courage as though we had suffered a big defeat. Let's act like men."

HUNS AND TURKS HAVE NOT BROKEN

Friction Existing Is Increasing, but Nothing Occurred Approaching Open Rupture.

Washington, July 31.—(I. N. S.)—There has been no open break between Turkey and Germany, according to the best advices reaching this city today. The friction between the two countries is increasing, it is stated, but up to the present time there has been nothing approaching open rupture.

Turkey has served notice on Germany that she will not consent to German control of Thrace and the Baku region on the Caspian sea, which contains some of the richest oilfields in the world; but negotiations designed to settle this controversy have been halted as the result of the death of Hakkı Pasha, the Turkish ambassador to Berlin.

In the friction between Turkey and Germany officials see possibilities that will be of great assistance to the allies. However, it is not anticipated that there will be any developments which will lead to a future war. It has been rumored several times that Turkey had been "feeling out" Italy through a neutral power on the question of a separate peace, but these rumors have never been verified and are generally discredited.

Military Works at Pola Are Blown Up

Official Announcement of Bombing of Great Austro-Hungarian Naval Base Made Today—Presumably by Italians.

Rome, July 31.—(I. N. S.)—Military works in the harbor of the great Austro-Hungarian naval base at Pola, which have been bombed, it was officially stated today.

Fires were observed in the vicinity of submarines and aviation stations. It is presumed that the attack was made by airmen attached to the Italian army or naval forces, but the cablegram did not specifically say so.

Italians Surprise Enemy
Rome, July 31.—(U. P.)—An enemy advanced post in the Doane valley was surprised Sunday night, and its garrison captured, it was officially announced today.

In the Brenta valley on Monday night, after a violent artillery bombardment the enemy attacked in force against Cornone, the statement added. "We counter-attacked decisively, and after a brisk hand-to-hand fight repulsed our assailants, forcing them to retire. Machine guns, a flame-thrower and prisoners were captured."

"Yesterday our aircraft repeatedly and effectively bombed military establishments. Five machines were brought down."

Austrians Threaten Reprisals
Berne, July 31.—(U. P.)—Threats of air raid reprisals against the Italians for attacks on Austrian towns are contained in an interview with Vice Admiral von Nagebyva, published in the Pester Lloyd today.

"The Italians ought to desist from raiding Pola, Trieste and towns along the Dalmatian coast," he said, "they don't we are warning of reprisals."

Raiders on Venice are hinted at in the interview.

American Soldier Captures Brother

Kenosha, Wis., July 31.—Private Frank Hornac, an American soldier in France and former resident of Kenosha, went "over the top" recently in an attack on an Austrian unit and was dumbfounded to find himself face to face with a younger brother, an Austrian soldier, whom he was about to bayonet. He took the brother captive.

Details of the experience were given by Hornac in a letter received today by Kenosha relatives.

"We went over," wrote Hornac, "and were clearing out the trenches. I had just killed a couple of Austrians; another lunged toward me, the butt of his gun lifted. I was about to give him the steel when he cast aside his weapon and cried, 'Brother, brother!' It was my younger brother. He surrendered to me."

Federal Status For Mooney Case Asked

Washington, July 31.—(I. N. S.)—Headed by W. Bourke Cochran and Frank Morrison, secretary of the American Federation of Labor, a delegation of labor leaders called at the White House Tuesday to request President Wilson to take the Mooney case out of California courts and to place it on a federal status.

Cochran said a written memorial would be prepared and presented probably next week.

However, through a misunderstanding, no appointment had been arranged for and the callers were forced to leave without seeing the executive.

Gray Becomes Candidate
Newark, N. J., July 31.—(U. P.)—Representative Edward Gray of the Eighth New Jersey district today announced his candidacy for the United States senate in the Republican primaries in September. He will oppose Governor Walter Edge and George L. Record of Jersey City.

A dagger in his left hand has a half-naked woman pinned to the earth, and the right foreground lies another woman victim of Hun frightfulness. The right hand of the Kaiser grasps the end of an American flag, which he is trying to tear from its staff. Under the big sack also are three smaller sacks, graduated to represent by comparison the sizes of the first, second and third Liberty loans.

Potassium Deposits May Be Investigated
Washington, July 31.—(WASHINGTON BUREAU OF THE JOURNAL.)—Representative Sinnott has asked the bureau of chemistry of the department of agriculture to make investigation of the possible development of potassium mines in Baker county, Oregon, where there are said to be valuable deposits in a pyrite base.

He has also suggested to the geological survey that investigation be made of conditions at Fort Rock, Or., being informed by letters from that section that livestock must be slaughtered because of the shortage of water. It had been hoped that artesian wells could be developed in that vicinity with some measure of government aid, but in recent appropriations congress has declined to make provision for artesian well work and no money is available.

Second Fire Starts In Mill at Morton

Morton, Wash., July 31.—Monday night, for the second time, the sawmill of J. H. Richards of Morton burned. The fire is supposed to have started from refuse. All logging equipment was saved, and the only loss is a small amount of timber. Monday afternoon an incipient fire in the logging works of the West Fork Logging company is supposed to have started from a donkey engine. The crew quickly surrounded it and placed it under control.
