

PORTLAND GIRL IS KILLED BY CRAZED SOLDIER AT CAMP

Miss Lucile E. Warren, 20 Years Old, Daughter of Mrs. W. H. Warren, and Soldier Victims.

TWO SOLDIERS WOUNDED

Jealousy Believed Cause; Ax and Revolver Weapons; Tragedy Occurred at Camp Fremont.

San Francisco, Aug. 28.—(I. N. S.)—Miss Lucile E. Warren, 20, pretty Portland, Or., girl, and Private Lloyd Jewell of F company, Second Infantry, are dead today at Camp Fremont, near Palo Alto, while Private Morgan Williamson and Private Clarence Essex of the same company, are lying in the base hospital recovering from wounds sustained when Williamson, apparently crazed by jealousy over the girl, ran wild with an axe and rifle at the camp late Tuesday.

A board of inquiry, headed by Major H. C. Clement today began an investigation and, until it is completed, no official statement will be given out.

It is stated by soldiers in the company that Williamson was chopping wood as punishment for an infraction of camp rules when the girl passed. He is alleged to have felled Essex, who was guarding the wood choppers, with his axe and, grabbing up Essex' rifle, to have shot Miss Warren. Private Jewell, who also was a wood chopper, rushed up and was shot while trying to disarm Williamson, according to the stories told. Williamson then turned the rifle on himself. His wound is not serious and the injury to Essex is superficial.

Miss Warren, a daughter of Mrs. W. H. Warren of Portland, registered at the Stewart hotel here August 7. She told the hotel management she had been at Palo Alto since August 1. Letters from her mother found in her room demonstrated with her for allowing her self to be escorted on pleasure trips when "J." could not get leave. Another letter signed by the name C. J. Wilson, also from Portland, stated:

"You know you are always a lady with me, and anything I can ever do for you will be done, if you will let me

Dr. Solf Reported Slated to Succeed Count Von Hertling

Zurich, Aug. 28.—(I. N. S.)—Dr. William Solf, German colonial secretary and former governor of German Samoa, may succeed Count Von Hertling as imperial chancellor, according to a report received here from Berlin.

Dr. Solf is one of the leading members of the so-called "western school of political thought" in Germany, which is strongly opposed to the views and policy of the reactionary junker groups of "easterners" which contend that Germany's destiny is in the east.

The German colonial secretary is a liberal and has been charged with holding the views of a group of liberal pacifists.

Dr. Solf's appointment as chancellor could be construed only as the opening of an attempt on the part of the kaiser to seek some sort of peace by negotiation, or the effort to avoid continuance of the war to a complete German defeat.

Mrs. W. H. Warren, 4103 Sixty-third street Southeast, mother of Lucille E. Warren, killed at Camp Fremont Tuesday night, said today she had received no official notification of the tragedy. She had received a letter—"a bright, cherry letter"—from her daughter Tuesday, she said, and knew of no reason for the affair.

She said her daughter wrote frequently, since she went to California to work as a bookkeeper, and had told her in intimate detail what she was doing and whom she had met. Of the soldiers mentioned in the dispatch Mrs. Warren said her daughter had spoken of but one—Morgan Williamson, who is alleged to have done the killing.

"I cannot understand why Williamson should have done anything like that," said Mrs. Warren. "Lucille always spoke pleasantly of him. She said she had met him through a friend who had returned from Honolulu."

The idea that her daughter had a "love affair" with Williamson was scouted by Mrs. Warren, who said the girl "had no love affairs."

Later she said the man to whom she had referred in her letters as "J." was "a very dear friend of Lucille's, now a soldier in France."

"I will not say they were engaged," she said. "I do not know whether they were or not."

C. J. Wilson, mentioned as having written to the girl, is "just a friend," said Mrs. Warren. She said she did not know where Wilson was.

"I have not seen him since the war started, I think," she said.

Reports that her daughter had married the soldier Jewell were discounted by Mrs. Warren.

"I had not heard of it if she had," she said.

SENATOR JAMES IS DEAD; HAD BRIGHT POLITICAL CAREER

Lawmaker One of Most Popular Men in Washington; Beloved by All, Regardless of Politics.

HE WAS ONLY 47 YEARS OLD

General Nervous Breakdown and Other Ailments Contributed to Cause Death Early Today.

Baltimore, Md., Aug. 28.—(I. N. S.)—Senator Ollie M. James of Kentucky, who had been a patient at Johns Hopkins hospital in this city for several months, suffering from a general nervous breakdown and other ailments, died at 8:55 o'clock this morning.

Washington, Aug. 28.—(I. N. S.)—Ollie M. James was one of the most popular members of the United States senate. Of giant physique and striking personality, he was beloved by Democrats and Republicans alike.

He was a native of the state he represented in the upper house, having been born in Crittenden county, Kentucky, July 27, 1871. He received his education in the common and academic schools of the county, and then took up the study of law with his father, L. H. James, and was admitted to the bar when 20 years of age. From boyhood he was keenly interested in politics, and at the age of 16 served as a page in the Kentucky legislature.

Prominent at Conventions Senator James first attracted attention in the legal profession when he was one of the attorneys for Governor Goebel in his celebrated contest for Kentucky's gubernatorial chair.

At Democratic national conventions Senator James always was a prominent figure. He was a delegate to the convention at Chicago in 1896, and delegate from the state at large to the St. Louis convention in 1904, and to the Denver convention in 1908, and was elected chairman of the delegation to all three.

He made the speech seconding the nomination of William Jennings Bryan as a delegate at large from the state, and was elected permanent chairman of the Democratic convention at Baltimore.

In which he nominated Woodrow Wilson and made the speech notifying the president of his election. He was also permanent chairman of the St. Louis convention four years later when the president was renominated.

Senator James was elected to the fifty-eighth, fifty-ninth, sixtieth and sixty-first congresses, and reelected to the sixty-second congress. He was nominated for United States senator by the Democrats in Kentucky in the state wide primary July 1, 1911, to succeed Senator T. H. Paynter, and was elected by the legislature on July 8 following for the six year term beginning March 4, 1913.

Senator James was always a staunch supporter of the Wilson administration against the attacks of its opponents. His last speech in the senate was one in which he defended the administration's conduct of the war against the criticisms of Senator Chamberlain and other members of the senate military affairs committee. It was in this speech he described the president as "walking a tight rope over a sea of blood." "Don't shake the rope," he warned.

Senator James was the eleventh senator to die during the sixty-fifth congress. His death comes on the day set for the eulogies of the late Senator Newlands of Nevada in the senate. Flags above the capitol and the house and senate office buildings were lowered to half mast this morning, and will remain so until the Kentucky senator is buried.

President Wilson sent a letter to Mrs. James, expressing warmest sympathy.

Governor Stanley May Succeed James

Lexington, Ky., Aug. 28.—(I. N. S.)—Governor A. Owsley Stanley will succeed Senator Ollie James, it was announced today. He will have more than a year to serve before James' term expires.

Senator James is known to have requested that Governor Stanley take his place in congress. The Democratic control committee will meet soon to make the appointment.

Governor Stanley is a former representative, and conducted the steel trust investigation some years ago.

It is understood here, however, that Governor Stanley may not resign to finish out the term of Senator James. Late reports from Lexington only are to the effect that the governor will offer the place to Judge Robert W. Bingham, who recently purchased the Louisville Courier-Journal from Colonel Henry Watterson. Judge Bingham only a short time ago inherited \$5,000,000 from his wife, who formerly was the wife of Henry M. Flagler, Standard Oil magnate.

People of Lebanon Join in Holding of Big Patriotic Sing

Lebanon, Or., Aug. 28.—The patriotic people of Lebanon last evening joined in the singing of "America" and "Keep the Home Fires Burning" in keeping with the president's request. The songs were led by Mrs. E. E. Register, assisted by a chorus of voices. Lieutenant Gallagher of Montreal, Can., fresh from the trenches at the front, addressed the assemblage.

Ohio Republican Is For Prohibition

Columbus, Ohio, Aug. 28.—(U. P.)—The Republican party of Ohio went on the water wagon today.

The state convention voted a bone dry prohibition law into the platform over the opposition of the Cincinnati delegates. It also endorsed the federal woman suffrage amendment over the same opposition.

LUDENDORFF TRIES TO BOLSTER HUNS' WANING COURAGE

Circular, Letter Taken From Prisoner Shows Concern of Germans Over Soldiers' Morale.

AMERICAN ATTACK PRAISED

Statement Indicates Ludendorff Realizes Necessity of Defense and News Is Broken Gently.

By Bert Ford With the British Army on the Pegasus Battlefront, Aug. 28.—(I. N. S.)—In an effort to stifle the concern and depression of his troops, which has been caused by their recent defeats, General Ludendorff has issued another circular of assurance, a copy of which was found on a prisoner taken Tuesday by the British.

General Ludendorff gives the American troops credit for great courage during their attack in the Marne sector.

The circular in part reads as follows: "I have a feeling that in many quarters there is certain anxiety on the subject of the enemy's attacks. It is not justified if our troops are on the quiver and do their duty. In the great mobile defensive battle on the Marne and Vesle it was on the eighteenth of July that the French won their real tactical success."

American Attack Bold "During the subsequent days the French were unable, in spite of the use of a great deal of artillery, to gain any advantage of tactical significance. Although our troops were not drawn up in prepared positions but in the open ground, all of the enemy attacks broke down with the heaviest and most serious casualties."

"Our withdrawal was not the consequence of the enemy's tactical successes, but was due to our regard for connections in the rear."

"The French made their attacks only half heartedly. The Americans attacked more boldly but in clumsy formations. The enemy owes his success on the first day to tanks, but these would not have been dangerous if our infantry had not allowed itself to be taken by surprise and if the artillery had echeloned to a sufficient depth."

Defensive Practice Advised

"We are now holding, to a certain extent, very strong positions. We can await every hostile attack with the greatest confidence. As I have already pointed out, we ought to be glad if the enemy attacks, because by this method he will fritter away his forces sooner."

"In defensive fighting both officers and men must be imbued with the will to conquer as in offensive fighting. This is a very strong position. We can await every hostile attack with the greatest confidence. Military critics see in the last part of Ludendorff's statement a veiled realization that from now on the German army will be kept on the defensive. They believe that Ludendorff sent out these instructions to allay alarm resulting from such future tactics.

The bond is in the sum of \$7500.

Munition Workers Granted Increase And Concessions

Washington, Aug. 28.—(I. N. S.)—All workers receiving less than 75 cents an hour are granted increases; a minimum wage and basic eight hour day are established and the right of the workers to bargain collectively is upheld in the decision of the national war labor board in the controversy between employers and workers in 66 munition plants in Bridgeport, Conn. It was announced today.

The board established a minimum

wage of 42 cents an hour for all male workers 21 years old and over and 32 cents an hour for female workers 18 and over. Women doing the same work as men, however, are to receive equal pay and the right of the workers to affiliate with trade unions is upheld.
