

MEMBERS OF BOTH HOUSES HEARTY IN APPROVAL OF NOTE

Many Speak in Unqualified Indorsement of Stand Taken by President in Latest Message.

WORDS HELD MOST CLEAR

Senator Chamberlain of Opinion Unconditional Surrender Only Will Be Found Satisfactory.

Washington, Oct. 24.—The position taken by the president in his latest message to Germany is extremely gratifying to members of the senate and house generally.

Many were outspoken in their praise of its terms and gave it the most unqualified indorsement.

Senator Reed of Missouri:

I heartily concur in the president's position that if we are to deal with the military and monarchical masters of government at all, it must be on the basis of surrender. Of course, the message holds out an inducement for the German people themselves to overthrow these masters. I do not think they will do this in the immediate future, and my impression at this moment is that they will have to continue the fight until Germany is more thoroughly thrashed, up to the point of her surrender, as mentioned by the president.

Senator Overman of North Carolina:

It is the greatest note yet. It is frank and lets the German people know exactly how we stand. It is a surrender or abdicate. I do not see now there can be any possible misunderstanding of the president's policy.

Hitchcock Approves Note
Senator Hitchcock of Nebraska, chairman of the senate committee on foreign relations:

That certainly sounds straightforward and satisfactory. The answer certainly fills the bill. I am confident it will meet with the approval of the allies, and that it will be accorded complete and strong support by the American people.

Meets Situation Squarely

While we may have some difficulty in understanding what the German notes to us mean, the German surely cannot have any difficulty in understanding what the president's notes to them mean.

There can be no question about the answer squarely meeting the situation, and its wholehearted approval by the public, I believe, is bound to follow.

Senator Shields of Tennessee:

Inasmuch as I am a member of the committee on foreign affairs, I would not like to express an opinion before reading the text of the president's reply. My position has been, and still is, however, that we should stand out for unconditional surrender, and that there should be no armistice while German forces are on foreign soil or in a position to renew the war.

Can't Trust Rulers

Senator Pomerene of Ohio:
The message is fine. It is quite plain that we can place no faith in the present rulers of Germany. I

think it is best that the fighting should go on until the Germans have unconditionally surrendered. A premature peace would be very disappointing, and the feeling is very general that, if the war is not fought out to a complete surrender, it will have to be battled out in the near future.

Senator McCumber of North Dakota:

I am delighted with the president's reply. He has brought the peace correspondence to the point we all have felt should be its result—a demand for unconditional surrender.

Nothing now can bring peace but that Germany place herself in the same position as Bulgaria and trust that the United States and the allies will exact nothing but what justice should demand. The note is a finality; when Germany surrenders, then, and then only, can we talk peace.

Germany Not Ready for Peace

Germany is not ready for peace yet. The latest utterances of her chancellor, Prince Max, have been defiant in reference to Alsace-Lorraine, to wanton destruction and atrocities at sea, and even went so far as to prate of liberalizing the German form of government, so as to give control to the people, after not before, but after—peace comes.

President Wilson's note should put an end at once to Germany's attempt to gain time for retreat to her own borders and reorganize.

Senator Thomas of Colorado:
This may turn out to be in effect a reference of the whole matter to Marshal Foch, as I advocated a few days ago, when the German note was published.

My impression is that the war will

go on. I cannot see how there can be any dealings with the Kaiser or the Hohenzollern regime, except as the result of surrender, according to my understanding of the president's language. It looks as though the Kaiser would have to go in any event.

Chamberlain Gives Approval

Senator Fletcher of Florida:

The president's note covers the ground fully. As I understand it, he demands complete evacuation and the laying down of arms and in addition that the form of the German government be changed. The note should be regarded as satisfactory by both liberals and conservatives in all the allied countries.

Senator Nelson of Minnesota:

The entire matter should be left in the hands of Foch, Haig and Pershing. If an armistice is granted they should grant it, and only they should state the conditions on which it is to be granted.

Senator Chamberlain of Oregon,

chairman senate military affairs committee:

The president's note may fairly be construed as a diplomatic demand for unconditional surrender, leaving to the military authorities of the allies entirely the adjustment of methods of evacuation of all occupied territory and arranging for such terms to be imposed upon the conquered as will make it impossible after surrender—for the German government and its allies to violate the peace of the world.

Two Words Called Judgment

The president very properly serves notice upon the military autocracy that he has no confidence in the Kaiser or any of those associated with him, but that if any terms are hereafter agreed upon that agreement must be with representatives of the people themselves rather than with the ones who have been accustomed to look upon treaties as scraps of paper unworthy to be observed if it suits their purpose to violate them.

I do not believe the president nor the allied authorities will be satisfied with anything short of unconditional surrender, and think the president makes that point perfectly plain in his note, leaving to General Foch and the allies' commanders the adjustment of the terms of any armistice that may be entered into to prescribe the course that must be followed by the German armies.

Chairman Fess of Ohio congressional committee:

The judgment of the American people has been announced in two short words, "unconditional surrender." Nothing has taken place to modify this demand.

Railroad in Baker Accused of Asking Unlawful Rates

Salem, Oct. 24.—The public service is proceeding in the circuit court for Baker county against the Sumpter Valley Railway company to compel that company to obey the orders of the commission relative to freight rates.

This action of the commission will be based upon an affidavit of the Baker White Pine Lumber company showing that the railroad company is still charging a 25 per cent increase in all freight rates when such increase has not been allowed by the public service commission.

The railroad company is said to be making an effort to get back under federal control and in the meantime it ignores the authority of the public service commission.

Frank J. Gould Asks For Divorce From His Second Wife

New York, Oct. 24.—(I. N. S.)—Frank J. Gould, youngest son of the late Jay Gould, has started divorce proceedings against his second wife, Miss Edith Kelly, according to reports received here from Paris by his friends. Incompatibility of temper is understood to be the grounds for the action.

At the time of her marriage to Frank Gould, Miss Kelly was a well known actress and had appeared in leading parts in "Havane" and "The Girl of Gottenberg." The marriage took place in 1910, a year after Gould was divorced from his first wife, Miss Helen Margaret Kelly. Mrs. Helen Kelly Gould later married Ralph T. Thomas of New York, who died, and then married Prince Novredin Viora, an Albanian nobleman.

WOUNDED MAN ON WAY HOME AFTER YEAR OF WARFARE

Lieut. Herman L. McLeod, With U. S. Marines at Chateau-Thierry, Lands in New York.

HAS LIVED THROUGH HELL

With Serious Abdominal Wounds, Plucky Officer Lives in Spite of Boche Bullets.

Lieutenant Herman L. McLeod, United States marines, who has been in France for more than a year and who has been so seriously wounded that the doctors consider it miraculous that he is alive, has arrived in this country. His parents, Mr. and Mrs. John McLeod, 181 Eleventh street, this morning received a telegram from New York, announcing his safe arrival and saying he would be home in a week or 10 days.

Lieutenant McLeod was in the battle of Chateau-Thierry and received a spinal wound from which recovery is very slow and which has left him with an unnatural gait. He suffered 11 internal punctures and one liver puncture, a shattered rib and other wounds.

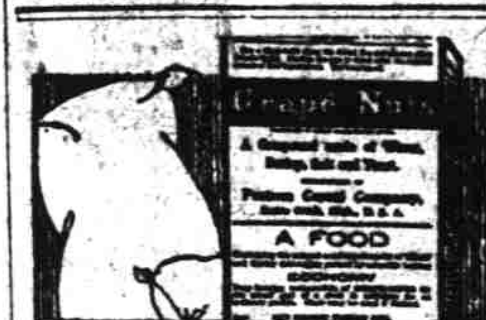
His last letter to his parents, bearing the date of September 24, was as follows: "I am coming home to you. I left Vichy two days ago and am on my way, but it is hard to realize when I think of the hell I have lived through for the past year and the number of times death has scared me in the face. Our Thanksgiving dinner will be together this year. My last one was here and I haven't any pleasant recollections of it. When I get back to the states I will be sent to a hospital, because I have to have another operation on my spine. I want to warn you not to expect to see a straight, soldierly man when you see me, because I am all broken up and battered to pieces and I have an awful walk."

"I am wearing another decoration given by the French general. I will be all covered with decorations and gold stripes when I get back. I have two gold stripes on my left arm showing that I have been here in the service for a year and one stripe on my right arm for my wound. My nurse said the stripe wasn't big enough for the wound I got. I didn't want to go back to the states as long as the war lasted, but I am not any good now, but I hope I will be well enough to return by spring."

The note was addressed to Kilgore's daughter, Hazel, and son, Billie, expressing his love and bidding them goodbye. It is said that Kilgore had been having trouble with his wife and that the two had parted last Monday.

According to Inspector Mallett, Kilgore sold a complete set of carpenter tools to a South Front street second-hand store for \$27.50, told the dealer of his trouble and said that he intended to go away. City Grappler Brady dragged the river Wednesday afternoon, but found no trace of Kilgore.
