CONGRESS PREPARING LAWS

Immigration Commissioner Favors Registration of Aliens With a Semi-Annual Reporting System

Washington, June 6.—(U. P.)—The word is being passed through "Red" circles for a demonstration on July 4, government officials here have been informed, it was learned today.

According to these reports the "May day" outbreaks, the June 2 bomb outrages and the proposed demonstration July 4 constitute a progressive series of demonstrations against the government as a result of very precautionary measure is being taken by officials to thwart the "Reds" in so far as the existing laws permit.

Congress is preparing legislation to further the government's campaign against the menace.

Commissioner of immigration Carnie, who favors registration of all aliens in the country, has conferred with Chairman Johnson of the house immigration committee, on the Johnson immigration bill, one provision of which stipulates that strict records of all aliens be kept by a federal registration system.

All aliens would register with the government under the bill and report twice a year.

ANARCHISTS JUST ARRIVED FROM EUROPE ARE SUSPECTED

Philadelphia, Pa., June 6.—(U. P.)—The possibility that anarchists newly arrived from Europe had a prominent part in the explosion of bombs in several cities Monday night was under investigation by federal agents and the Philadelphia police today.

It was learned from the secret service men who came here from Washington that a purse picked up on the lawn of the home of Attorney General Palmer the day following the explosion at the Palmer home has given them an important clue. The purse contained a note written in French, stating that the bearer had just arrived in New York from France, and naming the boat on which he was a passenger. The purse also contained French and Italian stamps. Leather experts said the purse was made in France.

Inside the wallet was also a picture of a boy about 9 years old. The boy's hair apparently was of the same color as that of the anarchist killed at the Palmer home and federal agents believe the boy is the son of the dead man. The French consular authorities in New York have been asked to find out whether the man actually arrived on the steamer indicated.

VANCOUVER HASTILY REPEALS ITS ANTI-JITNEY ORDINANCE

Vancouver, B. C., June 6.—(U. P.)—The ubiquitous jitney, legislated off the streets by the city council under pressure from the British Columbia Electric railway, today is affording Vancouver citizens their only means of locomotion. Hardly had the street cars disappeared before the jitney driver reasserted his flivver and all day Thursday piled to and fro, transporting hundreds of workers and women shoppers.

Thursday evening the city council repealed the jitney restrictions and all car owners are now legalized to operate at will. The council asks that a maximum fare of 10 cents be paid.

Labor leaders strenuously object to the jitneys and threaten to stop the supply.

Expect to Establish Identity

Washington, June 6.—(U. P.)—The identity of the anarchist who was decimated in an attempt on the life of Attorney General Palmer was expected by Washington officials to be cleared up by arrests in New York today. Although efforts to identify the man here have proved futile, government agents indicated today that developments in New York would go a long way toward clearing up the plot. The arrest in that city of a group of Spanish and Italian anarchists was expected, they said.

PREPARING PLANS FOR BIG STRIKE

It was impossible to compile any definite statement regarding the strike's effect before this afternoon.

Many striking telegraphers are reported being employed by the Postal Telegraph company to handle telegrams delivered to that company by business concerns and individuals.

Reports from union sources to Mann were declared by him to show the following condition:

At Winston-Salem, N. C., all operators were declared with 90 per cent reported out at New Orleans. The entire forces at Tampa, including some chiefs, at Knoxville and at Spartanburg, S. C., were given out. The offices at Moultrie and at Rome, Ga., were reported to be closed. Seventeen of the 21 men at Birmingham were reported to have quit. Nineteen men are said to have struck at Savannah.

The order for a general walkout in all southeastern states was issued late Thursday afternoon by International President S. J. Koenekamp of the Commercial Telegraphers' Union and Telephone Operators' association. Replying to a telegram sent last night to International President S. J. Koenekamp of the Commercial Telegraphers' Union, asking if both sides would agree to submit adjudication of the Atlanta telephone controversy to a local tribunal, Mayor Key today received the following telegram from Koenekamp:

"The nationwide strike is based upon nationwide grievances of long standing, of which the Atlanta controversy is a subsidiary. It is impossible to settle locally. We are not opposed to an adjustment at the hands of any fair tribunal if the employers will abide by the decision. Months of effort along these lines have failed to bring about a peaceful settlement. I appreciate your efforts to help solve the problem and assure you of my earnest hope that it will be found possible to reach a fair and equitable settlement. More than 100 strike breakers were brought to Atlanta to take the place of the striking union operators. As soon as H. C. Worthon, general manager of the Western Union throughout the country, had been turned back to private ownership he expressed great pleasure.

"The Western Union is very, very glad that it will be possible to reach a fair and equitable settlement. A full and clear hand to fight to finish, and the public can trust that we will do it. Business will continue to be normal."

IT'S FIGHT TO THE FINISH IS KONEKAMP'S WORD

Washington, June 6.—(U. P.)—President S. J. Koenekamp of the Commercial Telegraphers' Union of America, today declared Postmaster General Burleson's order restoring control of the wire companies to their owners means a "finish fight" between the telegraphers and the Western Union throughout the country.

"Wire control," Koenekamp said, "was made necessary by the Western Union refusing to reinstate unjustly discharged employees and to accept the proposals of impartial authorities. Postmaster General Burleson, by his action in returning the wires, shows himself a quitter. He has accepted the Postal men's problem which made necessary the original seizure of the wires by the government. We now find ourselves returning to the status quo ante and forced to fight it out."

Immediately upon notification that Burleson had ordered control of the wires returned to the Western Union, Koenekamp authorized a strike of Western Union telegraphers throughout the southeastern states.

"I am informed that 100 per cent of the men are out at New Orleans," Koenekamp said this morning, "and highly satisfactory word comes from the entire southeastern section of the Postal men, and others, however, want to go out also. It will be impossible to hold them in much longer. It is certain that the strike will spread throughout the country."

Electrical workers throughout the country have set June 16 as the date upon which they will leave their posts and it was regarded likely that Koenekamp will select the same day, or the day before or after for the nationwide telegraphers' strike.

But possibly it may come sooner, he indicated today.

Administration officials were keeping in close touch with strike developments. That President Wilson will take a hand was believed likely here. If he does act, labor leaders believe he will refer the trouble to the war labor board, removing it from the jurisdiction of the postoffice department. This would be satisfactory to Koenekamp, he says.

"The most of the whole matter is that we can no longer believe anything Burleson promises," said Koenekamp today. "He never keeps his promises."

CHANGE IN FOOD CURB DISCUSSED

Germans Said to Have Received as "Partially Satisfactory" Treaty Modifications.

Paris, June 6.—(U. P.)—Amplifications are being planned for the peace treaty by which the exact amount of Germany's war indebtedness will be known by November 1. It was learned from allied sources today.

Another conference was held by the experts of the allied and associated powers at Versailles to consider possible changes in the clauses dealing with economic restrictions. WORK SPEEDED UP

The German experts are reported to have taken the position that the changes already are "partially satisfactory."

The work of drafting the reply to the German counter proposals is being carried out with all possible haste with the various groups of experts contributing data.

President Wilson and Premier Clemenceau are said to have framed most of the preamble which will carry the rejection of the German proposals.

HUGO HAASE SAYS GERMANY CAN'T AFFORD NOT TO SIGN

Berlin, June 6.—(U. P.)—Hugo Haase, leader of the Independent Socialists, declared in an interview today that Germany should sign the peace treaty, regardless of whether she can obtain any modifications.

"Personally, I believe the German delegates should do their utmost to secure modifications, but they should sign in any event," Haase said. "It is more disadvantageous for Germany not to sign than to accept the treaty even in its present harsh form."

Haase said he saw small chance of the Independent Socialists taking over the government unless the workers generally demanded it.

"If all join in demanding a real Socialist government, then I believe all the Socialist factions will unite to form an coalition government," he said, "but such a movement would not be attempted by force."

At the time he had heard rumors of a plan to attempt to overthrow the government June 7, but said that investigation proved the rumor false.

BIG FOUR GET TOGETHER ON PEACE TREATY CHANGES

Paris, June 6.—(U. P.)—British and French delegates through American intercession were reported today to be approaching an agreement on the degree of modification of the German peace treaty which will embody the proposed changes in the terms probably will result in some concessions by both groups, the French receding from their previous stand of opposing all modifications with the British agreeing to abandon most of the alterations recently advocated by them.

The reply to the German counter proposals which will embody the proposed modifications is now expected to be ready for presentation early next week.

Arrest of Rhinelanders Delayed

Berlin, June 6.—(U. P.)—(Via London, June 6.)—Indignity recommendations of leaders who formed a new republic in the Rhineland have been held up by the government pending the reply of Marshal Erzerberger, chairman of the German armistice commission. Arrests would be impossible without the sanction of the allies as allied forces occupy the territory where the separatist leaders are living.

Erzberger Now Advocates Signing

London, June 6.—(U. P.)—Dr. Matthias Erzberger, head of the German armistice commission, after a prolonged discussion of the peace terms, is now advocating signing of the treaty, said an Exchange Telegraph dispatch from Berlin today, quoting the Deutsche Tageszeitung. Erzberger was being opposed to signing the treaty.

According to testimony of Newcomb Carlton, Western Union president, before house and senate committees, the transition back to private control will mean a complete change, so far as the public will be aware, in the conduct of the business. Carlton said he had been permitted to run the business just as before the war.

ESCH THROWS OUT HINT

Representative Esch, chairman of the house committee on interstate and foreign commerce, in announcing his committee would meet today hinted that Burleson appeared to be trying to "get out from under" the wires.

"At first hand it looks like Postmaster General Burleson wants to avoid the difficulties that now confront the companies," Esch said.

"The most important thing to determine is how the postmaster general's higher rates will affect efforts of the public to obtain lower ones through their utility commissions and legislation is needed so that clear authority is given the commissions to adjust rates as soon as the lines are completely returned to private control."

Members of the committee seem to favor some fixed adjustment period. First assistant Postmaster General Koons suggested a year, but other witnesses stated three to six months would be sufficient. The senate bill provides 60 days.
