GREAT FLORAL PAGEANT COLORFUL

OVERSEAS MEN ADD HEROIC TOUCH TO FESTIVAL PAGEANT



FLORAL PARADE FITTING CLIMAX TO PORTLAND'S FESTIVAL CELEBRATION

Gaily Decorated Vehicles Make Spectacular Display as They Wind Their Way Through Down Town Thoroughfares

Goddess of Victory Makes Her Last Appearance in Public—Ball Tonight Will Conclude the Week's Great Festivities

FESTIVE Portland was transformed into a grand fairyland of flowers, beautiful in their richness and remarkable for their splendid symbolism, when the great floral pageant that closes the demonstrative features of the Victory Rose Festival started upon its way about the streets of the city shortly after 2 o'clock this afternoon.

Great blankets of colorful roses, masses of a thousand varieties of spring flowers, arranged in odd and attractive shapes, here and there woven into words, made hundreds of automobiles veritable fairy bowers.

Private machines, burdened under their inspiring loads of Oregon's choice blooms, made up most of division 4, section 4. Ruth St. Denis and her pretty entry were attractive. A motor squad of Rose Festival officials was featured.

Following the section came the fine representation of public schools and Sunday schools, with thousands of pupils participating. As usual, the high schools entered gorgeous floats.

Much interest was manifested all along the route in the section, featuring Red Cross canton girls and the Red Cross band. The units made a wonderful showing.

KILLIES BAND APPEARS Clubs, business firms and societies competed closely with one another for honors from a standpoint of beauty, and representation and civic organizations, together with public corporations represented, fairly outdid themselves with beautiful creations on wheels.

The last section in the long line of march was that led by the popular Killies band, and included gaily decorated motorcycles and bicycles.

Union Secretary Is Indicted on Larceny Charge

HILLSBORO MAN IN GOTHAM SENSATION

Officer Who Elopes With Heiress Well Known in Former Home; Father Was Prominent.

Hillsboro, June 13.—There is no question that the Captain William Barrett, who lately eloped with a married Alice Gordon Drexel, New York and Philadelphia heiress, is the William Barrett who was born and raised in Hillsboro. Young Barrett is the son of the late W. N. Barrett, state senator at the time George E. Chamberlain was elected United States senator. He afterwards served as mayor of Hillsboro, and prior to his entry in legislative channels was district attorney.

The senior Barrett's first great grief came after the son, now Captain Barrett, returned to the coast. Young Barrett, then fresh from Annapolis, arrived in San Francisco and put up at one of the popular hotels. Being possessed of youth he found entry into San Francisco's best society circles and was soon frequenting the homes of rich and influential families. He represented that his father was rich and, on the strength of his statements, was sold \$3000 worth of jewelry.

Barrett promised to pay for them as soon as the money came from Oregon. He was later arrested and the father was taken to San Francisco and squared the account. The elder Barrett then welcomed the boy home. Young Barrett drifted to Tacoma and eloped with the daughter of Alexander Bailles, prominent socially in the sound cities. They came to Hillsboro to reside and remained nearly a year, where young Barrett made a pretense of studying law with his father. The humdrum of country life, however, did not appeal to the lad, and he moved to Portland. He was unable, having no carrying capacity, to give his wife and child the comforts to which she had been reared, and a separation soon followed.

Mrs. Barrett went to California and procured a divorce, and "Diamond Willie," so called because of the San Francisco diamond episode, left for the East.

Barrett's brother, Dr. Ira Barrett, is a practicing physician in Montana. After the separation of the William Barrett, no further news of the young man was heard until it was learned that he had joined the national army as a lieutenant in the signal corps and had gone to France.

The mother is in Montana at present visiting Dr. Barrett.

With her is the youngest son, about 12 years old.

Japanese Warships Rush to China to Protect Interests

Tokio, June 13.—(I. N. S.)—The Japanese cruiser Shama and the gunboat Hage have been rushed to Wu-Hu and Shanghai to protect Japanese interests against a boycott inaugurated by the Chinese, who are demanding an annulment of the peace conference decision, granting the Japanese territorial rights of Shantung peninsula.

Another warship has been sent to Canton. The anti-Japanese agitation is reported to have spread to Hankow and Nanking.

Chinese Officials Resign
Washington, June 13.—(U. P.)—Anti-Japanese feeling in China over the Shantung settlement and other questions has resulted in the resignation of the Chinese minister to Japan, Chang Chung-Hsiang, and other high officials, the state department announced today.

Peking is reported quiet. In Shanghai, Chinese are boycotting Japanese goods, and wearing badges proclaiming their attitude.

OLCOTT'S STATUS STILL PERPLEXING

Agreed on That He Is Governor in Fact, Appointment of Successor Perturbs.

8 DAYS WILL BE GIVEN FOR Foe's Reply

Orlando, Regarding Treaty Work as Finished, Goes Back to Rome; Radical Change Made.

Paris, June 13.—(U. P.)—The big four today completed their answer regarding the section of the counter proposals covering the armies of occupation. The answer, it was said, makes important changes in the treaty.

The personnel of the commission includes: Hudson, United States; Kerr, Great Britain; Tardieu, France; Vanutilli, Italy, and Sabourin, Japan.

A semi-official French note today said the reply will be handed to Foreign Minister Brockdorff-Rantzau either Sunday evening or Monday morning, with an eight-day limit for the Germans to sign.

Baron Makino was said to be insisting that discussion of the reply continue through today and tomorrow, owing to the decision reached yesterday to incorporate the changes in the text of the treaty instead of making them mere supplements. This would mean the reply could not be delivered before Monday or Tuesday. The important question of the left bank of the Rhine had not been settled when the council met today, it was reported.

Washington, June 13.—(WASHINGTON BUREAU OF THE JOURNAL.)—Senator McNary today stated that Senators Borah and Kenyon had no authority to speak for him when they announced that progressive Republicans in the senate were united in support of Hiram Johnson for nomination for president.

"I was not consulted on that," he said. "I will not support any man for nomination who is unalterably opposed to the League of Nations."

Over 150 Soldiers of Carranza Faction Killed in Wreck

Laredo, Texas, June 13.—(U. P.)—Between 150 and 200 Carranza soldiers were killed Wednesday near Aguas Calientes, Mexico, when a troop train carrying reinforcements to the Carranza garrison at Juarez from Mexico City via Chihuahua, was wrecked, according to the Monterey newspaper, El Porvenir, reaching here today.

It is not known whether bandits were responsible for the wreck. Scores of soldiers were severely injured, the newspaper said.

The troops were in command of General Rentorilo Luviana.

Treaty Withheld Till It Is Signed, Asserts Lansing

Paris, June 13.—(I. N. S.)—Secretary of State Lansing, at the direction of President Wilson, has notified the separate foreign relations committee that he is at present unable to comply with the senate demands for a presentation of the peace treaty with Germany, inasmuch as the document is not yet signed.

He added that the treaty has not been placed before any legislative body and will not, until it is signed.

HELLO GIRLS OF COAST TO QUIT MONDAY

Organizer in San Francisco Says He Has Received Definite Orders for Strike of Operators.

San Francisco, June 13.—(I. N. S.)—Thomas E. Robbins announced here today that he had received definite orders from the executive board of the International Brotherhood of Electrical Workers for the telephone strike on all lines of the Pacific Telephone & Telegraph company on the Pacific coast. The strike order is effective Monday morning at 8 o'clock.

Robbins is a general organizer for the electrical workers, and says that the workers on the coast are "100 per cent organized."

A break in the ranks of Western Union operators is expected soon, according to P. C. O'Connor, president of the local Telegraphers' union.

Three men have voluntarily joined the forces of the strikers since yesterday and a poll of 40 operators indicated that a break is certain, O'Connor said.

The crisis of the strike, union officials say, will come Monday, when the electrical workers are scheduled to walk out. The refusal of railroad operators to handle Western Union and Postal business has greatly strengthened the cause of the unionists, they declare.

A meeting of striking telegraphers and operators is expected Monday.
