

FORGE IN GIRLS' PROBATION DEPT. LET OUT BY JUDGE

Discharged Employes May Unite In Suit to Test Kanzler's Right to Seat in the Court.

BETTERMENT IS HIS EXCUSE

Mrs. Whiting, Mrs. King, Mrs. Mallett and T. B. McDevitt Are Those Who Must Quit.

Discharge of practically the entire force connected with the girls' probation department of the juvenile court was effected Saturday by Judge Jacob Kanzler of the court of domestic relations. That this action might hasten the bringing of a suit to test the validity of the act by virtue of which Judge Kanzler sits was forecasted freely at the courthouse. It was said that the discharged employes would join in such a suit.

Their contention is that, if an act is unconstitutional, as has been declared by District Attorney Walter Evans, they cannot be discharged legally, except by Judge Tazewell, who as judge of the previous juvenile court, appointed them.

The employes who were let out are: Mrs. Della C. Whiting, chief probation officer of the girls' department; Mrs. Sophie E. King, assistant probation officer; Mrs. Mary Mallett, assistant probation officer; and T. B. McDevitt, assistant probation officer in the boys' department.

Kanzler announced the following new appointments: To be acting chief probation officer of the girls' department, Mrs. Pringle, formerly of the attendance department of the public schools; to be assistant probation officers, Mrs. Kate H. Maguire and Mrs. Eva Pillsbury, formerly of the Woman's Protective division of the police department.

The new appointees, as well as the discharged officers, were all confirmed as qualified for the positions by the child welfare committee.

Appointment of William S. Hale as assistant probation officer for the boys' department was announced several days ago. Resignation of Miss Mary A. Kelly, head of the home placing department for girls, was also accepted Saturday by Judge Kanzler.

Concerning his new appointments, Judge Kanzler said they were made only for the betterment of the department, and that he had no criticism to make of the officers who were being let out.

FUNERAL OF HUSBAND OF SENATOR LANE'S DAUGHTER ARRANGED

Dr. S. D. Hicks, Richmond, Va., Specialist, Died of Heart Trouble During Auto Ride.

Richmond, Va., Sept. 20.—The body of Dr. S. DeLaucay Hicks, well known specialist, formerly of Norfolk and Washington, who married Miss Harriet Lane, a daughter of the late Senator Harry Lane of Oregon, was brought here today from Bethel, Conn., for burial in Riverview cemetery tomorrow afternoon, accompanied by his wife whom he married in Baltimore shortly before this country went to war with Germany.

Dr. Hicks left here recently on a motor trip for Bethel to visit his sister, Mrs. Isaac McBride, formerly Miss Nana Lane, whose husband, an artist and author, is now in Switzerland gathering material for a new book. Dr. Hicks drove the car himself and overtaxed his heart which had been giving him trouble for some time. He was stricken ill soon after his arrival there and died in a few hours.

His widow's mother and sister accompanied her to Richmond with the body. The burial services will be conducted by the Rev. G. Freeland Peter of St. James Episcopal church.

Primarily of Washington, Dr. Hicks came of an old Virginia family. Before he met Miss Lane, he served for a while as a surgeon in the French army and the western front.

Dr. Hicks' widow was Miss Harriet Lane, younger daughter of the late senator. They were married in Washington in December, 1916, and went to live in Norfolk, Va., shortly afterward moving to Richmond.

Dairymen Oeclare They Must Receive 35c Hundred More

An announcement that dairymen must receive \$2.85 a hundred pounds for milk beginning October 1 has come from the Oregon Dairymen's league. This is an increase from the present rate of \$3.50 a hundred. The league expresses, however, the conviction that an increase in the price paid by consumers to dealers is not necessary and should not be ordered.

It is pointed out that \$3.85 a hundred pounds to producers was the price recommended by the Portland milk commission and adopted on October 1 last year. The price received then by the dealers was fixed at 14 1/2 cents a quart if paid in advance and 15 1/2 cents a quart if paid after the middle of the month. When the dairymen in the spring voluntarily dropped their price to \$2.20 a hundred pounds, the dealers reduced their price to 13 1/2 and 14 1/2 cents a quart. When the producers made another voluntary reduction to \$3 a hundred pounds during the grass season, the dealers made no reduction.

When producers increased their price to \$3.50 a hundred pounds July 1, the dealers reestablished the scale of 14 1/2 and 15 1/2 cents a quart. A price of \$2.85 a hundred pounds is about 7 1/2 cents a quart, says the dairymen. This leaves between 7 and 8 cents a quart to pay the dealers for delivering the milk after the milk involves pasteurization, bottling and transportation.
