

KRAEMER ELECTED AS PRESIDENT OF HUMANE SOCIETY

Portland Attorney, Who Has Long Been Prominently Connected With Cause, Honored by Board

MANAGERS TO BE PICKED

New Executive Succeeds Albert Cowperthwait, Resigned; Society Plans for Active Work.

Otto J. Kraemer, prominent Portland attorney and member of the Humane society for over 20 years, was chosen Thursday as president of the organization at a closed session of the board of directors, to succeed Albert Cowperthwait, who resigned on request. The new president will complete the unexpired term between now and the annual meeting in March, 1920.

The resignation of L. D. Norris, humane officer, was accepted, to take effect November 1. Candidates for this position were not announced to the press.

These changes in the executive personnel of the Humane society are the result of charges recently preferred against Cowperthwait and Norris.

TO EMPLOY MANAGER
As a result of Cowperthwait's resignation, the position of manager is also left vacant, and several names are being considered as candidates.

Mrs. F. W. Swanton, secretary of the Oregon Humane society, said: "The directors are determined to get a general manager who will not only be a good business man, but who will be intellectually able to reach out and grasp the big work the society ought to do. We want a man who is capable of hiring the proper kind of officers to carry out the plans of our society, and we expect to pay whatever salary is needed to get a thoroughly qualified man."

"Last year \$100,000 worth of livestock was lost to the farmers of this state through neglect. We want to do for Oregon what has not yet been done. We intend to bring about a decrease in such losses. Our work is not sentimentalism. Sick cats and dogs are the least of our duties. That is why we intend to take our time and get the kind of general manager we want."

KRAEMER STATES VIEW
Kraemer will actively take hold of the affairs of the organization, but he does not intend to make any radical changes that are not impelled by necessity.

"The personnel of the present board is excellent," he stated, "and everyone has promised to assist me. We will carry out the object of the society as best we know how."

During the recent controversy the sessions of the board were closed to the public and the press, as the board believed was necessary, owing to the delicate situation. At Thursday's meeting it was announced that henceforth sessions be open to general attendance of those who are interested.

GOMPERS SUMMONS LEADERS OF LABOR

an early date to deal with several of the subjects contained in your telegram."

Organized labor is to join forces with the farmers.

This is one of the results of the defeat of labor's program in the industrial conference.

A meeting of representatives of the American Federation of Labor, the four big railroad brotherhoods and the Farmers' National council will be held either in Chicago or Washington next month, it is announced. The meeting will effect a powerful alliance between farmers and workers to reduce the cost of living and to formulate a general economic and political program that will include government ownership of the railroads and coal mines, government control of the packing industry along lines suggested by the federal trade commission and a democratic financing of war by increased taxation of big incomes.

MILLIONS ARE AFFECTED

The proposed alliance would include 4,000,000 workers and 750,000 farmers. Among the farmers' organizations which will take part in the meeting next month are the Non-Partisan league, the National Gleaner federation and state grain growers' associations.

Organized labor will cooperate with the farmers to reduce the cost of living by eliminating the middleman through the establishment of government-controlled central wholesale markets and by throwing open as public places privately owned plants and warehouses necessary to provide facilities for competitive marketing.

The farmers will help labor to establish collective bargaining and the other principles for which it fought in the president's industrial conference.

FIGHT TO FINISH SEEN

The proposed call of the conference of union heads by Gompers was taken here to mean that organized labor is tightening its ranks for a fight to the finish in the steel strike as well as in other industrial conflicts now in progress or threatened.

In leaving the industrial conference Wednesday, following defeat of the collective bargaining resolution, Gompers said:

"You have defeated the labor group in its declaration, but we will meet you again in conference, and when we do meet you there you will be glad to talk collective bargaining."

Gompers has also announced that contributions from labor organizations will be asked to support the steel strike.

As Gompers' telegram went out, miners and railroad men were planning a meeting with view to forming an alliance with those two unions.

It was also learned today that the four railroad brotherhoods are considering joining the American Federation of Labor.

DR. PARRISH ORDERS THAT ALL NEW CASES GO TO ST. VINCENTS

City Health Officer Says Good Samaritan Hospital Overcharges Municipality.

All emergency cases will be taken to St. Vincent's hospital and none to Good Samaritan, according to peremptory orders issued today by city health officer George Parrish. Parrish declares Good Samaritan overcharges the city, while the hospital management says its bills are made according to contract and that the health department even cuts off legitimate charges.

"In the future, the health department desires that all emergency cases of every description be taken to St. Vincent's hospital," Dr. Parrish's order reads.

"The bureau of health will neither pay the bills nor be responsible for those cases which go to Good Samaritan hospital."

Miss E. L. Loveridge, superintendent of Good Samaritan, declares that the last bill rendered to the city came back out beyond recognition.

"Items the city paid the two previous times were disapproved this month," she said. "I don't know why. We don't believe the city should be an object of charity, so we said we weren't anxious to have its business."

a tailor trying to make a new garment out of an old suit of clothes.

He liked to work with new cloth, he said, but declared that the old garment might be used as a pattern.

As a result of this feeling, the group may ask President Wilson to give it a fresh start as an industrial peace conference by reorganizing it and giving it a new name.

Approximately 500,000 workers now are engaged in striking, estimating the steel strikers at 200,000. About 300,000 harbor workers, machinists and other workers are also out. Approximately 1,500,000 men are threatening strike or pressing for higher wages.

COAL STRIKE LOOKS

These include 500,000 miners now under orders to walk out November 1 unless a settlement is reached in mediation now being conducted here by Secretary Wilson of the labor department.

More than 1,000,000 railroad workers are preparing to reduce their demands for increased wages, believing that the government has made little progress in reducing living costs.

November 1, it is believed, will bring a climax in the whole industrial situation. And Rockefeller Jr., who achieved a reputation for studiousness in the conference meetings, is sitting on the lid. It was phrased here today.

ROCKEFELLER'S PLAN HELD FAILURE IN HIS OWN PLANT

Pueblo, Colo., Oct. 24.—(U. P.)—With the framing of industrial peace in the hands of J. D. Rockefeller Jr. at Washington, 5,000 employees in his steel plant here have been on strike since the opening day of the nationwide steel workers' walkout. In this plant Rockefeller's famous industrial democracy plan, in which the employees elected their own representatives to meet with the company officials, had been in effect over three years when the plant was completely shut down by the strike.

The company officials are willing to deal with the men individually or collectively, but will not recognize their union.

that the trunk of documents seized on his ship at Halifax had been taken on board without his knowledge.

The testimony relating to conversations at German great headquarters emphasized the faithful misstatements of the German war lords as to the length of time it would take the United States

to get into the war with her full military strength.

TWO WILSONS, HE SAYS

Von Bernstorff testified that in his opinion "there were two President Wilsons—one prior to the war and the other that was typified after the rupture between Germany and the United States."

If war with America could have been averted, the witness believed that a peace of agreement could have been effected.

Dr. Gishheimer at this juncture read a cablegram which Count von Bernstorff had sent from Washington while he was still the German ambassador, saying that the United States had no intention of interfering with territorial affairs, but wanted to know exactly what Germany's peace terms were.

President Wilson was quoted as saying that Germany's refusal to publish her exact peace terms might be regarded as evidence of dishonest intentions.

Von Bernstorff testified that he told General Ludendorff that he thought it would take America one year to get seriously into the war. To this Ludendorff replied:

"We do not need that year. We can get through with it and finish the war in that time."

Dr. von Bethmann-Hollweg, chancellor of Germany at the outbreak of the war, was present and took voluminous notes.

METAL WORKERS ON TERMINAL JOB MAY GO OUT ON STRIKE

Employers and Union Men Fail to Reach Agreement Regarding Building of Tanks.

Probability of a strike of all union craftsmen employed in the construction of St. Johns municipal terminal and grain elevator grew today as it developed that neither side has taken any further steps to bring about arbitration of the controversy.

The strike is scheduled for Monday morning. Building trades workers will strike in sympathy with the boiler-makers, who had been employed in the construction of the oil storage tanks and who quit last Friday rather than work on material supplied by the Overmire Steel Construction company, listed by the union as an "unfair" shop.

The dock commission held a meeting Thursday and at a conference with labor leaders declared its position of being unable to arbitrate the Overmire contract so long as its terms were complied with. The Overmire company has been continuing the tank job with non-union labor.

The labor representatives agreed that the dock commission's position in regard to the contract was well taken and that, as a public body, it could not take a stand either for or against organized labor.

At the same time, the labor officials said, the union metal workers refused to work on material from the Overmire yard and moreover the other union men would not be permitted to work on a project where non-union men were handling "unfair" material.

The Overmire company has announced its intention to fulfill the contract under the conditions now being maintained.

The union men base their hopes of

victory on the fact that withdrawal of the building crafts workers will of necessity bring the tank construction to a standstill. This, they say, will constitute a violation of contract on the part of the Overmire company and the dock commission will be compelled to arbitrate it.

Another angle of the situation, however, in which the unions are interested, is the fact that the dock commission engineers are erecting the grain elevator, the most important part of the construction now under way, of a day labor basis. The commission disclaims responsibility for the work that has been contracted, but the strike of men employed on the elevator will be directly

against the commission engineers.

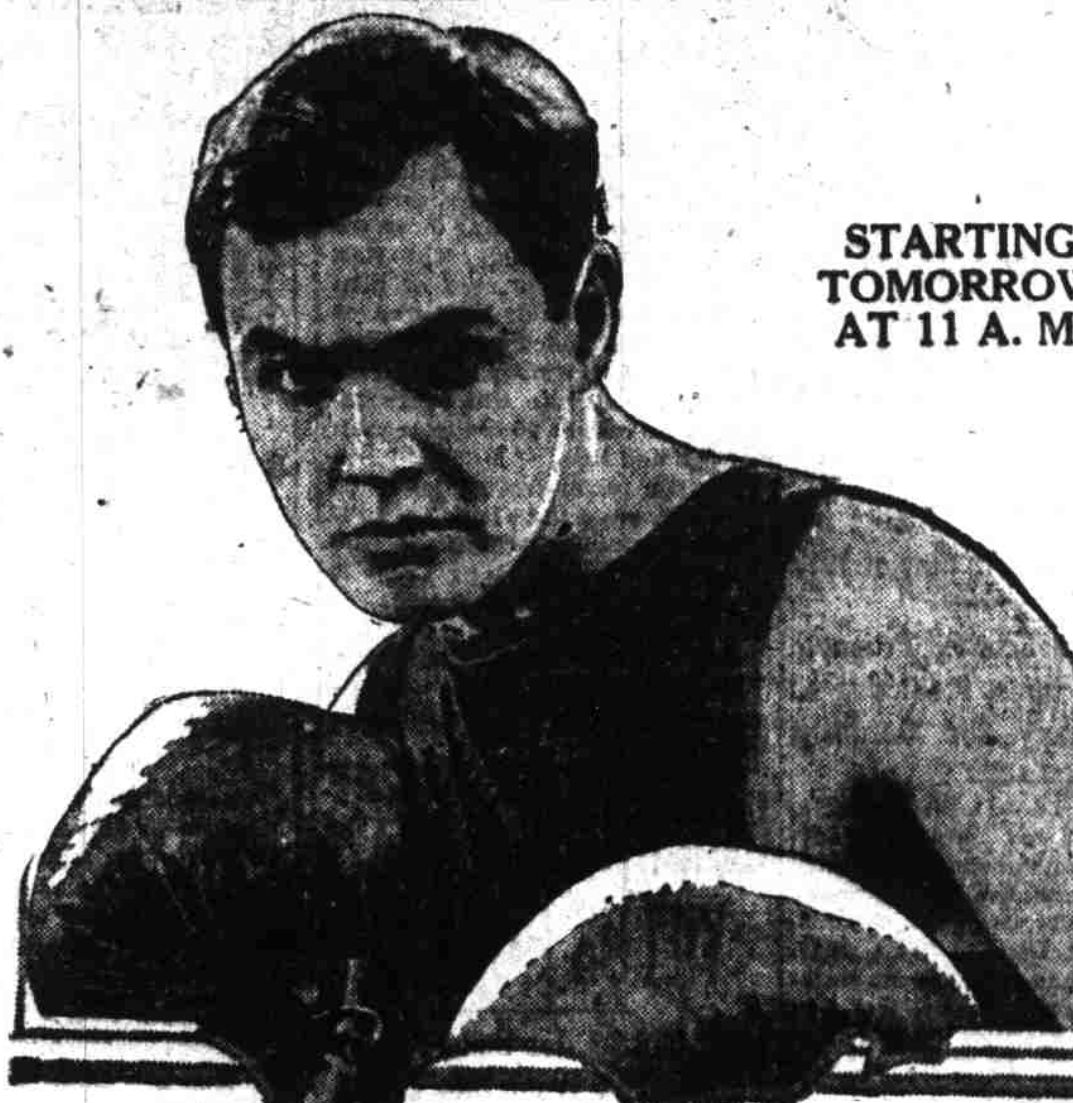
No statement of the position of the commission as to whether this work will be continued with non-union men was available this morning.

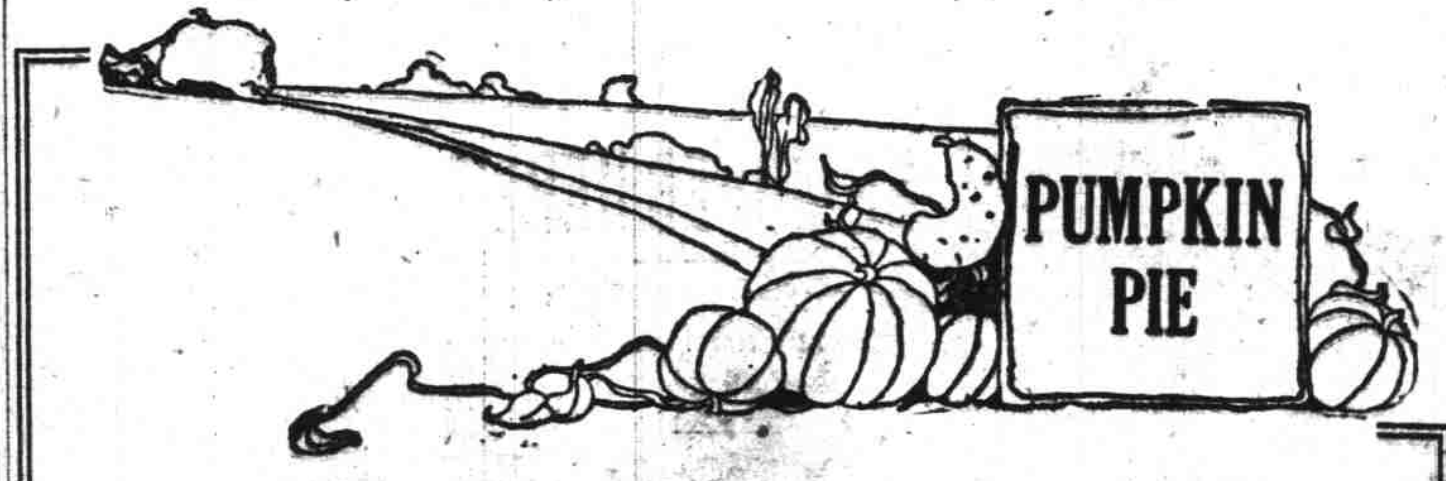
