

PARTY TICKET BILL PASSES BOTH HOUSES

House Puts Clincher on Senate Measure Backed by Old Guard to Displace Australian Ballot.

Political Fur Bristles and Oratorical Tongues Clash When Bill Is Recalled for Debate.

State House, Salem, Jan. 17.—The "straight ballot" bill, born of the oftentimes discredited but never disheartened old guard leaders of Multnomah county, was passed by the house tonight during such a scene of legislative confusion and disorder as has not been seen at Salem for several sessions. Gallagher of Multnomah county and Burdick, Deschutes, were the engineers who pulled the deal.

The bill had been sent, with all other house and senate bills in the hands of the house, to the special "steering committee" after being by the rudderless house in its attempt to get somewhere other than simple progress around an endless oratorical circle.

While the house milled about, waiting for this committee to make its report, Gallagher got down close to the speaker's desk and moved that the house recall the measure from the hands of the steering committee and lay it on the table. This was carried and the bill was then brought in.

Gallagher moved that it be taken from the table and placed on final passage. Smith of Baker, leaving the committee room where he, with other members of the committee, were at work in selecting the bills to be considered by the house, came into the chamber as the bill was being read.

He caught enough of the text to make him suspicious, and then, when the reading clerk had skipped through it, hitting the high spots of section after section, Smith, still unable to tell what it was all about, asked for information.

MANY EMERGENCY LAWS ARE PASSED

Suffrage, Capital Punishment, Compensation Favorably Acted On; Auto Drivers' Bill Passed.

Salem, Jan. 18.—The senate and house through their conference committee having agreed on the amendments to the special election bill the legislature adjourned sine die at 3:30 a. m. (Sunday)

State House, Salem, Ore., Sunday, Jan. 18.—(3 A. M.)—Eugene Smith was delivering a lecture on the labor and trade union features of the League of Nations covenant, in the house, while Mrs. Thompson was talking in the senate, both while the election bill was being engrossed.

An insane man came in from the lobby and, ascending to President Vinton's chair at 2 o'clock, began to deliver an address. He was asked to speak while the clerk worked at the desk and the members of the senate stood about singing "Bubbles" and Auld Lang Syne. When they sang the orator paused. When they sang the orator resumed. Finally they turned the lights off in the senate chamber, but the orator lit a match and continued to read his speech from the manuscript. At that point, however, the venerable chaplain of the senate, mounted a chair and began to address the darkened senate. And the mindless orator sat down. Thus the senate ended its extraordinary session.

Out of the session has come the enactment of the various so-called emergency measures which formed the basis for the session. The equal suffrage amendment has been ratified, the capital punishment amendment submitted to the people, the soldiers' and sailors' educational bill has been given more money and otherwise amended to make it more workable. The compensation act has been amended to provide more equitable relief to injured workmen. The fish and game controversy has been settled, for a time at least, and in a manner which even those who settled it admit it is of doubtful expediency. The Gallagher district irrigation bond guarantee amendment has been supported by legislation which makes it all right. The 4 per cent road bonding amendment has been submitted to the people, and the \$3,000,000 road bonding bill has been passed. The law providing for licensing of automobile drivers has been passed and signed by the governor.

This is the emergency program, and more. In addition to it the session has ground out a list of legislation the full scope and extent of which will not be fully known until time has been given to straighten out the tangled record of the last night of legislative riot. The session has been one of politics and contention. Out of it will come some good, but there has been much done that had no place in the session. All of the real emergency bills could have been counted on the fingers of two hands, yet there were nearly 100 bills introduced in the house and over 60 in the senate. These ranged all the way from petty local bills to those carrying

Miss Volheim Sues Reingold For Lost Faith

Young Woman Member of Multnomah Club Wants \$32,000 for Breach of Promise.

Three days before their marriage was scheduled to take place, alleges Eleanor L. Volheim in her \$32,000 breach of promise suit, Gall Reingold reneged. They were to have been married next Tuesday. On Saturday, she says, he told her it could never be. She lost no time in instituting civil actions.

Indeed so far had arrangements proceeded, according to Miss Volheim, that the wedding invitations had been engraved and a few of the early wedding gifts had found their way into the home of the bride-to-be. The relatives and friends of the couple had been notified, the trousseau purchased and the final arrangements were under way when Reingold notified the young woman that he could not marry her, according to the complaint.

ARE WELL KNOWN
The young people, say the papers on file in the county clerk's office, are well known in Portland, and are socially prominent. Reingold has interests in two jewelry stores. Miss Volheim is an accomplished pianist.

Miss Volheim sets forth that Reingold promised to marry her on December 15, and at divers times since that occasion. He had given her a handsome engagement ring and other presents, she asserts. Counting upon the coming marriage, she had gone ahead with the arrangements and has spent more than \$2000, she alleges. This she seeks to recover.

\$5000 MENTAL PAIN
On January 17, she says, Reingold, without reasonable excuse and willfully for the purpose of humiliating her, broke his promise and repudiated his agreement to marry her. She has been caused, she says, \$5000 mental pain, anguish, humiliation, mortification and impaired health. For being "deprived of the society, companionship, support and advantages of such a husband" as Reingold, as well as suffering and injuries in her prospects in life, she seeks damages of \$20,000. For "deceit and wanton injury," she desires \$5000 punitive damages.

REINGOLD SURPRISED
Reingold, who is 33 years old, Saturday night said he does not know anything about the matter and characterizes the suit as a "joke" and "absolutely absurd." He said Miss Volheim had been a customer at his store and he had been reading that her address was 713 East Couch street. Further than that, he refused to state.

Mrs. Volheim, mother of the young woman, declared the belief that the sudden breaking of the engagement by Reingold is due to the interference of his parents, caused by the difference in religion. Mrs. Volheim declared that in discussing their coming marriage with her daughter, Reingold would not consider their difference in religion as an obstacle, declaring himself an American and that that was sufficient.

Miss Volheim is a member of the Multnomah club, and was formerly a member of the Laurelhurst club.

CITY IS READY TO WELCOME PERSHING

Commander of American Army in Europe Due to Arrive in Portland at Noon Today.

Distinguished Visitor Will Be Kept Busy With Receptions, Banquets and Speeches.

Citizens of Portland and Oregon are prepared today to crowd into 10 brief hours a demonstration to General John J. Pershing of their sincere admiration and of their heartfelt gratitude and appreciation for his service in the world war.

The commander of America's victorious crusade—the soldier whose tactics turned the tide of battle—the man whose hand controlled an army of millions of this country's finest youth—is scheduled to arrive at the Union station at 12:30 o'clock.

In its nature the arrival of Pershing in Portland will not be a visit; it will be a triumphal return—a return to the Pacific coast—after an absence of three years spent in whipping the youth of the United States into form and then directing these same youths to whipping the Hun.

Time allotted to Portland to pay its respects to Pershing is brief. Numerous floods, washouts and slides have occurred on the O-W, over which his special car will be hauled, but officials of the railroad expressed the determination Saturday to have the distinguished visitor brought to the city on time.

If travel should be interrupted between Pendleton and Portland this morning, the general and his staff of nine military officers will likely be brought down the Columbia river gorge via the S. P. & S.

For more than a month Portland has been preparing a reception, but it was not until Saturday morning that the city began to put on its holiday attire of flags and bunting and make outward preparations for the reception of a distinguished visitor.

MANY VISITORS IN CITY
Numerous visitors from various sections of the state came to Portland during the week end and are prepared to pay their respects to the general. Hotels are already crowded and more people are coming into the city this morning on every train.

Be fitting the day of the week upon which the reception must be held, all pomp and excess ceremony will be foregone for a ceremony of dignity and pride.

Vancouver, Wash., Jan. 17.—Mike Hennessey, on trial here for violation of the criminal syndicalism law, was found guilty today by a jury in the superior court of Clark county before Judge R. H. Back. The case has been on trial all week. Hennessey was arrested about a month ago. He is alleged to have been drunk at the time and boasted of his membership in the I. W. W. Sentence will be passed later.

Robert McAdam and Leo Brookshier, fellow guilty of a similar offense in Judge Back's court last week, were sentenced today to serve from one to 10 years each at Monroe reformatory. Several other alleged members of the I. W. W. are in jail here awaiting trial.

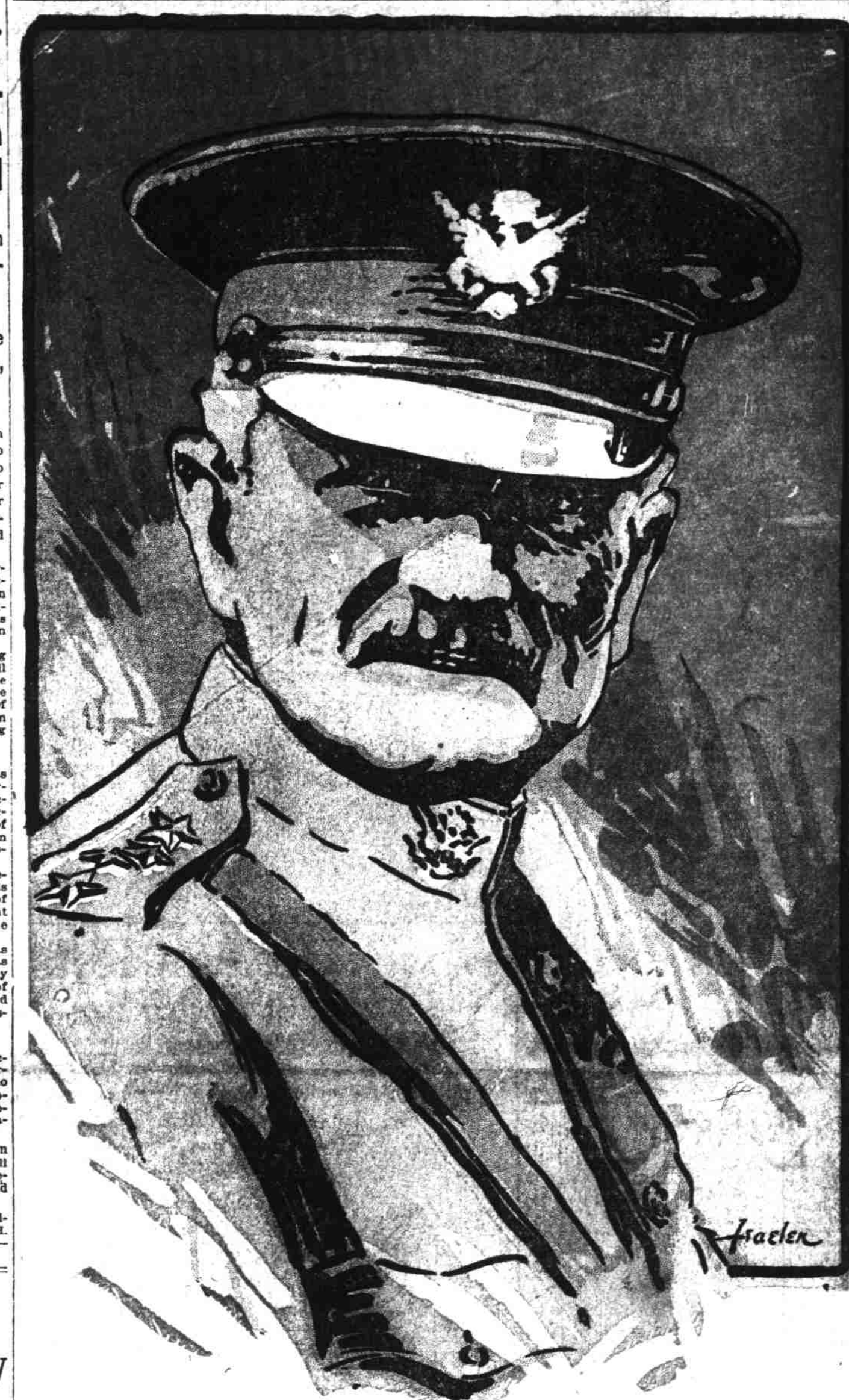
Senate Anti-Paving Royalty Measure Is Smothered by House

State House, Salem, Jan. 17.—An eleven hour measure passed by the senate and immediately afterwards killed by the house was a bill fathered by Moser, prohibiting the payment of royalties on any patented pavement used on highways in Oregon, until the validity of the patent has been definitely determined by the United States district court. The measure was regarded as a direction to the attorney general and the state highway commission to institute suit against the Warren Bros. company in an effort to determine the validity of the patent on their "bitulithic," on which there is now being held in abeyance by the state royalty payments approximating \$250,000. A bill by Representative Hare almost identical with Moser bill had been defeated by the house this afternoon.

Girl of The Dalles, Rabies Sufferer, Is Almost Cured

Oregon's most recent sufferer from rabies is almost cured. Bitten three weeks ago by a mad dog, Miss Gertrude Dohm, The Dalles girl, has almost completed the Pasteur treatment administered by the state board of health. Miss Dohm began treatments immediately after examination proved the dog mad. One injection a day of the Pasteur remedy for 21 days is declared to remove all possibility of the disease. The girl is the third victim of rabies reported in three months. These cases all came from Eastern Oregon, according to the result of an "epidemic"

DEATH PENALTY PLAN AMENDED

House Adopts Senate Resolution After Preparing Voters' Arguments For and Against.

State House, Salem, Jan. 17.—With but four negative votes opposing it, the house adopted the capital punishment resolution late in the afternoon. Those who opposed it were Graham of Washington, Hughes, Smith of Baker, and Mrs. Thompson.

The capital punishment resolution passed the senate Wednesday by vote 6 to 2.

The house took the resolution up for consideration at 4 o'clock and went into committee of the whole, on motion of Smith of Multnomah, for the purpose of amending it.

Smith contended that it was only fair and just that the people should be presented with arguments both for and against the question in the official pamphlet distributed to the voters by the secretary of state.

As the resolution came from the senate it provided that affirmative arguments only should be provided for by the legislature. These arguments were to be provided by committees of the American Legion and the Oregon State Bar association.

War veterans' meeting—Opens at Armory at 1:15 o'clock. Doors open for ex-service men of former wars only, at 12:15 o'clock. Pershing speaks briefly.

Rest period—At Multnomah hotel 2:30 to 5:30 o'clock.

Banquet—Main dining room of Chamber of Commerce, beginning at 6 o'clock. Brief address by Pershing.

Public reception—Auditorium, beginning at 8 o'clock. Doors open at 6 o'clock. No seats reserved. Pershing speaks at 8:15 o'clock.

Count Railway Mail Clerks in Portland If They Live Here

Railway mail clerks living in Portland should be counted in the census here. They are not included in the classification with soldiers, sailors and marines, who are enrolled at the place of duty. This is the warning today of William D. Bennett, director of the census in this district. Many enumerators misunderstood orders, he declares, and believed that mail clerks were counted on their "runs."

Persons not counted should telephone Broadway 2940, the census bureau, and give their names, Bennett says.

VOTE REPUDIATES ENEMIES OF PEACE

The Journal Poll Shows Overwhelming Indorsement for Terms of Treaty.

1—For compromise and immediate ratification, 702.
2—For Lodge reservations, 121.
3—For ratification of the treaty substantially as submitted by the president, 12,765.
4—Against any ratification, 248.

Such is the final count in the treaty poll after three weeks of voting.

The results are a complete repudiation of the position of Lodge. His reservations received but one hundred-fourteenth of the total vote. The position of the senate debate Friday, irreconcilables is also repudiated. Their attitude is reflected in the 248 votes cast against any treaty ratification. That vote is but one fifty-fifth of the total vote cast.

The poll has been a tremendous indorsement of the position of President Wilson. The vote for the treaty as submitted by him to the senate is 13,765, or 106 times as many votes as for the Lodge reservations and 51 times the vote against any ratification.

VOTE FOR RATIFICATION
The vote for compromise and immediate ratification is virtually a vote for the treaty, and combined with the vote for ratification of the treaty as submitted by the president aggregates 13,765, or 38 times the combined vote for Lodge reservations and against any ratification, which represents the total vote against the treaty. The total for the treaty is thus 13,767 to 248 against it, or 56 to 1.

Jam and Jelly To Soar Above Sweet Tooth

Preserves, Which Are Said to Have Been Reasonable for a Time, Are About to Fly.

Chicago, Jan. 17.—(U. P.)—"It's not a sweet outlook" for "sweets," according to G. B. Forrest of a canning and packing company here tonight.

Jams, jellies and other commodities are about to join the advanced "army of high prices" against the consumers' pocketbooks.

"Jams, jellies and preserves have advanced very little in the past year," Forrest said. "But they are about due for a rise. Sugar has advanced about two-fold, along with the many other necessities of the canning industry—and unless the unforeseen happens and raw materials tumble, these commodities are sure to rise."

"The greatly increased demand also figures in the rise. Many housewives, since sugar has advanced—have stopped home canning and the result is such an increased retail demand that retailers in many instances were unable to meet them."

SOVIET ADVOCATE OUSTED BY SCHOOL

Professor Who Wants Reds to Rule the World Is Fired by Florida College.

Gainesville, Fla., Jan. 17.—(I. N. S.)—The faculty of the University of Florida today had the resignation of N. L. Sims, president of political science, following publication of a letter in which he advocated soviet rule of the world.

The letter addressed to a friend in Africa was intercepted by the British government and turned over to the department of justice of the United States, which in turn communicated it to the university faculty.

"I glory in the soviet republic of Russia and pray for the day when it shall be established in all of the world," was one of the sentences of the letter.

"I imagine some of my letters may have been lost or destroyed by the censorship," Professor Sims wrote, "or elsewhere, for I have said things which would land me in the penitentiary for 20 years under the hellish American government and its espionage act."

New York, Jan. 17.—(U. P.)—Results of the intercollegiate treaty referendum, in which faculty and students of 329 American colleges voted on various proposals for settlement of the League of Nations and peace treaty situation, today showed a preponderant vote in favor of a compromise between the Lodge and Democratic reservations.

Complete returns on the various proposals were announced as follows:

Compromise between the Lodge and Democratic reservations: Faculty, 40,437; students, 33,499.
Ratification of treaty with Lodge reservations: Faculty, 1244; students, 19,917.

Opposition to ratification of the league or treaty in any form: Faculty, 486; students, 11,073.

Gasoline Test Bill Is Lost in Senate

State House, Salem, Jan. 17.—The gasoline test bill which originated in the house and met with an enthusiastic reception in the senate, the measure of that body was turned down by the senate, that body barely failing to receive the constitutional majority necessary to its passage.

The vote on the measure was 15 to 14, the bill failing only because of the lack of a constitutional majority.

Motorist Forced to Be Thieves' Driver

Robbed of his auto and \$4 by two strangers whom he picked up near Pullman at 9 o'clock, H. C. Meely of Hillsdale reported to police at midnight Saturday night that he had been forced to be chauffeur for the two bandits while they held up another motorist near Oswego and took \$80 and all the other man's gasoline, the auto tank having run dry. The two men then rode away in Meely's machine. The holdup men were described as being between 20 and 25 years of age.

SIMS DIRECTS ALL HIS GUNS ON DANIELS

Navy's Head Is Charged With Everything From Inefficiency to Lengthening of Great War.

Admiral Says Someone in Washington Told Him U. S. Would as Soon Fight Britain as Huns.

Washington, Jan. 17.—(U. P.)—Charges that inefficiency and mismanagement of American naval affairs actually delayed the surrender of Germany were made today by Admiral William Sims, ranking naval officer in Europe during the war.

Admiral Sims declared that on leaving for London prior to America's declaration of war he was admonished not to let the British "pull the wool over his eyes," and to remember that "we would just as soon fight the British as the Germans." He made further charges that the navy department at Washington disregarded advice from officers on the scene and hampered the winning of the war.

Sims was before the senate subcommittee investigating award of naval decorations, but when he read his charges, contained in a letter he recently addressed to Secretary Daniels, all thought of the original purpose of the investigation vanished and the subcommittee adjourned.

MORE INVESTIGATORS
A sweeping investigation of the navy's part in the war is certain, as a result of Sims' testimony, it was believed at the capitol tonight. The senate naval affairs committee will meet Monday to decide the question.

The admiral refused to disclose who gave him the alleged warning against the British until asked officially by congress. He did say positively, after the hearing, that it was made by a "person in the navy department."

Secretary of the Navy Daniels made no comment on the Sims charges beyond saying that the letter which was received several days ago has been referred to the general board of the navy, other high officers of the navy also again in silence.

Daniels refused to say whether he had instructed Sims not to let the British "pull the wool over his eyes." REED ANNOUNCES FACULTY ADDITIONS

Boas Comes From Whitman, Miss McGee From Vermont and Rebec From U. of O.

Three additions to the Reed college faculty were announced Saturday by the new board of regents. Ralph Philip Boas, formerly assistant professor of English at Whitman college, will succeed Professor Norman F. Coleman, who becomes president of the Loyal Legion of Loggers and Lumbermen. Miss Mary G. McGee of Middlebury, Vt., has been elected instructor in French, and Dr. George Rebec, professor of philosophy of the University of Oregon, will conduct two courses in education at Reed beginning next semester.

"Reed college is fortunate in its latest faculty elections," said James B. Kerr, member of the college board of regents. "These additions constitute the best of the first move toward increasing Reed's effectiveness in the educational world."

Kerr said no one has been chosen to succeed President W. T. Foster, who resigned lately, and the faculty administrative committee, Miss Florence Reed, Professor H. B. Hastings and Professor Coleman, will continue to perform the executive functions.
