

PORTLAND HEROES WILL BE HONORED TODAY BY FRANCE

Memorials to Be Presented to Relatives of 218 Local Boys Who Gave Lives in the War.

French memorials this afternoon through the American Legion will be presented to the nearest relatives of 218 Portland men who died during America's participation in the German war. The memorial service will begin at 2:30 p. m. at the Auditorium, when a program of music and eulogies will be sounded. Similar services will be held in cities all over the United States.

Thankful for America's assistance in a war that in the 37 months before the first American set foot on French soil had caused the loss in killed, dead, hopelessly wounded, missing and prisoners of more than 2,043,000 soldiers, France prepared handsome engraved scrolls bearing the name of each soldier, sailor and marine who gave the supreme sacrifice. Whether on the front or at camp, death of an American is recognized by the French.

"At the most critical moment of the struggle which had lasted for three years against German imperialism, you came as strong youths into a country where the young had perished," reads a French appreciation of the American soldier.

"To the weeping you brought a smile, to those who had been despoiled your generosity restored hope, to the fatherless children you offered joy.

"Often, marching toward dusk, along some valley road in France, you have watched the lights as they began to shine out from the windows of the little farm houses, while the mists gradually enveloped all but the shadowy forms of objects almost indistinguishable. Let it be so in your minds when you think of France. Remember the innumerable small homes which almost two million men have died to save, and those hearths where a fire still burns, though the polls who left it will never return. If any harsh thoughts remain, let the mists enfold all that is not the romance of this war—the drawing together in fraternal love of those who have suffered. This is the prayer of France.

FINLEY IS ACCUSED OF INTOXICATION AND RECKLESS DRIVING

Two Warrants Are Sworn Out in Connection With Car and Auto Crash Fortnight Ago.

Arthur L. Finley was arrested Saturday evening by the police on two warrants sworn to by P. Guth. Finley is charged in one with "driving an automobile in a careless and reckless manner," and in the other with "driving an automobile while intoxicated." He secured his release by depositing \$250 bail on each warrant.

Deputy City Attorney Fred Stadler, who issued the complaints, has been working on the case for several days. About 10 days ago Finley's automobile was in an accident with a streetcar and automobile on Hawthorne avenue, not far from East Sixth street. According to evidence which the city authorities say they obtained from witnesses, the automobile was on the wrong side of the street when hit by the streetcar. After the impact with the car, the automobile is said to have swerved to the right side of the street into another automobile. A short time after the accident the police received a report that the machine had been stolen. The police attempted to find the alleged thieves, but failed. The traffic department conducted an investigation and say they have evidence indicating that Finley was driving the automobile himself and was intoxicated at the time of the accident. City officials say the automobile was not stolen on the night of the accident. The complainant is a streetcar employe. The warrants were served by Patrolman L. W. Thorp. First hearing in the municipal court.

M'NARY AND CHAMBERLAIN VOTE WITH LODGE CROWD

Washington, Feb. 21.—(WASHINGTON BUREAU OF THE JOURNAL)—The Democrats who voted for accepting the original Lodge reservation were Ashurst, Chamberlain, Fletcher, Gore, Henderson, Myers, Nugent, Shields, Smith of Georgia and Trammell. All Republicans present voted for it, including McNary, Borah, Poindecker and Jones of Washington.

THREE OREGON MEN FAVOR R. R. MEASURE

Democratic Leader Kitchin swung all but a small number of Democrats against it. The real test in the house was on the motion that the bill be referred. This action was lost, 229 to 171.

Democratic leaders made plain they were objecting to the bill because of provisions guaranteeing the roads a 5 1/2 per cent return on their investment and not in response to the demands of labor, whose representatives with those of the railroad crowded the galleries.

During the day, labor opposition to the bill was carried to the president, as well as to congress. While the issue of the measure will take place today, union men carried to the White House a letter declaring "entirely inadequate to meet the present situation" the labor clause of the measure which sets up tribunals for settlements of wage disputes. This was regarded as significant in view of the fact that the president, in a letter to the railroad men a little more than a week ago, urged them to leave their wage demands to tribunals to be set up by congress.

"We feel sure," the union men wrote, "that you can agree with us to the extent that there is little likelihood that congress will be able to reach an agreement that will insure the prompt disposition of the question."

SEPARATE TRIBUNAL URGED

The union men then urged the president to set up immediately a separate tribunal for wage adjustment, regardless of congressional action.

The railroad men's letter was given Secretary Tumulty, by Timothy Shea, head of the railroad firemen, E. B. Jewell, head of the American Federation of Labor railway department, and E. J. Manion, head of the railroad telegraphers. These three form a committee which has been negotiating with Wilson.

In one sentence of their letter, the workers condemn the guarantee section of the bill, which bore the brunt of the attack in the house.

Defending the guaranteed during debate in the house, Representative Eech, chairman of the house interstate commerce committee, and one of the authors of the bill, said:

"Capital will not invest in railroad securities under the old law of fixing just and reasonable rates. The investors want the stability and the railroads must have additional credit."

PEACE TREATY AT LAST GETS INTO CAMPAIGN

that notice of withdrawal be given by a current resolution. On this the vote was 15 yeas and 20 noes, more than a two-thirds majority. Thirty-five Republicans and 10 Democrats supported it, while 20 Democrats opposed it.

The debate which preceded the voting began when Senator Walsh, Montana Democrat, took issue with Senator Lorah as to what the question would be when the treaty went into the campaign. Borah's position was whether the senate shall be instructed to ratify the treaty or reject it, but Walsh said that to his mind the situation would be that the Republican candidate would be run on a platform favoring ratification with the Lodge reservations and the Democratic candidate would favor ratification with interpretative reservations.

Senator Smith of Georgia said the proper solution would be to run a candidate pledged to take the United States record on the league entirely.

TIS JOHNSON'S PLATFORM

Senator Walsh said that, as he understands it, Senator Johnson of California was seeking the Republican nomination for president on that platform, but said he did not know how Johnson would record his position with that of Ellhu Root.

Senator Brandegee of Connecticut took Senator Lodge to task for seeking to compromise the Lodge reservation. "Why are we compromising and with whom?" asked Brandegee. "With ourselves? Is the president compromising? Not on your life. He stands pat. He probably has some principle in which he believes. Here we are frittering away time striking out and inserting words for the mere pleasure of finding synonyms. Everybody knows we are not going to sell the Monroe doctrine to Europe or abandon it, and we are not going to assume one iota of obligation under Article X. Then why prolong the autopsy? We might as well order the disinfector now and get this ghastly sight out of the way."

NOT JUSTIFIED, SAYS LODGE

Lodge, in reply, said he would not have been justified in slamming the door in the faces of senators who wanted to suggest modifications. He said he never intended to assent to any change in the principles of the reservations on the Monroe doctrine or Article X.

"But, if by adopting these other changes, we can get a two thirds vote for ratification I am willing to try it," said Lodge. "It's going to be in the campaign, no matter what we do about it. The state of New York put it into

The hospital has probably come nearer standing in the relation of parent to children than any other institution in the city, and numbers of children have been sheltered there for years.

POLICY IS IMPARTIAL

The present policy of impartial service to all those who apply will probably be carried out in the enlarged institution even more extensively than at present, according to Bishop Sumner's announcement. "Fully one third of the patients cared for at Good Samaritan hospital at the present time are treated gratuitously," he said. "The new Wilcox Memorial will make it possible to carry on free work even more extensively than has been done at Good Samaritan hospital for many years in the past. The board of hospital trustees has expressed deep appreciation of the gift, and the project for increased hospital facilities will be carried out as nearly as possible in accordance with the conceptions which Mr. Wilcox had long held and desired to see executed."

"In addition to the structure made possible by the bequest of the Wilcox heirs, an additional unit in the present group of hospital buildings is contemplated, and a campaign for a \$300,000 building fund will be carried on between March 1 and 10. A campaign committee of 41 business men has been appointed and will insure public support for a cause in which Portland is vitally interested."
