

## 21 ENEMY ALIENS, REFUSING PAROLE, TO BE DEPORTED

Salt Lake, Utah, April 1.—Twenty-one of the 73 interned aliens at Fort Douglas have refused to sign parole papers and will be deported. Several of these are under the impression that they will sign away all rights to their property being held by the custodian of alien property, while others are in fear that if they sign the papers they will be looked upon as traitors among their countrymen. Some refuse to submit to the terms of the parole and declare they will not report to the department of justice regularly nor submit to other American supervision. Some even go as far as to object to the provision that they get a job and take no part in radical activities.

Most of the aliens, however, are willing to submit to any terms to obtain their freedom once more. Four of the aliens were found to be insane. Six prisoners were released Wednesday and left for their homes on the Pacific coast. They are John Eder, Hall Spozza, Hugh M. Funkler, Martin Kratedin, W. J. Bumbala and Curtis Friedlander. Thirteen more will leave today for Portland and Seattle. They are George Handeifer, Frank Peter, Alton Kadlin, Joseph Koehler, Everson Verrier, Peter Munday, J. J. Carr, Matt Hann, John Haahagen, Fritz Kronze, Ernest Tolper, Henry Wohlberg and Frank Zukem.

## Carlisle Blackwell, Of Movie Stardom, Is Sued for Divorce

New York, April 1.—(U. N. S.)—Carlisle Blackwell, motion picture star, appeared before Superior Court Justice Peter A. Hendrick today as a defendant in a suit for separation brought by his wife, Ruth H. Blackwell. Mrs. Blackwell, who in 1909 married the star when he was a chorus man in a musical comedy, testified that her husband had deserted her in 1914, while they and their two children were living in New York. Thereafter, according to her testimony, Carlisle Blackwell paid her \$200 a week out of the \$500 he was then earning in the movies. Later his salary was \$1000 a week. Mrs. Blackwell testified, and his home at Spuyten Duyval was an elaborate affair with five servants, a valet and a chauffeur to attend him. Mrs. Blackwell also charged that her husband was supporting a cabaret performer, a French woman, singing on the Century roof. This assertion brought forth a strong protest from the defendant's attorney, who said he had agreed not to contest the suit for separation provided only necessary evidence was introduced.

Ex-Tammany Chief Held Incompetent in Fight Over Estate

New York, April 1.—Richard Croker, former head of Tammany Hall, and the most powerful political boss New York ever had, is declared in affidavits by his children and others to be senile, incompetent to manage his affairs, and completely under the domination of his second wife, an Indian bride whom he married in 1914, when he was 74 years old. An injunction restraining him from disposing of any money, securities or real estate in Florida, has been granted by the circuit court of Florida on application of Howard Croker, the younger of the sons. Appointment of a conservator, guardian or committee to take charge of Richard Croker's financial affairs has been applied for, and if this application is granted, ancillary committees will be applied for. These will take charge of the ex-Tammany chieftain's million-dollar estate in Ireland just outside of Dublin and of his property, valued at several millions more in New York state and elsewhere. The entire Croker fortune is estimated at \$10,000,000.

## Higher Costs Force Papers to Increase Sunday Issue Price

Philadelphia, April 1.—Owing to the constantly increasing costs in producing a newspaper, a price increase is necessary to raise the price of the Philadelphia Sunday papers. One very large item in the increased cost of production is the price of print paper. Within four years this item alone has been increased to the newspapers of Philadelphia a total of more than \$6,000,000 a year. The greater part of this \$6,000,000 increase has been within 18 months and much of it within six months. The most recent added charge for print paper will date from April 1. Beginning Sunday, April 4, the Sunday papers will sell for 10 cents in city and state.

## Medford Park Bill Is Favorably Acted On by Department

Washington, April 1.—(WASHINGTON BUREAU OF THE JOURNAL)—The interior department has returned a favorable report on a bill by Senator McNary to turn over 4500 acres of land

comprising Roxy Ann mountain, to the city of Medford, Or., for park purposes. An amendment is suggested to require payment to the government of \$2.50 an acre. A favorable report has also been returned by the department of agriculture on a bill introduced by Mr. McNary to authorize exchanges of land in the Oshoco national forest.
