

# MICHIGAN HAS 13 CANDIDATES FOR THE PRESIDENCY

New York, April 2.—(U. P.)—Campaign observers are predicting that Michigan will become a political cemetery Monday. Thirteen candidates for the presidential nomination—seven Republicans, five Democrats and one Socialist—are entered in the preference primaries there. The one polling a plurality in each party will get all that state's 30 delegates to his respective national convention.

While it is still comparatively early in the pre-convention campaign, Michigan is regarded as one of the "pivot" states this year, so far as the nominations are concerned.

The 13 candidates are: Republicans—Senator Miles Poindexter, Senator Hiram Johnson, General John J. Pershing, Major General Leonard Wood, Governor Frank O. Lowden of Illinois, Herbert Hoover and William O. Simpson of Detroit.

Democrats—Governor Edward J. Edwards of New Jersey, William J. Bryan, William G. McAdoo, Attorney General A. Mitchell Palmer and Herbert Hoover. Socialist—Eugene V. Debs. Michigan is normally Republican. In 1916 it gave Charles E. Hughes 327,952 votes, President Wilson 283,953 and Allan Benson, Socialist, 16,012.

At least two of the Republican candidates are expected to cash in on Roosevelt sentiment—Wood and Johnson, both of whom were personal friends of T. R., and are generally regarded as "progressives." Hoover backers believe he will inherit a large part of the liberal element that supported Roosevelt and Wilson.

The fact that Hoover is on both tickets is expected to create an interesting situation. This is the first time he has been put to the test politically since his telegram to the San Francisco Hoover club, which he alleged himself with the Republicans.

Most of the candidates have made intensive campaigns in Michigan.

which is sweeping through the state, seems to be waiting for the senator himself and his oratorical swing through the state.

Frankly speaking, the candidacy of none of the men openly in the race here, before seems to be causing much enthusiasm or much excitement. There is more Hoover talk in the lobbies and on the streets, and has been, than any other. "There is no use kidding ourselves," to quote one of the head men of the rival camps. "Hoover has struck the popular fancy more than any of the rest."

So, the situation presents most interesting possibilities. There is more beating of the tom-toms in the Wood headquarters and by the Wood workers than elsewhere. More money and more organization work has come from there than from the other camps. More workers have been sent out and more reports sent in. But does it all spell votes? Vox Populi will give the answer on the twenty-first of May.

# PERSONALITY MAY COUNT

The Johnson headquarters have not been idle, and they are more than ever energetic now. They have county chairmen and county workers scattered everywhere and all the Johnson army is waiting to whomp it up when the campaign clock strikes 11 and the senator opens the floodgates of his oratory throughout the state during this month or in May.

Joe Nunn and his fellow orators are rowing hard to keep the Lowden ship abreast of the current, and they claim great success. They are standing—more kindly stated, they are running—on the record of their standard bearer as a business man and as a governor.

And then comes Hoover and his volunteers. Not even his opponents deny that there is a latent and considerable Hoover sentiment scattered throughout the state. How many votes it represents is conjectural. Whether they will be cast is a question the answer to which depends more than a little upon the efficiency and the activity of the Hoover organization now setting under way. More than a few believe that a consistent Hooversman full of pep would put Hoover over the top in May.

Most observers believe that if Hoover's

campaign is not a winning one in Oregon it will redound more to the benefit of Johnson than of the rest and give him the state. It is, for one thing, going to make the candidates dine up for or against the League of Nations issue, without evasion or equivocation. No one doubts where Johnson stands on that question. He is expected to fall heir to the lion's share of the "bitter ender" vote. Anti-English as he is, the deponents concede him the pro-German and the Sinn Fein Ballots. Those who hate Japan and the Japanese will be under his banner, all together, making a positive following which will stick without regard to what Hoover says or does.

But these things are not the only ones there are many who have been "on the fence," claimed both by Wood and by Lowden, who have flipped and are flipping into the Hoover camp. It will be very interesting, this contest between money and the organization it can buy; spellbinding and the votes it can sway; a dormant "popular fancy" and the efforts of a volunteer organization to galvanize it into movement and power.

# BOURNE'S PUBLICITY BUREAU PRINTS ATTACK ON HOOVER

Washington, April 2.—As an indication of how one faction of the Republican party regards the former food administrator the initial attack on Mr. Hoover as a full-fledged candidate comes from the Publicity Bureau of the American Association for the former Senator Jonathan Bourne Jr., its president. Its charge was "camouflage" and its statement was as follows:

"Hoover is a man of confidence in the gullibility of the voters of the United States the New York World, leading organ of the Democratic party, asserts that 'although Hoover is a candidate for whom an emphatic popular preference is shown, he has no organization.'"

"No organization" indeed! "How comes it then, that a number of the leading newspapers and periodicals of the country, some of whose editors or publishers met at the famous dinner to Lord Grey, began simultaneously a serious campaign for Hoover for president, and suddenly his name comes by night, there sprang up a nation wide and efficient body of workers forming what looks to the experienced politician like a perfectly operating machine?"

"As a splendid precedent of political engineering, the Hoover machine is a masterpiece. It works so smoothly one can scarcely hear the wheels and gears and other mechanism as they do their allotted work. The makers of that machine have overlooked but one fact—that the voters of the country will see through the camouflage."

"Because the highest priced automobile on the market runs without noise, it is no evidence that it has no engine. In fact, the smoothness of the running is the best evidence of the perfection of the machinery. The Hoover machine is well constructed and evidently well supplied with fuel and oil and grease."

# LOWDEN GIVES PLATFORM IN PRESIDENTIAL CONTEST

The full text of the platform of principles upon which Governor Frank O. Lowden stands in his candidacy for the Republican nomination as president, as it will appear in the official voters' pamphlet issued by the secretary of state, is as follows:

"I am for a budget system that will enable the government to find out what is absolutely necessary for its economical maintenance, that will discover and eliminate sinucures, if there be any; that will expose padded estimates for appropriations and wipe out wastefulness and extravagance. This budget should be made in the treasury department, which should have the power to reduce estimates wherever expenditures are found to be excessive or unnecessary."

"I stand for efficiency and economy in government. I believe that government should expect and exact 100 cents worth of work for each dollar it pays out. Public officials and employees should give their entire time to the government's service. Government is the most important business any American has, and he cannot afford to neglect it."

"I am in favor of abolishing all useless agencies established for war purposes, and in favor of the reduction of millions of dollars to the taxpayers. I believe it would go far toward reducing the high cost of living."

"I believe we should ratify the peace treaty with reservations substantially as proposed by the foreign relations committee in the senate. The resumption of normal conditions at the earliest possible moment will aid in solving many of our present difficulties."

"I stand for stalwart, uncompromising Americanism which puts the interests of this country first. I am in favor of international friendships, but not international partnership."

"I believe we should have a better quality of Americans rather than a larger quantity. They should be more effective safeguards against the admission of undesirable foreigners than the government's service. I am for the deportation of aliens who place the red flag or any other mark above our own."

"We must maintain law and order. Our constitution is the basis of all our laws, and the man who violates it commits treason against our country."

"I am in favor of government by all the people, and not by a few. Equal justice to all, special privilege to none, should and must be our position before all the world."

"I am in favor of encouraging agriculture and recognizing the principle that it is and must remain our most important industry."

"The difference in cost of production at home and abroad."

# BALMER'S NAME SOON TO BE ENTERED IN OREGON PRIMARY

Attorney General A. Mitchell Palmer is soon to enter Oregon as an active candidate for the Democratic nomination for president at the San Francisco convention in June.

Word comes from Washington that former United States Senator Arthur D. Wood is in the immediate future for a visit to Oregon, Washington and other Pacific coast states for the purpose of getting the Palmer campaign officially under way.

Judging from the tenor of the announcement sent out, it is the purpose of the Idaho state headquarters in open state headquarters in Portland and gather together an active working organization in Palmer's behalf.

At present, Palmer is the only candidate for the Democratic nomination who has appeared as a probable seker after place on the Oregon presidential primary ballot. McAdoo has notified those who put of Idaho in sections in his behalf that he does not desire his name to be put on the ballot. George Lovejoy, who was directing the circulation of one set of petitions, has met the McAdoo representatives and stated that he would hold it in readiness for future developments. Newton McCoy, who has been back of the second set of petitions, has also stated that he intends to file his petition and put the former secretary of the treasury on the Democratic ballot whether he desires to be there or not. Aside from the McAdoo and McCoy petitions, a number of other Democratic candidates entering the Oregon contest, so far as reported.

# BACK LODGE IN PRIMARY FOR THE VICE PRESIDENCY

United States Senator Henry Cabot Lodge is standing in the headquarters to the League of Nations covenant, is to be a vice presidential candidate on the Republican primary ticket May 21. Back of the movement, and the petitions now in circulation to make it effective, are Judge Wallace McCamant, John V. Richardson, Hamilton Johnstone, Clarence Hotchkiss, A. L. Dundas and Chester Moores, all members of the Roosevelt Republican club, but in this regard acting in their individual capacity.

The determination to make Senator Lodge a vice presidential candidate in Oregon has grown out of the candidacy of Lodge and obscure candidates from the east and the desire of the backers of the movement to "have the Oregon delegation instructed for a candidate for whom they will not be ashamed to vote."

The subject came up at a meeting of the executive committee of the Roosevelt Republican club, and, as that organization is inhibited by its constitution from advocating or opposing the cause of individuals named, determined to start things on their own hook. Consequently petitions have been printed and are now in course of circulation. The subject was chosen by Judge McCamant explains, "because we thought he was well known and that the voters would support him for that reason, as against the unknown notoriety seeker who have announced their candidacy in the state. Personally I am an admirer of Senator Lodge and am glad to aid in putting him forward as a public service. The action has been taken without consulting Senator Lodge, and so far as I am concerned we will not communicate with him or ask his consent. Then whatever he may say will have no effect upon the circulation of the petitions or placing his name on the ballot."

# POINDEXTER MEETING CALLED TO PLAN OREGON CAMPAIGN

Friends of Senator Poindexter who formerly lived in the state of Washington are calling a meeting for next Tuesday evening at 7:30 p. m. at the headquarters in the Morgan building, room 635. They will then lay plans for the Oregon tour of Senator Poindexter. Numerous reports have been sent to the headquarters for such a meeting until finally Arthur B. Balmer and T. P. Tebbets, old friends of the senator's, have taken the initiative in charge and invite any other well wishers of the senator to attend to the meeting. It is also planned to have some noted speaker of Washington or Oregon present.

J. C. Herberman, manager of the Poindexter headquarters, is now arranging to get some man of national prominence to make a campaign of the state. Congressman Webster of Spokane probably will be in Portland some time early in April and Mr. Herberman is hoping to arrange for a big mass meeting for him. Senator Poindexter himself will be in the state at least two weeks before the Oregon tour and meet as many people as possible while here.

# WOOD CLUB TENDERED LUNCHEON

# BRYAN REFUSES TO TALK ON HOOVER'S CANDIDACY

Bryan refused to be interviewed on politics, except to say that he did not believe that prohibition would be a factor in the presidential campaign. He also refused to discuss Herbert Hoover as a presidential candidate.

# HALEY ENTERS G. O. P. FIELD FOR SEAT IN LEGISLATURE

Arthur L. Haley, who has been a resident of Portland two and a half years, has announced his candidacy for the legislature in the Republican primaries for representative. Haley was engaged as housing architect for the United States shipping board, Emergency Fleet corporation, for the Vancouver, Wash., housing project, and afterward acted as port engineer for Vancouver. Haley has the indorsement of the American Association of Engineers by his candidacy. His slogan is "Develop your natural resources; increase your payrolls by sane engineering investigation."

# G. O. P. TESTING PEACE DRIVE IS FACING DEFEAT

Washington, April 2.—(U. P.)—Republican leaders in congress will not be able to muster enough votes to pass their peace resolution over the veto of the president, leading house Democrats declared today after a canvass.

Both Champ Clark, Missouri, Democratic floor leader, and Representative Flood, Virginia, ranking minority member of the foreign affairs committee, stated it would be impossible for the Republicans to force the resolution by a two-thirds majority, necessary to override a veto.

President Wilson has indicated to close advisors that he will not sign the resolution, which, if Democratic predictions as to the house vote are true, means that a legal peace will not come until the senate and the president have agreed on some kind of a treaty. This in all probability will not be until after the election unless the president yields to the senate reservationists.

Democrats are massing their forces for an attack on the resolution when it comes up in the house. Determined Democratic party leaders to use the Republican peace resolution against its authors as campaign material was evidenced, Democrats said today, by the statement of the speaker, Charles McNary, in regard to the resolution.

# Three Safe Robber Suspects Are Held To U. S. Grand Jury

# MERCHANTS WARNED TO BE ON WATCH FOR FAKIRS SHRINE WEEK

In a warning issued to merchants of Portland, Liaison Inspector Hutchinson not only declared that unauthorized purveyors of novelties or emblems affecting Shrine week will be arrested immediately, but he called upon the merchants to cooperate in keeping the city clear of all trashy matter which generally is dumped on an unsuspecting public during such occasions.

"One or two arrests already have been made," said Hutchinson, "and many more will follow if necessary, to keep Portland cleared of the unauthorized salesman or purveyor. The police, augmented by several extra squads, will grab all suspects and take drastic action with all who are found guilty."

"All grants are being let by the concessions committee of the Shrine of which several city officials are members, and full authorization, together with proper credential cards, will be given."

"The soft drink and food concessions in the grandstands have not yet been granted and every person in the city who is planning to set up any kind of a stand for the sale of soft drinks or food in yards about town or in vacant stores will have to take out a license. These temporary places will also be required to conduct their businesses in a strictly sanitary manner. A deposit will be necessary before a permit is issued."

# DEFEAT OF SUFFRAGE IN DELAWARE TO STIR UP POLITICAL PARTIES

Washington, April 2.—(U. P.)—Final defeat of suffrage in Delaware will start a race between national organizations of the Democratic and Republican parties for the credit of making possible ratification of the amendment which enfranchises more than 26,000,000 women, it was believed here today.

Suffragists say they have not yet given up hope of ratification in Delaware.

Republicans point out that a Republican congress passed the amendment and that 26 of the 35 ratifying states have Republican legislatures.

Democratic entries in the race for the credit of final ratification would be North Carolina and Louisiana.

Republican entries will be Vermont and Connecticut.

The governor of North Carolina, according to suffragists here, has indicated that he may call a special legislative session in June and that he feels that there are good chances that suffrage would be approved. The legislature meets in regular session in May.

"The company cannot meet the first half of the annual tax payment next Monday. We want to give service as long as we can but we can't continue on the present basis of revenue and expenses."

Following a walkout of 3000 Pennsylvania railroad employees at Fort Wayne, Ind., yesterday, 700 switchmen and yard tenders of the Chicago, Milwaukee & St. Paul here were on strike today. They demanded a pay increase of nearly 50 per cent.

# Decline in Number Of Divorce Suits in County Reported

Divorce suits in Multnomah county are decreasing, according to figures compiled by Deputy County Clerk Buchtel, Thursday, covering the first three months of the year. In the period ending March 31, 311 divorce suits were filed, decrease of more than 25 per cent as compared with the last quarter of 1919. Ninety-three were filed in March and 100 in February.

The decrease is believed to be largely due to the attitude of Presiding Judge John McCourt, who has demanded genuine cause before granting decrees. All questionable cases are being thoroughly investigated.

Marriage licenses also decreased. In March there were only 174 issued as compared with 210 in February.

# Americans Are on Train Attacked by Bandits in Mexico

Washington, April 2.—(U. P.)—Major Burr, assistant military attaché of the American embassy at Mexico City, his wife, Dr. Florence Hale, and a Mr. Hurd, all Americans, were passengers on a train of the Mexico City-Cuernavaca railroad which was attacked by bandits on March 28 near Tres Marias, the state department was advised today by the American embassy at Mexico City.

All Americans escaped without injury, according to the advice.

# Limit Put on Students

# Tolls Cut Is Planned

Spokane, Wash., April 2.—Long distance telephone tolls of some residents of the Inland Empire outside of Spokane may be cut 50 per cent by a new system, announced by Frank Davies, assistant superintendent of the Interstate Utilities company, which controls the telephone lines in Northern Idaho.

# DAIRYMEN HAVE ACCEPTED RULING UNDER PROTEST

Dairymen will accept the findings of the milk commission appointed by the mayor. The reduction in the price of milk from 15 to 13 cents a quart—the dairymen receiving \$3.20 instead of \$3.90 a hundred pounds—will be effective as of April 7, it was said this morning.

Both sides in the milk controversy state, however, that they accept the recommendation under protest, believing the milk commission did not sufficiently investigate the facts governing the production and the distribution of milk.

A. M. Work, speaking for the dealers, said the new price would impose loss. Albert S. Hall, speaking for the Oregon Dairymen's league, repeated a former statement that the cost of production is in excess of the old price paid the producers—\$3.90, gross, a hundred pounds.

In announcing to Mayor Baker their acceptance of the commission's report, both distributors and producers said they did so because they had pledged themselves to abide by the commission's findings.

The dairymen insisted that the proposal by the milk commission for a division of the losses occasioned by sales of surplus milk at by-products price be put in more definite form.
