

SCORES OF INSANE ALIENS DEPORTED FROM PORTLAND

Two carloads of insane foreigners left Portland this morning for New York where they will be deported to their respective native lands. Seven of the lot were taken from the asylum at Salem and one man from Morningside hospital.

Four of the insane were Austrians and three were Germans, the first lot of insane from these countries to be deported since the beginning of the war in 1914. A car was brought up from the South with 25 inmates, including many anarchists, and Seattle district brought two aliens, making a total of 34 prisoners leaving Portland.

The subjects for deportation are in charge of Inspector Ed Kline of the immigration bureau in Washington. Other insane foreigners will be picked up en route and it is expected the number will total 100 when the cars reach New York.

Domestic differences attended the departure of one of the insane Germans. He had followed a Canadian woman into the United States, whose divorced husband he had worked for in Canada. He was committed to the insane asylum and later paroled, when the woman, against the advice of immigration officials, married to him. Then came the deportation measures and papers were made out to the woman so that she might accompany her insane husband to Germany. Then the German, in a burst of fervor for his fatherland, bent up his wife and told her she wasn't fit to associate with his relatives and friends in Germany.

The woman, weeping bitterly, went to the immigration authorities, with the result that her husband was sent on, while she is retained while her case is taken up with Washington for the purpose of canceling her deportation papers.

No Playground Sites To Be Purchased Till Court Action Ends

Where condemnation proceedings on lands desired for playground purposes are decided on no part of the land will be purchased until court proceedings are settled, even if certain lots can be had at agreeable figures, according to a decision reached by the city council this morning.

Commissioner Pier, in charge of the park bureau, introduced an ordinance calling for payment of \$4110 to Mrs. Helen L. Stratton for four lots included in the central east side tract bounded by Seventeenth, Twentieth, Taylor and Belmont streets. Commissioners Bigelow and Barbur objected to the purchase of the lots until values of remaining lots in the tract could be determined by condemnation proceedings.

The central east side property is assessed at \$33,065. Other owners, besides Mrs. Stratton, have refused offers made by Park Superintendent Keyser for their lands.

Siberia Painted as Country of Vast Natural Wealth

Siberia is a country whose resources in minerals, timber, fertility of soil and favorable climate are as great, if not greater, than those of the United States, said Dr. A. K. Higgs, Portland, speaking before the Portland Rotary club Tuesday afternoon.

Dr. Higgs spent a year in Siberia for the Red Cross.

"It is a land where birds sing; there are trees and flowers and fish in the streams," said he. "It is a wonderful country. It is not the land of eternal snow, ice and wolves where prisoners from Russia wear out their lives. That is a fallacious picture.

"But, nevertheless, it is a land blighted by revolution and radicalism and fear. Its development has raised until men can think sanely again."

Mrs. J. Creighton, Oregon Pioneer, Is Dead, at Age of 85

Mrs. Mary Jane Creighton of 471 Jefferson street, widow of John Creighton, died at the family home Tuesday night.

Mrs. Creighton was the daughter of David and Mary Ann McCully, pioneer residents of Salem. She was born in Burlington, Iowa, August 18, 1844, and crossed the plains with her parents in 1852, settling at Harburg. A few years later the family moved to Salem, where Mrs. Creighton spent her girlhood. She was married to John Creighton of Union, Or., December 24, 1868. They lived in Union until 1879, when they moved on a large stock ranch in Wallawa county. Upon the death of her husband in 1884 she moved with her four girls to Salem.

For the past 13 years she has lived in Portland with her daughter, Mabel. Three daughters and two brothers survive: Mrs. W. H. Dancy of Salem, Mrs. W. L. Jones of Salem, Miss Mabel Creighton of Portland, Alfred McCully of Butteville and F. G. McCully of Joseph.

Mrs. Sarah Goddard

SALES AGENT HAS LIVED HERE UNDER ASSUMED NAME

E. M. Padden, sales agent for the Metzger, Parker & Ferguson Realty company, who admits his true name is Everett Philpot, was arrested this morning by Deputy Sheriffs Christofferson and Beckman on a warrant issued from Nashville, Tenn., charging that Philpot obtained money under false pretenses. He was indicted in Tennessee on this charge in 1914.

He came to Portland at that time and for six years has been a resident here under the name of Padden. He has a wife and one child and resides at 467 East Fifty-seventh street north.

Bail was fixed by Circuit Judge McCourt at \$1000. It was stated that the man will not fight extradition proceedings, but he says he expects to be able to straighten out the difficulties without having to return to Nashville. The present charge involves an amount of a little more than \$900, but it was indicated that other charges might be filed.

ALLEGES TROUBLES BEGAN WHEN RELATIVES 'MOVED IN'
Divorce suits filed Monday include an action brought by R. W. Keith against Blanche M. Keith charging cruel and inhuman treatment; Fred P. Sadler against Elvie U. Sadler, desertion; Dora Hess against J. W. Tolliver, on the same grounds.

Mrs. Hess alleges that when she married J. W. Hess, he had two daughters, who came to live with them; and that soon after their marriage the plaintiff was neglected while her husband took his daughters on trips and to places of social pleasure, and that the plaintiff was ignored in the discussion of all family affairs, while the daughters were constantly consulted.

JUNGE GRANTED FURTHER TIME IN WHICH TO PLEAD
On behalf of August Junge, E. V. Littlefield has asked that the time to plead on grand jury indictments be extended until next Monday afternoon. This request was granted by Circuit Judge McCourt.

Junge, who has been indicted on four counts, one charging the obtaining of money under false pretenses, and three on the charge of larceny by bailee, appeared in court while the long indictment was read. He has been indicted to half in the sum of \$5000, the original bail amount of \$15,000 having been reduced to that figure. His bondsmen are Henry Schwartz, 844 East Eighth street north; Adam Bihl, 762 East Tenth street north; G. J. Hohnstein, 830 East Tenth street north, and Nick Spady, 763 East Tenth street north.

COURT FAVORS DEFENSE IN SUIT OVER PLOW PATENT
Circuit Judge Tazewell Tuesday decided in favor of the defendant in the suit of T. O. Bird against William Watson. Watson, who is a veteran of the Civil war, invented a combination tractor to plow in the summer, and the suit of Bird was to obtain a one fourth interest in this invention, based on an agreement that Bird would push the promotion of the implement. Watson alleges that it was not until the agreement was abrogated, nearly 14 months later, that Bird did bring to him parties who eventually became interested in the invention, and that the negotiations were between himself and other parties and not through Bird. He alleged that he did agree to "do what was right" by Bird, but would not give him a quarter interest.

GRAF HELD FOR CONTEMPT. RELEASED ON \$2000 BOND
H. H. Graf, who was arrested at Eugene, Monday afternoon, on the charge of contempt of court, on an order issued by Circuit Judge Tazewell, obtained his liberty Tuesday by putting up a bond for \$2000.

Graf, on April 16, was removed as guardian of the estate of John Hugo Bedford, Chauncey Bedford and Beatrice Ora Bedford, minors, after having been repeatedly notified to make a report of his action in handling the estate. The court order was that within three days he present to it all documents and property of the estate. Graf

WILL OF LATE H. B. JOHNSON IS SUBMITTED FOR PROBATE

The will of Hamilton Boyd Johnson, who died last February, was filed for probate Monday. Soon after his death, when no will was known to exist, Mrs. Annie Wylie, sister of the deceased, was appointed administratrix, but after a will, dated in 1910 was found in a safe deposit box rented by Johnson, and this was the instrument admitted to probate Monday.

In this instrument he provided for the leaving of his estate, with the exception of a diamond ring and \$250 in cash, to the widow. These items were to go to his daughter by a former marriage, Mrs. Bernard White, of Bellingham, Wash.

Dr. Lovejoy Is Too Busy to Return Here For Campaign Work
Tied down to official duties in the East, Dr. Esther Pohl-Lovejoy will not be able to return to Portland to take an active part in her campaign for the Democratic congressional nomination, for a time at least, according to Miss Clara Pierce, who has just returned from New York for a two months' visit with her parents, Senator and Mrs. Walter M. Pierce.

Dr. Lovejoy is presiding over the national convention of the National Woman's Medical association, now in session in New Orleans. Miss Pierce says, and next week will be in Connecticut to aid in bringing about a special session of the legislature of that state for the ratification of the national suffrage amendment. She is to go to New Haven by request of Mrs. Carrie Chapman Catt, president of the National Suffrage association, in an effort to induce the governor to call the session, which action he has heretofore refused to take.

Incidentally Miss Pierce says the foreword to Dr. Lovejoy's book, "The House of the Good Neighbor," the second edition of which is now being taken for the press, has been written by Herbert Hoover.

Complaint Is Made Against Foreigners' Ways of Marketing
Complaint against non-enforcement of the market ordinance aimed at "indiscriminate, subtle and servile foreigners" to the detriment of American producers was filed with the city council this morning by the Market Producers' association.

The communication calls attention to the present public market ordinance which states that "only bona fide producers shall be allowed to sell for more than one person on the market, and that producers shall have only one agent selling for them at one time." The Market Producers' association claims that foreigners are able to outwit market inspectors and disobey the ordinance.

Passenger Agents of Northwest to Meet
Holding the first meeting of the North Pacific Coast Passenger association, since that organization was reformed shortly after the conclusion of government control, passenger agents of the Pacific Northwest are gathering in Seattle today. A. D. Charlton of the N. P. is chairman of the committee and others who are in attendance from Portland are: William McMurray of the Union Pacific, John M. Scott of the Southern Pacific, and R. H. Crozier of the S. P. & S.

Shriners to Visit Alaska Following National Meetings
Imperial representatives of the Mystic Order of Shrine from over the country will take a month's cruise to Alaska immediately following the convention in Portland in June, according to word given out by Mayor Baker this morning.

The pleasure trip is being arranged by AFM temple of Shriners of Tacoma and will be under the personal direction of Ellis Louis Garretson, deputy imperial potentate, and incoming imperial potentate. Two boats have been chartered and more than 600 Shriners are expected to make the trip. Mayor Baker, W. J. Hofmann, A. H. Lee and Judge George Stapleton are Portland Shriners scheduled to make the journey.

Federal Agents Accusers
Charles Marquette, convicted in federal court last October on a charge of violating the Reed prohibition amendment and sentenced to a jail term therefor, was arrested by federal officers this morning for operating an illicit distillery.

GASOLINE CONTROL OR RESTRICTIONS ON MOTORS URGED

Washington, April 23.—(I. N. S.)—With reserve supplies of gasoline greatly depleted and with the reserve supply of crude oil sufficient but for six weeks, government officials are considering means of controlling the supply of gasoline or limiting the use of motor vehicles, it was learned today.

The bureau of mines is now engaged in collecting data on the production and consumption of gasoline as a basis for recommendations for the conservation of gasoline.

REMEDIES ARE SUGGESTED
One remedy which has been suggested is the allocation of available gasoline under government supervision and another plan has been advanced for restrictions upon the use of motor vehicles in order that a sufficient supply of gasoline may be assured for necessary uses.

Information collected by the bureau of mines indicates that the gasoline shortage, which is acute throughout the country, is due in a considerable degree to the attempts of foreign interests to corner the world's supply of crude oil.

SUPPLY IS REDUCED
Money borrowed by foreign interests in the United States at 5 and 6 per cent interest has been used to acquire available oil lands throughout the world. This movement has reduced the oil and gasoline supplies in the United States.

Demand for gasoline is now at the highest point it has ever been. To increase the stringencies of the situation and making the demand more acute, the bureau of mines has found that the quality of gasoline has rapidly deteriorated since 1915.

BRITISH AND AMERICAN OIL INTERESTS VIE FOR CONTROL

London, April 23.—British economists see developing a world-wide struggle between British and American oil interests for control of the dwindling international supply.

That the struggle will develop into a tremendous economic war as demands for the product increase and the available supply diminishes is the firm conviction of these authorities.

The Standard Oil company of America is reported as attempting to absorb the smaller foreign oil companies with a view to a world monopoly. At the same time it has been persistently reported and likewise denied that the British government is planning to secure a controlling interest in all of England's oil companies for the purpose of safeguarding the nation's war strength in the future. There is strong ground for believing such a move is near at hand.

Predict Smelt Run Will Continue for Another Ten Days
Smelt will continue to run in the Sandy river for at least 10 days and from all indications the up-river migration will continue to grow instead of decrease toward the end of the week, according to A. E. Burghdoff, state game warden.

Burghdoff and several other officials of the fish and game commission spent Tuesday morning on the upper Columbia. They reported that the fish were to be found as far up the river as The Dalles and that from the mouth of the Sandy river to Vancouver the Columbia was jammed with smelt.

Hines Is Sued for Personal Injuries
Sui against Walker D. Hines, director general of the United States railroad administration, through which Charles Schulze, a railway mail clerk in the Ashland division, expects to recover \$50,210, was started before Federal Judge Bean in the United States district court this morning.

Schulze alleges personal injuries in the performance of his duties.

Farmers Loaned Big Sum by the Federal Banks During March

During the month of March, 1920, an aggregate of \$9,703,290 was loaned to 2436 farmers of the United States by the federal land banks on long time first mortgages according to the monthly statements made to the farm loan board. The federal land bank of Omaha leads in the amount of loans closed, the same being \$2,194,100, the federal land bank of St. Louis following with \$1,928,000. The other banks closed loans in March as follows: Louisville, \$898,400; Houston, \$879,215; New Orleans, \$819,675; St. Paul, \$780,700; Wichita, \$608,100; Spokane, \$470,100; Berkeley, \$342,800; Springfield, \$306,600; Columbia, \$301,200; Baltimore, \$266,600.

During March 2269 applications were received by the 12 banks, asking for \$9,209,499, and during the same month 2676 loans were approved by them amounting to \$7,480,342.

On March 31, 1920, there were operating in the United States 3995 farm loan associations, and the total mortgage loans made by the federal land banks through these associations to 124,492 farmer-borrowers as of that date, amounted to \$344,721,366.

Suit Begun to Halt Hearst Purchase of Seattle Newspaper

Seattle, April 23.—(U. P.)—That William Randolph Hearst is endeavoring to buy control of the Post-Intelligencer here is the contention of Clark Nettleton, its publisher, in a suit filed in superior court late yesterday. The suit is brought to restrain George Boole, local financier, from selling 700 shares of Post-Intelligencer stock to Hearst. Boole has been cited by Judge John E. Jurey in court Friday to show cause why he should not be restrained.

Nettleton alleges he borrowed \$55,000 on December 2 last from the Union National bank, giving the stock and a note as security. The note, he says, was endorsed by Boole and Kenneth Mackintosh, supreme court judge, and was due March 1. On February 20, he alleges, Boole paid the note and took the stock, refusing to return it, despite repeated offers to pay its face value with interest, and is now threatening its sale to Hearst.
