

BLUEBEARD PLEADS GUILTY TO MURDER IN FIRST DEGREE

Los Angeles, May 6.—(I. N. S.)—
“Bluebeard” Harvey, arraigned on a charge of five of two dozen “wives,” pleaded guilty here today in superior court to the murder of Nina Lee Deloney, whose body he revealed in its Devil’s Canyon grave.

The indictment is one for murder in the first degree, warranting a sentence of death. Superior Judge Willis, before whom he pleaded, set Monday at 10 o’clock as the time to impose sentence. NO EMOTION SHOWN
“Bluebeard” stood alone, supporting himself on the rail of the jury box, as the indictment was read to him. Not one tract of emotion crossed his face as he was formally accused of the brutal crime.

To this indictment, how do you plead?” asked the prosecutor.
Harvey’s answer was in no faint a whisper, it could scarcely be heard. In reality his lips only shaped the word, “Guilty.”

Immediately Superior Judge Willis set Monday at 10 o’clock as the time for sentence. SANITY QUESTION
“As there seems to be some doubt as to this man’s sanity, I will appoint two physicians to examine him and report to me the court announced from the bench.

District Attorney Thomas Lee Woolwine did not make his recommendation to the court that Harvey be given life imprisonment instead of the death penalty. The district attorney did not address the court, as such a recommendation is only made at the time when sentence is pronounced, which will be Monday morning.

Woolwine declined to state whether he will follow the terms of his reported agreement with Harvey, in which the “Bluebeard” is said to have been assured, before the indictment, that if life imprisonment instead of the death penalty would be recommended. The indictment is based on the death of Nina Lee Deloney of Portland and Louisville, Ky., woman whom “Bluebeard” married in San Francisco and whose body he revealed Tuesday in its lonely grave.

INDIGNATION IS HIGH
Public indignation is at a high pitch here today at any possibility of the arch-murderer escaping the death penalty. Prominent citizens have interposed protests to District Attorney Woolwine against any recommendation of life sentence.
Early today Harvey sent for Woolwine, telling attendants that he wished to give additional facts. Everyone thought he had decided to have more murders, but when Woolwine arrived at the hospital he said he had experienced another lapse of memory and, therefore, didn’t know if he had disposed of other “wives.”

IGNORES INSANITY DEFENSE
“If I recall any other names of missing women and know what happened to them, I’ll send for you at once,” he said. He gave out the following statement today:
“There has been some talk about my building up an insanity defense. I do not wish to enter a plea of insanity. This is final. I wish the public to believe me when I sincerely state that I am possessed of an abnormal mentality.”
“‘There are obvious reasons why I desire to be found guilty of murder in Los Angeles county. I do not want to go back to Washington. I could never live through that ordeal. Capital punishment is in effect there now, and I might never live to stand trial. People are more primitive there. California penitentiaries are run better, anyway.”
“However, I am not emotional. When I have done these things, done away with the women, I can’t seem to stay any sort of emotion concerning them. They just appear matter of fact. I’ve tried and failed.”
Bluebeard is resting well, eating heartily and gaining strength rapidly, county hospital attendants declare. He will be fully strong enough to go into court Monday or Tuesday for his sentence.

Couple Married in Portland in Court In Divorce Action

Two Acquitted by Court of Stealing Government Wool

First Trial Called Here on the Charge Of Making Stills
The first trial on a charge of manufacturing stills for making whiskey will come before Judge Bean in federal court Friday morning, when the case of H. W. Hoeker and his son, Henry Hoeker, is called.

The Hoekers, who were arrested last fall, are accused of manufacturing the stills in their tin shop at 228 Ash street, and, according to United States Attorney Charles Reames, a complete plant, made of copper, carrying a still, was used in a straight shoot for the condensed liquor to pass through, will be introduced in evidence.

EX-POLICEMAN IS FACING CHARGE OF GRAFTING ON JOB

Charges of grafting from the Chinatown while he was a member of the Chinatown squad of the police force were made against H. L. Watson, ex-policeman, by Grace Lee, chief witness for the government in a prosecution begun today for violation of the Mann white slavery act. Watson was a member of the department for a few months during the winter. While still in probation he was discharged in March. He was arrested this week by the police and today a warrant charging white slavery was served on him by the government and he is lodged in the county jail awaiting preliminary hearing.

Watson collected small amounts of money from various merchants in Chinatown under the pretense that he was protecting them from police prosecution for illicit dealing in opium and other narcotics, according to the Lee woman’s statement. United States Attorney A. F. Flegel Jr.
According to the woman’s statement, he had her from Butte, Mont., to Port Townsend, Wash., thence to Seattle and finally to Portland. The last leg of the journey was accomplished last November before Watson was accepted on the police force.

When Watson was transferred from the Chinatown squad of the police force to the general squad, he endeavored to enlist Flegel’s services to get him back on the detail, Flegel said today. He refused to aid Watson, who a short time later was removed.

TWO SENTENCED TO COUNTY JAIL FOR STEALING POTATOES
George Abdie and Charles T. Tedesco were sentenced by District Judge Jones Wednesday to five months in the county jail for larceny. On April 17 they with three others pleaded guilty to the charge of robbing a Pleasant Valley farmer of 100 bushels of potatoes. Abdie and Tedesco were recommended to the watchful care of Attorney F. G. Smith, who indicated a personal interest in their welfare.

Only five days later both were arrested by Patrolman F. W. Gouldstone for violation of the state motor vehicle law. Abdie had only one license card on his vehicle, and Tedesco had secured no license, but was using Abdie’s other tag. They were sentenced to 30 days in jail and each pay a fine of \$50; but Smith took the matter to Governor Olcott and secured their pardon.

When Judge Jones learned of this offense after he had given the boys a new opportunity, he issued a bench warrant for them. When they appeared before him Wednesday, Deputy District Attorney George Mowry laid all the facts before the court, and although Smith asked for leniency for his tentative wards, they were promptly sentenced.

WIDOW SUES POWER CO. FOR LOSS OF HER HUSBAND
Suit for \$7500 damages was filed Wednesday by Mrs. Nellie B. Hauptert, widow of Joseph F. Hauptert, and administrator of his estate, against the Portland Railway, Light & Power company. The complaint recites that on May 6, 1918, while Hauptert was driving a motorcycle on Union avenue, he was struck by a street car and thrown to the pavement,

sustaining injuries from which he died. Hauptert was 79 years of age.

Water Company Bond Approved
Bond was approved and a franchise was granted by the county commissioners Wednesday to the Barwell Water company to lay and maintain water mains in certain county roads, beginning at the east side of Ninety-second street, and extending on the Jacobson road to Sunset Street, and on the north boundary, and beginning at the same street and extending on the Fuller road to the Clackamas county line.

Accused of Altering Meter
Mrs. May Schultz, who conducts a rooming house at 28 1/2 Park street, was bound over to the grand jury today by District Judge Jones on the charge of altering and preventing the proper registration of an electric meter. She is at liberty on \$250 cash bail.

Woman Sues Alleged Rival
Ida V. Roberts, formerly wife of Isaac S. Labowitch, from whom she was divorced last November, is suing Mrs. Sarah Cohen, in District Judge Stapleton’s court today, for \$25,000 for alleged alienation of the affections of Labowitch.

Seeks Writ of Review
Laura E. Kennedy filed a petition to the circuit court Wednesday, praying for the issuance of a writ of review compelling the civil service board of Portland to produce in court all records of the board in regard to her discharge from city service.

G. N. IS PLANNING NO EXTENSION IN LINE THIS YEAR

New extension work will not be attempted this year on the Great Northern railroad system, the company preferring to concentrate on improvement of present facilities and addition of new equipment, according to a statement made this morning by Ralph Budd, president of the road.

Budd, accompanied by J. H. O’Neill, general manager of the Great Northern, arrived Wednesday evening from St. Paul. The Great Northern officials were met at Spokane by L. C. Gilman, president of the S. P. & S. Budd has been making his periodical inspection trip and came to Portland to attend a meeting of railroad executives and confer on future use of the Union station by the Great Northern.

Budd is a former resident of Portland and one of the youngest railroad presidents of the larger systems. He was employed by the S. P. & S. as chief engineer for four years and had charge of the building of the Oregon Trunk railroad. His mother and sister are residents of this city.

“The Great Northern railroad is short of cars just like other western systems,” said Budd, “but we are attempting to overcome this by a faster movement of available cars until other equipment can be added. The outlook is gradually growing better for the purchase of new equipment and we are much encouraged by the rapid movement being made.”

Budd said the Great Northern had not yet given consideration to reestablishment of coastwise steamship service out of Portland because of the multiplicity

of problems which the railroads are facing. The officials of the Great Northern will probably leave for the North and East this evening.

INEXPENSIVE HOUSES MAY BE ERECTED IN OUTLYING SECTIONS

Housebuilders and representatives of the Portland Realty board will meet with Commissioner Barbur, in charge of the bureau of public works, Monday at 8 p. m., to formulate plans for the construction of numerous inexpensive houses in outlying districts to help solve the acute shortage in housing facilities.

Residential districts will not be encroached upon, but outlying districts will be canvassed to find out where land can be acquired cheaply for homes at low cost.

BIG SUNDAY SCHOOL CONVENTION OPENS; ATTENDANCE HEAVY

Delegates arrived in Portland this morning from all parts of Oregon to attend the annual Sunday school convention which began this afternoon in the First Presbyterian church, Twelfth and Alder streets. A public mass meeting will be held at 7:30 tonight. Classes for Sunday school workers, regardless of their denominational affiliations, will be held all day Friday from 8:30 a. m. to 4:30 p. m. A young people’s banquet will be served in the First Congregational church at 6 p. m., and another mass meeting will be held in the convention church at night. The sessions will last through Sunday night.

WEBSTER CHAIR CO. TAKES LEASE UPON BUILDING LOCATION

The Webster Chair company, a branch of the Webster Manufacturing company of Minneapolis and St. Paul, closed negotiations this week for the purchase of a quarter block at the southwest corner of Twenty-seventh and Nicolai streets from Wakefield, Fries & Co. The concern also secured a three-year extension of the lease on its present location at Fifteenth and Thurman streets through the same agency.

According to F. E. Thomas, local manager of the company, the new site will be used for a warehouse and manufacturing plant. The local branch is active only in distribution of chairs manufactured in the East, and the recent establishment of a cut-up plant here by Heywood Brothers & Wakefield, through the purchase of the Oregon Chair company, it is considered probable that the Webster concern will build a large finishing plant to meet growing competition in its northwestern market.
