

REDS ROUTED BY POLISH FORCE IN COUNTER ATTACK

London, May 25.—(L. N. S.)—"Russian Bolshevik forces, attacking the Poles on the northern end of the battlefield, are being repelled with heavy losses and in some sectors the Poles are launching vigorous counter assaults," said a Central News dispatch from Copenhagen today, quoting advices received there from Warsaw.

The dispatch added that fresh Russian reinforcements are constantly arriving on the Berezina river fighting line. Many of them are from the Red workers' army in the interior of Russia.

WAR BETWEEN POLES AND CZECHS HELD INEVITABLE Washington, May 25.—(L. N. S.)—Proclamations have been posted at Warsaw calling on the Polish government to take action against the Czechs and war seems inevitable unless the allies intercede, according to a cable from Warsaw received here today.

Reports of terrorization of Poles in Silesia by the Czechs have led to public demonstrations, the dispatch declared. Reports received in Warsaw from Teschen in the Silesian plebscites area show the situation is serious. Raids are being made by armed bands of Czechs in the Karwin mining region, the dispatch added.

RUSSIAN REACTIONARIES TO GIVE AID TO THE POLES By Frank Mason Prague, Czechoslovakia, May 25.—(L. N. S.)—Russian reactionaries are organizing two big armies in the Balkans to cooperate with the Poles in the war on the Bolsheviks. According to information from reliable Czech sources today, the French are supporting the military measures of the Russian reactionaries and have promised to propose to the entente at the Spa conference that the allies support this new anti-Bolshevik movement.

Opposition to the American people being called upon to assume responsibility for Armenia has been repeatedly voiced in the senate by both Republican and Democratic senators opposed to the president's attitude on the League of Nations and the peace treaty.

Vancouver, B. C., To Be Represented At Floral Parade

Vancouver, B. C., will be represented by an entry in the floral parade of the Rose Festival, according to word received today by Eric V. Hauser, president of the Festival association, from L. A. Wolfe of the Vancouver Board of Trade.

Particular significance is attached to the entry of the northern cities, for this is the first year in the history of the festival that either has been officially represented.

Hauser returned Sunday from British Columbia. He held a conference in Vancouver with J. P. D. Malkin, president of the board of trade, and with Wolfe.

In addition to the northern cities, Pasadena will again be represented by a gorgeous float. Recently H. R. Blauvelt, vice chairman of the parade committee, conferred with the officials of the Tournament of Roses association.

Should the Armenian mandate be declined, it is believed here, the European nations will proceed to adjust things to suit themselves without further regard for American views, either in the former Ottoman empire or elsewhere.

Neither Britain nor France cares to assume the mandate in Armenia. They said their capacities would be strained by obligations they had already undertaken, and turned to America because of the interest this country had continually manifested in Armenia.

Maintenance of an army far away from home and the expense incident to stabilizing Armenia are certain to arouse hostility. There are evidences of opposition also on the grounds that since America declined to join a League of Nations, it would be illogical for her to discharge the duties of a member of such a league.

The president offered no details about expenses or the plan of administration in his message. This information would be developed at hearings before the senate foreign relations committee.

While the mandate would come from the League of Nations, it is presumed it would be necessary to specify that America would not put itself in the position of accepting directions from the league. When the league covenant was prepared, a contingency was not foreseen wherein a nation not a member would be offered a mandate.

PAUPERS' GRAVES SURROUND CARRANZA'S BURIAL PLACE By Ralph E. Turner Mexico City, May 25.—(U. P.)—Surrounded by paupers' graves, marked only by tiny heaps of stones or simple wooden crosses, in the midst of a clump of evergreen trees on a knoll overlooking the valley in which nestles the City of Mexico, the body of Venustiano Carranza, murdered president of Mexico, was buried late yesterday.

To the eastward rises the snow-capped peak of the famous volcano Popocatepetl. The mound covering the simple casket is no different than the scores of those covering the more humble dead with whom Carranza was buried, according to his wishes in Dolores cemetery—the cemetery of sorrows.

In years past Mexico seen such crowds as those which choked the streets during Carranza's burial. They were all classes, sombered pious mingled with silk-hatted men of wealth and position, and thousands of women and children elbowing their way to positions where they could better view the procession.

The mob had gathered at the Carranza residence and in approaching streets long before 4 p. m., the hour when the funeral services in the home were to be held. The services were brief. They were attended only by intimate friends and a few officials.

LOBBYING FOR JUST CLAIM HELD LEGAL

Salem, May 25.—Lobbying before a state legislature or the congress of the United States in the interest of a just claim is neither against public policy nor unlawful, according to Justice Bean of the Oregon supreme court in an opinion handed down today in the case of Samuel Herrick vs. Charles W. Barzee.

Barzee, according to the testimony introduced in the case, had employed Herrick, a Washington attorney, to present a claim for \$1900, representing the value of improvements made by him on a homestead, the right to which was later cancelled, before congress. The claim was ultimately allowed by congress and Herrick instituted suit in the Multnomah county circuit court to collect his fee.

Barzee moved for a non suit on the ground that the contract was against public policy and the non suit was granted by Judge Gatens.

In his opinion this morning, reversing the decree of Judge Gatens and remanding the case for a new trial, Justice Bean declares:

"A contract for services to be rendered by an attorney before the legislature or the congress of the United States in securing the passage of a law for the payment of a just claim is not unlawful if it does not contemplate the use of improper means and if the services to be rendered are such as appeal to the reason of those whom it is sought to persuade."
