

DAY REELECTED TO HEAD REPUBLICAN COUNTY CAMPAIGN

Running true to program and according to prediction, J. L. Day's county central committee met at The Auditorium Wednesday evening, elected him county chairman, elected Joe E. Dunn state committeeman from Multnomah county, adopted a platform which, as is customary, pointed with pride to the days of yore, gave three rousing cheers and adjourned.

There never was any doubt, of course, as to just what the committee would do when it gathered at the call of his outgoing and incoming chairman. Day had seen to it that he would be in the house of his friends by filling some 300 cardinals for precinct committeemen, far more than the necessary majority even counting on possible defections. And, in order that there might be no confusion or uncertainty over the right path to follow, Chairman Day's lieutenants were conveniently placed, each with his appropriate motion to make and chore to do. In other words it was a well ordered and entirely harmonious convention which had its task cut out for it, and knew how to deliver.

In addition to the reelection of Day as chairman, and the selection of Joe E. Dunn as state committeeman in place of David M. Dunne, with whom Chairman Day has had a political falling out, Lynn B. Covert was elected secretary of the committee and Mrs. Clara B. French treasurer.

The platform was prepared by a resolutions committee appointed by the chair, consisting of J. C. Walsh, Martin Griffin, Captain C. T. Belcher, J. S. Roark, Mrs. W. R. Jacobson, Judge Robert L. Morrow and John R. Latourette.

The platform as adopted, which was an exhaustive document, opened, as usual with all party platforms, with high praise of the history and achievements of the party whose adherents adopted it. Its record in labor legislation was constructive and the only states having such legislation were Republican states, it pointed out. Suffrage was born in Republican states, the platform contended, and is being brought to a realization in all those states where the party is dominant. It declares for a league of nations founded on justice to America and the weaker nations of the world. It stands behind bonus legislation to soldiers of the great war, says reclamation of arid lands is of vital importance to the nation; champions reforestation and advocates the release of lands now held in forest reserves, conditional upon reforestation, and making them taxable to the state; recommends government aid and encouragement in the development of the water power of the nation; recommends the enactment of laws freeing American ships engaged in coastwise trade in behalf of a naval base at the mouth of the Columbia; stands "four square against Bolshevism" and advocates that the right of free speech be curtailed whenever it is used in any way to disturb the principles of American government; demands to know what Chamberlain has done for Oregon; recommends the establishment of a secretary of education as a member of the cabinet and holds that it should be the duty and the welcome privilege of every Republican to vote at the November election as a protest against the gross extravagance and utter incompetence of the Democratic party.

The committee also plans to stage a big demonstration in celebration of the presidential and vice presidential nominations made at Chicago and appointed a committee to take charge of the plans for the event. The committee consists of J. L. Day, ex-officio chairman; Joseph E. Dunn, Ed Mendenhall, George I. Thompson, Mrs. Clara B. French, Frank Lacey, Fred Valentine, C. B. Turley, A. A. Bailey, Mrs. Richards, Leonard Krause, Jr., Thomas McCusker, J. D. M. Crockett, James McCarren, L. R. Morrow, R. L. Searies, James Robinson and O. A. Eastman.

tion did not apply particularly to the Oklahoma case.

"But," he said, "a majority of the contests this year, as in former years, have arisen from the fact that district and state conventions in the south are often held in places where negroes are not permitted."

WARREN MOTION INDORSED

Committeeman Hynicka of Ohio, speaking on the motion, protested the motion was unfair to Oklahoma and suggested it was a matter to be placed before the national convention. Several committeemen jumped to their feet immediately, and Acting Chairman Pat Sullivan of Wyoming had difficulty restoring order. Committeeman Howell of Nebraska was finally recognized and made a speech indorsing Warren's motion.

"I am sick and tired of these everlasting flings at the south," said

Committeeman Jackson of Georgia, "from the gentlemen from Michigan and other parts of the north. They hold their conventions in hotels or anywhere they see fit."

In the case of the fifth congressional district of Missouri, both the Lowden and Wood delegations of two men each were thrown out. This reduces the total temporary roll of the convention to 82 and makes only 42 necessary for each choice. The Missouri delegates say they will carry their fight to the credentials committee.

WOOD LOSES 25

Owing to the fact that in the District of Columbia and the incomplete case of Mississippi, both contesting delegations were supposed to be for Wood, the score of defeats in contested delegates so far, including the disenfranchised Missouri district, was: Wood 35, Lowden 4.

The entrance of Jacob L. Hammon of Oklahoma in the race for the nomination has resulted in further distribution of the delegates. According to the best obtainable information the vote on the initial ballot, exclusive of the 89 contests yet to be decided, might be:

Wood 24, Lowden 17, Johnson 17, Nicholas Murray Butler 33, William C. Sprull 7, Senator Warren G. Harding 48, Governor Calvin Coolidge 23, Senator Howard Sutherland, Senator Miles Poindexter 14, Hammon 12, Judge J. C. Pritchard 5.

SUBJECT TO FLUCTUATIONS

This relative standing is subject to daily fluctuations as the result of decisions in contests, political "maneuvering" and to accept the word of several veteran politicians—the sensational testimony at the senatorial investigation in Washington of campaign expenditures.

The first divisions in votes of the national committee relative to the contesting delegations came yesterday. The first was on the tenth congressional district of Minnesota and the second on the fifth Missouri. The Minnesota contest was between a Johnson and a Wood delegation, the former winning, 36 to 12.

LOWDEN MOTION DEFEATED

The next division was on the motion to seat the Lowden delegation in the Fifth Missouri district, opposed by a Wood delegation. This was defeated, 25 to 20. But this action lost most of its significance when the committee decided to refuse both delegations seats.

The first cases scheduled to be taken up today were those of eight contests in Florida and 15 in Georgia, both of which had been referred to subcommittees. Next on the calendar was that of the district delegates in Mississippi, the delegates-at-large from that state having been determined yesterday.

GOLDSTEIN DECLINES TO RESIGN AS WOOD DELEGATE

St. Louis, June 2.—(U. P.)—Nat Goldstein, circuit clerk of St. Louis, today declared in answer to numerous declarations that he should resign as a member of the Missouri delegation to Chicago because of the Lowden campaign fund disclosures in this state, that he intended filling his seat in the convention.

Goldstein refused to comment on Governor Lowden's repudiation of him.

WORK ON J. K. GILL BUILDING WILL BE LAUNCHED IN 1921

As announced in The Journal several weeks ago, the J. K. Gill company will erect a new building on the quarter block at the southeast corner of Fifth and Stark streets. The building will be eight stories in height and cost approximately \$275,000. Construction will begin in January, 1921, according to W. A. Montgomery, vice president of the Gill company.

The site of the new building is owned by the King estate and was leased by the J. K. Gill company for a 20-year period with an option for a 10-year extension. The aggregate gross rental runs to about \$500,000, and at the termination of the lease the building will revert with the land to the King estate.

The ground leased has a frontage of 100 feet on Fifth street and an equal frontage on Stark. It is now covered by a three-story brick building occupied by the Sealy-Dresser store and other retail shops. The property was acquired by the King family in 1871 for a nominal sum and the building on the site was erected in 1900.

The J. K. Gill company has occupied its present quarters at Third and Alde streets for 27 years. The building was owned by the Masonic Building association and was recently purchased by I. Holman. The company has secured an extension of its lease on the building until the autumn of 1921. The J. K. Gill company was established here in 1870 and has been in continuous

operation under the present head of the firm since that date.

The lease of the King estate property was handled by W. A. Montgomery for the J. K. Gill company, and Alex Rue for the owners.

Funeral Held for Albert Richardson, Pioneer Contractor

Funeral services for Robert Richardson, pioneer builder of Portland, who died Tuesday in a local hospital, were held at 10 o'clock this morning at the Portland crematorium.

Richardson was born November 11, 1850, at Mount Pleasant, Canada. He was a member of a family of 13 children of whom seven are still living. He came to Oregon in 1870 and settled at Salem. In 1884 he removed to Portland, where he was in the building material business until 1920. After the loss of his wife in 1891 he retired from active business in Portland and went to his farm at Oak Grove, Or., where he lived ever since. In 1909 he married Miss Euphemia Bubb of Portland. He is survived by his wife, four sons, Norman S. Richardson and W. H. Richardson of Portland, Robert M. Richardson of Pasco, Wash., and Edwin I. Richardson of Tacoma, Wash.; three sisters, Mrs. Maggie Launder of Tacoma, Mrs. Charles Rathbun of Hood River and Mrs. Emma Slater of Oakland, Cal., and three brothers, John Ross Richardson of Portland, James Richardson of Tacoma and Jonathan Richardson of Tacoma.

Two Marines Are Wounded as They Attack Negroes

Waukegan, Ill., June 3.—(U. P.)—Two United States marines were wounded in a Great Lakes naval training station hospital today, and the naval authorities are planning the most drastic disciplinary measures for the station as the result of another race riot—the second in three days—in which a mob of sailors and marines late Wednesday night attacked the Waukegan police and attempted to burn down a hotel frequented by negroes.

Early Wednesday night the police received information that an organized band of sailors and marines intended to raid the Sherman house, the negro hotel which was the center of Monday's rioting, with the intention of setting fire to the structure. Armed with riot guns and reinforced by a number of overseas veterans, the police went to the hotel and awaited the attack.

At the hour designated, the mob of service men, numbering 150, poured out of a ravine back of the hotel and charged the structure. They were led by a sailor carrying the American flag.

The police commanded the attackers to halt, but the latter paid no attention. The hotel defenders then fired a volley into the air. The sailors and marines merely laughed—and came on. Then, while the terror-stricken negroes fled from the hotel—some of them women with babies in their arms—attackers and defenders closed in hand-to-hand fighting.

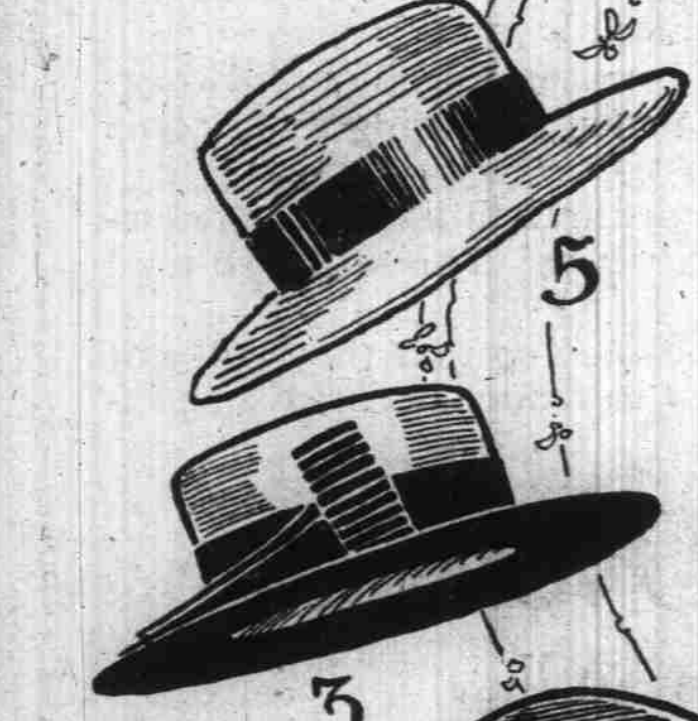
