

LEADING NOBLES ARE TO JOIN TRIBE OF REAL INDIANS

Imperial Potentate of Arabic Order of Mystic Shrine and Other Lodge Men to Visit Blackfeet.

W. Freeland Kendrick, Imperial potentate of the Ancient Arabic Order of the Mystic Shrine, and about a dozen other prominent Nobles, will be made members of the tribe of Blackfeet Indians before they reach Portland, according to information reaching Henry Dickson, city passenger agent of the Great Northern road, from Passenger Traffic Manager C. E. Stone, whose headquarters are at St. Paul.

Kendrick and other nobles will stop off en route to Portland, at Glacier National park, to attend the official opening of the park on June 15.

ALL DOLLED UP

Imperial Potentate Kendrick and his staff will be attired in the finery of their official regalia, for the Blackfeet Indians have arranged to meet them at the park station that day, when the Easterners will be taken into the tribe.

Louis W. Hill, chairman of the board of directors of the tribe, will be on hand at this notable ceremony of the Redskins. J. P. Jaeger of the housing committee of the Shrine announced Saturday that his committee would move from the Gasco building to their convention headquarters in the Oldsmobile salesrooms on Broadway, June 17, where all preparations will be made to care for the thousands who will come to the city for Shrine week.

Jaeger has called a meeting of two score or more Shriners in the Gasco building Monday night that plans may be laid before them for helping in caring for these thousands as soon as they arrive in the city.

MEET MONDAY EVENING

These men will work under the direction of Ivan Humason, Tommy Swivel and Harry Coffin. The meeting place is set for 822 Second street, and the time 7:30 o'clock sharp.

board for two consecutive terms during 1915 and 1916 he placed the local board in a strong civic position and appreciably increased its membership. Under his direction shady dealers were practically eliminated from membership in the board and the educational campaign was inaugurated which culminated in the passage of the real estate license law in 1919 by the Oregon legislature. As a result of his efforts to place the realty business on a higher moral level, Taylor was chosen first president of the Interstate Realty association which was organized here in 1918. This organization binds into a common union the leading realty dealers of Oregon, Washington, Idaho, Montana, British Columbia and Alberta and now has more than 1300 members.

In addition to his work in Portland and the Northwest Taylor has served several terms as a member of the executive committee of the National Association of Real Estate Boards and has been a strong factor in shaping the policies of that organization. During the war he served gratuitously as appraiser for the national association in work for the United States government and is credited in official reports with having saved the government hundreds of thousands of dollars in the purchase of real estate. The national association over which Taylor will preside for the ensuing year, has a membership of more than 10,000 realtors, representing over 200 real estate boards in this country and Canada. As president, one of Taylor's duties will be to visit the various realty boards of the association and these journeys will do much toward bringing the Pacific northwest prominently to the attention of Eastern financial interests.

The Taylor home is at 270 Shenandoah Terrace. Besides Mrs. Taylor there are four children, Arthur aged 14 and Annie aged 10, who join with members of the Portland board in congratulations to the new president of the national association.

Kansas City, June 5.—(U. N. S.)—Chicago is to be the next convention city of the National Association of Real Estate Boards. A decision to this effect was reached at the thirteenth annual convention of the association here this afternoon.

Immunity Assured From Prosecution For Gas Explosion

Nothing can be done in the way of prosecution by the city as a result of the gas explosion that demolished the home of F. H. Tatman, 1247 Milwaukee street, Friday, according to Fire Marshal Grenfell, who ascribes the occurrence to carelessness on the part of O. Ringhart, an employe of the gas company.

The city has no ordinance providing that shut off gates shall be provided for residence connections from the heavy street mains. There is a section of the building code providing shutoff gates on gas connections entering business houses.

The valve at the Tacoma residence, Grenfell said, was in good working order, but was in the lawn, covered by earth and grass and consequently hard to find. Being unable to find the valve readily, Ringhart is said to have attempted installation of a meter without shutting off the gas. The fire resulted. An ordinance to protect against accidents of this kind in the future is now planned by the fire marshal's office, it is said.

Portland's garden of Eden is no more, for the serpents there are dead. AUTO TRAFFIC TO BE RESTRICTED

No Cars Will Be Allowed to Use Congested District During Convention Week.

Prohibition of automobile traffic within the confines of a designated downtown congested district and enforcement of emergency traffic regulations at Union station are important steps taken by Captain Lewis, in charge of the traffic bureau, to insure safe handling of visitors during the Shrine convention and Rose Festival.

No automobiles will be allowed within the district bounded by Third, Yamhill, West Park and Oak streets. This will be in effect every morning from 10 o'clock through the day as late as necessary from June 21 to 26, inclusive. Business concerns making deliveries in the congested district will be asked to do so before 10 o'clock during this period.

RESTRICTIONS ARE SEVERE Only in extreme emergency cases will vehicles be allowed to operate in the restricted area. They will be equipped with signs bearing the inscription "emergency." Letters have been sent by Captain Lewis to all firms making deliveries pointing out restrictions that will be imposed.

Twenty special policemen, of the 100 that will be hired for the convention period, will be turned over to Captain Lewis. Four or five will be used at Union station to handle incoming crowds of visitors. No parking will be allowed north of the south side of Johnson street at Union station. But four taxicabs will be allowed on the stand outside of Union station at one time. As soon as one machine has received its fare another cab, marked with the new plaza block, will draw up to receive passengers. Incoming bands from various Shrine temples will use the plaza as an assembly ground.

MAIL ROUTES STATED Incoming freight and mail vehicles will approach the depot north on Sixth street and will go out west on Johnson street and down Irving. Baggage will be handled out of the depot on a runway over the tracks under the Broadway bridge, which leads to the plank driveway in the terminal yards. All cars carrying visitors over night-sewing routes as laid out by the Shrine committee, will be required to keep in line and not exceed 15 miles an hour. Special motorcycle policemen will patrol routes leading to Columbia highway and other scenic points.

Residents are urged to leave their cars at home except when actually needed in business or in courtesy to visitors. No parking in the downtown district will be allowed during the busy hours of the day. For-hire cars and taxicabs will be allowed to stand on Taylor and Yamhill as well as other streets off the congested area, according to Captain Lewis.

Make Portland Safe For Pedestrians and All, Urges Rossman

"We're going to have thousands of visitors in the city within a few weeks and we must make Portland safe for pedestrians and motorists alike," said Municipal Judge Rossman Saturday in imposing a fine on one of the many violators of traffic laws.
