Draft McAdoo for Nomination, Urges Delegate Lee Travis

Lee M. Travis, delegate from the first congressional district to the Democratic national convention, who is a Portland visitor today, contends that the convention ought to "draft" McAdoo for the presidential nomination, notwithstanding his statement that he is not a candidate for the office. Travis has a proposed plank for the platform dealing with highway construction, which he intends to present to the resolutions committee at San Francisco. It reads as follows:

"We favor liberal appropriations in cooperation with the states, for the construction of highways, which will bring about a reduction in transportation costs, better marketing of farm products, improvement in rural postal delivery, as well as meet the needs of military defense. In determining the proportion of federal aid for road construction among the states, the sum lost in taxation to the respective states by the setting apart of large portions of their areas as forest reservations should be considered as a controlling factor."

Alfred Ogston, New British Consul in Portland, Is Dead

Alfred Ogston, British consul in Portland, died late Monday afternoon at the family residence, 185 North Twenty-fifth street, from heart disease. Ogston came to Portland two months ago to assume the local consular charge of the British office at Washington, D. C. He left England for America about four years ago. Ogston was 42 years old. The widow and two small children survive. No funeral arrangements have been made, but the body may be shipped to England for burial. The Edward Holman company has charge of the funeral. Until other arrangements are made by the British government, Tranter will again act as consul.

Dog That Received Discharge Is Among War Relics Shown

Relics of the world war from a machine gun down to some of the smaller articles in a soldier's outfit, are being shown this week at the exhibit of the Veterans of Foreign Wars, held in the Park blocks at Clay and Park streets.

"Punkins," a thoroughbred fox terrier, and the only dog to get a discharge from the army, is on exhibition and serves as the main attraction. Punkins spent 14 months overseas with company C, Tenth-seventh engineers, nine months of this time being in the front line trenches. He was finally gassed in one of the Argonne engagements and had to be sent back to a hospital. At the conclusion of the war he was given an honorable discharge marked "excellent." The exhibit is being held under the supervision of Commander J. P. Jones. Admission is free, but a place is provided for persons to make donations. The funds received are used by the organization to buy favors for the 100 wounded soldiers convalescing in Portland hospitals.

Vagrant Son Sent To Break Rock for 60 Days' Sentence

SUIT IS BROUGHT FOR POSSESSION OF 15,000 MARKS

An order for 15,000 marks, deposited for security for an unpaid loan made in Portland, and which the depositor refuses to indorse, is the basis of a suit filed in the Multnomah county circuit court today.

L. M. Allen, doing business as Allen Brothers, filed the suit against A. Gerald Paffenbarger.

He says that March 25 he lent Paffenbarger \$168.87 and that Paffenbarger deposited as security an order on the director der Disconto-Gesellschaft, Berlin, for the 15,000 marks, but that through inadvertence he did not indorse it, and since then has failed to pay the loan and refuses to put his indorsement on the paper.

Allen asks for a court order compelling Paffenbarger to indorse the demand for payment of the marks.

TAILOR'S ATTITUDE MAY COST HIM CITIZENSHIP
Ralph Amato, tailor, 5309 Thirty-ninth street southeast, cannot become a citizen of the United States for the next five years. Indeed, he may consider himself lucky if steps are not taken for his deportation to Italy.

Amato was to have been examined for final citizenship before Judge McCourri. His witnesses were present but he did not appear. He was called up and expressed sentiments "inimical to an good American citizenship." He declared he wanted his application for citizenship cancelled and regretted the \$4 fee he had already paid when filing his application.

Paul Rothlisberger, a blacksmith, enjoyed a quiet day at the courthouse Monday when he appeared in District Judge Jones' court and gave a description of a silk shirt that must have outdone Solomon in all his glory. Kenneth Morris, 24, of 293 Tenth street, and Harry Achert, 23, employed in the circulation department of an evening paper, were turned over to the grand jury this morning by Municipal Judge Rossman on a charge of larceny of an automobile.

The youths were captured Tuesday after being pursued several blocks by William Dolph of Newberg, whose machine he said they attempted to take from Thirteenth and Main streets. Their bail was set at \$500 each, which they were unable to furnish.
