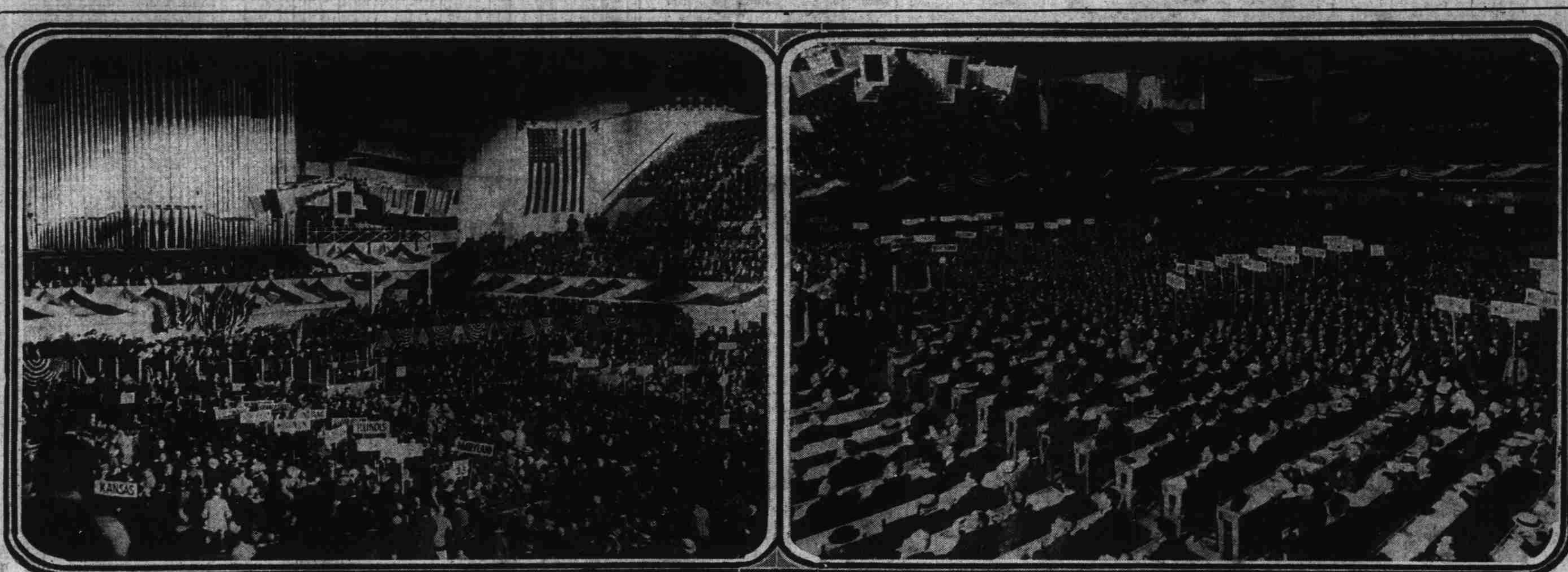

M'ADOO'S FOES WORKING HARD TO BEAT HIM

Former Secretary of Treasury Urges Dr. Jenkins Not to Put His Name in Nomination at the Democratic Convention.

San Francisco, June 30.—Anything to beat McAdoo. That's the lineup here today. Buck of the movement are not merely the managers of the Cox and Palmer candidacies but those who have the faint hope that a favorite son may be nominated—some dark horse who has a few votes now but who may grow as Harding did at Chicago. If the leaders in the race are eliminated.

The Democrats may be the last people to admit that they would imitate anything Republican but the spell of Republican strategy seems to be upon some of the managers here. Just as there was a combination to beat Leonard Wood at Chicago, there's a coalition afoot to defeat McAdoo.

The states who have dark horses to trot forth are being urged to hold their votes intact for dark horses. The Palmer and Cox managers feel that if McAdoo does get up to 500 votes or so, the veto power which they hold of one third of the votes or the opposition of the favorite son delegations will be sufficient to stop the advance of McAdoo. But coalitions against McAdoo are not so easy to sustain here. This coalition is not as closely controlled by leaders who can absolutely depend upon their delegates in a prolonged series of ballots.

Perhaps the thing that has hurt McAdoo in the last 24 hours is the too rapid growth of his boom before the balloting starts coupled with the opening of headquarters by over-zealous friends. Anything which gives the impression that McAdoo is an active candidate notwithstanding his professions to the contrary gives an opportunity to opponents of McAdoo to keep on questioning his sincerity. And delegates are quick to do those things. They are already saying McAdoo is party to a game of super-strategy here and are attacking him for it.

But William Gibbs McAdoo himself is doing all in his power to squelch efforts

Portland Takes Step to Prevent Bubonic Plague Spreading Here

Steps were taken by two agencies of the city Wednesday to prevent bubonic plague, now reported to be sweeping the Gulf coast and creeping up into the Middle West, from entering Portland.

The plague has not yet reached the Pacific coast, but Dr. George Parrish, city health officer, was advised that suspected cases have been reported in St. Louis. All the gulf ports are under quarantine.

Dr. Parrish conferred with Dr. Richey Waugh of the United States public health service this morning, requesting that two men immediately be assigned to Portland for a survey of the waterfront.

Bubonic plague is transmitted by rat fleas and the Portland waterfront, with

Equestrian Statue of Roosevelt to Be Commenced Soon

Portland friends of A. Phimister Proctor, noted New York sculptor, have received word from him that he will leave for Oregon shortly to begin work on the equestrian statue of Theodore Roosevelt, which Dr. Henry Waldo Cox has commissioned him to do. The statue will be a gift to the public from Dr. Cox and probably will be placed at Morningstar, near Mount Tabor. The statue is to be of Roosevelt as colonel of the Rough Riders.

"As far as I know," writes Proctor, "I am the first one commissioned to do an equestrian statue of Roosevelt, which fact is interesting to me because he strongly recommended me as the man to do one of Colonel William Cody (Buffalo Bill) which was proposed for Denver but which the war postponed."

Proctor is just completing an equestrian Indian for Denver's civic center. He is widely known for his Western subjects among which is the "Buckaroo" of the Pendleton Round-Up and "The Pioneer" which J. N. Teal presented to the University of Oregon and which stands on the campus at Eugene.

COX EFFORT TO STAMPEDE IS SENSED

Friends of Ohio Governor Greet Delegates With Noisy Demonstration When Session Is Resumed; Nominations Are Made.

San Francisco, June 30.—(U. P.)—A determined effort to stampee the Democratic convention for Governor Cox of Ohio was in full swing as Chairman Robinson called the delegates to order at 11:29 a. m. today to hear nominating speeches.

Cox rosters in the gallery dominated the situation with college yells and a song about "We'll nominate Cox or know the reason why."

Rabbi Meyer delivered the invocation while the crowd stood.

The immense throng, one moment surging about the aisles and yelling for Cox, Palmer, McAdoo and other candidates, was instantly silenced as the rabbi began praying.

When the last words of the invocation had died away the band and the organ boomed forth with the national anthem and the delegates and visitors stood quietly as the first verse was concluded. On the second hundreds joined in the chorus and sang through to the end.

Delegate King of Utah was recognized by the chair. He explained that when

Hagood Asks for Plank Pledging More Ships to Smaller Ports

San Francisco, June 30.—R. W. Hagood of Portland appeared before the resolutions committee last night in behalf of Portland and other port interests and argued for a plank in the platform pledging a more liberal policy of allocating government ships to the other ports of the country.

He insisted that four or five of the larger ports where big lines are already operating had been awarded an undue share of government vessels to the detriment of other ports. Among the latter were Portland, Galveston, New Orleans, Mobile, and other well known ports.

"We ask a declaration in the platform pledging the Democratic party to allocation of government owned ships for the maximum encouragement of development of independent ports and shipping companies, and the largest possible service for producers and manufacturers of the whole nation," said Hagood.

"Such action will encourage the organization of new shipping companies locally financed in the many ports of the country and it will prevent monopolistic control by massed capital of off-shore shipping business of the country."

He said New York, Boston, Seattle and San Francisco interests are said to be against the proposed plank, while it is supported by the other ports named, including Philadelphia and Norfolk.

Man Is Kidnaped By Robbers' Pals In Search of Loot
Yakima, Wash., June 30.—M. M. Newton, who disappeared about a month ago, was found today, asserting he was kidnaped. He said that when a boy in Kansas, living close to the Oklahoma border, he was arrested when a posse appeared here the day before his disappearance. He was later broke jail and was killed.

Pals of these men have been dogging Newton's footsteps for 20 years, he said, seeking to have him disclose where the money is hidden, believing he was one of the original gang. Two of these men appeared here the day before his disappearance, he asserts, and that night seized him as he was driving a truck to Yakima, took him in a high powered car to a retreat in the Oregon mountains, and tortured and starved him. Three days ago they released him, he said, and he made his way to La Grande where he telephoned his wife.

Non-Partisans and Foes Fight It Out in North Dakota Today
Bismarck, N. D., June 30.—(U. P.)—The national non-partisan league was still fighting today in the Republican primary to retain control of the North Dakota state government. Candidates of the Independent Voters' association were striving to stack up enough votes to oust the league.

WETS' HOPES FOR PLANK GO GLIMMERING

Cox's Announcement He Is Dry Lessens His Chances But Demonstrates Drys Hold Power; McAdoo Is Favored in Betting.

San Francisco, June 30.—Fierce fires of controversy are smouldering beneath the good humored and placid surface of this convention. The dispute is over the issue of a dry plank in the platform. It flamed up Tuesday in the platform committee in the sharp tilt between Bryan and Theodore A. Bell, representing respectively the drys and wets. Each asked the other whom he represented and how much he was paid for his services. The uproar that followed was noisy enough to require smelling salts for the weak-nerved.

It is regarded as certain that this controversy will reach the floor of the convention and that it will be a battle royal. Everybody wants to be present, and seats for Wednesday and Thursday are eagerly sought.

It is conceded that the hopes for a wet plank have gone glimmering. That was evidenced when the managers of Governor Cox insisted that he is a dry candidate. This desertion angered the wets at Cox, weakened him as a possibility and at the same time convinced the wets that all hope of a light wine and beer plank is gone. It is probable at this time that a majority of the wets will stand when the smoke of battle has cleared away on the floor of the convention is fruitful food for conjecture.

There is betting on the question of who is to be the nominee. At the Palace hotel several bets were made at 1 to 3 that the nomination will go to McAdoo. Bets were also made at the same odds that the ticket will be McAdoo and Cox or McAdoo and Meredith.

One bet of \$250, even, was made that McAdoo will be nominated on the fourth ballot. There is a settled conviction now that the nominee will either be McAdoo or a dark horse. Cox lost out

Watson Giles and his brother, accused of the murder, were shot by a posse headed by Sheriff Kemp near Diamond Mound.

Planks Friendly To Labor and to Bone Dry Groups Being Predicted

San Francisco, June 30.—(I. N. S.)—Unable to reach a unanimous agreement on the League of Nations, "wet and dry" and Irish issues, the "steering committee," composed of nine members of the Democratic resolutions committee, decided this afternoon to put all three of them up to the full committee for a final decision.

A tentative labor plank was agreed on, it was stated, but this was the only one on which serious differences of opinion had not developed.

San Francisco, June 30.—(U. P.)—Every one of the nine members of the resolutions sub-committee flatly denied today a widely circulated report that the committee last night rejected a proposal to put a wet plank in the Democratic platform.

The members are Senator Carter Glass, chairman; Secretary of State Bainbridge Colby; Senator Walsh of Montana; Vance McCormick, Pennsylvania; Senator McKellar, Tennessee; Horace Hawkins, Colorado; George H. Hodges, Kansas; M. M. Crane, Texas; and W. R. Patman, Maine.

There was no vote taken either formally or informally, were reached, they declared individually.

The report in question said the wet plank proposition was defeated, 8 to 1. Senator Glass reported to the full committee to complete its work before late today and suggested it be authorized to continue its deliberations.

Senator King, Utah, moved that the committee recess until 7:30 p. m. to give the subcommittee an opportunity to go ahead and that motion was adopted.

Glass invited members of the full committee to appear before the subcommittee to submit planks or discuss procedure. This was expected to expedite matters somewhat, and to mollify some members of the full committee who feared that the subcommittee might exceed its authority in some way in drafting the platform if left to its own devices. The meeting thereupon resolved itself virtually into a meeting of the full committee.

INDIAN WAR VETS RECALL EPIC SCENES

37th Annual Reunion of Men Who Blazed Trails Finds Ranks Thinned, but Memory Vivid and Spirit Courageous as Old.

If there had been a vagrant band of Indians and an arsenal of muzzle-loaders at Masonic Temple Wednesday morning, Portland might have been treated to a reenactment of the thrills of a pioneer Indian war.

All the other ingredients for an exciting campaign, including the men, members of the Indian War Veterans of the North Pacific—and the knowledge of the business of fighting, together with the fighting spirit of the pioneer, were on hand for the thirty-seventh annual reunion of the veterans, which opened at 10 a. m.

Surrounded by friends and relatives, the veterans of the Indian wars of the Oregon country, their ranks thinning appallingly from year to year, are gathering for the important business of re-enacting the tales of long gone days as they renew the friendships of those hardy times. They will transact business, memorialize congress and feast upon the bounties of the country their efforts helped create.

After 25 years as grand adjutant, Comrade Otto Kleeman forced the acceptance of his resignation after the veterans had endeavored to continue him in office. Kleeman gave absence from the city as the reason for his retirement. To his post the Rev. T. Broutelle, former grand chaplain, was elected. Comrade Cyrus Walker was elected chaplain. Other officers elected or re-elected were C. A. Wallace, senior vice-commander; G. W. Riddle, junior vice-commander; Mrs. F. L. Benedict, assistant adjutant; W. R. McCord, captain of the guard.

The big topic of interest from an official standpoint Wednesday was the discussion of Indian war trophies. The veterans declare they have been grossly slighted by congress in spite of frequent protests and they are about to formulate

M'ADOO FIRM IN SECOND REQUEST

Former Secretary of Treasury Admits He Has Wired San Francisco Asking That His Name Not Be Placed in Nomination.

At Same Time Dr. Burris Jenkins Says He Will Mention McAdoo's Name Before Convention and Tell Delegates He'll Accept.

Auditorium, San Francisco, June 30.—(U. P.)—Thomas B. Love, Texas national committeeman, and Robert Woolley, McAdoo supporters, announced this afternoon that Dr. Burris Jenkins, who was scheduled to place McAdoo's name in nomination, will merely make a brief statement in which he will say that while he is not officially offering McAdoo's name to the convention, he is in a position to state that if the former secretary of the treasury is nominated he will accept.

Auditorium, San Francisco, June 30.—(I. N. S.)—Reports that William G. McAdoo had again in a private message received here refused to allow his name to be brought before the Democratic national convention spread among the delegates here as they assembled in the auditorium shortly before noon today to listen to the nominating speeches.

Burris Jenkins, the Kansas City publisher who was scheduled to nominate the former secretary of the treasury, was found in the Missouri delegation.

"I will not discuss it now," said Dr. Jenkins.

The report may have been the work of press agents to cool the atmosphere. Jenkins said:

"I have heard that McAdoo has sent such a message. It did not come to me." "Are you going to nominate him?" Jenkins was asked.

"I can't answer that now," he said.

M'ADOO ADMITS THAT HE HAS SENT SUCH MESSAGE

New York, June 30.—(U. P.)—Admission that definite instruction had been sent from the East to McAdoo supporters at the Democratic national convention not to place William G. McAdoo's name in nomination for the presidency came from the office of Mr. McAdoo here this afternoon.

It was not stated who had sent the instructions, but a secretary said that it had been reported to Mr. McAdoo that Dr. Burris Jenkins had agreed to accede to the request not to nominate the former secretary of the treasury.

DAIRYMEN BUY 10 OREGON FACTORIES

Involving more than \$200,000 the Oregon Dairymen's league Wednesday signed contracts to purchase 10 cheese and butter factories in various sections of the state, according to an announcement made by Albert S. Hall, general manager of the league.

In addition the league announces the closing of a lease with the Terminal Ice & Cold Storage company of Portland for a part of its site upon which will be erected a modern cheese factory at an additional cost of approximately \$25,000.

Among the plants passing to the league by this sale are the big milk products factory of the Oregon Milk Producers company at Fifth and Couch streets, Portland. Eight tons of pasteurized milk are distributed daily through this one plant. The factories just purchased by the league are located at Portland, Broadbent, Marshfield, Norway, Myrtle Point, Arago, Danmark, Langlois and Bandon.

Hall states that a further investment of \$100,000 in other factories will be made by the league in the immediate future. Memberships representing over \$5,000,000 of milk are now represented in the league, says Hall.

MEN IN JAIL ARE ELECTED IN CANADA

Winnipeg, Man., June 30.—(I. N. S.)—The latest returns in the general elections for the legislature, made public today, indicate that the labor party has won a sweeping victory, electing at least 12 members to the house.

Fully half of the new members are either in the penitentiary or on prison farms, serving sentences for convictions arising from the labor strike here a year ago.
