THIRD PARTY MELTING POT IS STEAMING

Committee of Forty-Eight Convention Called to Order This Morning; About 1200 Delegates There; One Quarter Women.

THREE THERE FROM OREGON.
The three third party delegates from Oregon are: J. H. Hart, formerly a professor at Reed college; E. E. Schwartz, a teacher at Lincoln high school, and W. F. Adams, attorney in the Chamber of Commerce building, who circulated the petitions asking Hiram Johnson to bolt and become an independent candidate.

Third Party Convention Hall, Chicago, July 10.—(I. N. S.)—A new political party, lusty, though as yet unchristened, came into being here today.

Minus many of the political group units which it was hoped would come into the party organization at the last moment, the parent of the party—the committee of 48—presented a new party, in convention assembled, with the avowed purpose of capturing for itself the presidency and vice presidency of the country next November together with all other national offices the country offers.

FOUR CONVENTIONS ON

Four separate conventions were scheduled to be held: The Forty-eighters, the Labor party, the Single Tax party and the American Constitutional party. The first three, even though they may not amalgamate, were expected to run along coordinating lines.

Some minor platform differences have arisen between the Forty-eighters and the Laborites, and there is also the difficult question of a suitable name for the new party, but the leaders of both organizations have shown a disposition toward mutual conciliation for the purpose of presenting a united front.

OPPOSES "OLD GUARDS"

The issue presented by the new party, to the two older parties, was one of "progressivism" as termed by the party itself, as against what it believes to be the "old guard" principles of the Republican and Democratic parties.

The abolishment of economic privileges in connection with political parties of the country was announced as the main plank of the party's platform.

The convention was to convene at 10 o'clock, but it was an hour later before the delegates, numbering about 1000, began filing into the flag-draped hall, to the playing by the orchestra of Sousa's "Stars and Stripes Forever."

A survey of the delegates showed that at least one fourth of their number were women. Until the convention was called to order, the delegates were in a group about the various state banners, holding informal discussions of the party's affairs and becoming the candidates of their choice.

LA FOLLETTE'S NAME HEARD
The name of Senator La Follette was probably the greatest in evidence with that of Henry Ford a close second. Just before the convention was called to order it was learned that Senator La Follette, at Madison, Wis., had made a statement in which he said that his acquaintance with the automobile maker offered him, would depend on the assured permanency of the third party movement.

The boom for Henry Ford appeared to gather strength hourly. It was declared by the Michigan delegates who came to the convention unofficially instructed by the Detroit automobile manufacturer, that he would be glad to accept the nomination if it is offered to him and that he would make a red hot campaign to win in November.

FORD STRONG CONTENDER

Indications from the talk of the delegates were that the nominating, evidently will narrow down to a contest between Ford and Senator La Follette, with Frank P. Walsh the third strongest contender. Concerning the latter, much depends on the outcome of the Labor party as to the degree of strength Walsh will be able to muster in the convention. Indeed, if no agreement can be reached with the Labor party, it was stated by leaders of the latter, Walsh may decline to permit his name to come before the third party convention, running instead for the Labor party nomination.

"Atmosphere" Is All Lacking as Forty-Eighters Meet in Chicago

Chicago, July 10.—(U. P.)—Every age and every walk of life of both sexes is represented in the personnel of the committee of 48 convention, which opened here today as the first step in formation of a new liberal political party.

The most striking thing about the headquarters and convention hall in the Hotel Morrison is the utter absence of political "atmosphere." There are no resplendent signs adorning the delegates to vote for or against a president; no sweet young things pinning candidate buttons on lapels already coated with the celluloid; no luncheon or dinner speeches; no hales of literature; no parades—in fact, as things go politically, "no nothing."

Little knots of men or women or men and women gather about the reception rooms or in the lobby, earnestly discussing this or that phase of political or social economics. A debate is as easy to start as a fight at most conventions, and every debater appears to be willing and able to talk on any subject under the sun. And everyone is so intensely serious. There is none of the slap-of-the-back, hello-Bill that marks most political gatherings. Indeed, one of the most noticeable things is that the great majority of the delegates are utter strangers to each other.

The convention hall, known as the "cane room," is decorated with American flags and a few small white shields with simply a black "48" on them. It is small and will not seat more than 1200 persons.

FORD REBUKES BOTH OLD PARTIES

Detroit, Mich., July 10.—(U. P.)—In a scathing denunciation of the Republican and Democratic candidates for the presidency and the two old parties, the Dearborn Independent declares the support of Henry Ford's weekly for a third party movement here today.

"There is no reason why the choice of the American people should be limited to Cox or Harding, to the spineless Republican platform or the dead Democratic platform," the editorial declares. "The editor and his people are too big to stand on either platform."

NOT USUAL "THIRD PARTY"

"Third parties have fallen into disrepute because their sole purpose heretofore has been to boost somebody into office; when they failed to do that they were cast aside."

"But a movement of the American people, in rebuke of both subservient Democratic and Republican parties, would not be the usual 'third party' party."

In regard to the Republican convention the editorial says: "It is a money dominated G. O. P."

"The Republican convention was openly and shamelessly dominated by financial representatives of the powers that pull government influence like strings. Parties were not elected, but were sold."

In conclusion the editorial says: "If the people want a clean party they must act at once. They must act deliberately, they must act without reference to the precedents set by discredited parties and they must act with a confidence in their supreme control over all their affairs."

WILSON WAY ACCEPT COX RESERVATIONS

Democratic Nominee Plans to Assume Party Leadership on League of Nations Issue in Campaign; To See President.

Washington, July 10.—(U. P.)—The two League of Nations reservations to be proposed by Governor James M. Cox, Democratic presidential nominee, will probably prove acceptable to President Wilson, it was indicated at the White House today.

At the White House it was said the two reservations appeared to be purely interpretative and it was added Wilson has never objected to interpretative reservations.

Dayton, Ohio, July 10.—(U. P.)—James M. Cox, Democratic nominee, in his forthcoming visit to the White House, will urge President Wilson to back him in two proposed reservations to the League of Nations covenant.

It was learned today from unquestionable sources close to the Ohio governor.

The first provided that the United States enter the League of Nations with the distinct understanding of all other members that the American congress alone shall say when this country shall enter a war.

The second is a definite stipulation that all members of the league agree that its main and virtually sole purpose shall be the prevention of wars.

Cox, it is known, plans to assume the treaty leadership of his party on the basis of three reservations. He has been giving the whole issue careful consideration during the past few weeks and expects to make a statement outlining his views after the conference with the president and other leading Democrats.

Those close to the nominee say he believes his reservations will meet opposition to the present wording of the league covenant, but not impair the integrity of the Versailles pact. The point out his views are a compromise between those who stand pat for the league, but claim they favor an effective international tribunal to end wars.

**SINGLE TAX MEN
FEAR LA FOLLETTE**

Chicago, July 10.—(I. N. S.)—Declaring his willingness to fuse with the committee of 48 in the promulgation of any third party that would recognize the principles they believed in and would reject others they held taboo, the single tax party opened its convention in the Auditorium hotel here today. Robert C. MacAuley of Philadelphia, was named temporary chairman, and after his opening address the convention adjourned to give time for conferences with committees of other parties.

James C. Reis of Philadelphia, spokesman for the party, declared the delegates would not join any third party "if there are paternalistic or Socialistic planks or if the platform favors such taxes as the income or excise."

"Our delegates and the single tax leaders have declared themselves unalterably opposed to Senator La Follette as a presidential candidate," Reis continued. "Two men on either of whom we could agree are Amos Pinchot and Charles Ingersoll, both of whom are single taxers. Our choice for the vice presidency is former Mayor Pugin of New Jersey."

The third party platform as outlined in the keynote speech of Allen McCurdy of the committee of 48 is "too indefinite" for the single tax party and must be made more specific before that organization will agree to fuse with the movement, it was said today by Robert MacAuley, national chairman of the Single Taxers. He termed the speech of Mr. McCurdy "a wonderful word picture."

**Millionaire Draft
Dodger Reported to
Have Been Located**

Washington, July 10.—(I. N. S.)—Reports regarded by the war department as the most reliable yet received, reaching here today, were to the effect that Grover Cleveland Bergdoll, the millionaire draft dodger, has been located in the northeastern part of the United States, near the Canadian border.

Movie Crank Men And Musicians on Strike; Managers Keep Shows Open

Union motion picture machine operators, stage hands and musicians, including organists, in the five Portland houses of the Jensen & Von Herberg circuit, failed to report for work Saturday morning, following decision of the union to walk out in sympathy with machine operators in Tacoma, who have been out for two weeks.

The local theatres affected report they are operating as usual, and local managers say they expect no difficulty in keeping their houses open and their shows running.

"We are powerless to clear up the situation in Tacoma, even if we desired to do so," said C. S. Jensen, senior member of the J. & V. firm. "We own but one quarter interest in the Tacoma houses, and so have no majority voice in their operation. I have talked with H. T. Moore, general manager of the Tacoma houses, and he advises me that he is quite satisfied with the way things are running up there and that he expects no trouble. The Tacoma houses have been operating for two weeks without union employees."

Butte and Seattle houses under J. & V. direction are also affected by the walk-out under the same conditions existing as exist locally.

Tacoma operators are asking for an increase of from 85 cents to \$1.25 an hour.

About 100 persons are affected by the walkout in Portland.

The following statement regarding the strike was issued this morning by the National Federation of Musicians and Vicinity:

"On July 1 the Tacoma motion picture operators, who were working for a lower scale and worse conditions than the operators in other cities of the Northwest, presented to the managers in Tacoma a new wage scale and working conditions that would bring Tacoma up to the standard of the rest of the Northwest district. This scale was arbitrated and accepted by all the managers in Tacoma, except the Jensen & Von Herberg managers, who called their operators and told them their services were no longer wanted and immediately put non-union men to work, thereby causing an unfair condition to all union labor. The musicians therefore could not work under these conditions."

"The operators in all Northwest cities are members of the International Alliance of Musicians, and the musicians are all members of the American Federation of Musicians. Representatives of these international unions met with the managers in Tacoma, but were unsuccessful, whereupon they launched a strike for all operators and musicians working for the Jensen & Von Herberg management in Tacoma, Seattle, Yakima, Butte, Bremerton, Everett and Portland to cease working under the conditions set."

This call to operators, musicians, stage employees, bill posters and other employees in the theatres and motion picture houses in Tacoma, Seattle and Portland is now in session in Seattle in Portland, Jensen & Von Herberg control the Liberty, Columbia, Majestic, Peoples and Star theatres. All other theatres in Portland are fair."

**TACOMA OPERATORS ASK
SAME SCALE AS SEATTLE**

Tacoma, Wash., July 10.—(U. P.)—The strike of moving picture operators and musicians in Jensen & Von Herberg theatres here was called last week, but the musicians in the city have not yet joined in the strike. The operators are asking for the same scale as the Seattle operators.

The local operators demanded the Seattle scale of \$1.25 an hour and the musicians went out in sympathy.

Seattle Operators Out
Seattle, July 10.—(U. P.)—Movie operators and musicians in the Liberty, Columbia, Rex and Strand theatres here went on strike today in sympathy with operators in Tacoma. In a statement issued by the Greater Theatre Guild, the management said the theatres would continue to run.

**FIRE DESTROYS BIG
DALLAS SAW**

Dallas, Or., July 10.—Fire, believed to have resulted from a spark from a locomotive, Saturday destroyed the main building of the Willamette Valley Lumber company here, entailing a loss estimated to be not less than \$100,000. At 1:30 o'clock the fire was still raging, but was believed to be under control.

The blaze began about 12:30 o'clock in the slab chute and five minutes later the entire building was in flames. The lumber yard and other buildings were saved by hard work.

FEDERAL JURY SUGGESTED IN MILK INQUIRY

City Commissioners Consider Laying Activities of Dairymen's Co-operative League Before Body on Charge of Profiteering.

Federal grand jury investigation of the high prices now being charged for milk with possible prosecution for profiteering under the Lever act looms as a result of the inquiry into the milk situation now being made by city officials.

In response to a demand from Mayor Baker for immediate action, Deputy City Attorney Lionel Mackay, who has been conducting the investigation, Saturday morning, began preparing his report. It is a lengthy one and will not be ready for the mayor until Monday, Mackay said.

Baker would not say what his course of action will be, but he is known to be indignant at the attitude of the Dairymen's Co-operative league in attempting to force an increase at this time. The mayor's position is backed by all the members of the council.

SUGGESTS GRAND JURY
Commissioner C. A. Bigelow, who ordered Mackay to make a report during the recent absence of the mayor, is said to have suggested the federal grand jury inquiry, and those in touch with the matter declare the mayor probably will refer Mackay's report to United States Attorney Humphreys early next week.

From information gathered by Mackay, it is believed his report will be to the effect that an increase was unjustified.

MILK PRICE BOOSTED
The Portland distributors increased the price from 13 cents to 14 cents a quart July 1. The Oregon Dairymen's Co-operative league met last week and decided to boost the price of milk from \$2.20 per hundred to \$3.80. This is the cost to the distributors.

If it goes into effect the distributors say they will have to raise the price again to 15 or 17 cents. However, the distributors, according to city officials, are preparing to raise the price, and will not pay the high price asked. Negotiations between the distributors and producers are now pending, and a definite announcement from them is not expected until next week.

**LEAGUE PAYS \$60,000
FOR COOS BAY CREAMERY**
Marshfield, July 10.—The plant of the Coos Bay cooperative creamery in this city has been sold to the Oregon State Dairymen's league for \$60,000. Albert Seely, who has been manager, will remain cheese salesman. Other creameries owned by the league in Coos county are to be sold to the league.

**STUDIES EFFECT OF
JONES SHIPPING BILL**

Studying the possible effect the new Jones merchant marine bill may have upon Pacific coast commerce, N. Sumner Myrick, vice president and counselor of the United States Chamber of Commerce, arrived Saturday morning for a three days' visit in the Portland district.

Myrick is an authority upon shipping matters but did not care to discuss the probable effects of the new merchant marine ruling upon Pacific shipping until he had made a careful investigation at Pacific ports.

"The opinion prevails along the Pacific coast that provisions of the Jones bill will hinder foreign commerce," said Myrick. The same opinion is expressed to some extent in this port but back there the legislation is looked upon as being academic and possible to change after a trial.

Myrick outlined the Jones bill with members of the navigation committee of the Chamber of Commerce during the morning and left with port and dock commissioners for a tour of the Harbor in the afternoon. Sunday he will be the guest of C. E. Dant, president of Dant & Russell, exporters and exporters, and will be taken for a tour over the Columbia river highway.

Monday Myrick will address business men at the members' forum luncheon of the chamber. At 2 o'clock he will deliver a special address on shipping affairs to Portland shipping men.

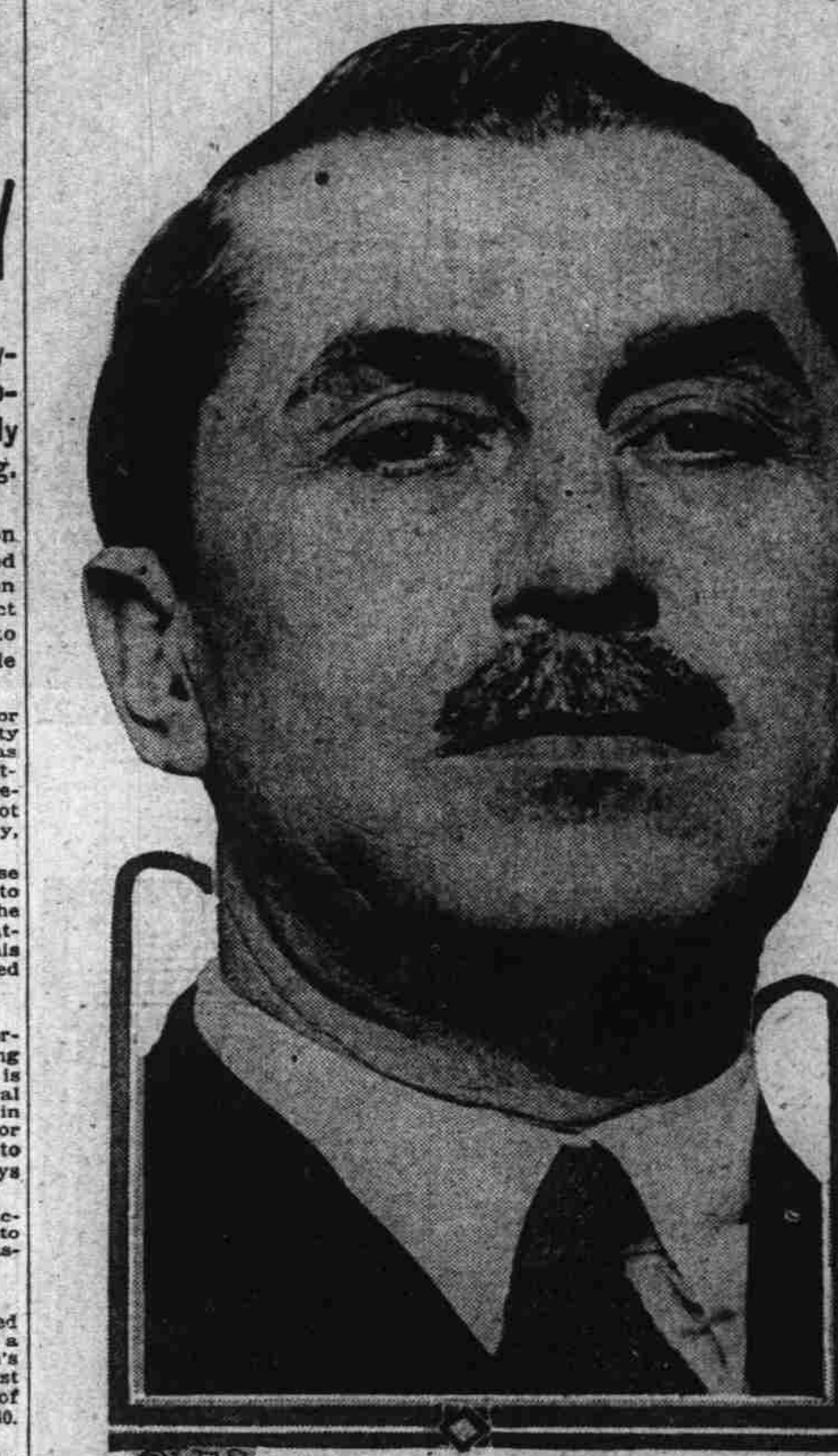

JOURNAL AIRPLANE MAKES QUICK RIP

Undertaken by heavy fog hanging over the ocean from the mouth of the Columbia river south, Pilot Fred DuPuy in The Journal's seaplane express service to Seaside, delivered copies of the first afternoon edition to the beach resort at 3 o'clock Friday afternoon, the earliest delivery yet made in the service.

DuPuy took off in an Oregon, Washington & Idaho Airplane company's P-boat from Lewis and Clark field landing basin a few minutes after 1 o'clock Friday afternoon. The west winds that have been blowing for several days delayed progress down the Columbia river and from Seaside on the pilot was compelled to feel his way through the fog. Guiding himself by the dim shadow of his plane on objects below as he flew near the ground, DuPuy finally reached the Necanicum and he circled three times over that stream before making sure of his bearings and gliding down to the float.

DuPuy rested for 50 minutes at Seaside, and taking to the air at 4 o'clock, returned to Portland in one hour, 20 minutes, remarkable time for a seaplane, and attributable to the fact that the high wind was behind the plane all the time.

Pilot Jack Clement is carrying the papers to the ocean side Saturday afternoon and he will remain there with his plane over the week-end.

**Body of Lost Man
Is Discovered in
Woods at Seaside**

Seaside, July 10.—The body of W. T. Gallagher of La Porte, Texas, was found Friday afternoon at 3 o'clock by James Burke and Henry Ober, a short distance from Seaside. Gallagher left Seaside June 25 to see his homestead on Tillamook Head and became lost, probably dying of over exertion. He was 60 years old.

He proved up on his homestead 28 years ago and has been in Texas ever since. His wife and son are en route from Texas.

"We were out for eight days," Henry Ober said, "and had tracked him more than 15 miles. He was confused and wandered for several days through heavy timber and swamps. He had wandered off the field road but a short distance from Seaside when he gave up and laid down to die."

MEREDITH AND FOUR TALK AT LUNCHEON

Cabinet Member Complains of Lack of Funds and Chairman of Appropriations Rises to Defend Own "Economy Program."

Much of the most important government agricultural work will have to be abandoned next season and some activities are already being abandoned because congress was not foresighted enough to appropriate sufficient funds to run one of the nation's most vital departments, according to a statement made by Edwin T. Meredith, secretary of agriculture, at a luncheon in his honor at the Chamber of Commerce Saturday noon.

"That the poor devil of a congressman is not even the first in the matter of appropriations with the governmental departments on one hand asking for more money and the public on the other clamoring for reduced taxation, declared Congressman Joseph Fordney of Michigan, chairman of the house ways and means committee, who followed Meredith.

FUNDS INSUFFICIENT
"Only one fourth of 1 per cent of the total amount of money appropriated by congress was for direct use in encouraging agriculture," declared Meredith. "A total of \$23,000,000 was appropriated for the use of the department, of which only \$12,000,000 will be available for agricultural development."

"This \$12,000,000 will have to care for the entire industry of the nation which, if sold out, would be worth approximately \$80,000,000, or enough to buy out all the other departments combined."

"With this sum we will have to take care of our agricultural development, our clothes, our food, our inspection service and all the other functions performed by the department."

GOOD WORK HALTED
"Some of the most important work, such as hog cholera and cattle tick campaign, will have to cease in many states and in others the work will be sadly impaired."

"County agents will have to be withdrawn from the field because there will not be sufficient funds to pay a fair salary."

"As a result of the reduced appropriations much work carried on by the department is being abandoned and will have to be abandoned still further."

PROJECTS ARE DELAYED
Some of the important work which will be curtailed or abandoned completely was outlined by Meredith as follows:

"All cooperative dairy extension work will be discontinued. Investigations at the Harney field station at Bend will be terminated."

"Final support of crop investigation work on the Umattila project will be withdrawn."
