

PORTLAND'S MILK PROBLEM LOOMS; ISSUE PRESENTED

Developments Expected This Week
—New Milk Commission May
Be Formed, Mayor Intimates.

Developments in the milk controversy this week will be watched for with interest, following the communication from Mayor Baker to President Alma D. Katz of the Oregon Dairyman's Cooperative league Saturday, intimating that another milk commission might be formed.

Early this week, officials of the league declare, suits will be started against the Portland distributors and some of the producers, charging against the first conspiracy to break contracts, and in the second instance, breakage of contracts.

Scores of these suits are expected to be filed in the Multnomah county circuit court. They are based on action of the distributors in mailing checks to the producers on July 16 in payment for milk, instead of to the league. The league declares its contracts with the producers bind the latter to sell their milk to the league, from whence it is resold to the distributors.

INQUIRY PROMISED
In his letter to Katz the mayor assured him that no prosecutions of the league would occur until the fullest investigation has been made of all phases of the controversy. The communication was a reply to one from Katz in which protest was made against the investigation by Deputy City Attorney Lionel C. Mackay. Early last week Mackay announced he was gathering evidence with which to prosecute the league under an old ordinance forbidding price fixing.

Replying to Katz's accusation that the Mackay investigation was one-sided, the mayor neither condemned or upheld the Mackay report, commenting on it as follows:

"I have gone through the voluminous data gathered by Mackay in his investigation and it bears evidence of painstaking care and contains much information emanating from the Oregon Dairyman's Cooperative league. I have not, however, finished the examination of Mackay's records and have formed no opinion on the subject, preferring to have your viewpoint upon certain phases of the question before proceeding further in the inquiry."

PROBLEM IS SERIOUS
Discussing the milk situation Saturday morning Mayor Baker had come to realize that it was the most serious problem confronting the city administration at this time. The mayor was

convinced that the city's milk problem was a serious one. He had been told by the dairy industry that the situation was serious and that the city's milk problem was a serious one. The mayor also said in the letter to Katz that he was giving consideration to the proposal made by the latter that another milk commission be appointed. "Your suggestion that I appoint a milk commission and that this commission consists of the dairy and food commission, the Oregon Dairyman's Cooperative league and a representative of the public," wrote the mayor, "has been considered and my view is that it is a commission, the general public should have more than one representative."

While I have every confidence in the integrity and ability of the dairy and food commission of Oregon and the head of the bureau of markets, I think it would be preferable, in the event the commission is appointed, that these gentlemen appear before such a commission as expert witnesses prepared to give the knowledge and information which they possess, rather than have them sit as members of the commission."

VIEWS REQUESTED
"You complain about the dealers, to whom I have referred to as the distributors, and also the consumers, and charge them with the intent to destroy the cooperative marketing organization of dairymen. Please give me your views upon the following points:

"1.—Are the dealers a necessary part of the milk industry of the state? If not, why not?
"2.—What would be the consequences if the dealers were eliminated?
"3.—If a commission should be appointed to make a thorough and searching inquiry into the essential facts involved in the controversy between the Oregon Dairyman's Cooperative league and the Portland dealers, what, in your opinion, would be the objective and the scope of this inquiry, especially relative to the conditions and the Portland dealers?"

The mayor denied Katz's charge that his administration was being used, without his knowledge, to serve the intent of the dealers and the consumers to break up the league of dairymen, and intimate that the league was using the mayor's name to avoid this disclosure of all essential facts.

MAJOR WILL WAIT
Mayor Baker said to The Journal, in commenting on the investigation generally, that he would await any definite action, such as the matter of appointing a commission, until after the meeting next Tuesday morning under the auspices of the Oregon taxpayers' league.

Persons sponsoring the state market director bill met Friday and resolved to investigate the trouble of the dairymen's league. Robert E. Smith, secretary of the taxpayers' league, called the meeting, which was held at the Chamber of Commerce. Those present were: Mayor Baker, Deputy City Attorney Mackay, Mrs. J. C. O'Brien, of the Housewives' league, Professors Scudder and E. M. Brand of Oregon Agricultural college and others have been asked to attend. No effort was made at the meeting Friday to investigate any phase of the present milk controversy, but the committee made plans to aid the producers, if possible.

BLANKET RISE IN ALL RATES GIVEN ROADS

equipment purchased and explaining other expenditures for betterment of the roads.

Approximately 1,000,000,000 persons ride on the railroads each year. The fund for equipment and betterment is intended to insure their comfort.

EQUIPMENT NEEDED
The roads estimate that they now need 100,000 new cars and 2000 new locomotives. Freight car needs are placed at 100,000.

The commission's decision has been long awaited by shippers, manufacturers and business men throughout the United States. It is intended to put the railroads on their feet. Since their return to private ownership the roads have incurred deficits totaling approximately \$100,000,000, according to estimates here. This loss has piled up since March 1, when the government turned the lines back to private management. It must be made good by the government.

Shippers and manufacturers in all parts of the country for months have complained of inadequate rail facilities. Many could not ship their products. The decision followed hearings held by the commission in April, May and June. For several weeks members of the commission have worked night and day trying to adjust the conflicting claims made at the hearings by shippers and railroad officials.

RATES NOT SPECIFIC
The new rates are intended to be operative until March 31, 1932.

The commission's decision is a sort of outline to the roads as to how schedule they can fix in fixing increases. It does not fix specific rates on any particular commodity. Fixing the actual rates is up to the individual railroad companies.

Neither can the railroads simply take the increased percentages allowed by the commission and apply them in a blanket manner to existing rates. Railroad rates are complicated through a host of special considerations. The commission's decision is a chart or guide which the railroads will give to the shippers to be used in fixing new schedules.

Each road as it works out its new schedule will give notice to the public of the rates by to how schedule in the office of the commission here.

OPEN TO PROTEST
The new rates then may become effective five days later, unless protest is made. In that case the entire schedule or a section of it may be held pending investigation by the commission. Such investigations probably will be numerous for each schedule filed.

The commission's decision was approved by all members in its general conclusions. Commissioners Eastman and McChord, however, had minority reports stating they disagree with other members as to the method followed in computing the increases allowed. Walter D. Portland Pickers To Save Flax Crop Bought by State

Salem, July 31.—The Marion county flax crop which seemed doomed to loss through inability to secure laborers for pulling the crop will be saved, thanks to the timely assistance of C. H. Gram, state labor commissioner, who, in cooperation with the state employment agency at Portland, has arranged for the importation of 150 men and women for work in the fields around Turner and Astoria.

Pulling of the 600-acre crop began Saturday, a number of the "pullers" reaching the fields from Portland Friday afternoon. The flax was planted under contract with the state, which has agreed to take the entire crop at a stipulated price, the farmers to deliver the crop at the state flax plant here. It is estimated that the crop in Marion county this year is worth approximately \$100,000.

Vocational Bill Is Aid to States in Helping Injured

Attention of the Chamber of Commerce has been called to the passage of the vocational rehabilitation bill, which will provide funds on a match basis to states wishing to fit their injured industrial workers for other occupations. The bill provides a fund of \$750,000 for the first year and \$1,000,000 each succeeding year.

This sum is to be distributed on a 50-50 basis to states, the government guaranteeing to match state appropriations up to a certain limit. This money has been referred by the chamber to the state accident commission. The commission has been asked whether it has a fund available for this purpose. The passage of a new law would be necessary.
