BRITISH ARE DISTURBED AT FREE POLAND

Wrangel of Facto Regime Recognized and France Will Join in Great Offensive Against Bolsheviks in Southern Russia.

London, Aug. 11.—(U. P.)—A meeting of the British cabinet was hurriedly called late today.

London, Aug. 11.—(I. N. S.)—France will give military aid to General Wrangel's de facto government in Southern Russia for a great offensive campaign against the Moscow soviet government, according to news from Paris this evening.

The evening papers expressed alarm over the new Russian situation which has been created by the announcement of the French foreign office that France has recognized the anti-Bolshevik de facto government set up in Southern Russia by General Wrangel.

CABINET MEETING
The announcement that France will throw her military support to General Wrangel's "white" administration coming immediately after President Lloyd George's speech conciliating soviet Russia, caused a big sensation.

It was pointed out that France's action may have been taken at this psychological moment to influence Roumania.

If Roumania should declare war against soviet Russia two routes would be open to France to send troops into the country.

One line by land through Roumania, the other by sea through the Dardanelles. General Wrangel's army of 25,000 men is now in control of 25,000 square miles of territory in Southern Russia.

ADVANCES INTO RUSSIA
Beginning his offensive at Sebastopol, General Wrangel soon took over all of the Russian mainland. After defeating the soviet forces in a number of engagements, General Wrangel's army crossed the Dnieper.

The soviet government at Moscow took alarm over the situation and began a

SUFFRAGISTS GAIN IN TENNESSEE TEST

Nashville, Tenn., Aug. 11.—(I. N. S.)—The first test vote on suffrage in the Tennessee legislature came this afternoon in the lower house and resulted in a victory for the suffrage amendment.

The vote came on a motion to table a resolution offered by anti-suffragist leaders, which sought to hold up action by the legislature until mass meetings could be held in every county in the state and their results returned to the legislature. The resolution was tabled, 52 to 37.

An effort will be made today in the senate to pass a resolution requesting all workers for and against suffrage from outside the state to fold up their tents and leave, and let the legislators settle the question without outside influence.

The resolution will be introduced in the senate by Senator Lon McFarlane, who voted for partial suffrage, but who is opposed to ratification because of constitutional objections. It is aimed largely at workers of the national woman's party, the organization which picked the White House, although it is aimed also at a strong anti-suffrage lobby as well.

McFarlane's resolution is largely the outcome of an incident between Speaker Seth Walker of the house and Miss Betty Gram of Oregon, a militant leader. Walker had been counted on by the women of the state, but according to Miss Gram on Monday told her he had changed his views. At any rate, after she interrogated him, his opposition to suffrage became pronounced and

Prices Decline, but Bottom of Grade Is Long Distance Off

Washington, Aug. 11.—(I. N. S.)—The price of principal food commodities, paid to producers, decreased about 11.5 per cent during July, according to a statement today from the department of agriculture. However, the July prices paid to producers increased about 2.9 per cent over the 10-year average. On August 1, the index figures of prices was about 0.2 higher than a year ago, 17.5 higher than two years ago and 73.6 per cent higher than the average of the past 10 years on August 1.

AMERICAN GAMBLERS' MONEY IS ASSISTING IN CANTU REVOLUTION

(United News)
Washington, Aug. 11.—Money paid by American gamblers, possibly the cause of the Cantu revolution in Lower California, according to Deets Pickett, research secretary of the Methodist temperance society, in a letter to Baltimore Colby, secretary of state. Pickett reported alleged findings made on a trip to Tia Juana, Mexico, from which he just returned.

The American gamblers operating concessions at Tia Juana near San Diego, are using Cantu \$350,000 a month from profits they are reaping from American citizens, Pickett asserted. He gave a vivid picture of the "wide open conditions."

American gamblers and vice exploiters are maintaining just across the line, in and near Tia Juana, Mexico, facilities for gambling, cock fighting, dog fighting, prize fighting, prize fighting and every other iniquity outlawed by American people," Pickett said in his letter.

PONZI'S BANK IS CLOSED BY STATE ORDER

Hanover Trust Co. of Boston Shuts Doors on Demand of Bank Commissioner, Who Alleges Doing Unsafe Business.

Boston, Mass., Aug. 11.—(I. N. S.)—The Hanover Trust company, in which Charles Ponzi deposited his funds, and of which he was a director, was closed this afternoon by order of State Bank Commissioner Allen.

The bank commissioner took over the management of the bank on the ground that it was doing an unsafe business.

Commissioner Allen declared the bank had violated the law in loaning \$500,000 to Ponzi on his certificates of deposit for \$1,500,000, thereby constituting a withdrawal of the deposit before the time specified. He also said that he had found the general condition of the bank's loans "unsatisfactory."

Practically all of Ponzi's funds are believed to have been deposited in the Hanover Trust company. Bank Commissioner Allen a few days ago ordered the bank to stop issuing certificates of deposit for Ponzi's account.

Ponzi held a certificate of deposit for \$1,500,000 in the Hanover Trust company. He was ordered by the receiver to stop issuing certificates of deposit for Ponzi's account.

ADMITTS SERVING TIME
Ponzi, "financial wizard," this afternoon admitted that he was the man who was sentenced to three years for forgery in Montreal in 1908 and said he served time in the federal penitentiary at Alcatraz, Cal., for smuggling Italians across the international border.

Ponzi stated in a dramatic manner that he was ashamed to confess that he had made money by deceiving his past and that now he wanted to have his story told by his own lips. He announced that he had resigned from his position as the head of directors of the Hanover Trust company until his affairs were settled and he would call in all of his note holders and meet his obligations at once.

EXPLAINS HIS CONFESSION
Ponzi insisted that while he confessed to forgery in Montreal he was innocent and made the confession and served his sentence as individuals for their former jobs.

Livestock Rates On Carlots Held Unfair; Meredith Fixes New Rates

Washington, Aug. 11.—(I. N. S.)—Declaring that certain rates charged by Chicago commission houses on cooperative shipments of livestock to be unfair, Secretary of Agriculture Meredith today fixed rates to become effective on August 16, under the powers given by the food control act.

Secretary Meredith announced the following car lot rates for commission men:

For more than one and not more than 10 owners, \$2; for more than 10 but not more than 20 owners, \$3; for more than 20 owners, \$4.50. In no case shall any owner of such car lot pay a higher rate than the maximum charge for a car having a single owner.

The action follows a complaint by the American Society of Equity that, as a result of action by the Chicago livestock exchange, members were required to charge a different and higher rate on livestock in car lots having more than one owner. The difference between rates for single and plural ownership, it was complained, was unreasonable and discriminatory in that it was laid for the purpose of discouraging the marketing of livestock by farm organizations.

WOOD DENOUNCES STRIKE-BREAKERS

Denver, Colo., Aug. 11.—(U. P.)—Immediate deportation of all strike-breakers who are operating street cars in Denver was ordered by Mayor General Leonard Wood after a conference with tramway, city and union officials late yesterday.

His scathing rebuke of city and tramway officials for bringing armed strike-breakers to the city and characterized the action of the strikebreakers in shooting as cowardly murder.

REDS 18 MILES FROM WARSAW

N., went on the rocks finally this afternoon when the matrimonial court of the Catholic church ruled that her marriage to Roger Beckwith, the former Baron Wilhelm von Brincken, from whom she was presently divorced, was valid. As the church does not recognize divorce, it will be impossible for Mrs. Abercrombie to remarry in the church.

And her mother, Mrs. George McGowan, declared emphatically this afternoon that she would not marry out of the church.

Commander Nelson is on his way back to his post, and it was reported Mrs. Abercrombie would soon be at rest after the nerve racking days of uncertainty by visiting relatives in Santa Barbara.

FREE POLAND, FREE RUSSIA, U. S. POLICY

America Is Expected to Extend Material Aid to Poland as Result of Note to Italy on Russian Situation.

Washington, Aug. 11.—(U. P.)—President Wilson will shortly extend material aid to Poland in conformity with his promise to use "all available means" to protect that country's independence, it was stated today in official quarters here.

The pledge of American support of Polish independence and territorial integrity was contained in a statement of the Polish situation, which took the form of a note to Baron Azevansa, the Italian ambassador here. The note, which was a reply to an inquiry from the Italian government concerning this government's policy, was made public by the state department.

The chief features of the note are:

1. A statement that the United States' policy "will be directed to the employment of all available means" to maintain Poland's political independence and territorial integrity.

2. Refusal to sanction Lloyd George's plan for a peace conference at London in which the allies would take a hand in making peace between Russia and Poland.

3. Warning that Russia's interests must be sacrificed to the interests of Poland. Russia must be held in abeyance until the people set up a government representing their own will.

4. Scathing denunciation of the Bolshevik regime and emphatic refusal to join in or approve any sort of recognition of it.

5. Approval of allied efforts to "bring about any peaceful solution of the existing difficulties," and promise of any support on justifiable means to that end.

6. Expression of the hope that the Russian people "will soon find a way to set up a government representing their free will and purpose," and a

MAN CARRIES OWN DEATH CERTIFICATE

Field, until recently residents of Portland who now live at Buxton, telling how he had died gallantly on the field of battle. A beautiful little death certificate was made out and insurance matters were being arranged.

Then Field, spoiled all plans by appearing perfectly well and happy except for a lame arm and a few other little reminders of the wounds he received at Soissons.

MEETS OLD FRIENDS

Field is having a hard time convincing people he is not dead.

Within his pocket alongside his death certificate, Field carries a citation from Uncle Sam, to one James E. Field, private first class, Company M, Eighteenth Infantry, for gallantry in action at Soissons July 18 to 24, 1918. Field was wounded at Soissons and removed to a French hospital. This was his "lost" from his regiment and the conclusion was that he had perished in battle.

His right arm was injured to the extent that he could not write his own letters, and his parents, after receiving notice of his death, would not believe the letters written by his nurse were really from him.

TRUTH FINALLY DAWNS

It was not until he came back to the United States eight or nine months ago that his parents realized, through the aid of a friend, that he was still alive.

Besides having trouble convincing people that he is alive, Field is having difficulties over obtaining a vocational training course under the federal aid act, because of residence. Because he happened to be in Ohio when he enlisted, Oregon would not accept him as a resident, and because in Ohio he gave Oregon as his residence, Ohio won't do anything for him.

Field came to Portland in 1906 and lived here until five years ago.

DUBBED "DEAD"
