

PRISONER TAKEN BY TIL TAYLOR CONTRIBUTES \$5

Sheriff T. M. Hurlburt Friday morning received a contribution of \$5 for the Til Taylor Memorial fund from a prisoner in the county jail whom Taylor had arrested after a long, hard chase in Eastern Oregon. The prisoner is Benjamin F. Jarrell, who is serving sentence of one year because of the dead Umatilla sheriff's persistence in tracking him down for moonshining operations.

"I notice in the papers that you are collecting funds for the Til Taylor memorial," Jarrell said in his letter. "I enclosed you will find \$5—the best I can do. I cannot express how sorry I was to hear of his tragic end. It is a shame that a brave, good man like Til Taylor should have been shot from behind by a dirty cur."

Jarrell is an outstanding character in the "moonshine" brigade. He was arrested at Astoria on the charge of making illicit liquor, brought to Portland and released on bail. He then went to Eastern Oregon and established a still in a most inaccessible spot. Sheriff Taylor and his men had a great chase in apprehending the man and one of the incidents was the descent of cliffs by ropes to reach the Jarrell still. He was convicted and sentenced to one year in jail and to pay a fine of \$100 in October, 1919.

The campaign at the courthouse was reopened Friday morning. Attaches of the sheriff's office made pledges of more than \$100, and the situation in practically all of the courthouses, but subscription lists were placed in each.

The fund at police headquarters has passed the \$50 mark.

Judge Bean's Ruling Kills All Hope of Dry Law Violators

Visions of freedom seen by many inmates of the county jail convicted of violation of the internal revenue laws went glimmering Friday morning when Federal Judge Bean interpreted his recent ruling that the prohibition laws in effect repealed the older revenue statutes.

Sam Conrad and Joseph Wilson, charged with the operation of moonshine stills, had presented applications for writs of habeas corpus which, although allowed by the court, are qualified so that the pair cannot be freed. By implication Judge Bean declared that he would hold such violations of the revenue laws culpable under the newer statutes and that persons convicted of revenue law violations shall be held for violating prohibition laws.

The writs allowing Friday require that the United States marshal deliver the two men, now in the county jail, for a hearing in Judge Bean's court Tuesday morning. The two have admitted their offenses against the revenue laws and, the judge implied, he will hold them on the strength of these admissions.

Conrad was committed to jail March 10 on an indictment dated February 28, following his arrest on January 22. He was fined \$500 and sentenced to serve six months. Wilson pleaded guilty to a revenue law violation on February 9 and was committed March 11.

SUFFRAGE FORCES BEAT ANTI'S COUP

Nashville, Tenn., Aug. 20.—(I. N. S.)—Standing like a stone wall, the immortal suffrage 49 again today defeated the anti's and prevented an adjournment of the house of representatives from Friday until 3 o'clock Monday afternoon. They then forced 10 a. m. Saturday for the next session date.

Every man who voted Wednesday for or against ratification today was in his seat and every man lined up exactly as he did on that occasion. Speaker Walker failed to avail himself of his opportunity to call up the ratification resolution for reconsideration, despite his claims last night at the anti-party meeting that he had 53 votes against suffrage.

Today was the last day in which Speaker Walker alone had the right to bring up the resolution. Tomorrow any member can do so, and suffrage leaders intend to bring it up immediately, table it and have the Tennessee suffrage fight over.

Governor Roberts, it was reliably learned today, has sent to Secretary of State Bainbridge Colby, a certified copy of the journal of the house of representatives, and a certificate that Tennessee has ratified. The governor refused to make any statement regarding the matter.

FREE TREATMENT IN HOSPITALS ASSURED IN WILL

Good Samaritan hospital is to receive approximately \$40,000 to sustain a free room for the use of persons requiring hospital care and who have no means for such service. This bequest is made in the will of George Boschlin, who died at 347 Fremont street, August 14. The will was admitted to probate Friday.

Boschlin had lived in Portland for many years, and a peculiar fact in connection with his bequest is that during his last illness he persistently refused to consider going to a hospital for care. He left an estate of the approximate value of \$49,550. For seven years he had been a widower and it is stated that he left no heirs-at-law.

Paul van Fridagh, a friend of many years standing, is named as executor of the will, which is dated October 7, 1919. The legatees under the will are Louis Jann, Barberte Jann and Hulda Jann Bauer of Clarke county, Washington; Mrs. Charles Adwen, Fred John Denke and Arthur Denke of Portland; Mrs. Louise Schulze, adopted sister of the late Mrs. Louise Boschlin, of Bremen, Germany. These are given sums from \$1000 to \$25,000, and are of the nature of trust funds and not personal belongings. The remainder of the estate is given to the Good Samaritan hospital for the purpose indicated above.

Circuit Judge McCourt appointed as appraisers of the estate H. G. Effinger, William G. Beck and A. A. Lindsay.

COURT DECLINES TO FREE GARNISHED BONUS CHECK

A letter from the war department to W. P. Chandler, returned services man, presumably containing a \$50 bonus check, and now held by Sheriff Hurlburt under garnishment, will remain in the sheriff's possession for the purpose of return of the plea made by Edward J. Shinner Friday before Circuit Judge McCourt for an order releasing the letter. The letter remain where it is," said Judge McCourt. "This young man comes to court to show what a worthy fellow he is and that he shouldn't be interfered with, but he has no competitions as soon as he is outside, engaging in bootlegging."

It appears that Chandler and three other men signed a note on which \$200 was borrowed, and that the garnishment of his bonus check was to help pay this note. It was brought out in court that the loan was secured for the purpose of one of the men going to Blaine, Wash., and purchasing liquors to be brought to Portland for the Shriners' week, but after the liquor was safely here it was stolen from them.

POLISH WOMEN TAKE ARMORED TRAIN OF REDS

Warsaw, Aug. 20.—The women's battalions in the Polish army have shown the most conspicuous bravery in the fighting against the Bolsheviks.

Reports here today declared that the battalion engaged in the region of Thorn was largely responsible for the Polish success in that region. The women fighters captured an armored train which the Bolsheviks were using in the fighting there and which was relied upon to protect and keep open the railway line, serving as an important link in the Bolshevik communications.

INTEREST REVIVES IN DEVELOPMENT OF COWLITZ COAL

Interest in development of the coal fields on the Cowlitz river in Lewis county, Washington, which has been dormant for 20 years, has again been revived by port and dock authorities and commercial organizations of Portland and Astoria.

Few citizens of the Northwest have realized that within 40 miles of this city lies a cinnabar coal field said to have a product suitable for both steam and coking purposes lying in veins from 8 to 14 feet thick, and that the United States geological survey estimates over 250,000,000 tons of coal in the tract.

First investigations of the cinnabar coal fields was made in 1899 and 1900 by railroad and mining engineers. These engineers reported that 20 miles up the Cowlitz is a tract of land containing seven workable veins, of which three contained good coking and blast furnace coal. Trials which seemingly proved the quality were made in 1919.

Waterpower and oil development on the Pacific coast has led to time and an abandonment of development plans, but with fuel becoming scarce and higher priced and a demand growing for natural gas, interest in the Pacific coast has suddenly been revived.

Members of the dock commissions of both Portland and Astoria have been studying the supply from a marine standpoint. J. E. Gratke of Astoria recently visited the tract and recommended to the port commission and Chamber of Commerce of the lower Columbia river city that some steps be taken to obtain the tract for development by Astoria.

Gratke reported that 14 veins with a combined thickness of 146 feet show on the property and that development should allow placing of coal in the hands of the consumer at about 45 per cent.

Members of the commission of public docks of Portland have expressed a similar interest in the development and believe the coal could be developed at a comparatively cheap rate.

The tract consists of 149 acres and is owned by Dr. S. Nichols and J. W. McBride of Portland and Pat Welsh of Spokane. It is said that the price demanded for the property in 1900 prevented development.

McBride says that the coal in the tract is proved to be the best steam coal on the Pacific coast, the highest grade of gas coal west of the Mississippi river and the only coal in the West that will make suitable coke for smelters.

Interest in iron ore development in Oregon has grown apace in the last year. Several operations are said to be ready to start development work, but have been awaiting the locating of suitable iron ore coal for smelters. In the instance of these interests for a suitable supply of cinnabar coal, it is believed, may assist in the development of the coal field. Further investigations are to be made by both Portland and Astoria interests.

Elderly Man Drops Dead in North End

Papers in the aged man's pockets revealed his name and the address given. The body was taken to the morgue.

YANK BORING-IN TACTICS BRINGING VICTORY TO POLES

London, Aug. 20.—Tactics which were first advocated in the world war by American army chiefs, and which were generally adopted and swept the allies to victory, are now being followed by the Polish army, under French command, and driving the Red armies of Russia in precipitous retreat on all fronts.

These tactics involve the "unlimited" offensive. Reports from Warsaw declare the Polish attack is progressing so favorably that if he can keep it up for three days more, the Bolsheviks will be completely defeated.

It is pointed out by military authorities that until the last year of the war, the French and British armies relied entirely upon the "limited offensive" for all attacks against the Germans.

An attack would be planned to advance the allied line a specified distance, and there it would stop, regardless of conditions that the enemy might be found to be laboring under when the objective was reached.

Such tactics were rendered necessary by the lack of reserves, but there were many instances in which the allies might have done much more damage to the enemy had the offensive been pushed. The American idea, however, was to attack and keep on attacking so long as ample reserves were available and guns and transport could keep up with the advance. These ideas are now being used against the Bolsheviks. The Poles have not merely relieved Warsaw and then "dug in," as might have been expected, but are pushing their advantage all along the line to the utmost.
