

HUMAN BONES AND RIFLE DISCOVERED BY LOCAL HUNTER

A gruesome delivery was made by the sheriff's office to that of the coroner late Tuesday afternoon, when a gunnysack filled with human bones was turned over to Coroner Smith. The bones are those of an unidentified man, believed to be a victim of accident or suicide.

H. H. Hale of Kendall station, well-known in local athletic circles for his football prowess, was hunting at Rocky Point, about 15 miles out of Portland on the Linnton road, Tuesday, when he made the discovery.

He first found a .25-35 caliber Remington automatic rifle with its muzzle buried in the earth, and nearby some human bones. He carried his find to the sheriff's office, and immediately returned to the densely wooded and isolated spot at Rocky Point, with Deputy Sheriff Christensen and Schirmer.

Near the gun the hunter discovered the remainder of the skeleton of a man who had been about 5 feet 6 inches in height. The clothing was a striped white and black shirt, dark trousers with a white or light-colored stripe and there were black button shoes, 6 1/2 in size. Pearl cuff buttons laced over with gold were in the shirt and the clothing was of good quality. In the clothing was found a pocketbook containing what appeared to have been a \$5 bill and a pocket comb.

The skull was shattered into about 30 pieces, presumably from a shot. Two empty shells were found near the skeleton and there was one loaded shell in the gun. The rifle is numbered 14175.

The theory of the sheriff's office is that the man while hunting accidentally wounded himself and then, when he decided no help was available, put himself out of misery by sending other shot into his body. This is based on the finding of the empty shells beside the loaded gun.

In one side of the pocketbook was found a calendar for the month of September, 1918, indicating that the man met his fate about two years ago. At first it was thought the body might be that of William L. Hirsch, son of Patrolman L. Hirsch, who has been missing since October 26, 1919. Careful investigation proved that the clothes and the gun found do not compare with those belonging to Hirsch. Hirsch was last seen in the woods near Cochran. Many searching parties have covered the hills and woods, but no trace of the young man has ever been found.

COUNTY WARRANTS WILL BE CASHED

Although county warrants on the general and road funds have been stamped "Not paid for lack of funds," members of the board of county commissioners declare there is no reason why any county employee should sacrifice any part of his or her wages in order to get their warrants cashed.

"I have positive assurance from the Northwestern National bank, the Ladd & Tilton bank and the Hibernian bank," stated Commissioner Holman at the meeting of the commissioners Wednesday, "that they will cash the warrants issued by the county without discount."

"It appears to me that the county employees who take their warrants to professional warrant shavers and discount them are showing poor business judgment. They have never come to the board and presented the matter or they would be advised that this is unnecessary. They can go to the banks, at least three of them anyway, and I believe there are others, and get the full face value of their warrants in cash."

blades and a whetstone were found near another body, which is thought to be that of Clyde Pollock, a local lumber worker, who is missing. Two lower front teeth are missing.

Another is that of Charles Harmon, who operated a peanut stand here. A key ring bearing his name was found beside it.

Mrs. C. Bilderback has been identified by a gold ring. She was a woman about 45 years of age. Her daughter Leona, 19, was with her.

The body of Leona Bilderback was found. The mother and daughter occupied a room together, while her father and brother slept on cots in a lower hall and escaped.

Others who are missing and thought to have perished, although not identified among the bodies, are Frank Wilson, Klamath Falls; Charles Shadrick, aged 37, employed by Oleson Huber, highway contractor, and Bob Dawson, who came here from Portland. He was 32 years old. A sister, Mrs. King, lives in Portland.

A coroner's investigation will be held Wednesday to ascertain the causes of the fire, and, where possible, the identity of the victims. Mayor I. R. Struble and Health Officer Dr. A. A. Boule telegraphed Governor Olcott, asking him to send a representative here to investigate rooming house conditions.

BABY IS SAVED
Those injured in the fire from burns and accidents in jumping are recovering. A list of injured follows:
Harry McCharles, badly burned and bruised; William Morse, bruised and burned; Thomas Higgins, feet burned, cuts and bruises; Mary Capluso and her four-day old baby, not seriously injured. Mrs. Capluso, an Italian woman, threw her baby out to the father and then escaped. D. Boyard, 40 years old, suffered badly burned ears, face and neck and bruises. He jumped.

Many others were burned and injured less seriously.

PORTLAND MAN BELIEVES DAUGHTER AMONG VICTIMS

The Mrs. Dolly Parker, whose maiden name is given in Klamath Falls dispatches as Miss Grace Hall, and who is reported to be one of those burned to death in Monday morning's disastrous fire, is believed to be Mrs. Dolly Fiorance Parker, 60, daughter of Mr. and Mrs. Otto A. Hall, 2145 Sacramento street. After reading accounts published in Tuesday's Journal, Hall said

Wednesday morning that he is certain the victim is his daughter.

Mrs. Parker is but 16 years of age, according to her father, but looks 19. She weighed 125 pounds, was 5 feet 2 inches tall, dark eyes and hair, and had the appearance of being heavy set. She is said to have been exceptionally bright for her age, and to have been handy at nearly any kind of work.

The girl and Joe Parker were married in March. They lived together for about two months. Since that time she has earned her own living, the father says. She has never written home, the parents keeping track of her through a girl friend in the neighborhood with whom she corresponded regularly.

Shortly after leaving her husband Mrs. Parker went to the home of an uncle, Daniel Maxfield of Salem, where she worked. More recently she is said to have worked in a restaurant at Salem and to have stopped at the Capitol hotel. Nothing has been heard of her for two weeks, the father said.

Hall said that his daughter had been trying to keep away from her husband. The reason for their separation he could not say. Parker is said to have written to Hall several times asking for the address of his wife.

DEPUTY FIRE MARSHAL TO INVESTIGATE BLAZE

Salem, Sept. 8.—In response to appeals for assistance addressed to Governor Olcott by A. A. Spole, health officer, G. W. Allen, deputy state fire marshal, left Tuesday night for Klamath Falls to cooperate with city authorities in establishing responsibility for Monday's fatal conflagration and in eliminating other serious fire hazards that might exist there.

Monday's fire at Klamath Falls, it is pointed out by officials here, was practically forecast by members of the state fire marshal's office in a report following a survey of fire hazards in that city in September, 1919.

In that report it was pointed out that no ordinances regulating the construction of buildings existed, and that unless this condition was corrected immediately "Klamath Falls will be known as a conflagration town."

Antagonism between the city recorder and other city officials, it was declared, was responsible for the many fire hazards existing in the city at that time. Rubbish piles, defective flues, and many other fire menaces were said to exist in the city, which condition the fire chief was powerless to correct because of his limited authority and the lack of fire prevention ordinances.

Shadrick Among Klamath Dead

Charles D. Shadrick of Portland was positively identified as being among the dead in the Klamath Falls fire Monday. Luther Shadrick, 756 Amherst street, and Linley Shadrick, 1230 Vanderbilt street, and Mrs. Susie Myers, recently of Redondo Beach, Cal., are brothers and sister of Shadrick.

GROCERYMEN IGNORE MILK COMMISSION

will plead that the arrangement is a temporary one.

HEARING DENIED
In concluding the resolution declares that the milk tribunal has gone on record as condemning the retailers without a hearing and that the latter cannot be expected to enter into any further negotiations with the body.

"If the milk commission can later on make a decision fair to us, none will be able to rejoice more than we," the resolution reads, "but if they continue to be unfair, we shall continue to assert our rights and our independence, and rely on fair minded public opinion, which loves a square deal, to support us in that position under the circumstances."

"I am sorry they have blown up over it," said William L. Brewster, chairman of the milk commission, Wednesday, in commenting on the action of the grocers.

INTEREST CARED FOR
"The only ground they have for complaint, and it is small, is because they were not represented at the meeting. Their interests were taken care of by the distributors, whose advantage it was to secure as square a deal as possible for the retailers."

"I told MacLean that the arrangement was only temporary and when the commission adjusts the October milk prices the retailers will be given the fullest consideration. MILK LITIGATION ARGUMENTS DRAW NEAR TO FINISH

Final arguments on the hearing before Circuit Judge McCourt on the application to make permanent the temporary injunction against the milk distributors, prohibiting them from undertaking in any manner to induce the Oregon Dairymen's Cooperative league to break their contracts with the league, are drawing to a close. It is probable Judge McCourt will take the matter under advisement Wednesday.

Arguments on points of law occupied most of the court sessions Tuesday.

AFFIDAVITS PRESENTED
Special interest was thrown into the proceedings immediately after the sessions were resumed in the afternoon by Dan Malarkey, one of the attorneys for the league, presenting affidavits from dairymen in Coos county, substantiating his previous statements to the court, to the effect that representatives of the Nestle Food Products company had informed them the company had won the case at court, and that their contracts with the league were null and void, and that they could now deliver their milk to the company's condenser.

One of the affidavits stated that A. F. Fiegel Jr., who is a deputy United States district attorney, was accompanying the company's representative and advising that the league members could void their contracts with the league by incorporating, or selling their cows to their wives.

DENIAL IS MADE
Immediately after the introduction of these affidavits, A. F. Fiegel Sr., who appears as attorney for the Nestle company, made a statement to the court in which he declared that he still maintained that the affidavits were false, and he read to the court copies of letters and telegrams he had received from McDonald, the company's representative at Bandon, and from A. F. Fiegel Jr., in which they made emphatic denial of the statements of the affidavits as "absolutely false and untrue."

In closing his argument for the league, Attorney Malarkey discussed the attempts of the milk producers to get a fair price for their products, and said: "Anybody who produces anything has an inalienable right to try to secure in the sale of that product the cost of production and a reasonable profit. That is just what the Oregon Dairymen's Cooperative league is trying to do, and that is not an unlawful purpose. The men complaining are the middle men, yet they are in as tight a combination as is possible."

The Dalles, Sept. 8.—Twenty houses to accommodate employees of the King dehydrating plant, which opened Tuesday, working on Bartlett pears, will be constructed at once, according to C. C. Rose, local manager for the company. The houses will be modern in every particular and will be built to house four or more families and equipped with all conveniences for light housekeeping.

Both the King company and the Libby cannery have sent out appeals for 200 girls to aid them in disposing of the pear and prune crops. The industry, they say, is threatened with a serious loss through the lack of help. Good wages are paid and an appeal to the women of Oregon to come to The Dalles for canning season has been sent out.

Permit Issued for \$30,000 Dormitory

The North Portland Evangelical institute is erecting a dormitory at 1184 Northwick street at an expense of \$30,000. A permit covering the construction work was issued by the building inspector's office Tuesday afternoon. Bartelso & Johanson have been awarded the contract for the work.

SPECTACULAR WAR SCENES ENACTED IN CITY TONIGHT

Under the light of battle flares, men will advance from masked trenches on enemy barbed wire lines, penetrating the gas barrage wearing gas masks.

Batteries will rain bombardment on the opposing sides. Trench mortars will follow, machine guns will spatter and hand grenades will thunder.

Overhead an attacking airplane will be illuminated with the flash of the aerial bombs sent to bring it down, and from its wing tips will play signal fires.

LEGION TO STAGE BATTLE
These are some of the things that will be seen Wednesday night at the spectacle being given by Portland post No. 1, American Legion, "The Battle of the Argonne," being reproduced at Vaughan street baseball park.

The American Legion band has been organized, and will make its first appearance prior to opening the show. Philip M. Hicks, the director, is in charge of the affairs of the band of the fifth regiment, Oregon National Guard, and has gotten together a 35-piece band. Skilled musicians with years of training are among the band's complement, and an attractive program has been arranged. The concert will start at 7:30 and last an hour. These numbers will be played:

"March et Cortège—La Reine de Fable" (Gounod); overture, "Maximilian Robespierre" (Hoffmann); idyll, "First Heart Throbs" (Ellenberg); legend from the opera "Martha" (Flotow); "Invitation to the Waltz" (Weber); ballet music from "William Tell" (Rossini); gems from the works of Stephen Foster.

Charged With Using Dogs in Hunting Deer

C. H. Fowler of Goble and A. E. Meierotto of Portland were arrested Sunday evening on headwaters of the Clatskanie river by Deputy Game Warden R. H. Clark, J. J. Craig and William Brown and charged with using dogs in hunting deer and failing to tag their deer. Peter Remy and Joe Rubano were arrested early Sunday morning 10 miles east of Portland by Clark and Deputy Warden Warren Cornell, charged with hunting ducks during the closed season. All pleaded guilty before Judge Hawkins in the district court and were fined \$25 each.
