Eugene, Sept. 27.—Herbert L. Leonard, alias Hood C. Martin, who claims to be heir to an estate of \$200,000, slipped out of the county jail Saturday. The fugitive had just finished a short term for larceny by bailie, and was being held over on representation from naval authorities that he was a deserter. Saturday Dr. Joseph Thompson, of the navy, arrived in the city and in company with a local recruiting officer went to the jail for conference with the prisoner regarding a confession he had made to the officers. The two were left in the jail with the prisoner for a short time while the sheriff stepped outside to attend to another matter, and during his absence one or the other of the officers opened the cell door and failed to lock it again. The prisoner instantly took advantage of the oversight.
