

APPEAL ELECTRIC SIGN CASES TAKEN UNDER ADVISEMENT

Circuit Judge Tucker took under advisement today the appeals from the judgment of the municipal court of Dr. Paul Yates, dentist, and Mrs. Martha Smith, owner of the Alba Dentists Dental company. Each was fined \$40 in the municipal court for having electric signs extending over sidewalks that the municipal court held are in violation of a municipal ordinance.

At the hearing on appeal it was shown that the signs were constructed and maintained under permits issued by the city in 1916, but also that the ordinance pertaining to the maintenance was revised in 1918, and that under it the dental signs would be in violation of the law. The question is whether when the city issued the permits under which the signs were erected, and without any time limit, such permits would be subject to the revised ordinance.

AUTO WEDGED BETWEEN CARS; DAMAGES IS ASKED

David Dahm wants \$2500 from the Portland Railway, Light & Power company for damages sustained May 7 in a rather unusual accident. He filed suit against the company Thursday. Dahm says he was driving with his wife and little daughter in their automobile, following a streetcar on East Washington street, when the streetcar stopped and the auto was halted right behind it. He says a second streetcar came up behind him on the same track and crushed the auto between the two streetcars, throwing the three persons to the pavement, smashing the car and causing personal injuries to himself.

The judge said Carrasco began over the wife's refusal to deed to her husband property she owns in Spain.

BOARD TO TALK TO TEACHERS ON TENURE, SALARIES

Teachers' tenure and teachers' salaries will be threshed out at a meeting of the school board with Portland teachers next Tuesday evening, from 8 to 9 o'clock being devoted to the tenure question, and from 9 to 10 to the salaries.

The Federated Teachers' council, to which was referred the salary schedule, split up, and the different classes of teachers have each reported their own recommendations. The grade teachers have asked for a minimum of \$1400 and a maximum of \$2300; the high school teachers have asked for a minimum of \$1700 and a maximum of \$2500, with \$2700 minimum and \$2900 maximum for heads of departments. Special teachers have asked for \$1800 to \$2300 for manual training, \$1600 to \$2100 for cooking and sewing, \$1500 to \$2100 for physical training.

PRINCIPALS ASK MEETING

Principals have not yet made their recommendations in writing, but have asked for the privilege of meeting with the board. This was granted, but their request for an executive session was denied.
