

TWO SENTENCED TO PENITENTIARY FOR AUTO THEFT

Because Mrs. H. M. Shields declined to ride from Yakima, Wash., to Portland in a "bug" automobile, her husband and his brother, O. D. Shields, were this morning sentenced to serve 13 months at McNeil's Island prison for violation of the national motor vehicle theft act. Rex Shields, a brother of the two men, is in the Oregon state prison for stealing a machine.

The two boys owned a "bug" and when they decided to come to Portland Mrs. Shields refused to ride in it, they declare. They blamed her for suggesting the theft of a small touring car. The boys transferred the bodies and drove both cars across the state line. The cars were sold here, O. D. Shields declared, at Mrs. Shields' suggestion. They pleaded guilty before Federal Judge Wolverton to grand jury indictments.

WOMAN'S TRIAL SET

Georgia Landon, wife of George Landon, held for trial for a Mann act violation, pleaded not guilty to the charge this morning. Her trial was set for November 11 and an order committing her to jail will be contested by her attorney, Roscoe Hurst, who pleaded before Commissioner Drake some weeks ago that she be confined in jail because she had no means of support.

George Black was sentenced to 90 days in jail and pay a fine of \$100 for selling liquor to Indians. He pleaded guilty to a grand jury indictment returned Thursday.

D. N. Morgan, an elderly man, pleaded not guilty to an indictment charging him with violating the Mann act. Trial was set for January 6 and he was returned to jail for want of bail.

John Basch was allowed 10 days to enter a plea to an indictment charging transportation of liquor. Stillman Andrews pleaded not guilty to a charge of operating a still and trial was set for December 28.

HAGGERTY INDICTED

J. E. Haggerty, who has styled himself as a soldier, poet, professor of chemistry, inventor, and government geologist, was indicted Thursday afternoon on a charge of using the United States mails to defraud.

Haggerty is charged with advertising in the newspapers and through the mails

Haggerty is now under arrest at Kansas City, Mo. Lusk said, on a charge of impersonating a federal officer. Lusk said the grand jury found all claims made by the burner to be false. The sworn statements of nine persons, who claim to have been swindled by Haggerty, are attached to the indictment. The grand jury returned 26 indictments, of which 22 were general true bills, seven secret true bills and six not true bills.

DRAFT EVADING CHARGED

Ivar Silwanen is charged with failing to register in 1917 and with having absented himself from Oregon between May, 1918, and May, 1920.

In an effort to gain citizenship on June 14, 1920, Frank Vilenius is alleged to have falsified in the court at Astoria that he did not claim exemption in the draft. His questionnaire shows, according to United States Attorney Humphreys, that he claimed exemption as an alien.

H. M. Shields, Orvil D. Shields, Edgar Corn alias James Dorney, and W. H. Cunningham alias Robert Thomas were charged with violation of the federal motor vehicle act. Cunningham and Corn are charged with deserting the army at Camp Lewis and stealing an auto in Tacoma and driving it to Portland.

DRY LAW VIOLATORS

The most sensational liquor indictment is that returned against Nettie C. Connett, George Wilkinson and Everett N. Lowther of Will Run.

For alleged theft of a 50-cent piece from the mail box of H. T. Dyer of Millikan, an indictment was returned against Lester Winkler.

Other indictments for violation of the prohibition laws: Stillman Andrews, Mildred Andrews, Lester Talmadge, Warren Ruff, Adella Sullivan, H. H. Buckner, Ferrero Constantino, Henry Behreder, Wiley E. Knighton and Archie Hopkins.

The narcotic cases involve two Chinese, two negroes and one white, who are, respectively: Harry Ching, Charlie Ching, Louie Ervan, Thornton Robinson and John Perry.

NOT TRUE BILL

Not true bills were found as follows: Leo A. Holmes, violation of Mann white slave act; Phillip Kowitz, impersonating United States officer; Herbert H. Wilson, violation of Mann white slave act, and the following for violation of the prohibition law, Henry Abramkoff, H. Conley and Fred Zintz.

All the liquor, narcotic and white slave cases were handled by Assistant United States Attorney Charles W. Reames and Austin P. Figg Jr.

Following the report to Judge Wolverton, the grand jury retired for further deliberation.

KIDNAPED TACOMA BOY RETURNED TO HIS GRANDMOTHER

Tacoma, Wash., Oct. 22.—(I. N. S.)—Worn and weary, 21-month-old Bobby Stagg is with his mother and great-grandmother here today after five weeks of travel and turmoil—two trips across the continent and life in many hotels and apartment houses. It was September 14 he was snatched from his mother's arms, it is alleged, by George T. Stagg, the father, who is divorced, and with the aid of Betty Brainerd, a newspaper woman of Seattle and New York, carried away to the metropolis.

It was in a hotel room in Vancouver, B. C., that Bobby was restored to his mother's arms, after being brought back from New York by two women said to be in the employ of a New York newspaper. A few minutes after a telegram had been received by a Tacoma newspaper, saying the child was in Vancouver and would be delivered to a person who should ask for "a bundle." Mrs. Stagg was on her way to the Canadian city, accompanied by two local newspaper reporters. At the Vancouver hotel designated the reporters were conducted to a room where the two women with Bobby were. The women left abruptly and Mrs. Stagg was sent for to take up her precious burden from the bed and cover it with tears and kisses.

Safe return of the child had been promised by friends of Miss Brainerd, who is said in New York for complicity in the kidnaping. Harry Smith, chief of police here, declared today efforts to extradite Miss Brainerd will not be relaxed. King county officials at Seattle who have been working on the case also declare there is no intention of dropping the prosecution. Mrs. Stagg was wired to New York to continue the prosecution of Miss Brainerd.

W. B. AYER SHOWS UP FALLACY IN PORT BILL

ation of its scope and purpose as made from time to time by its advocates. Propaganda regarding this bill was confined almost exclusively to the development of docks and terminals at Guild's lake and Mooka bottom, as very clearly set forth on the map filed at the city hall and published in the Oregonian on March 25, 1920, and, on March 25, the following extract from the account of the meeting at the city hall:

PLAN IS OUTLINED

The plan submitted to the city council yesterday by F. M. Warren, J. B. Czer and F. C. Knapp, representing the Committee of 15, among other things, says: "The scheme includes the construction of piers, slips and industrial sites on the west side of the river, served by railroad trackage facilities, including depots for inbound and outbound freight. The plan also provides that the mainline would not only be adequately served by railroad facilities, but, in addition, would offer berthing facilities for 75 ships of 500 feet length each."

The discussion following this publication has clearly demonstrated that the cost of the completed project would exceed \$40,000,000, and this cost has not been denied by the advocates of the measure when I have asked them about it.

STATEMENT PUBLISHED

By September 17 the criticism of this dock development plan had become so pronounced that the Committee of 15 published in the press a revised statement of the scope and purpose of the bill, shifting their argument from the necessity of dock development to one of channel improvement.

From this statement one learns that new equipment and work on the channel from Portland to the sea would consume about \$5,000,000 of the proposed bond issue and take 12 years to complete before a permanent 32,000-foot channel would be completed; that the cost of the land adjacent to Swan island would not exceed \$4,200,000, and that Swan island, Guild's lake and Mooka bottom would be filled from opening the west channel and closing the east channel, resulting only in producing raw acreage.

If the public misunderstood the effect of the measure, it is because it would not understand what the policy of the commission will be.

HOME RULE DENIED

Regarding the much-discussed question of home rule, the Committee of 15 does not deny, of this measure should pass, that the commissioners would have the right to issue bonds and to build docks and construct terminals, in accordance with the map filed by them, without the usual restriction of the vote of only the people affected. There can be no question but that this is a denial of the right of home rule.

It has been pointed out that the legislature has authority to authorize the present port commission to issue bonds for channel improvement. The committee states that it is fearful the delay would retard the progress of channel work. They also say that in conference with the directors of the chamber, held immediately preceding their late action, the chairman of the port commission made the following suggestion: "That no steps would be taken towards acquisition of lands until a measure could be submitted to the legislature authorizing the establishment of reclamation districts, etc."

It will be noted that this statement only says that the measure would be submitted to the legislature. It does not say that the Swan island project would be suspended until the legislature had passed the measure and the full promise would be fulfilled if it were simply submitted but not passed. But it should be publicly known that this proposition, such as it was called for by the chairman of the port commission declining to agree to the following request: "That the commission agree now not to issue any bonds for the purchase of land or its development or do any work on closing the east channel and opening the west channel, without submitting the whole Swan island project to a vote of the people of the port district."

ACCUSED REALTY BROKER REQUESTS TIME TO PLEAD

N. R. Long, indicted by the Multnomah county grand jury a few days ago on the charge of operating a real estate brokerage business without a state license, appeared with his attorney, Franklin F. Korell, before Presiding Judge Tawell this morning and asked for further time in which to plead. The time was set for 9:30 o'clock next Wednesday morning and Long was allowed to go on his own recognizance.

This is the first case of the kind brought under the statute of 1919 which requires the issuance of real estate brokerage licenses. Being a test case, there is possibility of its being taken to the supreme court eventually. Long, it is said, has been conducting real estate deals from time to time while putting most of his time on other lines of employment.

The state law, passed at the last session of the legislature, provides that all real estate brokers operating in Oregon must secure state licenses and the cost is \$25 a year. They must also deposit with the state insurance department a bond for \$1000 to insure clients harmless from their acts as brokers. It is said the outcome of the Long case will be watched with interest by realty men in all parts of Oregon.

CARRASCO GUILTY OF THREAT AGAINST WIFE, SAYS JURY

Andrew Carrasco, who was found guilty, after a jury trial, of threatening to kill his wife, was sentenced by Circuit Judge Morrow this morning to 90 days in the county jail. He has already spent several weeks in jail.

The family troubles appear to have arisen over property interests, which include real estate in Multnomah county and an unsettled estate in Spain. Efforts are being made to secure a division of the property there and leave his family in possession of the property here.

INJUNCTION AGAINST TAILORS WILL BE ARGUED LATER

A return on the temporary injunction issued by Presiding Judge Tawell, prohibiting Ray Barkhurst and Herbert Greenland, Portland tailors, from employing members of the tailors' union in their shops pending the full hearing of the suit brought against them by the Merchant Tailors' association, in which \$2500 is asked for alleged breach of contract, was scheduled for hearing before Judge Tawell this morning.

John W. Kaste and Chester Sheppard, attorneys for the contending sides, were engaged in other court cases and in open court Kaste stipulated that Barkhurst and Greenland may employ as many union tailors as they desire, pending the final hearing, without being considered having violated the court order. With this understanding the court postponed the hearing to a date to be later arranged.

REQUESTS MEETING OF JUDGES OF ELECTION

County Clerk Beveridge states he is especially anxious to have a full attendance of judges and clerks of election boards at the meetings arranged for next Monday and Tuesday evenings at 7:45 o'clock in the courtroom of Circuit Judge McCourt, second floor of the courthouse. At that time Beveridge will personally give instructions to the members of the election boards, so their work may be facilitated.

YEGGS MAKE HAUL OF \$25,000 FROM SCOTTSBURG SAFE

Roseburg, Oct. 22.—Trace of the safe blowers who robbed Hedden's store and postoffice at Scottsburg of \$25,000 in cash early Thursday morning was found Friday. The point where the robbers landed their boat was located and they are believed to be hiding in the canyons on the lower Umpqua river.

The robbery is believed to be the work of professional yeggs who had intimate knowledge of Hedden's store.

Roseburg, Oct. 22.—Robbers blew up the safe in the store of John Hedden at Scottsburg Thursday morning between 12 and 1 o'clock, and escaped with \$25,000, mostly in cash. The Scottsburg postoffice is located in the store. Stamps and other valuable articles were taken besides the cash.

The cracksmen were evidently professionals. They carefully piled clothing on the safe before setting off the explosive. Several residents of the town were awakened by the muffled boom, but none thought to investigate.

Scottsburg is the oldest town in the county and the most isolated. A great volume of business is conducted there, because it is at tidewater and the terminal of the county roads. A large part of this business is done through Hedden's store, and as there is no bank closer than Reedsport, Hedden often has large sums of money in his store safe. Sheriff Quine and two deputies were rushed by auto to the Lower Umpqua county, where Scottsburg is located, immediately after word of the robbery was received.

All the roads and mountain trails leading out of the county are being guarded. Most of the \$25,000 was in paper money, with a few hundred dollars in silver.
