

TRAFFIC PROBLEM BEING STUDIED BY 4 COMMISSIONERS

The special traffic committee appointed by Mayor Baker, composed of Commissioners Bigelow, Mann and Pier, is holding almost daily sessions for the consideration of plans for relief of congestion in the downtown district. At the session this forenoon the matter of interurban stage terminals was further discussed.

Representatives of the newly organized Oregon Automobile Cooperative association appeared and told of their prospects of speedily securing a location for terminal facilities, and it was proposed that all auto stages shall be required to have established terminals with proper facilities, it was stated.

The new association has filed its articles of incorporation at Salem, and it was reported today that it now has 96 of the interurban auto buses signed up in its membership. They include the lines to Newberg, Forest Grove, Salem, Camas, Vancouver and the various Sheppard stage lines, it was stated.

The officers of the new autobus cooperative association are: C. S. King, president; H. A. Bartlett, vice president; O. B. Cole, secretary-treasurer; W. M. Hays, business manager, and John A. Logan, attorney.

ROSE FESTIVAL DIRECTORS "FARM OUT" CONCESSIONS

The Rose Festival directors have sold the concession for the sale of ice cream, peanuts, popcorn, soda water, novelties, etc., to Edward Popick, 305 Oak street, for the three days of the festival. The festival management is to get a percentage of all receipts and in order to be protected it has had an ordinance passed by the city council prohibiting anyone from selling anything on the streets during the festival without wearing a badge provided by the festival directors. Violators of this ordinance are subject to a fine of \$100 and imprisonment for 30 days, according to its provisions. In past years "private concessionaires" have overrun the streets during fiestas, and the directors and the ordinance is said to be aimed at these "free lancers."

RESULT OF CIVIL SERVICE EXAMINATION ANNOUNCED

The city civil service commission has announced the results of examinations held April 19 and 26 for the positions of plan clerk and deputy building inspector in the city bureau of buildings. For the position of deputy building inspector there were seven applicants, one of whom, Carroll F. J. Kurtz, is an ex-soldier, and he heads the list with a rating of 96 per cent. The two next highest are Walter A. Trout, 83.40 per cent and Edward A. Dunlap, 81.80 per cent.

BIGELOW IS ACTING MAYOR DURING BAKER'S ABSENCE

City Commissioner C. A. Bigelow, in charge of the department of public affairs, is now acting mayor of Portland, during the absence of Mayor Baker on month's vacation, which will include participation in the Shriners' convalesce at Des Moines and a visit to his daughter, Mrs. Russell Dudley, in Kansas City. Acting Mayor Bigelow began his new official duties this morning and had a constant flow of visitors to his office.

public mind has been thinking of or will express at the voting booths tomorrow, is as yet unknown.

The soldiers' bonus amendment is the only proposition before the people for which any organized campaign has been waged. The American Legion has been active in support of this and the soldiers boys and their friends have been working, though not intensively, for its adoption.

Saturday afternoon the Portland Realty board held a special meeting and adopted resolutions endorsing the amendment and urging that the people give it favorable consideration at the polls.

POLLS OPEN AT 8

The polls were open at 8 o'clock in the morning and will close at 6 o'clock in the evening. County Clerk Beveridge reports that he has had a difficult time of it in filling up the lists of election officials, but has at last succeeded in signing up enough judges and clerks to do business, though time will tell whether they all show up at the appointed place and hour to begin their duties.

It has been supposed that the new law providing for a double shift of tallies to count the ballots would be put in operation at tomorrow's election, but this will not be done, Beveridge says, because the county commissioners concluded that they would not be justified in the additional expense.

WOULD COST MORE

It is estimated that it would have cost from \$4000 to \$5000 more to conduct the election under the new law than the old, owing to the fact that the additional officials would have to be fed, while additional voting equipment and accommodations would have been necessary.

So, faced with the expected light vote of a special election, the commissioners decided to proceed under the old law, use the customary day and night boards only and commence the count at the close of the polls at 8 o'clock.

217,099 VOTERS REGISTERED FOR TUESDAY'S ELECTION

Salem, June 6.—A total of 217,099 voters are registered for Tuesday's election, according to figures compiled by the secretary of state's office here this morning. The registration prior to the election of last November was 264,469, with 247,399 voting.

The slump of nearly 50,000 registered voters is regarded here as an indication of a lack of interest in the contests at the special election. Thousands of names have been cancelled from the registration lists within the past two months by county clerks because of failure of those registered to exercise their franchise privileges within the last two years.

Nomination of Leland L. Smith Sent to Senate

Washington, June 6.—(WASHINGTON BUREAU OF THE JOURNAL)—Leland L. Smith's nomination as consul of class 7 was sent to the senate today by the president. Smith, who is a resident of Portland, Or., was among those nominated at the last session of congress, but left unconfirmed on March 4.

Leland L. Smith is the son of Mr. and Mrs. Walter V. Smith of 704 Hoyt street. During the war he served overseas in the army for more than two years, much of which time he was United States military observer with the anti-Bolshevik forces in Roumania, Poland, Russia and Ukraine, with the rank of captain. Upon his return to the United States he passed examinations for the consular service in Washington.

It is customary for entrants into this branch of the government service to begin with one of the three grades of vice consul. Captain Smith's high record in these examinations won for him appointment as consul in which service there are seven grades. Confirmation of appointment will be followed by an assignment to service.

INHERITANCE TAX HELD DEDUCTIBLE

Washington, June 6.—(I. N. S.)—The United States supreme court today handed down a decision that inheritance and estate taxes may be allowed as deductions in the computation of net incomes.

Thousands of income tax cases are involved in this decision. The court's ruling will deprive the government of immense sums collected under protests from estates.

"The sole question for decision is, was the estate tax paid by the executors and claimed by them as a deduction, the income tax return for the year 1918, an allowable deduction in ascertaining the net taxable income of the estate for that year?" the court decision stated.

"The estate tax not only accrued, which means became due during the taxable year of 1918, but it was paid before the income of that year was returned or required to be returned. When the return was made the executors claimed a deduction by reason of that tax. We hold that under the terms of the act of 1918, the deductions should have been allowed."

200 Reed Students And Alumni Leave On River Exursion

City Hall Briefs

The purchasing agent of the city of Minneapolis sent to City Auditor Funk Saturday notification that the Minnesota

city has for sale 226 Dean voting machines. He says a law recently passed by the state legislature makes the further use of these voting machines in Minneapolis impracticable, but he believes that Portland or Multnomah county could make a profitable deal with Minneapolis for them.

The total cost of the Winona street and Dekum avenue sewer system is \$10,114.20. The assessment has been apportioned and is on file at the office of the city auditor. Time for filing objections expires today.

Eugene Printers' Wages and Hours To Be Arbitrated

Eugene, June 6.—The publishers and employing printers of Eugene and the members of the Eugene Typographical union have agreed to submit their dispute as to wages and hours, and their differences will be adjusted by arbitration.

On May 1 the printers presented a request for an increase in wages to \$42 for day work and \$45 for night work, weekly, and for a 44 hour week instead of a 48 hour week. The employers offered to continue the present scale of \$36 for day work and \$39 for night work and to grant the 44 hour week in job shops, but to retain the 48 hour week in newspaper plants. The printers rejected this offer Saturday. According to employers, the average wage here is about \$2000 yearly, including overtime.

Creswell Woman Dies While Sightseeing

Mrs. Louise M. Stone of Creswell died suddenly Sunday at the emergency hospital after being taken ill while sightseeing with her husband, John W. Stone, on Council Crest. Death was ascribed to heart disease. Guy G. Stone, a son, lives at 73 East Twelfth street.

U. S. DROPS LARGE ANTI-TRUST SUIT

Washington, June 6.—(U. P.)—The federal government in the supreme court today dropped its anti-trust suit against the American Can company.

The case was one of the government's big "trust-busting" suits.

In lower courts the government failed to obtain a decision against the company and today asked the court to dismiss its appeal.

The motion made by Solicitor General Frierson was immediately granted.

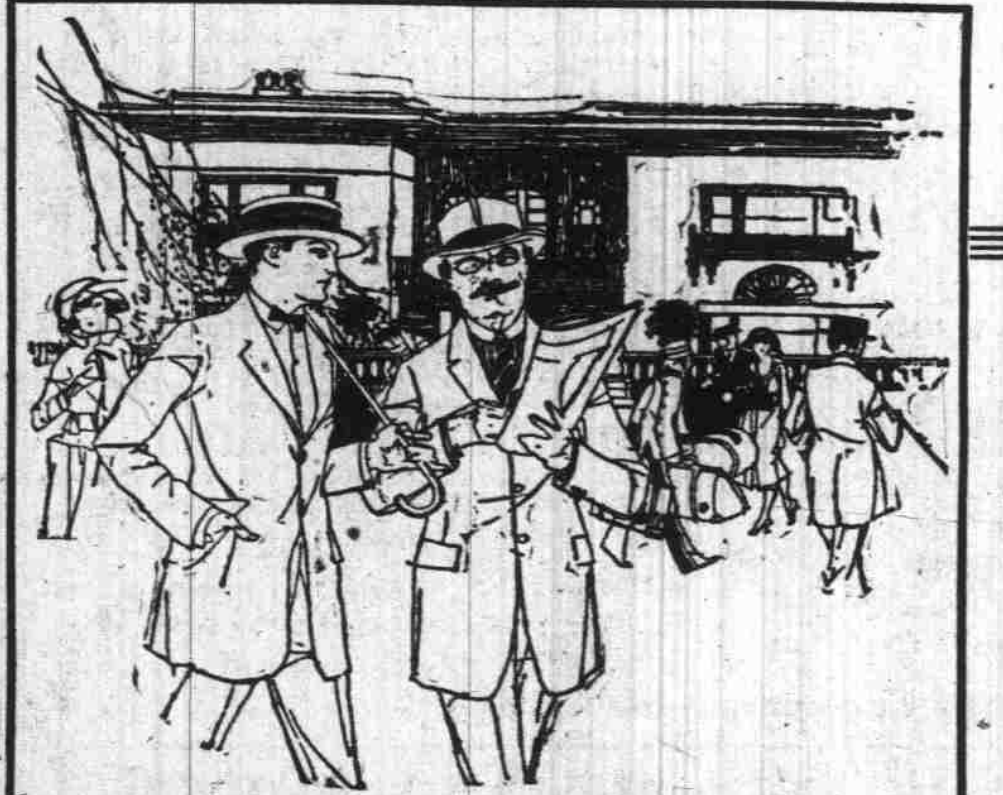
