

COUNTY OFFICIALS TO GET 8 CTS. PER MILE FOR CARS

County officials who use their own automobiles in doing the county's business, will get only 8 cents a mile for expenses hereafter instead of 10 cents they have been receiving.

The county commissioners passed a resolution to this effect at the meeting today. They expect to save about \$125 a month on the expense of the eight cars privately owned, now in the county's service. The cost to the county of these cars has been running between \$600 and \$700 a month.

The eight cents a mile takes care of depreciation, gasoline and interest on investment, according to figures presented. The commissioners were confronted by the bothersome fact that the cars owned by the county and used by county officials cost about 12 cents a mile. Why they should cost nearly twice as much to operate as the privately owned cars was something they couldn't decide on the spot of the moment, but decided to investigate. There are six such cars.

The only explanation I can see is that the officials who operate the county cars are careless with them," stated Holman. "There isn't any law by which we can force them to be careful, but we are going to set about trying to get some results."

Liquor Case Postponed

Failure on the part of D. A. Norton, attorney for George Webster, character actor at the Baker theatre last season, to comply with the rules of the federal court, resulted in postponement of argument for dismissal of his client. Norton neglected to file affidavits in the case until Saturday, whereas court rules require that all matters for consideration on Monday's action calendar must be filed by the previous Wednesday night. The case was put over one week.

Whiskey Makers Fined

For manufacturing whiskey in their homes during March, 1920, Warren Eccles and Frank Schermer of North Bend were fined \$100 each this morning by Federal Judge Bean, following a plea of guilty to the charge of violation of the law. The two had previously pleaded not guilty and were to have been tried next Monday. Each man was given 30 days in which to pay his fine. The court was advised that one defendant has eight children.

SELLWOOD SCHOOL HOLDS EXHIBITION

new things have been added to the regular manual training course, house wiring and plumbing being the two most important.

URGES SCIENTIFIC BASIS FOR WORK OF TRAVELERS' AID

"From my rather superficial knowledge of local conditions, I would say that the traveler's aid work has been carried on as well in Portland as in any other city adhering to the old and sentimental methods," declared Virgil V. Johnson, general secretary of the National Association of Travelers' Aid Societies, with headquarters in New York city, in addressing the conference of Oregon, at its opening session this morning at the Unitarian church.

"However, in view of your 1925 exposition it seems that the time has arrived to put the work on a scientific basis, to relieve the women of the entire responsibility and to make the work one of general responsibility and of the greatest scope."

ON SCIENTIFIC BASIS
New York has had travelers' aid work since 1885, but only about one runaway girl a month was picked up until the organization was placed on a scientific basis, with trained case workers in charge who could and did give the necessary follow-up work.

"During the past year 1920 girls were picked up by the department, including a number of cases that had been recurring for a term of years, these being finally worked out and permanently disposed of. Most of the runaway girls lie about themselves, nine tenths of them have a sex problem involved and it is in such cases as these that the trained case worker only can get at the bottom of things and offer the real remedy."

"I was told by a member of the Travelers' Aid board of San Francisco that that city did not lose a single runaway girl during the exposition, and this fact should be food for thought for Portland, in view of its coming exposition."

WELCOMED BY MYERS

Johnson told a number of striking incidents of the value of having trained people of the highest paid type in Travelers' aid work and of the necessity of making the work cooperative with all other social agencies and institutions. The conference opened with a brief address of welcome from the president, Dr. Samuel C. Kohn, who outlined the aims and purposes of the association and bespoke the attendance of all social workers during its three days' session. In the absence of Mayor Baker, Stanley Myers, deputy city attorney, gave a brief address of welcome to the social workers on behalf of the city. Brief remarks

covering some of the phases of their work were given by Mrs. Frances Saul of The Dalles, secretary of the home service section of the American Red Cross, and Miss Miriam Wood of Astoria, secretary of the home service section of the American Red Cross.

OTHERS TO SPEAK

The social platform of the churches is the topic for discussion this afternoon, the speakers being Rabbi Jonah B. Wise, Rev. George Thompson and Dr. W. T. McElveen. This evening social and industrial adjustments will be discussed by representatives of the Chamber of Commerce, who will outline the program of the national association, and by C. N. Ryerson, editor of the Oregon Labor Press, who will speak on "The Social Creed of the American Federation of Labor."

Rural social problems will be discussed Tuesday morning, the speakers including Ray E. Carter of Seattle, representing Community Service; R. W. Kirk, superintendent of schools of Oregon City; John H. Rudd, county secretary Y. M. C. of Oregon and Idaho; Rev. E. V. O'Hara of Eugene, who will speak on "The Church and Rural Life."

TO GIVE BOUQUET

An outstanding feature of the afternoon session, when small town social problems will be discussed, will be an address by Miss Florence Ward of the United States department of agriculture, who recently completed a survey of the foreign born women in this country, in which she covered the home life of 10,000 of these women.

Other speakers will be H. C. Seymour, director of the club work of the Oregon Agricultural college; Rev. William H. Boddy, pastor of the Community church of Hood River; Miss Elizabeth Hoppe of the Oregon Tuberculosis association, and Mrs. Clarence E. Shotwell, county probation officer from Bend. In the evening at 8 o'clock the annual banquet and election of officers will be held at the Hotel Benson.

Charge Is Dismissed

MELLON BECOMING FAMOUS FOR OWN BRAND OF CIGARS

Washington, June 20.—Andrew W. Mellon, millionaire banker member of President Harding's cabinet, seems on the verge of acquiring a picturesque fame quite apart from his official duties as secretary of the treasury.

Mellon, like Uncle Joe Cannon, smokes innumerable cigars. And like Uncle Joe, Mellon is coming to be known by his cigars. Official Washington is wondering about them.

Mellon effects a very short thin example of the weed, barely bigger than a cigarette. A story is gaining favor that the secretary's cigarette-cigars are especially imported. Mellon's desk tray is generally littered with stubs. He smokes them nervously and quickly, handling them delicately in slender fingers.

ENERGY ASTONISHING

Mellon's smoking habit is taken by his friends as an index of character. Small of stature, with delicate features, the secretary, nevertheless, seems abundant of nervous energy. His capacity for work astonishes 10 a. m. Washington.

Mellon was one of the first of President Harding's cabinet to begin the long workday, after the president himself. The secretary often arrives at his palatial office suite in the treasury department at 8:30 a. m. Washington ordinarily gets down to work at 9:30 a. m., as far as the heads of bureaus and higher officials are concerned. Or, at least, Mellon often is on the job after 6 p. m. Few job seekers are able to get to the treasury department office before Mellon arrives.

MOVES ABOUT SWIFTLY

The secretary's long day begins when he slips into the private elevator in the basement of the treasury and is whisked up to a private corridor leading to his private suite of offices. An attendant relieves him of his hat and coat, the secretary moves swiftly about the big room adjusting the curtain shades and heavy portieres like a palatial housewife and then slides into the big chair for work. Thus enthroned, the secretary of the treasury, by contrast, seems a small man.

A list of appointments, the length of an arm, usually confronts the secretary when he opens his business day. A touch of an electric button on his desk and the first visitor, visitor or stenographer, is ushered into the big office. Three minutes later the visitor's chair beside the desk is vacant and a new visitor is being ushered in.

Secretary Mellon impresses visitors as a mild mannered man who could get real mad when he wanted to do it for a purpose. His eyes have a look of hardness at times. But for the most part they show unusual calm. Few persons in Washington can tell of seeing the secretary with "a mad on." But that may be because no one wants to risk it. The secretary is much sought after

by social Washington. Invitations to dinners, parties and entertainments flood to his desk. Whether he accepts many is a mystery. His name seldom appears in the society sections of the newspapers.

Mellon is regarded as the most dignified and staid member of the cabinet. He affects a close cropped white mustache which is not quite as grey as his hair. He favors dark colored clothing of a conservative cut, but which, at the same time, is the envy of some of the capital's "advanced dressers."

Mellon also has the reputation of appreciating a joke. Friends say he tells anecdotes of the variety intended to cause a quiet smile rather than a hearty laugh.

BANKER AND FILM ACTRESS SPEAKERS

Experts of finance and of the motion picture world attracted 600 business men to the members' forum luncheon of the Chamber of Commerce at noon today.

W. F. H. Koelsch, past president of the National Credit Men's association and president of the New Netherlands National bank of New York, was one speaker, and Clara Kimball Young, motion picture actress, was the other. "The entire banking system of the world is now confronting one common problem, that of credit," said Koelsch, who asked the business men to voice their recognition of the federal reserve system for the work it did in maintaining credit during the crisis of war and demand that the system be kept clean of politics and be allowed to continue with its work in bringing the nation back to a better business basis.

Koelsch said that much of the return to normalcy is dependent upon the development of foreign trade, and pointed out the great part that Portland can play in reestablishing business through its export trade channels. Clara Kimball Young made a plea for a more liberal censorship of motion pictures. She said that "all the producers want is fairness from the public, which should be the judge of the pictures." She contended that if a picture was not good, the public would soon discover the fact, and that "word of mouth" advertising would soon put such unpopular pictures out of the market. She likewise made a plea for the imposition of a duty on foreign-made films, which, she said, are now flooding the American market and threatening the motion picture industry in this country.

Rail Men Expected

D. W. Pantius, general manager of the San Diego & Arizona railway, was scheduled to arrive in Portland today to familiarize himself with this territory. The San Diego & Arizona road was recently completed through Southern California and Northern Mexico and is one of the engineering marvels of the Southwest. The road was completed through the joint efforts of the Southern Pacific and Spreckles interests.

Swimming Hole Takes Toll

St. Paul, Minn., June 19.—(U. P.)—Three boys were drowned in the Mississippi river here today while swimming. The victims were Albert Mann, 9; Albert Sutton, 10, and his cousin, John Flynn, 9. Their bodies were recovered half an hour after the tragedy.

POLICEMAN'S GUN KILLS WRONG MAN

San Francisco, June 20.—(I. N. S.)

An investigation was under way today of the killing at midnight last night of Albert O. Braun, prominent Los Angeles business man, who was fatally shot by Martin T. Fehey, one of two policemen lying in wait at Keena's garage, 3580 McCallister street, for auto thieves.

Following a preliminary investigation, Captain of Detectives Duncan Matheson ordered Patrolmen Fehey and Smith arrested and booked on charges of manslaughter. He declared the investigation would be thorough.

Braun, in company with his brother and sister-in-law, Mr. and Mrs. George

B. Braun, Mrs. Max Foehr and Max Foehr, their step-father, had been on an auto tour of the city and returned to the garage about midnight. The Los Angeles visitor got out to open the door and as he did a command rang out from the darkened garage, "Hands up."

Braun responded with an order, "Drop those guns!" Two shots rang out and Braun dropped dead behind the car which had, by that time, entered the door of the garage. One of the bullets passed through his head, causing instant death. The remainder of the party quickly alighted from the machine and lined up against the wall, believing they were being held up.

George B. Braun, 31 Parsons street, brother and host of the dead man, declares that the officer, who was in plain clothes, fired after the single warning and without informing the party that he and his fellow officer, Alexander Smith, also a plain clothes man, were policemen.

The officers assert that Fehey shot while Braun did not throw up his hands and made a motion which they claim looked like a motion to draw a gun. Braun, however, was unarmed.
