

HOSPITALS RAISE STANDARDS, SAYS DR. W. MUSGRAVE

Standards in the hospitals of America are being rapidly improved, Dr. W. E. Musgrave of San Francisco, declared today at the opening session of the Tri-state Medical association, which is being held at the Multnomah hotel this week.

Dr. Musgrave took for his subject hospital betterment on the Pacific coast. He told of a survey conducted among the hospitals of the United States and Canada in 1916 by the College of Surgeons, and explained that faults found were being remedied. He said the practicing physicians worked as individuals rather than units, that dishonest and unscrupulous physicians were found, records of cases were not being kept and that in many hospitals proper laboratory facilities were missing.

STANDARDS ARE RAISED
Of 697 hospitals in the United States and Canada, the speaker said that only 79 met the standards of the College of Surgeons in 1916, while in 1920 a total of 406 of the 697 had adopted the standards fixed.

Dr. Frederick Green of Chicago, representing the American Medical association, pointed to the duty of the medical profession in making the public acquainted with medical matters. He said the public should be informed of work being carried forward by the physicians.

Judge Harold M. Stephens of Salt Lake urged that all hospitals be brought up to the high standard required by the American College of Surgeons. He said all should have the minimum amount of equipment necessary for physicians to properly carry on their work.

The tri-state medical meeting is being held in conjunction with the annual meeting of the Oregon State Medical association. The meeting will continue over Friday and Saturday. More than 250 physicians from Washington, Oregon and Idaho were in attendance at the opening session this morning.

DOCTORS ARE GUESTS
At the noon hour the doctors were guests of the League for the Conservation of Public Health at the Multnomah hotel when Celestine J. Sullivan of San Francisco spoke on the work being carried forward by the organization.

Speakers this afternoon will include Dr. William F. Braasch of Rochester, Minn., Dr. Robert E. Farr of Minneapolis, Dr. Alan Brown of the University of Toronto, Dr. R. E. Coleman of Vancouver, B. C., and Dr. Frederick Eppin of Spokane. All will deliver papers on technical subjects.

Tonight the physicians will attend a reception to visiting speakers at the home of Dr. and Mrs. Joseph A. Pettit. A large number of women here for the meeting will be taken to the packing plant of Swift & Co. on a tour of inspection.

Uncle Sam Will File Suit Against Cement Trust in New York

Washington, June 30.—(I. N. S.)—Another step in the government's action against "business combinations" was taken today when Attorney General Daugherty announced that he had instructed the district attorney in New York to immediately bring suit against the anti-trust statutes against the Cement Manufacturers' association, its officers and members.

The members of the association produce 20,000,000 barrels of cement a year, constituting 30 per cent of the total national production.

Minister Feels It His Duty to Attend Saturday's Battle

New York, June 30.—Rev. Dr. John Roach Straton, pastor of Calvary Baptist church, one of the largest congregations in New York city, has been engaged to "cover" the Dempsey-Carpenter fight for Universal Service. He will write of the fight as a "Return to Paganism." Dr. Straton said today: "I think it is my duty to go to the fight, feel that somebody ought to tell the truth and so I'll attend. It will aid me in my battle against a repetition of it."

C. D. Lyle Dead at Clarkston
Clarkston, Wash., June 30.—C. D. Lyle, aged 77, died at his home here Sunday night.

GILMAN DENIES HE KNOWS OF MERGER

Knowledge of any plan of the Great Northern to absorb the Spokane, Portland & Seattle rail interests in Oregon and Washington were denied this morning by L. C. Gilman, vice president in charge of Western operations of the Great Northern.

"It is highly improbable that the Great Northern is going to have the capital to advance for the buying out of the Northern Pacific Railway company's half of the stock, and still more highly improbable that the Northern Pacific would sell its interest in the S. P. & S," said Gilman.

MERGER IS REPORTED
A report gained circulation this morning crediting George B. Martin, operating vice president of the Great Northern at St. Paul, with the confirmation of previous reports that the S. P. & S. and Great Northern would merge.

"This report of a merger has been in circulation for 10 years," said Gilman. "but thus far I have not seen an official order that would confirm the belief that the S. P. & S. would lose its identity in the larger line."

Officials of the S. P. & S. have not received advice either confirming or denying the report, supposed to have originated in St. Paul. Some are inclined to believe that the confirmation is authentic, since some changes in personnel continued for July 1 have been postponed without reason being given.

BIG SUM NEEDED
It is said that it would cost the Great Northern \$3,500,000 to purchase the Northern Pacific interest in the joint line. Sale of this line with its allied interests would cause the Northern Pacific to lose its entry into the Willamette valley and Central Oregon.

Should Martin's reported confirmation be authentic, local officials say that extensive legal steps would be necessary before the deal could be consummated and that a merger could not be possible before the passage of many months.

Rates in the bill include cattle less than 2 years old, 1 cent per pound; over 2 years, 1 1/2 cents; and fresh beef and veal, 2 cents; sheep and goats, 1 cent; fresh mutton, 1 1/2 cents; fresh lamb, 2 cents; swine 1/2 cent per pound; fresh pork, 1/2 of 1 cent; bacon, hams and shoulders, 1 1/2 cents; hides, free; milk, 1 cent per gallon; cream, having less than 30 per cent butterfat, 5 cents; over 30 per cent, 10 cents; oleomargarine, 8 cents per pound; cheese, valued at less than 30 cents per pound, 5 cents per pound; over 30 cents, 25 per centum ad valorem; live poultry, 5 cents per pound; dead, 4 cents; prepared or preserved, 25 per centum ad valorem; eggs, 6 cents per dozen; frozen eggs, whole 20¢ or albumen, 4 cents per pound; dried, whole yolk or albumen, 15 cents; horses and mules, valued less than \$150 each, 50 per cent; valued at more than \$150, 20 per centum ad valorem; honey, 2 1/2 cents per pound; fish, fresh, frozen or packed in ice, 1 cent per pound; salmon, pickled, salted, smoked, kippered or otherwise prepared or preserved, 25 per centum ad valorem; packed in oil or other substance, 25 per cent ad valorem;

The normal expiration of enlistments probably will approximate one-half the service in any manner, 30 per cent ad valorem; and every effort will be made to meet the requirements of the congress at the earliest possible day.

OBLIGATION INVOLVED
"I would not feel justified in asking the secretary of war to enforce the dismissal of men who have enlisted for a definite term of service. There seems to be a moral obligation involved, the violation of which would be demoralizing to the spirit of the army itself, and might prove a very serious discouragement when enlistments are desired in the future."

"I have thought I ought to say these things to the congress now, because in its earnest desire to reduce the army personnel and limit army expenditures the congress has especially provided that no deficit shall be created."

WILL AVOID DEFICIT
"The secretary of war will seek to avoid the creation of any deficit, but if a probable deficit develops in a just procedure to reduce our enlisted forces I will report to the congress at the earliest possible day and ask it to relieve the embarrassment of the secretary of war and make such provision as will be necessary to deal justly with our enlisted men while attempting to keep faith with the congress to the fullest possible degree."

Deputy Coroner Falk, who decided today that no inquest would be necessary, learned on investigation that Howatt

had driven to a filling station and that Miss Bruce had stepped from the car to allow the tank to be filled. When the car was started again, she did not resume her seat but mounted the running board for the few blocks between the station and Howatt's home, whither the party was bound.

The clutch failed to catch as Howatt was starting, however, and the car "bucked," causing the young woman to lose her hold. Her head struck the pavement.

jewelry department at the Meier & Frank store. She made her home with her sister.

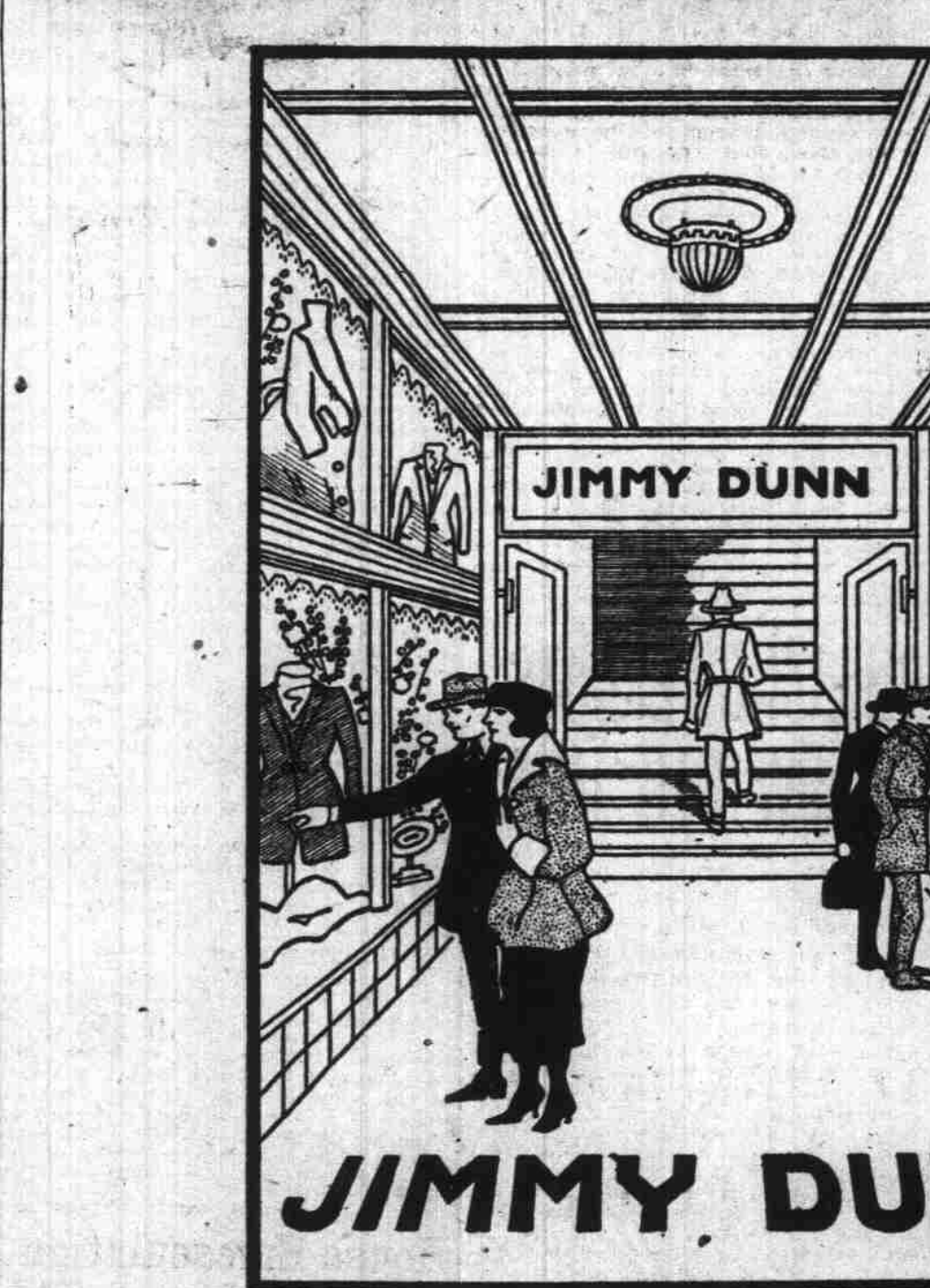
