

G. L. GOODSELL IS ELECTED HEAD OF OREGON LEGION

Eugene, July 2.—G. Lane Goodsell of Portland was unanimously elected commander of the Oregon State Department, American Legion, for the coming year, early this afternoon. George A. Goodsell of Medford was named vice commander, Prescott W. Cookingham of Portland state treasurer, and Edward J. Elvers of Portland was reelected state adjutant after a close race.

Committee reports took up the greater portion of the morning session of the closing day of the third annual convention, the work of the resolution, Oriental and Americanization committees securing the most attention.

RESOLUTIONS INTRODUCED
Phil Hammond, Oregon City, of the resolutions committee introduced resolutions demanding the immediate removal of Henry Albers; requesting the secretary of the interior, senators and representatives from Oregon to Washington, D. C., and Governor Olson to use their influence in seeing to it that the Klamath public lands are open to entry for ex-servicemen of the state; to unilaterally oppose the commercial acceptance of all German and Austrian motion picture films by motion picture corporations of the United States; to express the appreciation of the state department of the American Legion to the people of Oregon for their patriotic support of the World War veteran state aid act at the recent election.

APPROVE APPOINTMENTS
Other resolutions express the approval of the appointments and confidence in the entire personnel of the commission appointed to administer the Oregon World War veteran state aid act, and assure the members of the commission of the hearty support of the organization; favor the appointment of the Federal Reserve Bank of Portland to the position of appraiser and attorneys for the commission in the various counties where this is possible without jeopardizing public safety; approve and confirm the action of Portland post No. 1, in promptly and effectively investigating and combating the unpatriotic propaganda of the Pacific Northwest German Speaking Roman Catholic societies; change the dates of holding the annual state conventions of the American Legion so that the convention will not be held on the first or last three days of any month.

AGAINST ORIENTALS
Jerry Owen, Portland, of the Americanization committee, made motions that the state department be petitioned to move to prohibit the publication of all foreign language newspapers in the United States; that only citizens of the United States be employed in all public works; that any child born of parents who cannot be assimilated should not be permitted citizenship. All the motions and resolutions were unanimously adopted.

Barge E. Leonard of the Oriental committee made a motion demanding that congress be petitioned to expedite the disposal of the menace to our posterity and our form of government because of the fact that xenophilia in this country are increasing rapidly.

MAKES REPORT
Governor Ben W. Olcott, chairman of the Oregon World War veterans' state aid commission, made a report to the convention in which he said that everything was being done to expedite matters in connection with the aid matters and he requested ex-servicemen and women be patient. He cautioned that at no time should they be allowed to place any claim in the hands of any unauthorized representatives of the commission and not to pay out any money for the furtherance of the claims for no one will be able to secure payment of the claim than the claimant himself.

Raritan, N. J., July 2.—(I. N. S.) President Harding, who came to Raritan to spend the Fourth of July at the home of Senator Frelinghuysen, today awaited the arrival of a special messenger from Washington bearing the Knox-Porter resolution establishing peace between this country and Germany.

It is expected that the president would allow no delay, but would sign the resolution immediately, so that a proclamation of peace could be issued on the Fourth of July.

The president and Mrs. Harding arrived from Washington shortly after 1 o'clock last night. President Harding was so anxious to get upon the golf links that he was driven directly to the Raritan Golf Club, where he played 14 holes with Speaker Gillet, Senator Hale of Maine and Senator Kellogg of Minnesota. The women members of the party in the meantime motored to Senator Frelinghuysen's home.

Mr. Harding planned to get an early start upon the links this morning. The president and Mrs. Harding expect to return to Washington Tuesday.

NEW RATE VICTORY WON BY PORTLAND

Portland scored another rate victory when it was announced this morning by F. H. Fogarty, assistant general freight agent of the Northern Pacific railroad, that rail-and-water rates now effective for grain shipments to California via Puget Sound would apply to Portland also after August 2.

Heretofore grain from the Middle West has been shipped to Seattle for transshipment to California on ships of the Admiral line. Portland was not included in the joint tariff. Action was taken by the Port of Portland and as a result an amendment was made including this port.

"After the first of August grain from the Dakotas, Montana and Minnesota may be shipped through this port on an equal basis with Seattle and Tacoma. The rates are effective on the same steamship line, the Admiral line. It is believed that the new tariff will materially increase the shipments through Portland and will also lead to heavier milling here."

Officials of the railroad explained the old tariff on the grounds that heretofore there has been insufficient coastwise traffic from Portland to justify a joint rail and water rate. The appearance of the Admiral line in the field changed that argument and to meet it the new amendment was made.

B. BRANCH, PIONEER POLICEMAN, DEAD

Ben Branch, oldest Portland policeman, died shortly after 8 o'clock this morning at his home, 295 Lincoln street, after a losing fight of several weeks against death. He was 78 years old.

The pioneer policeman walked a Portland beat for 42 years and is widely known throughout the city. He retired on pension December 31, 1915.

In the early days Mr. Branch patrolled the Front street district. Many stories are told of him in the police department where he was known and beloved by all who have been on the force for any period of time.

Death resulted from weakness brought on by old age. It was reported almost two weeks ago that the aged policeman was dying, but he rallied at the time and vigorously fought a great battle against death. His advanced age, however, was again his enemy and he continued to weaken slowly until the end came this morning.

Candidly, I think Georges Carpentier has an awful gall to even think he has a chance against Dempsey. Carpentier is a nice looking fellow. He's a good fighter in his class, but whoever told him that he could lick Dempsey must have been leaning up against the bamboo.

Bernard Shaw says that the French challenger should be the favorite in the betting. He saw Carpentier beat a couple of second raters in London. According to Shaw, the Frenchman is perfect. Of course you must remember that the pink whiskered scribe has not seen many fighters. There haven't been many fighters over on the other side to look at.

BEST ONE HE KNOWS
Up to the present time Carpentier is the best fighter he has ever seen, and, of course, he looks like the works to him. I used to think my dad was the best boxer in the world when he boxed with me as a kid. I had seen pictures of Chaymal, McLaughlin, and Jim Corbett, but the only man I had seen box was my old man. He sure did look like the cake to me.

When I saw George Lavigne, Peter Jackson and Corbett a few years later my old man ran one, two, twenty-eight. He was an awful joke to me then. Dempsey is a real fighter. He has a perfect hand and a good body. He should have. He is young. He is in excellent shape, he can take a sock on the chin, and come back. He can hit with either hand and he's a good boxer. Dempsey has the ideal build, too. He is a bit over six feet tall and in ring costume tips the scales at about 190 pounds.

DEMPEY ALWAYS "THERE"
What better bet could a fellow ask for than that?

Dempsey has been tried out and never yet has been found wanting. Dempsey met every heavyweight he was boxed and beat them decisively. Before Dempsey met these men they were supposed to be great. We considered them tough customers. After Mr. Jack planted them in a horizontal position they suddenly became second raters, that is, certain Dempsey knockers said they never amounted to anything anyway. But they did.

They were tough until Dempsey got them. They were as tough as they could be. They never had a man beat them in regard to lefts and rights. They never dreamed of such a thing. Morris, Fulton and Wally crumpled before his attack. It wasn't that he was a superior boxer. It was his indifference to their punches that killed them. He tore in where angles feared to tread.

AWFUL SHOCK COMING
Carpentier has never seen a fighter of this type. Jeanette boxed him but Joe was never aggressive. Wells boxed him but never met him. Dempsey boxed him and he was a kind-faced coddle. Levinson faced him like a bloke getting his first start at the electric chair.

Does Carpentier expect Dempsey to step out there with a silly grin on his mug and wait for developments? I really think he does. I really think Descamps does, too.

Boys, it's going to be an awful shock. We have a heavyweight title holder today who is more aggressive and powerful than John L. Sullivan. A swell fellow out of the ring, kind and courteous. In the ring, a snarling bulldog.

Final Rounds In Previous Big Fights

Jack Johnson vs. Jim Jeffries, Reno, July 4, 1910—15th round:
Jeffries in distress. Johnson dashed at him like a tiger with a rain of rights and lefts. Jeffries went down for the first time in his ring career. . . . fell under the top rope, over the lower one and onto the overhang of the platform. He was up at the count of nine, helpless. A short left to Jeffries' chin and he went down again. As the referee counted seven one of his seconds put his foot into the ring and Referee Rickard proclaimed the black man champion.

Joe Willard vs. Jack Johnson, Havana, April 5, 1915—28th round:
Willard met Johnson as the latter was coming from his corner and sent a long left to the negro's face, making his head bob. Willard smashed a right to the stomach. Johnson clinched. Referee Welch broke them. Willard rushed Johnson into a corner. Willard feinted. Johnson dropped his guard and Willard swung to the point of the jaw. The negro's knees folded up, and as he sank slowly to the floor Welch began to count the negro champion out.

Jack Dempsey vs. Jess Willard, July 4, 1919—12th round:
Willard staggered to the center of the ring apparently dazed. Dempsey smashed at the champion with right and left. Willard scarcely making any effort to return. As the bell rang he reeled back under a straight right to the jaw. He never came back for the fourth.

WEST LINN WILL VOTE ON BONDS
Oregon City, July 2.—A bond issue for \$25,000 for the erection of a gymnasium for Union High School District No. 2 will be voted on Tuesday by the taxpayers of West Linn. The unexpected growth of the student body has made an additional building necessary, according to the school board.

When the new high school building was constructed it was arranged to accommodate 75 pupils, which was considered a safe margin, since the enrollment has never been more than 50. However, during the past year 113 students were enrolled in the high school and it is expected that at least 175 will register in the fall. The auditorium of the building has been used as a gymnasium, but due to the increase in pupils it will be necessary to turn it into a classroom.

Under state laws a certain amount of gymnasium work is required in every school, and space is needed for the work. The gymnasium plans call for a building with a 50x60 swimming pool, dressing rooms and the gymnasium room proper. The school already has equipment to supply the building.

School Clerks Must Have Books in for Audit by Tuesday
Oregon City, July 2.—Under a decision handed down by Attorney General Van Winkle, it will be necessary for all clerks of county school districts to turn in their books to the county boundary board for auditing. The legislature provided at the last session that the books of every district should be audited, but the measure failed to state how the work should be financed. Since the districts did not see their way clear to provide the money for the audit, the order to turn the books in was withdrawn June 22.

The attorney general has decided that the law makes it necessary for the districts to stand the expense. Brenton Vedder, county superintendent, has asked that all books be in the hands of the boundary board, of which he is a member, by Tuesday. The board has engaged the services of C. A. Chambers for the audit. The cost will be divided between the 142 districts according to the time required for each individual unit.
