

DOUTY WILL BUILD NEW SAWMILLS ON YAQUINA RAILROAD

Newport, Or., Sept. 13.—"In a country which is unsurpassed for dairy possibilities you have not a cheese factory or a dairy; in a land where berries grow wild in profusion you have scarcely thought of the fruit canning industry; in a place where salmon crowd the bay and deep sea fish might be caught by the ton you have done nothing to establish a hatchery or the fishing industry."

"Residents of Yaquina bay, you have lost your pep."

OPERATE IN SIX MONTHS

The Yaquina Northern logging road, built during the war by the Warren Spruce company and purchased recently by the Multnomah Box & Lumber company, will be put in operation within six months, according to Douty, who said that from 200 to 300 men will be employed along the line. He said that it would require from \$500,000 to \$600,000 to put the Yaquina Northern road in operation, including a small mill. In addition, the company has expended \$400,000 on the Rainier mill and probably \$300,000 more will be necessary to place it in operation, so that it would take from three to six months to dispose of preferred stock, which would pay 10 per cent interest and which he expected to retire in from five to seven years.

SELLS HALF INTEREST

Douty said that he had had an opportunity to dispose of half his interest in the company for cash to a St. Paul corporation but had decided not to release his hold on the common stock. The company has been authorized to issue \$1,000,000 stock, pay value and contemplate issuing an additional \$500,000 worth as soon as he has purchased timber, which is now being cruised and on which it holds title.

He said that the timber along the Columbia river, especially spruce, was being exhausted rapidly and a new field was necessary for his company and that he would now be operating two shifts in the Portland mill if spruce logs were available. His plan is to erect a number of small mills along the newly purchased line, which would be an almost inexhaustible supply of spruce, and ship the logs to the assembling yard at Portland.

MAKING END DISCUSSED

Deploping the transportation facilities at Yaquina bay, Douty stated that the Southern Pacific railway company had no competition and had earned a reputation for furnishing only from 30 to 60 per cent of the cars required when business was good. He said that he did not think there was sufficient water on Yaquina bay for large vessels. The California lumber market, accessible to small coastwise schooners, was too uncertain to be called good, he said, and sending vessels carrying less than 2,000,000 feet on long voyages to the Orient or the Eastern coast of the United States does not pay.

One large company, having 102 steamers, wished to place 30 of them on this coast, he said, and another, having a number of converted barges, which held 2,250,000 feet of lumber and were towed by big boats, required 20 to 30 feet of water on a bar at low tide to navigate it.

That he had no intention of running passenger trains over his line into Newport, three and a half miles west of Yaquina station, was another statement by Douty.

S. P. COMPANY REFUSES

He said that the Southern Pacific company had been approached, and after several months, had replied that it would not undertake to operate passenger trains into Newport because it had terminal facilities, representing a large outlay of money, already established at Yaquina, the terminus of its line, and that running trains into Newport would not increase its revenue any. However, the company offered to allow the Multnomah Box & Lumber company to run its passenger coaches and express cars over its line to Newport. If the latter company would furnish a locomotive, train crew, pay 5 cents a mile for passenger cars and 3 cents for express cars and put up an indemnity bond.

The government is now building the north jetty of Yaquina bay, having finished the south jetty, except for a spur which was added to the original plan. The entire project will cost about \$1,800,000 and the residents expect to have close to 30 feet of water on the bar at low tide. They have made the government appropriations dollar for dollar, showing their faith in the community and hope to see a large manufacturing lumber plant erected on Yaquina bay.

Corporation Tax Is Increased by Senate Committee

Washington, Sept. 13.—(I. N. S.)—The senate finance committee in executive session today accepted two of the recommendations of Secretary of the Treasury Mellon for the revision of the internal revenue laws.

They are: Repeal of the capital stock tax as of July 1, 1922, increasing the corporation tax to 15 per cent.

The house fixed the corporation tax at 12 1/2 per cent. It is at present 10 per cent.

The finance committee also accepted the house provision for the expiration of the excess profits tax on January 1, 1922.

Secretary Mellon had recommended that the expiration be made retroactive to June 1, 1921.

PRUNES AND DRYER BURN, LOSS \$6000

Vancouver, Wash., Sept. 13.—Fire due to an overheated furnace destroyed the prune dryer of Neils Futtrup at Felida, seven miles north of Vancouver, at 5:30 o'clock this morning. The loss included 700 boxes of dried and fresh prunes and is estimated at \$6000, with \$3500 insurance.

EVANS CHARGED WITH FIRST DEGREE CRIME

fied Evans as the slayer of Doran. Evans had driven Doran and himself from Bend to The Dalles Saturday night, Ducharme declared.

MONEY FOUND HIDDEN

On Saturday night, Ducharme said, Evans took the two in his machine to a lonely spot on the road southwest of the city, where, in the early morning, began shooting, dropping Doran at the first shot and afterward riddling the body with bullets. Evans was brought back from Madras by Sheriff Levi Christman and deputies Monday evening. The sheriff at Madras reported that no money was found on Evans when he was arrested, but Sheriff Christman, examining the prisoner's clothing more carefully, found \$135 hidden in the lining of his trousers. This amount corresponds with the sum which Doran was said to have been carrying Saturday.

When Doran's body was found, he clothing had been rifled. In the pockets Evans was found and his watch lay a short distance away. Evans maintained a stoical silence. He was visible unnerved when the officers took him before the body of Doran today but continued only to mumble denials of the deed.

EVANS SAYS NOTHING

On the way to the Dalles Monday, told the officers that he would give his story the witness stand and he has refused to make any statements of any kind. E. O. Stadter, Bend attorney, arrived in The Dalles today to represent Evans in the case. Evans is also expected in the city within a few hours.

Evans was a property owner of Bend. He had been employed at the Brooks-Scanlon mill, where there last on September 7, when he got in six hours' time. District Attorney Galloway is firm in the belief of Evans' guilt, maintaining that no circumstance exists which casts a doubt in the prisoner's favor, and he expects to go to trial on the first degree murder charge. The murder of Doran has aroused the greatest excitement here but so far there have been no demonstrations against Evans.

HELD ON LIQUOR CHARGE

Vancouver, Wash., Sept. 13.—Deputy Sheriff Frank Cornelius and Federal Prohibition Officer Bunker of Tacoma arrested Cecil Howe at the end of the Woodland bridge Monday riding in an automobile owned to have been stolen from N. P. Johnson of Kalama. The driver of the car made his escape although Deputy Cornelius fired two shots at him. A quart of moonshine was found in the car. Howe was turned over to Sheriff Hoggatt of Cowlitz county. The car was returned to Johnson.

MRS. W. S. STRANGE DIES

Kalama, Wash., Sept. 13.—Mrs. William S. Strange died Saturday and the funeral was held from the Congregational church of Kalama, Sunday. She was born in 1856 and was raised in Kalama. Her husband, a young son and her mother, Mrs. Tompson of Kalama, survive.

LEGION TO FLOAT BONDS TO PAY FOR CLUB FURNISHINGS

Members of Portland Post No. 1, American Legion, in session in their parlors at Sixth and Pine streets Monday night, decided by almost unanimous vote to float bonds of \$5, \$10 and \$20 denominations and totaling \$10,000, to liquidate the indebtedness of furnishings of the clubrooms and to carry on the work of the legion.

Commander T. H. Body appointed a bond committee, of which E. C. Mears is chairman, to function immediately. The committee is made up of E. C. Mears, chairman; Frank M. Moore, Walter B. Gleason, Joseph Hammond, Eugene O'penheimer, Nathan Moszkowsky, Rex Parrellus and Earl R. Goodwin. It was decided at the meeting to retire one-fifth the amount of the bonds each year for the next five years and the rate of interest will be 4 per cent.

FUNDS FROM MEMBERS

It also was pointed out that in order to maintain the clubrooms it would be necessary to obtain funds from the members because it had become the policy of the post to not to attempt to seek any more financial aid from the businessmen of Portland. The clubrooms will be kept open all winter for a rest room for the ex-service men and a place to meet their friends when the rainy season sets in. A memorial in honor of William F. Berry, who killed himself last month, will be drafted and hung in the clubrooms. His untiring efforts in behalf of former service men were known to all who came in contact with him and his loss will be keenly felt. Tributes were paid him by Commander T. H. Boyd and V. P. Williams, both of whom gave a resume of his wonderful war record, outlining how he served overseas for several years with the Canadians, was terribly wounded and shell-shocked and was given the famous Mons medal before he was invalided home. He then joined the American forces, in which he remained until after the armistice was signed.

Work of distributing bonus applications is being carried on by the local post in conjunction with the state headquarters and more than 4000 were given out the first week.

SPECIAL FORBES MEETING

As soon as definite word is received as to when Colonel C. R. Forbes, head of the veterans' bureau of Washington, D. C., will arrive in Portland, a special meeting of Portland post No. 1 will be called, at which all matters in which former service men and women are interested will be discussed. He is expected Wednesday or Thursday, according to the latest information received by Commander Boyd.

The members at the meeting Monday night unanimously passed a resolution condemning the delay in disposing of the Joseph Wernicke case, naturalized Austrian of Portland, who is accused of giving aid to a German spy. The post is opposed to any further delay in holding the trial.

Dr. C. Van Cleave, chairman of the entertainment committee of the post spoke briefly on what his committee had planned in the way of entertainments for the winter season. He said that American Legion dances will be held every Tuesday night at the Broadway dance hall. The income from the dances will go toward expenses of running the post. The second dance will be held tonight. Immediately following Monday night's session, the women's auxiliary served cake and coffee.

Witness Released On Bond in Federal Murder Prosecution

After surrendering himself to the United States marshal Monday afternoon and giving \$500 bond to guarantee his appearance, Eliza Miles was released by United States Commissioner Frazer pending the action of the federal grand jury on the murder charge against Mrs. Alma Wurtzberger, his aunt. Miles is the government's star witness. He returned to Salem Monday night, after being examined by United States Attorney Humphreys.

Miles came to Oregon from his home in Douglas, Ariz., about a week before the murder to visit Mrs. Wurtzberger. After killing her husband with a hammer while he was sleeping in bed, Mrs. Wurtzberger is said to have awakened Miles and requested him to accompany her to Salem where she surrendered herself to the sheriff. The government will prosecute because the murder was committed on the Chemawa Indian reservation, which is government property.

Two Streets May Be Closed to Traffic During Recess Hour

The city council will consider granting authority to the board of education to close East Fifty-seventh and East Fifty-eighth streets between Sacramento and Thompson streets during the recess hours of Rose City Park school. The measure was introduced by Commissioner Barbur.

Application for the erection of a two-story building as an apartment house for three families made by Mrs. O. Hylander will come before the council Wednesday. The plans call for the building to be put up on East Forty-ninth street between Broadway and Halsey street.

Plans for improving the vacant block opposite the union depot will be taken up at the council meeting. The request for action was made by F. O. Vincent.

Recommendations to change the name of Campbell street from Lombard to Kusnetz streets to Elmore street will be considered at the council meeting.

Oath of office will be administered to J. J. Maszkowsky as special police officer.

Garden Truck Hit Hard by Frost in Vicinity of Salem

Salem, Sept. 13.—Tomatoes, pumpkins, squash and kindred products of the garden and field suffered severely from the premature cold snap which hit this section of the valley Monday morning, according to belated inventories of the truck gardeners in the Salem section. The damage at the state hospital farm southeast of here, alone amounted to approximately \$5000, according to Dr. R. E. Lee Steiner, superintendent of the institution.

The damage throughout the county will aggregate several thousands of dollars, although no one is in a position to hazard anything like an accurate estimate, inasmuch as the damage is confined to garden truck, most of which is in small patches and widely scattered.

Permits for Garages To Be Passed on by Council Wednesday

Six cases involving the erection of garages, four for private use and two public, will be considered by the city council at its meeting Wednesday morning at 10 o'clock.

Helen Lamberson has filed a petition for permission to erect a garage for public use at 386 Eleventh street, while the Eagle Garage company has asked permission to make an addition to the garage it now operates on Ninety-second street, between Foster road and Fifty-eighth avenue southeast.

Those wishing to build private garages are: C. A. Wells, Heights Terrace, between Hall and Seventeenth streets; W. M. Ainsworth, between Avenue between Atlantic and Greeley streets; Lester O. Fellows, 540 East Thirty-second street, and C. O. Richards, 673 Market Street Drive.

Deer Island Is Visited By Fire; Loss \$10,000

St. Helens, Sept. 13.—The two story frame Deer Island hotel, operated by M. O'Connell and owned by J. F. Lloyd, and the residence of Elma Lloyd at Deer Island were destroyed by fire this morning. The blaze was discovered about 8 o'clock, coming from the roof of the hotel. Lack of a water system prevented effective fire fighting but a bucket brigade saved other nearby structures. The loss is estimated at \$10,000, of which \$7000 was suffered by J. F. Lloyd.

Deer Law Violation Costs Hunter \$100

The double charge of killing deer out of season and selling venison was placed against Chester Alexander of Marshfield by P. A. McDaniel, district deputy game warden in charge of Coos county, and resulted in the payment of a fine of \$100 and costs, according to a report filed at the headquarters of the state game commission today.

CATHOLIC BISHOP STRICKEN

Sioux Falls, S. D., Sept. 13.—(I. N. S.)—Rev. Thomas O'Gorman, venerable Catholic bishop of the Eastern diocese of South Dakota, today sustained a stroke of paralysis and is in an unconscious condition at his home here. He is 78 years old.

SUIT IS DROPPED; TIMBER FIRM WILL PAY GOVERNMENT

That irregularities had been admitted by officials of the Oregon Lumber company in securing a large amount of timber in the La Grande district about 1903, was the information received this morning by United States Attorney Lester W. Humphreys from Attorney General Daugherty.

Humphreys was directed by Daugherty to cancel the trial date of the \$3, 181.66 suit which the government has brought against the company, as company officials were settling the matter direct with the department at Washington. Trial had been set in the federal court for October 19, the case being handled by Assistant United States Attorney Hall S. Lusk.

According to the complaint, the company induced people to enter upon the land under the timber and stone act, and is alleged to have cut the timber from the land before the patents were issued. The entries were canceled in 1913 and 1914 without patents having been issued. Legal proceedings were started three years earlier.

Humphreys said he has been informed

that the company admits cutting off the timber, but denies the damages amounting to \$53,000. It contends it removed only \$1000 worth of timber. The complaint alleges 3,154,941 feet of yellow pine, 114,793 feet of Douglas fir and 121,230 feet of western larch to have been cut.

The Oregon Lumber company is organized under the laws of Utah, but practically all its operations have been in Oregon.

Reed College Open With Registration Reaching 300 Mark

Reed college opened its fall term Monday with all its dormitories overflowing. Total registration of 300 was assured today and the faculty turned away students living in Portland who were anxious to live on the campus.

"It is best to stop the growth of an institution at the point where the students and the faculty can still meet in close relationship with each other," was the way President Richard F. Scholz defined his view of the matter in an address to the incoming freshmen.

"We do not want to develop a Reed type. Reed is a place for the development of individual personality and we wish to give all range possible for the growth of individual differences."

New students registered up to Monday numbered 129. There are 186 old students, bringing the total enrollment, if they re-register, to 315.

LIBERAL POLITICAL PARTY IS PLANNING TO GET INTO RING

New York, Sept. 13.—Plans are being made today for a new liberal political party.

It will be launched formally this fall and will undergo its first actual test of strength in the congressional elections of 1922.

The movement is sponsored by the Committee of Forty-eight, which is acting independently of any other organization. There will be no attempt at an alliance with the Farmer-Labor-Socialist, Single Tax or other parties. In fact, any possible support by those parties will be discouraged.

J. A. H. Hopkins, national chairman of the Committee of Forty-eight, said today he believed the two major parties had "grown to be counterparts" and had "outlived their usefulness."

"Instead of being distinctive, the Republican and Democratic parties now include reactionaries, conservatives, liberals and radicals," he said. "We believe the great mass of independent voters in this country are liberal in political thought. It is our purpose to amalgam-

ate them in one party, which may even take the name of 'Liberal.'"

Hopkins thus outlined the present plans of the Committee of Forty-eight: "A national conference will be called this fall, composed of representative men and women from all states, for the purpose of adopting a national and state organization plan. A national committee will be elected and organizations initiated in each state preparatory to the elections. The heart of this movement lies in the Middle West."

Vallejo Chamber to Support 1925 Fair

Support of the Vallejo, Cal., Chamber of Commerce to the 1925 exposition project was unanimously pledged at a recent meeting of the organization, according to advice received by the Portland chamber today. A resolution was adopted saying the Vallejo organization "congratulates Portland for the foresight and energy in undertaking a celebration of such magnitude and paramount importance to the Pacific coast."

CHINESE FINED \$10
Charged with using profane and abusive language to waitresses employed by the Seward hotel, Henry Lee, Chinese cook employed in the hotel kitchen, was fined \$10 this morning by Municipal Judge Roseman. Miss Goldie Barnett, formerly employed as a waitress, signed the complaint and appeared against the Chinaman.
