STANDIFER TO GET PAYMENT ON SHIP CLAIM

Matter on Way to Settlement on Basis of Not Over \$2,791,000, Subject to Audit; \$10,000,000 Demand Is Disallowed.

Washington, Oct. 21.—(WASHINGTON BUREAU OF THE JOURNAL.)—Claims of the G. M. Standifer Construction corporation of Portland and Vancouver, Wash., on account of cancelled contracts and other losses growing out of wartime and post-warship construction are on the way to settlement at a figure not exceeding \$2,791,000.

The total of the Standifer claims as presented to the board aggregate over \$10,000,000. Many of the items were ruled out as adjustments made and the maximum fixed as above stated.

Surplus materials owned by the government in the Standifer yards were closed out around 50 cents on the dollar, which is said to be higher than the average by the government on such materials.

The shipping board has no figures as to a reported sale of incomplete ships by Standifer to the Nafrina line, as that was a private transaction, but the Nafrina line is involved in serious difficulties and whether any profit will accrue to Standifer is unknown.

The attorney referred to who appeared for the Standifer corporation after employment by the shipping board is understood to be C. W. Guthrie, former chief counsel for the shipping board, and who afterward appeared for Standifer in seeking a settlement of the corporation's claims against the government.

Losses are charged. Newspaper articles published this week in Washington charged the shipping board had lost millions through the Standifer deal.

Portland firms win army bids. Bids for nearly \$130,000 worth of foodstuffs were awarded by the United States war department today to Portland firms who underbid both Seattle and San Francisco on contract for supplies to feed the army.

Wires and cables suspended below the car caught her. She lay, half hanging and half crumpled in the cables, until she was rescued through the door on the first floor.

Mrs. Wright was taken to a physician in the building. She was cut, shocked and bruised, but her injuries are not considered serious.

BOARD CALLS RAIL HEADS AND UNIONS

Chicago, Oct. 21.—(U. P.)—The United States railway labor board this afternoon issued an order citing the railroad officials and leaders of the "Big Five" brotherhoods to appear before the board on Wednesday morning at 10 o'clock and give testimony as to whether they have been or are violating decision No. 147—the wage cut decision.

The board will require the brotherhood chiefs, it was announced, to show cause why they should not be punished for violating a strike cut decision by calling a strike in protest against it.

DENTIST CUT THROAT WITH FALSE TOOTH

Demountable Piece, Perhaps Made by Brumfield Himself, Used by Him in Suicide Attempt; Talks in His Delirium of Being Shot.

By D. D. Mathews. Roseburg, Oct. 21.—With a short piece of demountable bridgework, taken from his own mouth, Dr. Richard Melvin Brumfield attempted to cheat the gallows, Thursday night by cutting his throat.

Brumfield's face and body were twitching this afternoon and his temperature was 101 when examined by Dr. Charles B. Wade. When Wade entered the cell Brumfield said: "Hold up my head, so I can turn over on my side and rest easier. He was breathing heavily and his lips were dry and hot. Doctors declared that he should not be moved until his fever subsided."

Barring infection or possible reopening of the wounds by Brumfield, the convicted slayer of Dennis Russell, an expected recovery, although the life is still considered in danger. Planning of sentence of death, scheduled for Saturday morning, will depend, however, on an examination made by physicians in the morning. Meanwhile Brumfield is being closely guarded.

Lying on his cot, soaked with his own blood, Brumfield recovered, unconscious, by Sheriff Starmer and a C. L. Hadley, night jail guard, about 9 o'clock Thursday night. Physicians were rushed to the jail but it was some time before the flow of blood could be stopped.

The condemned murderer had removed his clothing, put on his night-shirt and was either sitting or lying on his cot when the act was committed, as no blood was found on the floor. Bed clothing, however, and his pillow were soaked.

When seen by a Journal representative this morning, Brumfield, his face a deathly white, was lying on the jail cot murmuring incoherently. His wounds had just been closed by Dr. Charles B. Wade, stationed at the front of the blood-soaked bed clothing, most evidence of the fact that Brumfield had done his best to end it all. Occasionally his body would twitch as though the man was suffering under agony.
