

PLANS ARE BEING MADE TO EXTEND TILLAMOOK LINE

Plans are being prepared by timber owners and railroad interests with a view of beginning the extension of the Gales Creek & Wilson River railway toward Tillamook this spring or summer, according to assurance given by officials of the Hill lines in this district.

Because the plans are in embryo and no agreement has definitely been reached between the Great Northern and Northern Pacific railways and the timber owners, the officials would not comment for publication.

The timber interests said to be engaged in drawing up the agreement which the railroads are expected to approve are: J. L. Washburn, the E. Hall Land company, John W. Blodgett, the Tillamook Yellow Fir company, Porter Haskell and the Whitney company.

Last fall during the visit of Ralph Budd, president of the Great Northern, an option was taken on the Gales Creek & Wilson River railroad extending from Willamette, where it connects with the United Railways, to Agard, in the Washburn timber.

Because the timber owners are still undecided whether to bear the expense of building the railroad themselves or leave it to the Northern lines, the railroad companies have refrained from purchasing any of the right of way.

The timber owners are eager to have the road built soon, however, since there is a large stand of burned over timber which could be marketed.

Miller-Crier & Co., contractors, have under advisement plans for making the extension. As projected, the line would run from Agard down the Wilson river to a point near its confluence with Jordan creek where it would branch off through a tunnel to the valley of the Kelches river and join the Kelches River railroad of the Whitney Lumber company. This would leave only approximately 30 miles of line to build.

Advice also is given to the effect that the Northern lines plan to electrify this extension, making possible quick service to the Tillamook coast section.

These activities would make it appear obvious that the owners are not making overtures to the Union Pacific and Southern Pacific for entrance into this section.

California Savants To Test Einstein in Eclipse Observation

Berkeley, Cal., Jan. 11.—(U. N. S.)—Under the leadership of Dr. W. W. Campbell, director of Lick observatory, a group of University of California scientists will go to "Ninety Mile Beach," Australia, to take astronomical observations during the total eclipse of the sun, September 21, 1922, which will test the validity of the Einstein theory of relativity. It was announced today. The "Ninety Mile Beach" has hitherto been considered inaccessible, but the Australian government will place a special vessel at the disposal of the scientists for the landing. To make preliminary observations, Dr. R. J. Trumpler will sail March 31, while the main expedition will go July 18.

Revival of Baptist Program Noted by Dr. J. Y. Richardson

Revival of the Baptist program embodied in the "New World" movement of 1919 was announced today by Dr. John Y. Richardson of New York, director of the general board of promotion of the Northern Baptist convention. He is spending most of the day here in consultation with Baptist leaders.

A drive for \$200,000,000 was started two and one-half years ago, but only about half the churches responded, Aitchison said. In spite of depressed financial conditions, the response to the new movement is gratifying and old pledges are being taken up, he said.

Last year, he said, the church gave more than \$15,000,000 to missions or at the rate of \$10.05 a member, in addition to a per capita of \$13.06 for general church support. On the broader mission and educational work, the goal this year is \$20,000,000, with a \$5,000,000 increase next year and a \$25,000,000 total in 1924.

Under the new plan, Aitchison said, lectures and conferences will take the place of literature used in the previous campaign.

WOMAN ON STAND TELLS HOW SHOT KILLED HUSBAND

Mrs. Clara C. Briggs sat on the witness stand in Circuit Judge Morrow's court today and told without outward emotion how Ed Breshers killed her husband, Joe Briggs. Her story told how the two men and their families were relics of the backwoods days, when everyone was a law unto himself.

Briggs and his wife were living on their barge, moored in Columbia slough in front of the Breshers ranch home, on November 15, when the shooting took place. Briggs wanted to return 125 boxes of apples and 20 boxes of pears that he had bought from Breshers and which he had failed to sell down the Columbia, where he transported them in a small boat while his wife remained on the barge.

WANTED TO LEAVE

Briggs returned with the apples November 12. He and Breshers argued most of the time until Tuesday morning. That morning, Mrs. Briggs said, she heard the men arguing outside. Breshers was in his launch and Briggs was standing on the barge.

According to her story, Briggs started to unload the apples and had about 25 boxes ashore when Mrs. Breshers and the hired boy, Eddie Stevens, boarded the barge with a note from Breshers, warning Briggs to be away by 12 o'clock. Mrs. Briggs told Mrs. Breshers they would be away long before that.
