

WAYSON LACKING IN SYMPATHY, SAYS DISABLED VETERAN

The case of Charles E. Lee, a veteran of the World War, was claiming compensation for tuberculosis trouble, nervousness and other disabilities, occupied the entire forenoon session of the public hearing at the courthouse today of charges of insubordination and lack of sympathy for service men preferred against Dr. N. E. Wayson, head of the United States public health service.

Lee took the stand when court opened at 10 a. m. and his testimony continued until noon. The specific charge against Dr. Wayson is that he said to Kenneth Cooper, cooperation officer of the United States Veterans' bureau, "There isn't a darn thing the matter with this man to prevent his continuing vocational training," or words to that effect.

GOES TO HOSPITAL.

Lee's testimony showed that he enlisted in the army in August, 1917, and was discharged January 2, 1919. He was confined to various hospitals during a great deal of the time he was in military service and stated that he was not sent overseas. Following his discharge Lee applied for hospitalization at Missoula, Mont., Seattle, Tacoma and Portland and received medical attention and observation from the United States public health service in each of these cities.

Lee stated that he went into vocational training as a bookkeeper at Seattle and afterward dropped this work to take up study for the profession of hotel manager. He also took a trip on an order on a shipping board vessel to the Orient, but was confined to his bed most of the way home. In Portland Lee took up vocational work as a watchmaker, and the charge against Wayson is based on a conversation which is said to have taken place between the head of the public health service and Cooper relating to Lee's fitness to continue in this work.

An exhibit of X-ray photographs showing the bones of the left wrist of an ex-service man, featured Thursday's hearing. The photographs were presented by Dr. F. E. Elmer as evidence for the defense against the specific charge that Frank LaPort, a World War veteran, had not received proper hospital attention.

According to the testimony of witnesses, LaPort applied for treatment at the office of the public health service in the medical building, early in December, 1921. He was taken to St. Vincent's hospital, where examination by Dr. M. E. Steinberg and other members of the public health service staff showed tuberculosis of the bones of the left wrist.

OPERATION SUCCESSFUL.

An operation was performed December 31 for the removal of diseased portions of the bones and tissues from LaPort's wrist, according to Steinberg, and the wound healed satisfactorily, allowing the patient free use of fingers of his left hand, which had been stiff and useless prior to the operation. Following the operation LaPort refused to accept of amputation, it was stated, and was removed to the city isolation hospital.

It was charged that while at the city hospital LaPort had not received proper treatment and that officers of the public health service had neglected to call at the isolation ward and dress the wrist. Dr. J. C. Walsh and Dr. H. Stipple of the city health department, testified that Dr. Wayson had been notified by Dr. Parrish, city physician, that LaPort was in need of surgical attention and that Wayson had neglected to look after the patient.

Dr. Steinberg said that the changing of the surgical dressings was a simple process which could be accomplished by a hospital nurse, and that it was the duty of the physicians at the city isolation hospital to see that the condition of all patients under their care. He said that he had been warned by Dr. Wayson against visiting the smallpox isolation ward and going from there to the surgical ward at St. Vincent's hospital.

SAYS LAPORT SATISFIED.

Dr. Elmer testified that LaPort was well satisfied with his treatment at the isolation hospital; also that the operation for the removal of diseased bones and tissues from the patient's wrist had been successful and offered his photographs in proof of this assertion. The exhibit was viewed by the investigating board in charge of the hearing and duly entered in the record of the case. LaPort was absent from the city, as was Dr. Parrish.

Dr. Wayson testified that he had received no request from Dr. Parrish for attention to LaPort while he was quarantined at the isolation hospital and presumed that the patient was properly cared for while there. He said that he had every reason to believe that LaPort had fully recovered from the tubercular condition of his wrist.

FIND ALLEGED BOOTLEGGERS.

SANE; HELD TO GRAND JURY.

Counsel for J. Timmons, alleged bootlegger, failed in his efforts Thursday before United States Commissioner Fraser to prove his client mentally unbalanced and not accountable for law violation. Fraser held Timmons to answer to the federal grand jury under \$750 bonds.

Barney Pearlman, who was arrested several days ago in a downtown office building, was also held under \$500 bond. Pearlman had a "general agency" of firms in which he is alleged to have sold liquor exclusively.

C. J. Cooper, who has been addicted to narcotics for 35 years, was also held on a charge of having narcotics in his possession. His bail was set at \$1500. Cooper claimed he had the drugs for his own use only, and was not a retailer.

JURY DENIES DAMAGES.

ASKED BY DR. CATHEY.

Dr. George A. Cathey, who brought suit for \$3500 against the P. R. L. & P. company for personal damages and damages to his automobile in a collision with a streetcar on Kings Heights after his return from the Elks' convention at Salem, was denied damages by a jury in Circuit Judge Morrow's court, Thursday afternoon. There were three women on the jury.

W. H. Whiteaker Arrested Again In Stock Deals

W. Harrison Whiteaker was convicted in 1913 of selling fake oil stock in Oregon and sentenced to from one to five years. He was out on bail while the case was being appealed and when he lost in the supreme court in 1915 he gave himself up to the warden of the penitentiary. The arrests were based on secret indictments returned by the Multnomah county grand jury. The arrest was made on representation of T. B. Handley, corporation commissioner, and the Ad club's better business bureau.

Federal Courts and Capital Out to Ruin Labor, Says Senator

Washington, Feb. 10.—(I. N. S.)—Existence of an "unholy alliance" between the federal courts and the "vested interests" to crush labor and reduce free-born American workers to the condition of Russian serfs was charged in the senate today by Senator La Follette (Rep.) of Wisconsin.

"For more than a quarter of a century 'big business' combinations have suppressed competition, acquired a monopoly of control of prices, seized the farmers, plundered the consumers and oppressed the wage-earner," La Follette declared.

Evangeline Booth Arrives Saturday; Reception Planned

Commander Evangeline Booth of New York city, chief executive of the Salvation Army forces in the United States, will arrive in the city Saturday morning on a two-day visit. She will spend the morning inspecting local army institutions and at 2 o'clock will be in a parade in her honor, which will be led by the police. The parade will start from the Multnomah hotel at 2 o'clock and will be through the principal streets. The Elks band and drill team, the mayor and several leading citizens are expected in the line. Miss Booth will deliver her only public address while in the city at The Auditorium on Sunday night.

Will S. Hale Placed On Film Censorship Board by the Mayor

Will S. Hale, first assistant chief probation officer attached to the court of domestic relations, has been appointed a member of the local board of motion picture censorship by Mayor Baker on the recommendation of the federation of churches. The appointment will be placed before the city council today for final approval.

ULSTERIES ARE ATTACKED; ONE CONSTABLE KILLED

Belfast, Feb. 10.—(I. N. S.)—One policeman was killed when a party of 30 armed Sinn Feilers ambushed a detachment of Ulster special constables near Tyrone, Donegal county, today. There was a brisk exchange of shots, according to a dispatch received here.

Dublin, Feb. 10.—(I. N. S.)—An army of 7000 men, commanded by a former British army officer, has been concentrated on the Ulster side of the frontier of the Armagh-Tyrone county line, according to information received here this afternoon.

London, Feb. 10.—(I. N. S.)—Great Britain has warned the Irish provisional government at Dublin that British troops will be used to protect Ulster if the Irish republicans renew their raiding activities on the Ulster frontier, it was announced in the house of commons this afternoon by Colonial Secretary Winston Churchill.

No one attempts to deny that the situation is serious and that fratricidal war may break out at any moment. What may be the beginning of such a warfare started Thursday when nine additional men were kidnapped during considerable promiscuous shooting along the border.

Government officials are debating whether a large force of British troops, in spite of the terms of the treaty, must not be left in Ireland to maintain order. It is worthy of note that the evacuation, which until recently was proceeding rapidly, has now slackened.

Ulster leaders are loud in their demands for retention of the crown forces "for protection against raiders," while the provisional government insists that it is fully capable of handling the situation itself.

It is learned here that the government plans to leave 14 battalions in Ireland. This, however, is not at the result of the recent outbreaks, but was determined upon after the signing of the treaty.

RATIFY PACTS, IS PLEA TO SENATORS

authority, I submit to the senate that if we cannot join in making effective these covenants for peace and stamp this American approval, we shall discredit the influence of the republic, render future efforts futile or unlikely, and write discouragement where the world is ready to acclaim new hope," he said.

"Because of this feeling, because I believe in the merits of the engagements, I submit them to the senate with every confidence that you approve."

REPLACE DISAGREEMENTS.

President Harding declared that the conference treaties replace menacing disagreements and establish surer ties instead of uncertainties which easily might lead to armed conflict.

"The powers in conference," said the president, "took the world of the Pacific as they found it in fact. They dealt with actualities by voluntary and unannounced agreement and have advanced international peace."

That the treaties are not based on force was his contention.

"It is worth while saying that the powers in this conference sought to concert to dispossess any power of rights or property," he continued. "All the signatories have given up rights, which they had, as their contribution to concord and peace, but at no sacrifice of national pride, with no regret or resentment to later flame in conflict. The offerings are of free will; the conscience is that of world cooperation; the observance is a matter of national honor."

NO ALLIANCE, HE SAYS.

He assured the senators that "nothing in any of these treaties commits the United States or any other power to any kind of alliance, entanglement or involvement."

"It does not require us or any power to surrender a worth while tradition," he said.

Harding begged the senators not to accept a doctrine of despair, which would regard these as meaningless treaties.

"Nations may not trust one another," he said, "then, indeed, there is little on which to hang our faith in advancing civilization or the furtherance of peace," he said. "We can no more do without international negotiations and agreements in these modern days than we could maintain order and neighborliness at home without the prescribed rules of conduct which are more the guarantees of freedom than the restraint thereof."

RECALLS LEAGUE OPPOSITION.

"American unwillingness to be a part of the League of Nations has been kept in mind in framing the present documents," he said, "and the treaties submitted today have no semblance or relationship as the wish to promote the common inspiration."

"These treaties leave no power depleted," he assured you the nine powers have been brought more closely together; they are stauncher neighbors and friends; they have clearer and better estimates of one another; they have seen suspicion challenged and selfishness made to retreat, and they are more strongly welded for right and justice in international relations than ever before.

COVET NO POSSESSIONS.

"We have convinced the onlooking and interested powers that we covet the possessions of no people or of no powers in the Far East, and we know for ourselves that we crave no further or greater governmental or territorial responsibilities there."

"Contemplative of what is ours, and mindful of a long-time and reciprocal friendship with China, we wish the opportunity to continue development of our peaceful relations in equality with other nations to strengthen our ties of friendship and to make sure the righteous and just relationship of peace," he continued.

He admitted that the Pacific has been a source of grave concern.

NO EXCUSE FOR WAR.

"There has been apprehension of territorial greed, a most fruitful cause of war," he said. "The conference has dispensed both and your ratification will stabilize a peace, for the breaking of which there is not a shadow of reason or real excuse."

"We shall not have less than before. There is no narrowed liberty, no hampered independence, no sovereignty, no added obligation. We will have new assurances, new freedom from anxiety and new manifestations of sincere good intentions; a new demonstration of that honesty which proclaims a righteous and powerful republic."

WILL RESPECT RIGHTS.

"I am ready to assume the sincerity and the dependability of the assurances of our neighbors of the old world that they will respect our rights, just as I know we mean to respect theirs."

"I believe there is an inviolable national honor, and I bring to you this particular covenant in the confident belief that it is the outstanding guarantee of peace for the Pacific which will justify the limitation of armament and prove a new guarantee to peace and liberty and maintained sovereignty and free institutions."

"No allusion has been made to the treaty restraining and limiting the use of the submarine and the prohibition of noxious gases in warfare. Since we are asking the world's adherence, it is assumed that none in America will hold aloof."

TWO PARTIES IN DELEGATION.

He appealed to the senate's sense of jealousy for its prerogatives by noting he had had both Republican and Democratic senators on the American delegation.

"The senate's concern for entanglements, for preserved traditions, for maintained independence, was never once forgotten by the American delegates," the president said.

Noting that other conferences on world problems are to come, the president declared "I will be glad to try again," if the senate will not "advise and consent" on the present documents. Every caution compatible with accomplishment had been exercised, he said.

Harding assured the senate that the executive realized the menaces, the anxieties and the apprehensions to be met.

"None of us," he said, "means to endanger none of us would sacrifice a cherished national inheritance."

Lakeview Gripped By Worst Storm; Communication Cut

Klamath Falls, Feb. 10.—Lakeview is in the grip of the worst storm of its history. It was learned by telephone this noon. Telephone and telegraph lines are cut off in every direction except to this city and no trains or stages have reached there for 72 hours.

Snow is so deep the pedestrians can make their way only with the utmost difficulty, it was said. The last mail that arrived was distributed from horseback because carriers could not buck the drifts on foot.

Raid Chinese Dens; Take Pipes, Opium; Two Are Arrested

Members of the morals squad raided two Chinese opium dens Thursday night, arresting 10 Chinamen and confiscating their worth of opium and several beautifully ornamented pipes. One raid was at 91½ North Second street and the other at 57 North Fourth street. Ah Bow, alleged proprietor of the first place, was charged with conducting an opium den, and Young Sing, alleged proprietor of the other place, with having opium in his possession. Eight men were charged with visiting opium dens.

BANDITS REPULSED BY TRAIN GUARDS

El Paso, Texas, Feb. 10.—(I. N. S.)—An expedition of 35 heavily armed Mexicans crossed the border from Texas into Mexico last night and attacked the express train. Detachments rushed by General Jose Mendez, commandant at Juarez, freshly mounted while the bandit gang had been hard ridden, pursued the attackers and was expected to overtake them.

The leader of the band was identified by a railroad agent as Nicolas Rodriguez, who is out on bond following his arrest on charges of plotting against the Mexican government in El Paso.

The station agent, who had opportunity to view the gang and its equipment closely, declares it had new saddles, cartridge belts, rifles, canteens, etc., bearing United States marks.

"I am convinced the outfit was financed from some American city, very probably New York," said Consul General Senor Montes De Oca. "No hostile group of Mexicans in the West has money enough to undertake such a move."

Propose Licenses And Examinations In Plumbing Trade

An ordinance regulating plumbers by license and examination may be proposed to the city council as a result of a conference today between City Commissioner A. L. Barbur, of the department of public works, and representatives of the Master Plumbers' association.

The plumbers expressed themselves in favor of a tentative scheme outlined by Barbur, whereby plumbers would pay an annual license fee of \$100 and submit to an examining board before being granted the privilege of practicing the trade.

While the fee is high, plumbers said it would keep irresponsible jack-of-all-trades from interfering with responsible firms.

A similar ordinance was drafted several years ago, but at that time the particular proposal was declared unlawful, as it was in violation of the state code.

Fund to Advertise Portland to World Urged at City Club

The question of including the Diamond lake area within Crater Lake park and the matter of advertising Portland to the world were discussed by the City club at its weekly meeting today. On the Diamond lake question a committee returned a report unfavorable to the inclusion of the territory, while S. C. Goodwin, superintendent of the local bureau of the park service, argued for the plan. No action was taken by the club.

In urging that Portland tax payers establish a fund to advertise the city, William H. Crawford of the department of industries of the Chamber of Commerce pointed out that it took New York 175 years to become as large as Portland today. The plan of several Canadian towns of advertising the town with funds raised by taxation was advocated by Crawford.
