Requests for permits to build two moving picture theatres on the East Side will be considered by the council Wednesday. David H. Ryan petitions for the privilege of enlarging and improving a building at Sandy boulevard and East 46th street, for a picture theatre, and Lee Thomas asks for permission to build a theatre and store at Rural avenue and Milwaukee street.

A building permit calling for a plant 25x120 feet and three stories high was issued Saturday by Building Inspector Plummer to the Columbia Tire company. The new plant will be in Kenton. It is estimated the cost will reach \$150,000.

A vast ocean of "primary energy" fills all space; controls all universes and planetary systems in their courses; holds each and every atom of physical life together, and grants health and success to men and women who make scientific use of its magic forces.

This is the teaching of Baron Eugene Fersen, Russian scientist and so-called "mystic" and "wonder man" who arrived Saturday from the East and is scheduled to lecture Sunday, Monday and Tuesday evenings at Lincoln High School auditorium. Baron Fersen is an energetic gentleman, between 30 and 40 years old. He speaks the English language perfectly and intelligently, and wears a Red Cross uniform, because he is a member of the Russian Red Cross society, an active agent of the Slavonic Relief association and a member of the work of the American Red Cross society.

The Baron is the organizer and chief exponent of the philosophy of the "Light Beams" society of teachers of truth with national headquarters at Washington, D. C., and branches in 20 of the largest cities of the United States. The society was first taught by Baron Fersen at Moscow, but he explained that he left Russia shortly before the beginning of the Russian revolution and since his operations to the United States since that time.

The Portland society of "Light Beams" has about 150 members. Senator Watson, Indiana, who in the senate on May 4 said the attorney general had told him he was not in any way connected with the Morse pardon, tonight declined to make a formal statement on the case. He did retort that Daugherty told him the statements he had previously made to the senate. "The attorney general knows his statement to Senator Watson was untrue," said Caraway. "The attorney general did represent Morse."

Caraway also declared Daugherty to make good his threat to conduct personally the cases against the alleged war grafters. 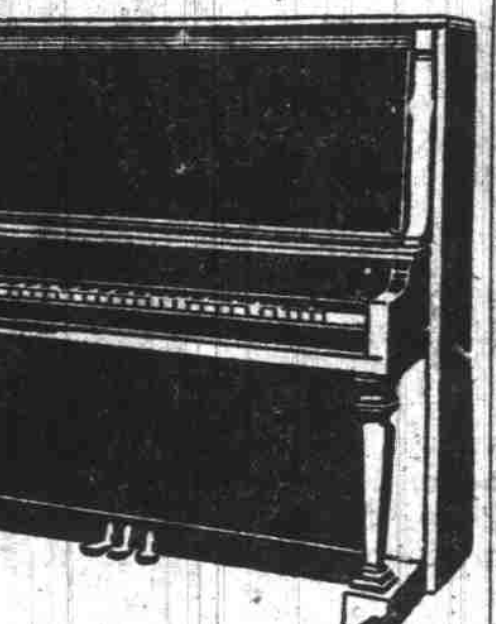

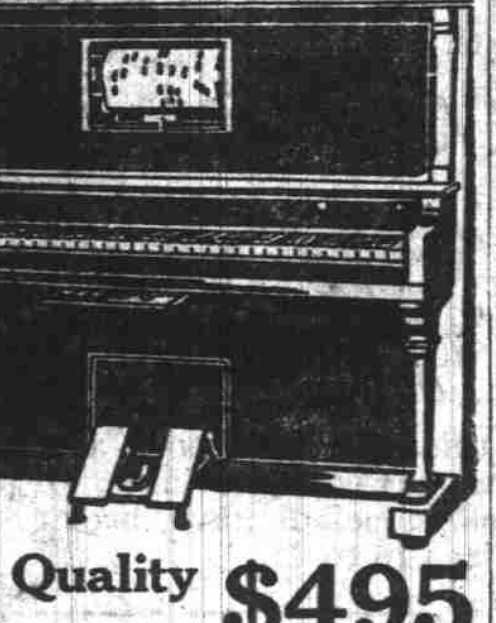
