

OREGON EXHIBITS ARE VIEWERS AT WASHINGTON FAIR

Southwestern Washington Fairgrounds, Aug. 30.—Crowds from Portland, Seattle, Tacoma and points on the main lines between these cities are here today in full force. One of the best racing programs offered during the week is included in today's program.

Judging in the departments was begun Tuesday, but owing to the unusually large exhibits complete reports were not given out except in one or two instances. The overflow in the livestock filled two large tents. Incomplete reports from the judging of swine showed a large number of winners from the state of Oregon.

Edward School of Albany, Or., brother of W. A. School of Chehalis, won first and second honors for his display of Chester Whites for boar one year old and over; first prize for boar under six months, first and second prizes for sow one year old and over, first prize for sow one year old and under, first and second prizes for sow under six months.

W. H. Paulmuth, president of the Fair, said that the fair was a success and loud in his praises of the quantity and quality of the exhibits. Other prominent visitors were Clifford Babcock, state highway engineer, and Dr. David Livingston, superintendent of the Western Washington hospital at Steilacoom.

The total number of livestock exhibited was 899 head, or 300 more than last year, while in the poultry department 1000 birds were on display, 100 more than last year. The increase in these two departments is indicative of the increase in all exhibits. In the poultry department, however, judging was not completed. E. D. Hosmer of Oregon won first prize for cockerel in the White Wyandottes.

Thursday will be "governor's day," when Governor Louis B. Hart and a party of state officials will be guests of honor, as well as Elks, Kiwanis and Rotarians. At a luncheon Thursday the governor, his party, Lewis county commissioners, fair officials and Centralia Rotarians and Kiwanians will be guests of the Chehalis Rotary and Elks clubs at a luncheon at the St. Helena hotel.

LARGE SHOWING IS MADE IN LIVESTOCK SECTION

Southwestern Washington Fairgrounds, Aug. 30.—Tuesday was Willapa and Grays Harbor day at the 14th annual Southwest Washington fair. Representations from those vicinities were extraordinarily large. Placing of exhibits was completed Monday night. Judging was in progress in the livestock department, in which at least 450 head of cattle, besides horses, sheep and hogs are entered.

Six herds of Jersey, three of Guernseys, four of Shorthorns, three of Herefords, two of Red Polls and three of Holsteins from outside the county, are local herds shown.

one of the most important features of the convention. Before the last general convention which was held in 1919 at Detroit, the general work of the church was divided into three departments: a board of religious education and a joint commission in social service.

UNIFICATION OF WORK

"In order that all of the general work of the church might be unified and developed and more efficiently carried on, the present board of religious education and council now takes the place of these agencies.

In addition to giving its report showing what has been accomplished in the way of coordinating and strengthening the church's work, the council will present to the General Convention for its consideration a program of work to be carried on during the next three years, together with a budget for current and existing work.

The board of religious education and social service activity to be carried on. The budget and the program with the price tag of \$21,000,000 in the next three-year period."

In 1919, the last year of the triennial general convention was organized, the receipts for the general work of the church were \$1,111,972. In the first year under the council and following the nation-wide campaign, the receipts were \$3,092,178, or an increase of 177 per cent. This increase has been substantially maintained.

Bishops began arriving early in the week and already a score or more from all sections of the world, many of them accompanied by their wives, are in the city, some stopping at the Multnomah and others at the Hotel Hawthorne, which is being operated by Portland people. Bishop Gallor, the president of the house of bishops, was expected to arrive this morning for the lowland national park, but the delay of trains made the time of his arrival uncertain. The bishops, of whom there are 63 in the world, will be present at the convention to discuss informally the proposed revision to the prayer book and other business matters in order to expedite the business sessions of the convention.

The general convention, which is the chief governing and law making body of the church, consists of the house of bishops and the house of deputies. These houses sit and deliberate separately, and all legislation must be adopted by both houses.

The house of deputies is composed of clerical and lay deputies from all the dioceses and missionary districts. Each diocese is represented by four clerical and four lay deputies. Each missionary district is represented by one clerical and one lay deputy. There are 63 dioceses and 33 domestic and foreign missionary districts. The total membership of the house of deputies is now 620.

Chicago, Aug. 30.—To right the wrong which her husband made his first wife suffer, Mrs. Eleanor Bock, wife of a wealthy California mine owner, came to Chicago Tuesday. Ever since she learned that she won wifehood from another woman, Mrs. Bock declared, a shadow has come between her and her husband which she feels will not lift until she finds the "other woman."

It is a strange triangle which she would straighten—one in which sympathy replaces jealousy and pity, reprimand.

Two years ago John G. Bock, a painter, left Chicago to seek his fortune in the Klondike. His wife, Mrs. Lottie Bock, a fashionable dressmaker, remained behind in Chicago to sew and dream of the day when he would return to her and they would be reunited.

Bock's dreams came true, but he failed to return and share their reality with his wife. Instead he went to California, where he met a younger woman, wooed and married her.

One day the new Mrs. Bock learned her husband's past. She found the picture of a pretty woman dressed in the fashions of the '90's and Bock told of his having deserted her.

"I don't want to see her," she said, "I don't want to see her." "I feel I must find the woman who waited for his return."

Alleged Abducted Indian Heiress Is Found; 2 Arrested

Tulsa, Okla., Aug. 30.—Pretty Millie Naharkey, Creek Indian heiress, is back at her home at Red Fork, Okla., and a nation wide search of six months duration is ended.

But the story she has told of her abduction has resulted in one of the strangest legal mix-ups in the history of the oil country, where sudden fortune, mysterious disappearance and tragic disillusionment every day takes place.

On becoming of age last winter the young woman became heiress to oil lands valued at \$200,000. Almost on the day she came of age she disappeared. For weeks it was thought she had eloped. As time went on her former guardian, Stephen B. Nelson of Tulsa, started investigation.

The girl was found by detectives hidden away in a remote section of the Ozark mountains in Missouri, according to Nelson. A. B. Reese and W. E. McNulty, local oil brokers, were accused of her abduction. They are being held in jail at Joplin, Missouri, according to Nelson, charged with kidnaping and harboring.

TRADE IS TEMED PORTLAND CHANCE

The Pacific coast port that gets into the trade of Southern Asia first with regular trade will be so far superior to the other ports of the Pacific in the future, in the opinion of John A. Fowler, trade commissioner for the United States to that section. Fowler arrived today en route to the Far East.

The government trade commissioner is sure that America can develop an enormous trade in the countries which he covers. These countries are the Netherlands Indies, British Malaya, Siam, French Indo-China and the Philippines.

"These countries are served very carefully by the European countries at the present time, but American goods are recognized to be so far superior to the European goods that a regular American service could build up trade relations to an enormous plane of volume. There would be a sure lean year to start but the fat years would follow."

"At the present time the Pacific coast, which is a supply base, can supply only ready demand. The trade of these Southern Asia countries is not potential but actual."

Fowler said that he could not develop fertilizer manufacturing industries to supply the Far Eastern trade, as well as the domestic trade. He said that phosphorus products were in demand at present.

The trade commissioner will leave for Seattle tonight to return Monday, when he will convey with Portland business men their policy in the Orient. He said that he intends to do all in his power to follow out the policy in the future. He will speak at the members' forum luncheon of the Chamber of Commerce next Tuesday noon.

HARVEST OF GRAIN IN CLARKE IS GOOD

Vancouver, Wash., Aug. 30.—The grain harvest in this county is virtually over and the yield was greater than anticipated. The dry weather shortened the straw, which was unusually light, but did not affect the heads, as yields of better than 40 bushels of wheat to the acre are reported from the majority of farms. Some of the oats did not do so well and the returns were comparatively light.

The late potato crop will be up to average, as the rain came in time, but early potatoes will be light and those remaining in the ground, growers say, will develop second growth. Corn for ensilage will make a bumper crop, as many fields are higher than a man's head and still growing. The silo has become a part of every dairy ranch in the county and corn is considered the best crop for ensilage. One great benefit to dairymen caused by the rain is the growth of new grass in pastures.

Services for Virginia Wells Held in Boston

The funeral of Miss Virginia Wells, 23, of Portland, who died at Boston, Mass., Tuesday, will be held at the home of her brother, Scott Wells, in the residence at 2 o'clock Thursday. Friends made this morning by her father, Dr. J. Hunter Wells, No. 673 Halsey street.

Miss Wells was born in Korea, where her father was a medical missionary for 32 years. She came to Portland when 14 years old. She attended school here, and afterwards graduated from the Portland academy. A year ago Miss Wells fell ill. She spent some time in the hospital, attempting to regain her health, and then went to Boston, where she died. Besides those already named, she is survived by a sister, Helen, and a brother, Milton, both of Portland.

LEADERS PLEDGE FULL SUPPORT TO TICKET OF PARTY

Pendleton, Aug. 30.—The Umatilla county Republican central committee, all candidates from Vale to Hood River and the party leaders in the entire district pledged themselves to 100 per cent support of the state ticket at a meeting here Tuesday of the party's representatives with Walter L. Toose Jr. and C. E. Ingalls, chairman and secretary respectively, of the Republican state committee.

Three meetings were held by the officers of the state committee. The first was with the candidates, all of whom had either been seen personally or produced their pledges, not only to work in harmony with the state committee, but to use their efforts to further the campaign of the entire ticket in their localities rather than their own individual campaigns.

Congressional committeemen, who met with the party representatives early Tuesday afternoon pledged themselves to take an active interest in the campaign.

At 3 o'clock Toose and Ingalls met with the Umatilla county precinct committee and found its membership to be a man behind the entire Republican campaign. Toose made a plea for party harmony.

The meeting endorsed the plan of the state committee to take the women into the organization on a 50-50 basis and the appointment of committees to get into direct contact with the voters.

A resolution of appreciation for the plan and efforts of Toose and Ingalls to further the work of the campaign was adopted.

The officials of the state committee leave here for Heppner and Condon and will close their swing around the state in Eugene, September 3.

TURKISH TROOPS MOVE ON GREEKS

Constantinople, Aug. 30.—(I. N. S.)—Turkish nationalist troops are advancing against the Greeks over a 12-mile front in the Bilejik sector of the Anatolian battle front, said dispatches from the war zone today.

The evacuation of Karahissar, 150 miles southwest of Angora, by the Greeks, has cut off the Greek forces in the northern part of Anatolia from the main body.

Heavy casualties have been inflicted upon the Greeks and many prisoners have been captured, according to claims made by the Nationalist war office at Angora.

The Greeks in Northern Anatolia are falling back upon Broussa, their base. This force is in a dangerous position and the Turks are threatening to roll it up entirely. Broussa is 200 miles west of Angora and 55 miles south of Constantinople.

The Turks are employing extensive forces of cavalry as well as heavy artillery. In the region of Karahissar the Greeks were compelled to leave valuable stores of war supplies behind when they retreated.

An American destroyer, lying in the harbor at Samsun, has been warned not to communicate with the shore. All the Anatolia ports have been ordered closed.
